MEMORANDUM

Subj: Irangate - Europe

This is to respond to the December 11, 1986 memo concerning European "press coverage of Iran-US-Israel-Contras. (Did not receive David Gordis' memorandum,of December 8.

Then the story broke, and particularly after President Reagan's declarations referring to "a third country's involvement" and later Attorney General Meese's pointing to Israel's role, there was a brief moment of possible scapegoating of Israel, at least in Jewish appreciations. Israel's clarifications and denials, however, considerably cleared the atmosphere. And all the information coming to light in subsequent reporting on the subject stuck to the US rather than to Israel.

I did make telephone rounds in several European Jewish communities and documentation centers to inquire about the manner of media reports in their respective countries and possible effects on the image of Israel. Mone had even saved clippings, none seemed especially concerned, none thought it useful or necessary to delve into the matter be it with a study or retracing unsaved coverage.

The enclosed article from <u>Le Monde</u> of December 19, published just as I received your December 11 note, is the last one I saw in France pin-pointing Israel's role. As you will see, it is factual and fair, and pretty much clears Israel of having been the initiator in this arms transfer or having gained financially. Mote, too, that the writer is not known for his sympathy to Israel.

In Italy, for example, reactions to a Peres appearance on television and ensuing talk on the subject were good. The arms scandal was used by some Italian politicians (a natural given the forthcoming change in government there this March 1987) to attack warm supporters of the U.S. and Israel like Minister Spadolini. But this was part of the daily menu of internal politics and not important as far as relations or image of Israel is concerned. To emphasize the point, one of the persons I spoke with in Milan told me that several comments on the recent Palestinian camp battles in Lebanon were to the effect of: remember our articles condemning Israel for Sabra and Chatila in 1982? Why are we all so calm about Chatila today? No, Israel is not being blamed for this arms deal, said the Milan friend.

Something along the same lines came from the <u>UK: "Yes, a bit of fallout."</u> But only from those who are always anti-Israel and especially those who strongly objected about England's breaking deplomatic relations with Syria over the Hindawi case. The same people who also raised questions in Parliament about the disappearance of Mordechai Vanunu and those ever looking for ways to cast aspersions against Israel. But none of this was massive, our English friends insist, repeating that the criticism comes from sources known to be anti-Israel and anti-US, taking this occasion to attack the US, attack Israel's links to the US, brand Israel as a US puppet, used to do the US dirty work.

A variation to this theme also comes from <u>Belgium</u>: a few adverse reactions there too came from those generally critical of Israel who took the opportunity to point out that it is a state like all others, with the same faults and scandals as others, plus a willingness to be an intermediary for the US. But criticism of Israel in Belgium is stronger for its ties with South Africa than for its shipping arms to Iran: "Everyone knew Israel was supplying arms to Iran; and so what else is new?"

As you know, Europeans always had problems understanding some types of American upheavals. So it was with <u>Waterga</u>te; and Nimon is still spoken of as one of the best presidents in US history, a great and wise statesman, etc. For the Iranscam there is a sense that the entire matter was clumsily conceived and carried out, but also acceptance that this is the sort of foolish entanglement governments at times get into.

Of course, this does not mean that US credibility will not be challenged in the future by European governments, bodies and people, whenever suitable to their foreign policies and apt to bring advantages; or just simply when they wish to wave a flag or be proud. However, the Iran-contras arms deal chips are likely to fall on the US, not Israel.

The French Jewish community was much more upset about the tensions arising from the sordid murder in <u>Besançon by Wakkash</u>, and when Israel declared that Makkash could not be extradited because of the danger of his being assassinated in a French jail. More understood and calming in this situation was the modified later stance taken by Israel, namely that this was a return lesson for France's release of Abou Daoud after Israel had asked for extradition.

Perhaps it all boils down to Europeans having a long history, and almost expectations, of government scandals and dirty deals, and being more prepared to overlook most of them. And this probably because they are also without illusions in the first place. Though the press here does criticize such happenings -lately even beginning to do the kind of investigative reporting the US is admired for -- it and the public do not ever take the position that they are putting down angels or gods. They know to begin with that there is nothing pure and angelic in politics and governments.

Dear David and Marc:

I am again facing a problem I wished would not become important for the rest of my employment with AJC: the dizzying ups and downs of exchange rates.

During the past year I have watched this rate go down, hoping that it would stop at a reasonable level. It has now reached a very serious and personally frightening point, the lowest in six years and, adding to the distress, a reading that there is still no end to the downward slide.

Checking with other US Jewish organizations in Paris -- JDC and Hias -- I learned that the first took steps to stop the salary erosion of their overseas staff one year ago; and the second is in the decision process. I therefore would like to ask that similar action be taken in my case: namely that a reasonable rate level be pegged and a differential between it and the actual exchange granted, as was done some fifteen years ago, under the same circumstances.

I believe a fair peg would be between Frs. 7.50 to 8.00 per dollar, and effective as of January 1, 1987. This is far below the heights reached a couple of years ago, but would permit relief from the present 6.00 and possible lower rate. I understand that JDC has set the rate at Frs. 7.80; Hias is still deciding.

Will not bore you with sordid personal details. Nonetheless, I urge your agreement to what I think is an equitable and justified request. My problem is quite serious, I feel it daily and it is causing considerable stress.

Thank you in advance for a rapid, and I trust favorable, decision.

Dear David:

Enclosed is my report -- long, but maybe you will feel you were present because of this -- copies of the resolution, the Conference program and list of participants, the list of European projects. Under separate cover I am sending all the printed matter I managed to pick up. As I told you on the telephone, since I became "officially present" at the meeting so late, there was no kit available. Still I scrounged stuff around, but almost all was from US organizations and you may already have seen it. Am not including the National Conference on Soviet Jews material, which I am sure you have.

I missed the night session at which I am told Yoram Dinstein gave a superb lecture about the Helsinki accords and how to use them. Unfortunately, neither he nor Prof. Seweryn Bialer had prepared their interventions in writing; but I am promised a copy as soon as transcribed, and assured that it will not be too long ....

Also enclosed is clipping of interview of Shcharanski from Le Monde of September 11, which I thought well worth your reading. Shcharansky is. far from being the only one who feels this way about Gorbatchev and his new men and his modernity. As a matter of fact, there was surprise expressed here when, after his second meeting with Gorbatchev in Moscow, this past July, President Mitterrand commented much more favorably about future relations and with greater (not full, just greater) belief about Gorbatchev's sincerity. The more tender view is, as I said, not shared by many, rather the contrary and more so since the Daniloff affair. On the last, the feeling is that the Russians won again; and the diplomatic expulsions hassle between the British and the Soviets is much recalled as also won by the Russians, and showing the mettle of the "adversary."

Finally, Al Chernin broached the possibility of another World Meeting (No. 4? 5?) but the participants unanimously agreed that it was too Executive Vice-Presidents Emerisoon to even think about it.
