The Jewish Community

The population of Mexico -- 72 million -- is now second in size in Latin America. The Jewish population -- 45 thousand -- constitutes the third largest Latin-American Jewish community (after Argentina and Brazil). 96% of the Jews live in Mexico City. The community is made up of 55% Ashkenazim from Eastern Europe; 40% Sephardim from the Middle East, North Africa and the Balkans. In the last few years a number of Israelis have immigrated. The main coordinating organization is the Comite Central Israelita de Mexico.

Anti-Semitism in Mexico

Several years ago there seemed to be an increase in the anti-Semitic activities of the right wing. This has receded and, while there are anti-Semitic materials being published and distributed by this group, the Jewish community does not consider it a significant threat. Left-wing anti-Semitism under the guise of anti-"Zionism" and/or anti-Israel publications continues and remains a source of concern to the community. The PLO maintains an office in Mexico City, but a recent petition for diplomatic recognition and to increase their staff was denied by the government.

Mexico's Relations with Israel

Generally, bilateral relations have been good. The vitriolic anti-Israel articles in the media and speeches in the UN during the Lebanese crisis have ended or are much muted. Recently Mexico and Israel signed a new agreement for scientific, technological and cultural cooperation. Perhaps the most significant aspect of this agreement is the fact that it was signed in Jerusalem. Given the attitude of the previous Minister of Foreign Affairs who had refused to allow any agreement to be signed in Jerusalem, the action by the present Minister of Foreign Affairs, and the supportive involvement in the decision by the new Mexican Ambassador to Israel, is considered by the Jewish community as a very positive omen.

Most importantly, Mexico, despite persistent pressure from Arab countries and from left-wing elements in Mexico, continues to sell oil to Israel. At present, 40% of Israel's oil requirements are imported from Mexico. It should be pointed out that the sale of oil to Israel is of great mutual benefit since Israel pays for this oil in cash, which is of significant assistance to Mexico currently undergoing a major economic crisis.

AJC and Mexico

- * The American Jewish Committee has long had an interest in developing a close relationship between the U.S. and Mexico.
- * The AJC established an office for Mexico and Central America in Mexico City in 1966. Directed by Sergio Nudelstejer, it is the only American Jewish organization based in the region and maintains a close relationship with both the Mexican Government and Jewish community.
- * During his tenure (1976-1982) the former President of Mexico, Jose Lopez Portillo, visited the United States four times. Each time he met with an AJC delegation. His predecessor, President Luis Echeverria, met with an AJC delegation in 1976.
- * Mr. and Mrs. Bruce Ramer of Los Angeles represented AJC at the official inauguration of President Miguel de la Madrid in December 1982.
- * The AJC also met with then-Presidential candidate de la Madrid during the visit to Mexico of the AJC Board of Governors in February 1982.
- * We have supported liberal immigration legislation which would benefit, among others, persons of Mexican origin now living in the United States.
- * We have established an American-Hispanic Dialogue which was inaugurated in San Antonio, Texas in February 1984.
- * The AJC has become the "address" for Mexican Government officials who wish to establish a relationship with the Jewish community in the United States and its various organizations.

Talking Points for Meeting with Mexican President

1. Mexico is a particularly important country to us as Americans because (a) it is a neighbor, (b) it is a substantial presence in Latin America, and (c) it is an important country in the Third World. As Jews we are also interested because Mexico has a significant Jewish community to which we have close ties.
2. We would be interested in hearing the President's evaluation of the current political and economic situation in Mexico and the prospects for the future.
3. How does he evaluate the relationship between the United States and Mexico at this time? Is there a particular role that an organization like the American Jewish Committee can play in strengthening that relationship?
4. How does he evaluate the relationship between Mexico and Israel?
5. We are concerned about the politicization of international organizations and their specialized agencies which divert attention from their stated and widely-shared goals. We would welcome the President's comments on this subject.
6. One of the issues of great concern to Jews and to others who are interested in human rights is the situation of Jews in the USSR. We would like to ask the Mexican President to consider possible intervention through appropriate bilateral and multilateral channels to address this issue.

WASHINGTON, May 17....President Miguel de la Madrid of Mexico has told a delegation of American Jewish Committee leaders that "Mexico has a permanent attitude of friendship and respect for the Jewish people" and considers itself "a friend and defender of Israel."

Mr. de la Madrid, who is visiting the United States on a state visit, met with the AJC delegation shortly after his recent discussions with President Reagan. It was his only meeting with a Jewish group during his visit to the United States.

In response to a statement of welcome from Theodore Ellenoff of New York, chairman of AJC's Board of Governors, President de la Madrid said, "Mexico is consistent in its historical philosophy toward the Mexican Jewish community. We in Mexico appreciate all the diverse groups that compose our society."

Reaffirming his statement of last October in which he repudiated anti-Semitism in Mexico, Mr. de la Madrid said: "We are friends of the Jewish community in Mexico, and we deeply appreciate the culture from which they stem. Jews in Mexico are fully Mexican and are equal in every way in Mexican society."

In discussing the Middle East, the Mexican president declared: "Since the inception of Israel as a state, we have been a defender of Israel . . . While Mexico does not always agree with Israel's policies, we speak openly of our differences." He added: "We think frankly that it is essential to take up the question of the Palestinian people. Unless that problem of the Palestinians is resolved, conflict will be perpetuated with all the dire consequences that we know."

The AJC delegation, while acknowledging the importance of resolving the status of the Palestinians, said the critical issue on which peace in the Middle East depends is the refusal of Arab nations and the PLO to acknowledge the right of Israel to exist as a sovereign state.

President de la Madrid responded by noting that "The Mexican Government and people support the right of Israel to live as a sovereign state. Our approach to this problem is the same as with all international problems. We are consistently on the side of peaceful solutions."

"We believe in diplomatic solutions rather than in military solutions in the Middle East as we do in Central America and elsewhere. We defend the sovereignty of all nation-states as inviolable."

The AJC delegation questioned the Mexican president as to his government's views on the Soviet and Arab-led campaign in the United Nations, UNESCO, and other international agencies to "delegitimize" Israel and the Jewish people by their "incessant defamation of Zionism and world Jewry."

President de la Madrid discussed the issues that he had earlier examined with President Reagan, including: Mexican-U.S. relations; differing foreign policy approaches to Central America; Mexico's economic crisis; the need for increased commerce, trade and tourism between the U.S. and Mexico; and the issues raised by Mexican immigrants to the United States. "There are real problems between the United States and Mexico, but in general relations between our two countries are at a good level," he said.

Rabbi Marc H. Tanenbaum, director of AJC's International Affairs Department, asked the President if Mexico "would intervene vigorously on behalf of Andrei Sakharov and his wife, Yelena Bonner, who face imminent death unless Soviet authorities allow her to obtain immediate proper medical treatment." He added that "we are concerned about the fate of Anatoly Shcharansky, Ida Nudel, and other harassed and persecuted Jewish refuseniks who are being denied their human rights in violation of the Helsinki Accords and UN Covenants."

President de la Madrid said that these human-rights concerns were "very much on his mind," adding that he would "do everything possible to be of assistance to Sakharov, Shcharansky, Nudel and others."

The Mexican and AJC delegations agreed to remain in contact with each other during the coming months. Besides the Mexican president, the Mexican delegation included Jorge Espinoza de los Reyes, Mexican Ambassador to the United States; Jesus Silva Herzog, Minister of Finance; and Hector Hernandez, Minister of Commerce and industrial development.

The AJC delegation also consisted of Howard Greenberger, professor of law, New York University, and chairman of AJC's Task Force on Latin America; Alfred Moses of Washington, chairman of AJC's National Executive Council; Leon Silverman of New York; Gordon Zacks of Columbus, Ohio, retiring chairman of AJC's International Affairs Commission; Hyman Bookbinder, AJC's Washington Representative, David Harris, deputy director of AJC's International Affairs Department; and Sergio Nudelstejer, director of AJC's Mexican and Central American office.

NEW YORK, Dec. 19...The American Jewish Committee today cabled the Mexican Government a statement of its "outrage and concern" over "slanderous and defamatory statements against the Mexican Jewish community recently made before the Mexican House of Representatives by Deputy Miguel Angel Olea Enriquez."

During a December 1st discussion of reforms of the organic law of the Bank of Mexico, Deputy Enriquez, in calling for more severe sanctions against those who violate the exchange control, charged that "Mexican Jews are experts in these matters. Therefore, they can avoid...all payments of taxes; they inflate their assets; they get financial credit even after blowing up their assets and they speculate with their money." Mr. Enriquez is a representative of the official government party, Partido Revolucionario Institucional (PRI), and is a member of the finance committee of the Mexican House of Representatives.

In a telegram sent to the Mexican Ambassador to the United States, Jorge Espinosa De Nos Reyes, Gordon Zacks of Columbus, Ohio, chairman of the AJC International Relations Commission, and Rabbi Marc H. Tanenbaum, director of the AJC International Relations Department, declared that Deputy Enriquez's "baseless charges are nothing less than a scurrilous and libelous attack on the moral integrity and loyalty of Mexican Jewry and constitute a manifestation of group libel."

At the same time, Mr. Zacks and Rabbi Tanenbaum acknowledged in their telegram that "we are gratified that Minister of Interior Manuel Bartlett and Representative Enrique Soto Izquierdo, Secretary of the Great Commission of the House of Representatives, in the name of the Mexican Government and the Partido

Revolucionario Institucional (PRI), have categorically rejected these racist statements rightly characterized by them as 'characteristic of totalitarian and reactionary regimes' and violative of the principles of the Mexican constitution."

These forthright rejections of Deputy Enriquez's personal views were issued on December 7 and 8 following a series of meetings between Mexican Government officials, House of Representatives spokesmen headed by Humberto Lugo Gil, President of the Great Commission of the House of Representatives and four representatives of the Comite' Central Israelita de Mexico (the Mexican Jewish Central Committee). Sergio Nudelstejer, director of the Mexico and Central American office of the American Jewish Committee, was one of the four official Jewish spokesmen.

In behalf of the AJC, Mr. Zacks and Rabbi Tanenbaum in their telegram to the Mexican Ambassador requested that "you communicate our message of outrage and concern to President Miguel de la Madrid." They also requested an appointment shortly with the Mexican Ambassador "in order to discuss what steps might be taken to counter the negative effects of this episode and to assure that it will not happen again."

The official statement of the Mexican House of Representatives rejecting the views of Deputy Enriquez and issued by Great Commission's secretary, Deputy Izquierdo, declared, inter alia:

"In the name of the PRI majority of this Legislature, I must point out that such unfortunate expressions in no way reflect the thoughts of the Deputies of my party, and are the exclusive responsibility of whoever says them.

"Racism of any kind has always been rejected by the Mexican people, because it clashes absolutely with its principles, traditions, and ideals. This is characteristic of totalitarian and reactionary regimes.

"Equality before the law is an individual guarantee found in our Constitution; even the education being taught at the Mexican State and in the authorized institutions must, among other things, be according to the Constitution 'sustainer of the fraternity and equality ideals, which are the rights of all men, avoiding privileges among races, or sects, or groups or sexes or individuals.'

"Unlawful behavior of any kind that a person might incur is not characteristic of any group of Mexicans, nor can it be attributed in any sense to any ethnic group; neither to any particular group of immigrants.

"Before, during and after the Second World War, the people and the Revolutionary Government of Mexico gave refuge and hospitality to refugees of different origins, among them quite a number of Jews, whose children and grandchildren, without denying any special features of their original culture, are now Mexicans with full rights.

"The Mexicans of Jewish origins are Mexicans by the same token and with the same rights as the rest of our fellow citizens.

"All deserve our respect, and none of our laws or of our acts within the Government have, or try to have, nor should have, elements of prejudice of any kind against them, nor against other Mexicans, not even against foreigners of another origin.

"Mexico is an open country, open to all effort and help from all its children, even from all human beings, without any distinction of nationalities and always within the wide framework of our Constitution and our Laws."

Mr. Nudelstejer reported to the AJC national office in New York that a number of articles and editorials have appeared widely in the Mexican press, notably Novedades and Ultimas Noticias, all of which condemned the anti-Semitic statements of Deputy Enriquez and underscored the danger of these public statements against Mexican citizens of all races and religions.

In the leading Mexican daily, Excelsior, a columnist, Leon Garcia Soler, writing on December 4, stated that Deputy Enriquez "shamed fellow-members of the political party PRI and placed the Mexican Government in the unfair position of appearing as an anti-Semitic regime." He termed Deputy Enriquez's statements "a criminal irresponsibility" and called upon Mr. Humberto Lugo Gil, President of the PRI, to "repudiate the statements of Olea Enriquez" and to censure him.

On January 19, a delegation of AJC leaders will visit Mexico and will meet with government leaders and the Mexican Jewish community leadership.

NEW YORK, Dec. 27...The American Jewish Committee today cabled President Miguel de la Madrid of Mexico its expression of "warm greetings" for his statement last Wednesday confirming "the full and equal citizenship of Mexican Jewry and their constructive role in strengthening Mexico's economy and society."

The cable, sent by Gordon Zacks of Columbus, Ohio, chairman of the AJC's International Relations Commission, and Dr. Marc H. Tanenbaum, director of AJC's International Relations Department, declared that "we view your positive appreciation of the role of Mexican Jewry as a rejection of the offensive anti-Semitic statements made recently by Deputy Miguel Angel Olea Enriquez as not being representative of the convictions of the Mexican government and people."

On December 1, during a debate in the Mexican House of Representatives, Deputy Enriquez singled out Mexican Jews as "experts in speculation" and tax-evaders, suggesting that they are among "Mexican traitors, shameless people, and profiteers."

On Wednesday, December 21, President de la Madrid held a meeting with seven Jewish leaders, among them Sergio Nudelstejer, director of the AJC's Mexican and Central American office. According to a telephoned message from Mr. Nudelstejer to AJC's national offices in New York, the Mexican president "spoke warmly and with feeling of his admiration and appreciation of the constructive role of the Mexican Jewish community in helping Mexico cope with serious economic and social difficulties. He said that Mexican Jews are an important and valued part of Mexican society, and he thanked them for their productive contribution to its welfare. He then asked the Jewish delegation to convey his best regards to each member of the Jewish community of Mexico. President de la Madrid said that Mexican Jews are full and equal citizens of our country."

Members of the Jewish delegation represented Friends of Hebrew University, who invited him to address their international banquet in Mexico City in October 1984. President de la Madrid accepted the invitation, which was taken as a conscious sign of friendship for Mexican Jewry.

During the conversation, the Mexican President spoke warmly of Israel's great contribution in agriculture, water reclamation, and land reform, and expressed his hope of closer collaboration between Mexico and Israel in these and related areas.

Prior to that meeting, Mr. Nudelstejer reported, the Mexican government's chief of press informed the Jewish delegation that President de la Madrid was determined to stop the anti-Jewish recrimination of Deputy Enriquez, and he chose the occasion of this meeting to make clear "that he did not want this libelous attack to go any further."

In their cable to the Mexican president, Mr. Zacks and Dr. Tanenbaum also welcomed his "acknowledgment of the positive ties between Mexico and Israel in the area of economic development and technical assistance which can only benefit both countries."

On January 19, a delegation of AJC leaders will visit Mexico and will meet with government leaders and the Mexican Jewish leadership.

NEW YORK, Sept. 20 -- The American Jewish Committee today expressed its sadness and solidarity with the Mexican people following yesterday's earthquake.

Messages went out today to President Miguel de la Madrid and to Bernardo Weitzner, President of the Comite Central Israelita de Mexico, signed by Howard I. Friedman, AJC President; Leo Nevas, chairman of its International Relations Commission, and Rabbi Marc H. Tanenbaum, director of the International Relations Department.

Their message to President de la Madrid read:

"AMERICAN JEWISH COMMITTEE IS DEEPLY SADDENED BY TRAGIC LOSS OF LIVES OF MEXICAN CITIZENS RESULTING FROM EARTHQUAKE. WE EXPRESS TO YOU AND MEXICAN PEOPLE OUR SOLIDARITY AT THIS DIFFICULT HOUR. IF THERE IS ANY WAY WE CAN BE OF ASSISTANCE TO YOU, PLEASE CALL ON US. OUR HEART FELT PRAYERS FOR THE SPEEDY RECOVERY OF GREAT MEXICAN PEOPLE FROM THIS TRAGIC EVENT."

Their message to Mr. Weitzner read:

"AMERICAN JEWISH COMMITTEE DEEPLY SADDENED BY TRAGIC LOSS OF LIVES OF MEXICAN CITIZENS RESULTING FROM EARTHQUAKE. WE EXPRESS TO YOU, MEXICAN PEOPLE AND IN PARTICULAR TO MEXICAN JEWISH COMMUNITY OUR FRATERNAL SOLIDARITY AT THIS DIFFICULT HOUR. IF THERE IS ANY WAY WE CAN BE OF ASSISTANCE TO OUR MEXICAN BROTHERS AND SISTERS, PLEASE CALL ON US. OUR HEART FELT PRAYERS FOR THE SPEEDY RECOVERY OF MEXICAN PEOPLE AND JEWISH COMMUNITY FROM THIS TRAGIC EVENT. MAY THE NEW YEAR BRING MEXICAN JEWRY PEACE AND TRANQUILITY."



Mexico's President Rejects Anti-Semitic Statements

The American Jewish Committee today cabled President Miguel de Madrid of Mexico its expression of "warm greetings" for his statement last Wednesday confirming "the full and equal citizenship of Mexican Jewry and their constructive role in strengthening Mexico's economy and society."

RAPPROCHEMENT ENTRE COMMUNAUTES JUIVE ET MEXICAINE

Deux minorités qui s'ignoraient jusqu'ici

New York, 4 avril (Ben Gallob). Les communautés juive et mexicaine des Etats-Unis mènent le même combat pour l'égalité, mais doivent combler l'immense fossé «d'ignorance mutuelle» qui les sépare et qui constitue «l'obstacle majeur» à leur coopération.

Telle est la conclusion de la première conférence des leaders des deux communautés, qui s'est récemment tenue aux Etats-Unis.

Cette conférence, qui réunissait des responsables religieux et laïcs, était organisée par l'archevêque Patrick Flores, de San Antonio, et le rabbin Marc Tanenbaum, directeur des relations internationales de l'American Jewish Committee (AJC). Les communautés juive et mexicaine ont en assuré le financement.

Pour les participants, cette rencontre aura permis de dégager et de mieux comprendre les problèmes et les intérêts communs tout autant que les différences.

Pour le rabbin James Rudin, directeur des affaires inter-religieuses de l'AJC, le rapport démographique des deux communautés à l'ensemble de la population américaine doit être tenu pour responsable de l'ignorance dans laquelle elles se sont mutuellement tenues jusqu'ici. «Nous avons été victimes des schémas culturels dominants», a-t-il ajouté, et devons dorénavant marcher ensemble».

Les participants sont tombés d'accord sur le fossé culturel et social entre les deux communautés. Ainsi, près de la moitié des jeunes Mexicains des Etats-Unis ne dépassent pas le lycée, alors que 90% environ des juifs ont une formation universitaire. Or, a souligné M.Tanenbaum, «la première génération d'immigrants juifs aux Etats-Unis était dans une situation analogue à celle des Mexicains aujourd'hui».

M.Henri Cisneros, maire de San Antonio, a fait valoir que «l'électorat hispanique» constituait maintenant une force, notamment à l'heure de la campagne présidentielle, et a suggéré que juifs américains et Mexicains américains trouvent à cette occasion des formules d'alliance. Mais en réalité, a ajouté M.Cisneros, cette alliance doit être plus vaste et est «impérative sur les plans éducatif, financier, religieux de l'organisation sociale et du développement économique.»

Pour M.Cisneros, Israël pourrait être «d'une aide précieuse» pour le développement des pays d'Amérique centrale, en raison de son expérience avec les pays du Tiers-Monde et de son avance technologique, notamment dans l'irrigation. Les organisateurs ont décidé de créer un comité conjoint destiné à organiser des conférences ultérieures et à concevoir des projets de coopération.

subject: Follow-up on Verbal Onset against the Jewish Community in Mexico.

Following up on my memo of December the 6th, I want to tell you that the Delegation of the Comité Central Israelita de México (Mexican Jewish Central Committee) formed by four people, one of them being myself, had the chance to meet with the Minister of the Interior, Mr. Manuel Bartlett and with Under-Secretary, Mr. Jesús Dávila Narro. During this interview, which lasted approximately one hour, we stated very clearly that the Mexican-Jewish community feels offended, hurt, and worried with the declarations given out at the House of Representatives by deputy Miguel Angel Olea Enriquez. The Minister of the Interior said that he understands perfectly well the reasons for unrest and worry within the Jewish Community and at the same time he assured us that it had been an unfortunate phrase said by a single individual and that under no circumstances does it have the sympathy or support neither of the Mexican government nor of the PRI (Partido Revolucionario Institucional - Official Govenment Party). When the Jewish delegation mentioned to him that 5 days had already passed without any answer from the President of the Great Commission of the House of Representatives, with whom we were to deal about this same matter as well, he immediately placed a private call, returning afterwards to where we were and telling us that we had for the next day (wednesday the 7th) an appointment with Mr. Lugo Gil, President of the Great Commission of the House of Representatives.

On Wednesday the 7th, the same delegation met with the President of the Great Commission of the House of Representatives and discussed for an hour this serious issue. The Delegation was told that the PRI rejects completely and utterly the declaration of Olea Enriquez and in answer to our petition, accepted to make a public statement to clarify their position and their rejection of Olea Enriquez's anti-Jewish standing. This statement would be given out by the Press Office of the House of Representatives to the press, radio and TV media at a national level.

Yesterday, Thursday the 8th, the information media published the above mentioned statement.

On the same Wednesday 7th of December, a meeting was called of all the Jewish Institutions in Mexico, to make it known to them the steps taken by the official Delegation and the results obtained.

"During the course of the debate held during the plenary session at the House of Representatives on the first day of December of 1983, in relation to the reforms to Article 23 bis of the organic Law of the Bank of Mexico, Deputy Miguel Angel Olea Enriquez had an unfortunate way of expressing himself, referring to the Mexican Jews.

"In the name of the PRI majority of this Legislature, I must point out that such unfortunate expressions in no way reflect the thoughts of the Deputies of my party, and are the exclusive responsibility of whoever says them.

"Racism of any kind has always been rejected by the Mexican People, because it clashes absolutely with its principles, traditions and ideals. This is characteristic of totalitarian and reaccionary regimes.

"Equality before the Law is an individual guaranty found in our Constitution; even the education being taught at the Mexican State and in the authorized institutions must, among other things, be, according to the Constitution 'sustainer of the fraternity and equality ideals, which are rights of all men, avoiding privileges among races, or sects, or groups or sexes or individuals'.

"Unlawful behaviour of any kind, into which one might incur, is not characteristic of any group of mexicans, nor can it be attributed in no sense to an ethnic origin; neither to any particular group of foreigners.

"Before, during and after the Second World War, the people and the Revolutionary Government of Mexico gave refuge and hospitality to foreigners of different origins, among them quite a number of Jews, whose children and grandchildren, without denying some special features of their original culture, are now mexicans with full rights.

"The mexicans of Jewish origin are mexicans by the same token and with the same rights as the rest of our fellow citizens.

"All deserve our respect, and none of our laws or of our acts within the Government have, or try to have, nor should have, elements of prejudice of any kind against them, nor against other mexicans, not even agains foreigners of another origin.

"Mexico is an open country, open to all effort and help from all its children even from all human beings, without any distinction of nationalities and always withing the wide framework of our Constitution and our Laws

It was by these means, that, in a certain sense, we were able to subdue the prevailing unrest and worry within the Jewish Community. But, the basic question is still in mid-air: Is the attitude of this mexican House Representative a very personal point of view, or, in a certain way, does it carry the untold feelings of thousands or millions of Mexicans? This is the real and serious question that must be answered...

The meeting with Mexican President, Miguel De la Madrid is still pending and we do not know if the President will grant us this interview because the problem in itself has been taken care of with the official declarations to the press.

Some articles and editorial commentaries have appeared in the Mexican Press, all of them condemning this antisemitic standing of Olea Enriquez and advising of the danger of this kind of public statements against mexican citizens, regardless if they are Catholics, Moslems, Protestants or Jews.

I met with Mr. Mark Gregory Davison, Second Secretary at the Embassy of the United States of America, who is in charge of the Political Affairs Department and who had a special interest in knowing all details of this incident. I informed him about the development of this situation and asked him please to have his office in Washington transmit to you this information. Hope they did so.

Am enclosing articles of the daily newspapers NOVEDADES and ULTIMAS NOTICIAS as well as a copy of the Press Release given out by the Secretary of the Majority of the PRI at the House of Representatives and its English translation.

Would like you to know about a very unusual and serious act that took place last Friday, December 2nd, in the Mexican House of Representatives.

While a discussion was going on, on important new laws relating to the financial situation of the country, a representative of the PRI - (Partido Revolucionario Institucional, which is the official government party), - Mr. Miguel Olea Enriquez, while addressing the House and defending a proposal of law that would establish more severe sanctions against those who violate the exchange control, in one of the paragraphs of his public address, said the following:

" The Mexican Jews are experts in these matters. Therefore, they can avoid, here in the Federation, all payment of taxes; they blow up their assets, they get financial credit even after blowing up their assets and they speculate with the money".

This open and public declaration by a representative of the official political party and member of the finance committee of the House of Representatives, makes us think about several possibilities. First, that it might be an official standing of this political party (of the PRI) or, it could also be the personal opinion of this representative, Miguel Olea Enriquez.

Another thing that worries us is the fact that no other member of the House of Representatives or a member of any other party, be it from the right or left wings, made any attempt to deny or disagree with this statement.

Some newspapers, specially the Excelsior and Uno + Uno had an ample covering of this matter. More so the Excelsior daily, which gave it its most important headline on the front page.

This statement made by the representative of the PRI, of a clear-cut and dirty antisemitism, has highly worried all the Jewish community, specially the serious accusation against a single group, making this minority appear before the

[opinion as unloyal to the country at a moment of economical crisis in Mexico.

On Sunday, December the 4th, in the same Excelsior newspaper, a columnist by the name of Leon García Soler, by his own initiative and will, gave out a verbal onset against the declaration of the representative of the House, Mr. Olea Enriquez, where among other things, he points out that the statement made by Olea Enriquez "shamed the fellow-members of the political party PRI and placed the Mexican Government in the unfair position of posing as an antisemitic regime". Further on he added: "...a criminal irresponsibility. This member of the official party PRI, who in the past condemned fascism and fought against nazism, now makes a statement of the lowliest antisemitism by saying that 'The Mexican Jews are experts in dealing falsely with dollars'...". This journalist called upon Mr. Humberto Lugo Gil, President of the PRI (Revolutionary Institutional Party) to have him censor the above statement of Olea Enriquez.

The Comité Central Israelita de Mexico (CEntral Jewish Committee of Mexico) is working on some official intervention with the Ministry of the Interior; with the President of the PRI; with the President of the House of Representatives and they are even ready to go as far as a meeting with Mr. Miguel de la Madrid, President of Mexico.

The President of the Central Jewish Committee, has invited me to participate in a very small delegation which will meet with the above mentioned official personalities.

This same afternoon, I will meet with Mr. Mark Davidson, Political Officer of the American Embassy who called me in to hear my personal opinion as the Director of the AJC Mexican branch office, in relation to this serious matter.

Yesterday morning, I met with Mr. Moshe Arad, Israeli Ambassador in Mexico and we exchanged points of view concerning this issue. He also seemed very worried and he expects a strong reaction on the part of the Mexican Jewish Community.

Enclosed please find clippings of the daily Excelsior; of the Uno + Uno newspaper, and a part of the commentary of Mr. Leon Garcia Soler which also appeared in Excelsior newspaper.

Will keep you informed on further developments of this issue. Would appreciate it if you keep this information confidential, just for you and the AJC Leadership but not for publication, at the moment. Any comments or suggestions will be appreciated.

Dijo Olea Enríquez que "el control de cambios es necesario en las circunstancias actuales, y entre más duro, más conveniente sería. Estamos en un sistema dual, con un mercado libre y otro controlado", y mencionó luego que el gran beneficiado con las devaluciones ha sido el exportador, que antes vendía a 28 y ahora lo hace a 139, porque sigue pagando a sus empleados salarios que no tienen esa pro-

porción y sin embargo "está chillando porque le quitan 18 pesos por dólar controlado".

El diputado por Chihuahua prosiguió: "Otro de los problemas es el industrial que pide créditos o el que saca un permiso de importación de maquinaria o de insumos y se le da dólar controlado, y luego va al extranjero y deja parte de esos dólares allá. PRI: conviene un control de cambios duro

■ Aprobó la Cámara la reforma a la Ley Orgánica del BdM

La mayoría priista expuso ayer — en la tribuna de la Cámara de Diputados — que el control de cambios es necesario y que, en las actuales circunstancias, "entre más duro" será más conveniente.

El priista Miguel Olea Enríquez estableció lo anterior durante el debate que culminó con la aprobación de la reforma a la Ley Orgánica del Banco de México que fortalece el régimen de control de cambios e, incluso, tipifica las infracciones que se pueden cometer en caso de no respetarlo.

Larga fue esa discusión en que las diputaciones panista y pedemista se opusieron a la reforma ya que, desde su particular óptica, limita las libertades y constituye más que un control de cambios "un sistema de penalización y persecución". Frente a esa postura, las fracciones pesumista y pepinosocialista demandaron que el nuevo régimen cambiario sea más rígido y contenga la fuga de divisas.

En particular, el pepinosocialista Héctor Ramírez Cuellar indicó: "Esta iniciativa implica que en estos últimos doce meses ha habido un sensiblemente retroceso en lo que respecta a la aplicación del control de cambio, no como lo es en sí mismo sino como política económica". Y, en otra parte de su intervención, añadió: "Esta reforma indica cómo se han violado los decretos del Ejecutivo, especialmente por parte de los exportadores".

La defensa de ese sector, desde antes de esa intervención, la hizo el panista Felipe Gutiérrez Zorrilla, quien se quejó de la indefinición del artículo 23-bis de la Ley Orgánica del Banco de México y sostuvo que "se dictaban las normas de persecución en contra de los exportadores y de los importadores".

El panista sostuvo que había cierta inconstitucionalidad en el control de cambios, y abdicación de funciones por parte de los legisladores al dar un poder discrecional al Ejecutivo en la materia. Con él coincidió después el pedemista Raymundo León Ozuna, quien salió con la bandera de que el control cambiario inhibía el fomento del comercio exterior.

El pedemista se quejó amargamente del "dique" que implican las nuevas medidas cambiarias y pasó al tema recurrente de pedir que se investigue la fortuna de José López Portillo, que ahora, dijo derrocha en dólares por Europa.

Más de una respuesta recibió esa postura. El presidente de la Comisión Legislativa de Hacienda, Jorge Treviño, indicó que la reforma a la Ley Orgánica del Banco de México contenía dos puntos sustanciales: facultar al Ejecutivo para establecer un régimen de control de cambios, conforme a un marco dado en unas reglas que la propia reforma corriente y, además, establecer la tipificación de las infracciones a las reglas en materia cambiaria establecidas por el Ejecutivo.

Treviño explicó el fundamento constitucional de la reforma y precisó, aunque remendó posteriormente su dicho,

que las nuevas medidas cambiarias "no podrían tener otro destinatario más que a los importadores y exportadores". Luego, en razón de que el PPS sostuvo que la fuga de capitales continúa, Treviño informó que en 1982 esa fuga fue de 6 mil 500 millones de dólares y que, aunque para este año "tenemos cifras precisas", disminuyó sensiblemente ya que hay un superávit de dólares que, al mes de septiembre pasado, era de 3 mil 200 millones en la balanza de pagos.

Más de tres horas duró el debate, no obstante que la reforma incidía en un solo artículo de la Ley Orgánica. El PRI tuvo que mandar tres oradores a la tribuna —el propio Treviño, Miguel Olea Enríquez y Antonio Favila Meléndez. De ellos, también destacó Olea Enríquez, quien señaló que el exportador "es un gran beneficiario de la devaluación, sigue pagando a sus trabajadores con salarios que no tienen esa proporción y le entra más dinero".

"Los judíos mexicanos —dijo el priista— son expertos en esas cosas. De esa manera evaden impuestos aquí en la Federación, inflan sus activos, consiguen créditos después de que inflaron sus activos y además especulan con el dinero. Necesitamos forzosamente ponerle coto a esos malandrijos".

Asimismo, demandó investigar a las empresas mexicanas que funcionan en Panamá, Las Bahamas y otros países, porque mediante ellas, se trafica con divisas.

En su oportunidad, el pesumista Salvador Castañeda O'Connor indicó que la re-

forma a la Ley Orgánica del Banco de México implica que existe "una creciente violación de las normas" que integran el régimen cambiario del actual gobierno. Manifestó que las sanciones que ahora se incorporan revelan que sigue la fuga de dólares y recordó cómo su partido, desde un principio, propuso un sistema integral del control de cambios.

Lamentó también que se dejará en manos presidenciales la decisión de implantar o suprimir el control de cambios y pidió que ese sistema se incorpore a la propia Ley Orgánica del Banco de México. Precisó:

"Si no se persigue el contrabando de divisas y si no se le castiga no puede haber auténtico control de cambios".

En términos semejantes, Héctor Ramírez Cuellar, del PPS, inició denunciando que la presencia de Miguel Mancera Aguayo, director del Banco de México, "revela hasta dónde ha penetrado la derecha en el manejo de la política económica del gobierno".

Por esa vía, narró como el actual gobierno fue liberalizando el control de cambios hasta que la realidad le demostró la necesidad de hacerlo más rígido y lamentó, así, que no se controle el mercado libre que, de hecho, es negro. Reconoció el valor de la iniciativa, pero no dejó de apuntar lo anterior.

Igualmente, el pesumista Marino López Ramos pidió un control de cambios "permanente" ya que hay "que cortar las garras a exportadores de capitales, presionar nombres desnacionalizados".

Sergio has been trying to get in touch with Rabbi Hier who is the executive director of the Center and hopes to persuade him to cool it.
2. On another matter, Sergio wanted to know whether you have done anything relating to his concern that a number of people from the Miami Chapter had sort of invited themselves to FEDECO. Sergio would appreciate hearing from you on this matter.



It is with distress, particularly after your most gracious participation in our Chapter Board meeting on November 28, that I call your attention to the enclosed news release from our national headquarters. This episode in which Deputy Miguel Angel Olea Enriquez slandered the Jewish community of Mexico is disgraceful.

As you will note, our national leadership, including Dr. Marc Tanenbaum, the director of our International Affairs Department, has communicated with Ambassador Reyes and acknowledged that Deputy Enriquez's characterization has been categorically rejected by officials of the government.

I would be less than candid if I did not inform you of the serious level of concern and outrage among our Board of Directors, whom you have met. I would appreciate any information which you can share with me that reflects your government's view of this disgraceful incident and, naturally, your own assessment.

Invited by the Information Service Department of the U.S. Embassy in Mexico, I accepted to participate as a speaker on two evenings of study of the Jewish Community in Mexico.

This was an interfaith activity between the fellow-members of the Union Church in Mexico together with the Beth Israel Community Center (Conservative) and the American Jewish Committee.

Quite a number of members of the Union Church, members of the U.S. Embassy and people of other faiths have shown special interest in knowing and learning about the different aspects of the Jewish Community in Mexico.

For this purpose, two activities were organized at the Beth Israel Community Center. The first one consisted of a lecture that I gave on the subject: "The Jewish Community in Mexico: Its Origins and Present Structure within the Mexican Society". This lecture of mine took place last Thursday, December the 8th. The second one will be held on December 13th. It will be a tour to four Synagogues starting out with the Beth Israel Community Center, where I will join Rabbi Samuel S. Lerer in leading this tour and explaining the origins and structure of each of the communities we will be visiting.

From Beth Israel Community Center, the group will go to the Beth-El Synagogue (conservative), of the younger Jewish generation. Then to the Maguen David Synagogue (orthodox) which belongs to the Jewish community of Damascus and we will end up visiting the Nidjei Israel Synagogue (orthodox) which belongs to the Ashkenazi Kehilah.

I believe that this activity will serve the purpose of knowing better the Mexican Jewish Community and at the same time to establish better relations with members of other religions and faiths, and in this particular case with members of the Union Church.
