the New Zionism"*

Mrs. Matzkin, a former vice-president of Hadassah, now serves on its National Board. Zionism has made marked changes in its policy in recent years. Mrs. Matzkin will tell us how it affects us.

Rabbi Marc H. Tanenbaum

*"Jewish-Christian Relations in
the Post-Vatican II Era"*

The Ecumenical Council now is history but the effect of its "Encyclical on the Jews" is still to be seen. What can we expect from it? Rabbi Tanenbaum, who observed during its formulation in Rome, is the one who can tell us.

Rabbi Marc H. Tanenbaum is National Director of the Inter-religious Affairs Department of the American Jewish Committee. He has served as a vice-chairman of the White House Conference on Aging, the Religious Advisory Committee of the President's Committee on Equal Employment Opportunity, Consultant to the Children's Bureau, White House Conference of Religious Leaders on Race.

An authority on Christian-Jewish relations, he is the Jewish Consultant to the Pius XII Religious Education Resource Center and The Sister Formation Conference. He has worked closely with Cardinal Bea's Secretariat and the American Catholic hierarchy to advance Catholic-Jewish understanding and has been active in a similar program with the World and National Council of Churches Committees on the Church and the Jewish People.

Dr. Gerson D. Cohen

*"Assimilation in an Historic
Perspective"*

How unique is the position of the Jew today faced by the forces of conformity? Whether he will survive as a Jew is a matter of conjecture. Historically, the situation is not unparalleled as this eminent scholar will point out in another of the dramatic presentations that have made Dr. Cohen's appearances the highlights of our lecture series in past years.



Dr. Gerson D. Cohen formerly was Assistant Professor of Jewish Literature and Institutions at the Rabbinical School of the Jewish Theological Seminary of America. From 1950-1960 he was Gustav Gottheil Lecturer in Semitic Languages at Columbia University where he is now an Associate Professor of History.

Doctor Cohen was ordained by the Seminary in 1948, receiving with distinction the degree of Master of Hebrew Literature. He was graduated Magna Cum Laude with special honors in the social sciences from the City College of New York in 1944, and was elected to Phi Beta Kappa. In 1958 Dr. Cohen received a Ph.D. from Columbia.

Rabbi Sam Silver

"Life Among the Others"

Rabbi . . . chaplain . . . editor . . . columnist . . . sum up Rabbi Silver's titles, but hardly his widely ranging activities and accomplishments. A native of Delaware, he was ordained at Hebrew Union College in 1940. He was director of the Hillel Foundation at the University of Maryland and, from 1942-46, U. S. Army chaplain serving in Hawaii and the Philippines. Upon his return he was Assistant Rabbi in Cleveland for five years, then Director of Public Information for the UAHC and editor of "American Judaism" from 1952 through 1959.



Since 1959 Rabbi Silver has served in a triple capacity; primarily as spiritual leader of Temple Sinai, Stamford, Connecticut, but also as columnist of the "Digest of the Yiddish Press" in the National Jewish Post and President of the Association of Jewish Chaplains of the Armed Forces.

Rabbi Freehof recently retired as Rabbi of Rodef Shalom Temple in Pittsburgh, which he served for thirty-two years. He is Chairman of the Central Conference of American Rabbis, Committee on Responsa, and Past President of the World Union for Progressive Judaism. He is a renowned lecturer, writer and Radio-T.V. personality.

Father Sloyan is Head of the Department of Religious Education at Catholic University of America in Washington. 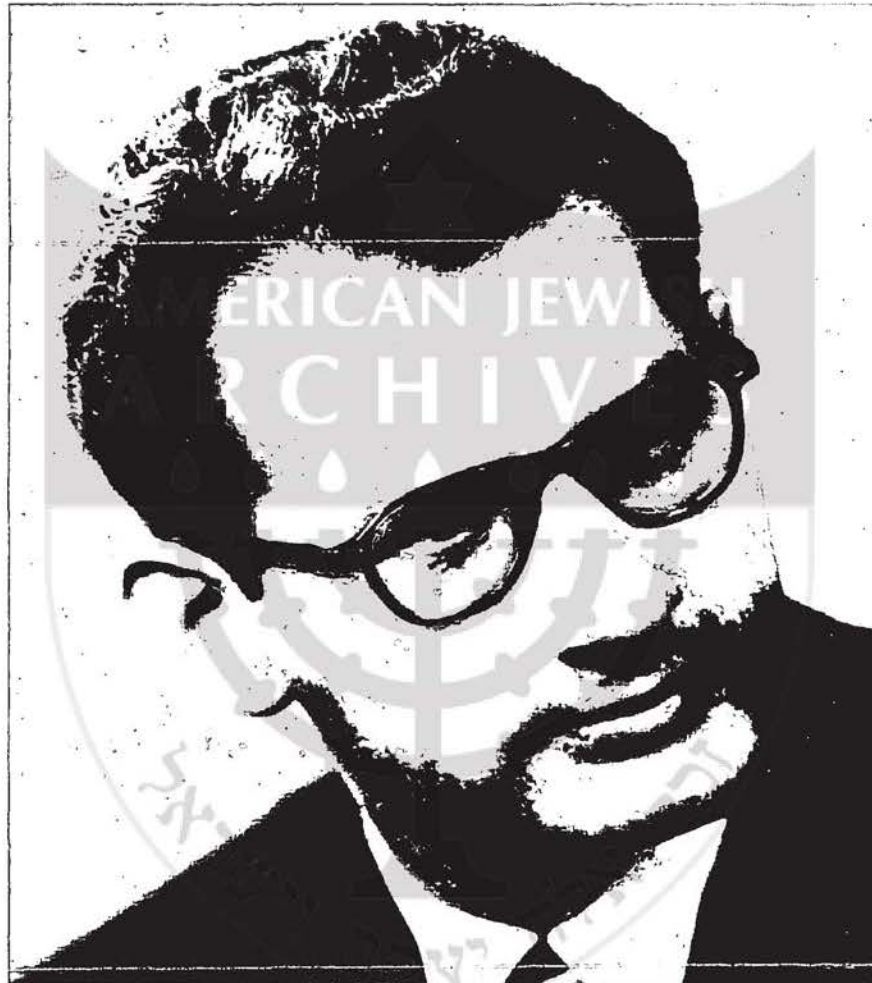

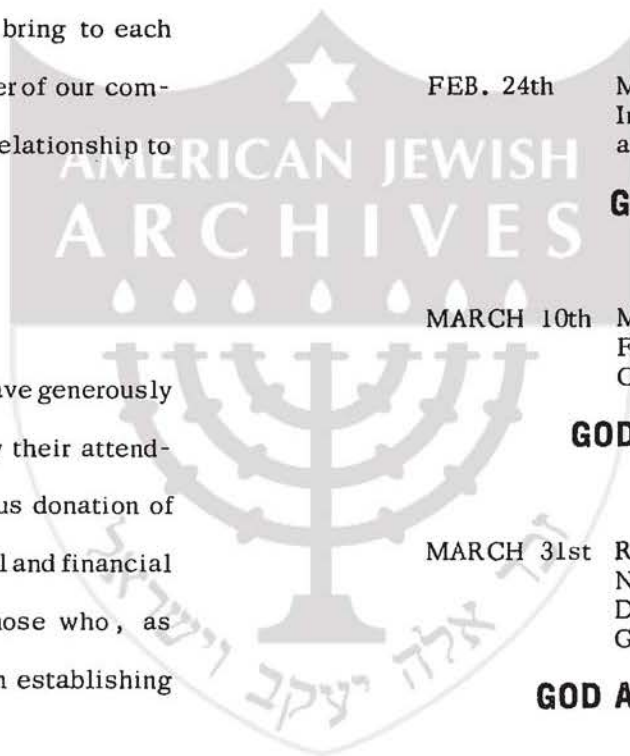

Ecumenical Institute Leaders

DR. JOSEPH SITTLER



Dr. Joseph Sittler of the Divinity School at the University of Chicago is a former president of the American Theological Society and a leading writer on Christian ethics and contemporary thought. He has been a delegate to various ecumenical conferences and World Council of Churches meetings and attended Vatican Council II. A consultant to the Luther World Federation of 1957, Dr. Sittler has filled distinguished lectureships at Harvard, Yale, Duke, and other universities. The latest of his several books is "The Care of the Earth," published in 1964. Dr. Sittler did his undergraduate and graduate work at several universities in this country and at the University of Heidelberg.

FATHER DANIEL J. O'HANLON

Father O'Hanlon, professor of theology at Alma College, Los Gatos, Calif., has been described by fellow Catholic leaders as perhaps the ecumenical movement's best spokesman in this country. He did his undergraduate, doctorate and post-graduate work at a number of leading universities in the United States and Europe. Father O'Hanlon attended Vatican Council sessions as a correspondent for "America," a weekly U.S. Jesuit journal of opinion, a theological consultant, and interpreter. He was co-editor of "Christianity Divided," a symposium of essays by leading Protestant and Catholic theologians.



RABBI MARC H. TANENBAUM

Rabbi Tanenbaum is an authority on Judaism and Jewish-Christian relations and is much in demand as a lecturer before Christian and Jewish groups. At Vatican Council II, he was the only rabbi in Rome at the time of the Catholic Church's vote on the "Jewish declaration." He has worked closely with the Vatican Secretariat, the American Catholic hierarchy, and with Protestant councils on ecumenical and interreligious relations. A member of various vital UN and UNESCO affiliated committees and of White House conferences, Rabbi Tanenbaum is a pioneer in race relations, having been a founder and program chairman of the historic National Conference on Race and Religion.

MEET OUR LECTURERS



PROF. ISRAEL KNOX was educated at the College of the City of New York and at Columbia University where he received his Ph.D. He is the author of "The Aesthetic Theories of Kant, Hegel and Schopenhauer" and "Rabbi in America: The Story of Isaac Mayer Wise." Dr. Knox has lectured widely on aspects of Jewish culture (especially literature) and on philosophical topics before YMHA's, Jewish Centers, temples, labor groups, women's organizations, etc. He has contributed essays and reviews to "The Menorah Journal", "The Reconstructionist", "Commentary", "Jewish Social Studies", and "The Journal of Philosophy." He was assistant professor of philosophy at Ohio University and is now associate professor of philosophy at New York University.



DR. ALBERT I. GORDON is the Rabbi of Temple Emanuel, Newton Centre, Mass. He was formerly Executive Director of the United Synagogue of America, the national organization of Conservative Synagogues. He is a lecturer in Judaism at Andover Newton Theological School.

Dr. Gordon is a native of Cleveland, Ohio. He received his B.A. from New York University and his M.A. and Ph.D. from the University of Minnesota and was ordained at the Jewish Theological Seminary of America in 1929. He received the degree of Doctor of Divinity, honoris causa, from the Seminary in 1964. In 1930, he accepted the call of Adath Jeshurun Synagogue, Minneapolis, and occupied that pulpit for sixteen years.

Dr. Gordon is the author of three noted sociological studies, "Jews in Transition"; "Jews in Suburbia" (1959) and "Inter-marriage: Interfaith, Interethnic and Interracial" (1964).

MENASHE UNGER, the son of a famous Chassidic Rabbi who still has followers in many parts of the world, is the scion of a Chassidic rabbinic "dynasty" going back to the Rabbi Elimelech of Lizansk at the turn of the nineteenth century. Menashe Unger is the author of many books on the history, the philosophy and the social significance of the Chassidic movement.



After receiving Semicha as a rabbi, he studied in Vienna and later at the Hebrew University in Jerusalem.

His articles have appeared widely in Yiddish and Hebrew publications in Europe, Israel, Latin America and in English in the United States. He is especially noted for his ability to present the complicated and varied aspects of Chassidism in modern terms.

Since his arrival in the United States in 1934, he has been a member of the editorial staff of the Jewish Day, and subsequently the Jewish Day-Morning Journal, where his daily column from the Ancient Spring about Jewish folklore, customs and their origins appears.



MAX I. DIMONT is the author of the best seller "Jews, God and History" of which more than one half million copies are now in circulation. Born in Helsinki, Finland, he came to the United States in 1930. During World War II, he served in the Intelligence Section of the XVIII Airborne Corps of the American Army in France, Belgium, and Germany. Mr. Dimont has lectured from coast to coast. At the same time, he is engaged in business in St. Louis and is currently writing a book on Jewish history for juveniles entitled "The Wonderful Adventures and Fortunes of the Jewish People."

DR. ABRAHAM J. FELDMAN was ordained at the Hebrew Union College. He holds the following degrees: D.D. (Hebrew Union College); S.T.D. (Trinity College); LL.D. (Hillier College); D. Hum. (Hartt College of Music). Past President of Hartford Rotary, the Synagogue Council of America, the Central Conference of American Rabbis, A member of the Board of Trustees of the Hartt College of Music, and a founder and member of the Board of Regents of the University of Hartford. He teaches a credit course on The Old Testament at the Hartford Theological Seminary. Visiting Professor at Hebrew Union College-Jewish Institute of Religion. Was the first "Distinguished Alumni Professor" at the Hebrew Union College-Jewish Institute of Religion, in Cincinnati, and is a member of the Board of Overseers of his Alma Mater.

A much sought-after lecturer and the author of many books, his latest being "The American Reform Rabbi — A Profile of A Profession" which is receiving favorable reviews in all parts of the country and overseas.



CHARLES ANGOFF has had a many-sided career as creative writer, lecturer, editor and teacher. For many years, he was associated with the old American Mercury when H. L. Mencken was its editor. Mr. Angoff is a graduate of Harvard College and a faculty member of the B'nai B'rith Institutes and is adjunct Professor of English at New York University, and Professor of English at Fairleigh Dickinson University in New Jersey.

Author and editor of more than 30 books, Mr. Angoff has had two plays produced in "little" theatres and has contributed poems, stories, essays, one act plays and reviews to more than 100 magazines and newspapers here and abroad.

DR. BERNARD MARTIN has just assumed the Abba Hillel Silver Chair of Jewish Studies in the Department of Religion at Western Reserve University in Cleveland. Educated in the public schools in Youngstown, Ohio, he holds a B.A. Degree with Honors from the University of Chicago, his Rabbinic Degree from the Hebrew Union College in Cincinnati and its Degree of Master of Hebrew Letters with Honors. He is also an M.A. and Ph.D. from the University of Illinois. For two years, he served as Chaplain of the United States Army in Japan and has served congregations in Champaign, Ill., Chicago, and more recently, in St. Paul, Minn. Rabbi Martin is the author of a book entitled "The Existential Theology of Paul Tillich" and is the author of many articles which appeared in scholarly journals. He has lectured at many Universities and is chairman of the Executive Committee of the Special Interest Group on Theology of the Central Conference of American Rabbis.



DR. ARNULF M. PINS is currently Associate Director of the Council on Social Work Education and Teacher-in-charge of the New Jersey extension of the Hebrew Union College—Jewish Institute of Religion, School of Education. Formerly, he served as director of the Personnel and Training Services of the National Jewish Welfare Board, a Program Director of the Jewish Community Centers of Chicago and a field work instructor for the University of Illinois School of Social Work.



A founder and twice chairman of the National Jewish Youth Conference, Dr. Pins was for six years president of the UNESCO Institute on Youth in Germany. In 1950, Dr. Pins served as chairman of the Youth Advisory Council of the Mid-Century White House Conference on Children and Youth.

He is the author of "Who Chooses Social Work, When and Why?"; "Israel and the UN" and several Picture Prayerbooks of Jewish Holidays for young children. He has been a frequent contributor to many journals.

A Phi Beta Kappa graduate of Columbia College, Dr. Pins holds a Master of Social Work degree from the Columbia University School of Social Work and a doctorate from Columbia University's Teachers College. Born in Germany, he received his early Hebrew education in Israel. He came to the United States in 1939. A staff sergeant in the U.S. Army during World War II, Dr. Pins was acting Jewish Chaplain for Northern Luzon in the Philippines.

RABBI MARC H. TANENBAUM is National Director of the Inter-religious Affairs Department of the American Jewish Committee. He was the only Rabbi in Vatican City at the time of the introduction of the Jewish decree at the Ecumenical Council, where he was consulted by numerous Cardinals, Bishops, and Protestant observers. Rabbi Tanenbaum has held a number of significant government, civic, and religious positions of national prominence. He has served as a vice-chairman of the White House Conference on Children and Youth, the White House Conference on Aging, the Religious Advisory Committee of the President's Committee on Equal Employment Opportunity, Consultant to the Children's Bureau, White House Conference of Religious Leaders on Race. He was the Executive Director of the Synagogue Council of America during the Presidency of our own Dr. Feldman.



Regarded as an authority on Christian-Jewish relations, he is the Jewish Consultant to the Pius XII Religious Education Resource Center and The Sister Formation Conference. He has worked closely with Cardinal Bea's Secretariat and the American Catholic hierarchy to advance Catholic-Jewish understanding.

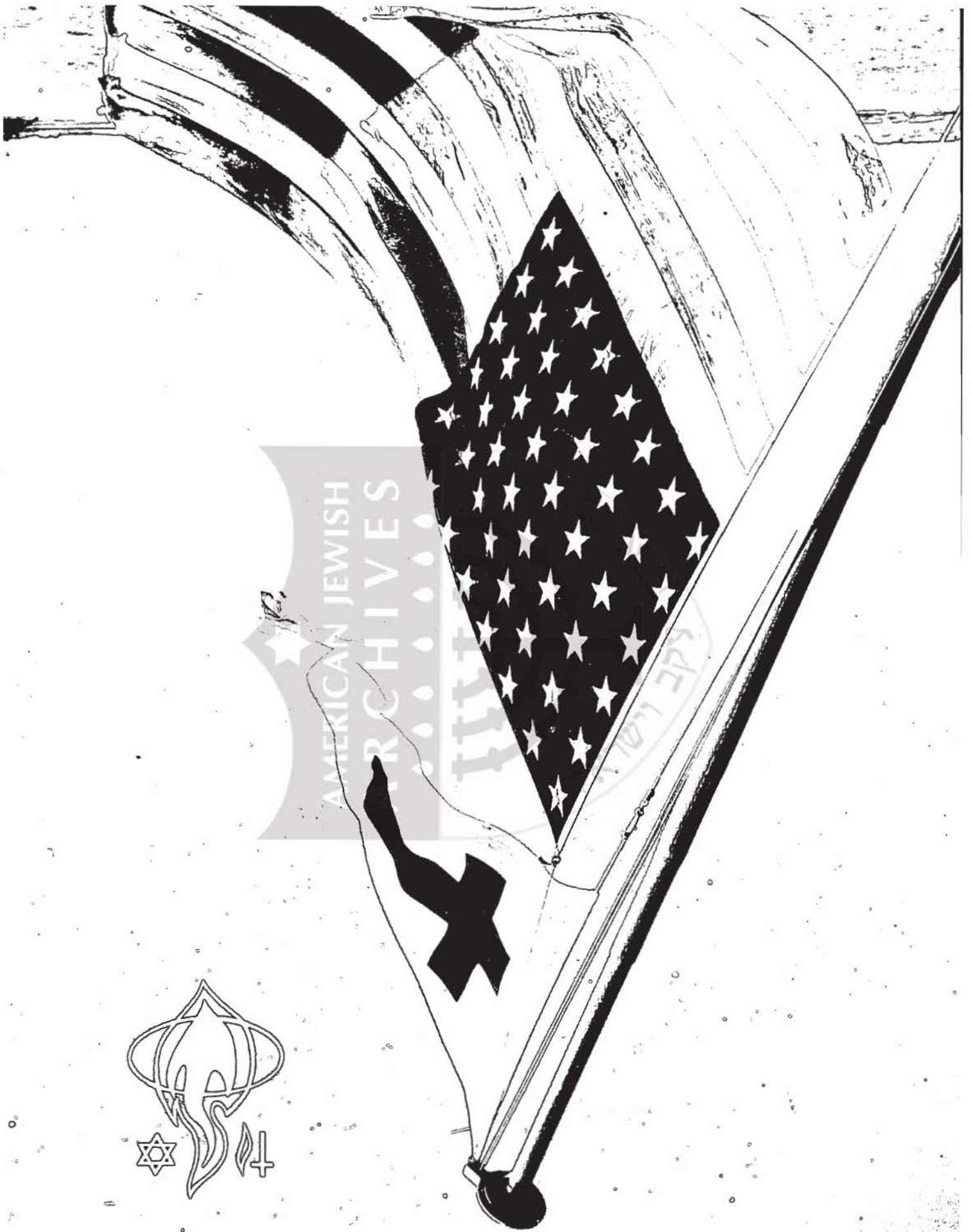

Message from The Secretary of the Navy



MESSAGE FROM THE CHIEF OF CHAPLAINS

The times in which we live deplete our personal and professional resources. Even when events do not threaten, life is ever increasingly complex. Varied and pressing demands arise from all sides. Give help, provide services, supply program, furnish resources, contribute advice, prepare guidelines, exercise supervision, indicate direction.

We do not object to these demands on our time or our capacities. Willingly we pump into our ministry all our energy and personal resources. Among his writings are "Religion in Illness and Health", Harpers, 1962; "Pastoral Counselling: Its Theory and Practice", Harpers, 1951, and "Psychiatry and The Bible", Harpers, 1956.



REVEREND EUGENE C. KENNEDY, M.M.
Father Kennedy is a Member of the Maryknoll Missionary Society. Ordained at Maryknoll, New York, he studied at Catholic University of America where he obtained his M.A. and Ph.D. in philosophy, majoring in psychology. Presently teaching at the Maryknoll Seminary, Glen Ellyn, Illinois, Dr. Kennedy is also a visiting Professor of Pastoral Counselling at Mc Cormack Seminary in Chicago; Supervisor of priest counsellors in the Archdiocese of Chicago, and consultant to a number of Catholic dioceses and religious orders of men and women. He is Co-Author of "The Genius of the Pastorate: Personal Growth For the Candidate, Seminarian, and the Priest", Sheed and Ward, 1965. Among his recent contributions in the field are "Aggiornamento, Anxiety and the Seminary" and "Seminary Education In a Time of Change", Fides, 1965.

REVEREND FREDERICK R. McMANUS

Father McManus is both Professor of Canon Law at the Catholic University of America and the Director of the Secretariate for the Bishops' Commission on the Liturgical Apostolate. Ordained in Boston in 1947, Father McManus has been an assistant priest in the Cathedral of the Holy Cross, Archdiocesan Master of Ceremonies, Secretary of the Metropolitan Tribunal, and Professor of Canon Law and Moral Theology at St. John's Seminary, Boston, Massachusetts. He is the editor of *The Jurist*; Associate Editor of the *Yearbook of Liturgical Studies*; President of the Liturgical Conference; Consultant and Peritus in Liturgy at Vatican Council II, and Secretary of the Episcopal Committee on English in the liturgy. Among his writings are "The Ceremonies of the Eastern Vigil" "The Rites of Holy Week", "The Revival of the Liturgy", and "The Council and the Liturgy".



DR. H. BOONE PORTER

Dr. Porter is a priest of the Episcopal Church of the Diocese of Kentucky. After service as a staff sergeant in World War II, he completed his studies at Yale University where he was elected to Phi Beta Kappa. Prior to ordination, Dr. Porter attended Berkeley Divinity School in New Haven, Conn. Following ordination he was engaged in graduate theological study both here and in England where he received the Doctorate in Philosophy from Oxford University in 1954. Having been a Professor of Ecclesiastical History at Nashotah House, he was appointed to the new professorship of Liturgics at the General Theological Seminary in New York City. He is presently serving on the Standing Commission on the Liturgy and is a member of the Home Department of the Episcopal Church. His most recent book "The Day of Light" is a study of the biblical and liturgical meaning of Sunday.

A native of Philadelphia, the Bishop received his college, seminary and post-graduate training at Catholic University of America where he received his Doctorate in Canon Law. Prior to his appointment to Charleston, he was Auxiliary Bishop of Richmond where he served as Diocesan Moderator of the Council of Catholic Women; Secretary of the Board of Consultors, and Clerical Examiner for junior clergy. He founded the Catholic Physicians Guild of Richmond. Presently he is Secretary of the National Council of Bishops of the United States; Chairman of the Sub-committee for dialogue with the Presbyterian and Reformed Churches, and Member, Bishops' Committee for Revision of the Constitution of the U.S. Bishops' Conference.



DR. DONALD YOUNG
Dr. Young holds a B.D. degree from Garrett Theological Seminary, Master's degree from Northwestern, and a Doctor's degree in Education from the University of Pennsylvania. He is an ordained minister of the Methodist Church and served two years as Associated Minister in a Wisconsin church. He has been successively Counselor, Supervisor and Assistant Director in the Marriage Council of Philadelphia. He is also at present Assistant Professor in Family Study in Psychiatry, School of Medicine, University of Pennsylvania. From 1961 through 1964, Dr. Young was Director of Pastoral Training, Department of Education, Menninger Foundation, Topeka, Kansas. Among recent articles published in cooperation with colleagues are "Mental Health Teaching in Professional Education", "Family Crisis in Group Therapy" and "The Failure of Courtship".

TOPIC AREA: "THE ECUMENICAL MINISTRY"

RESOURCE PERSONS

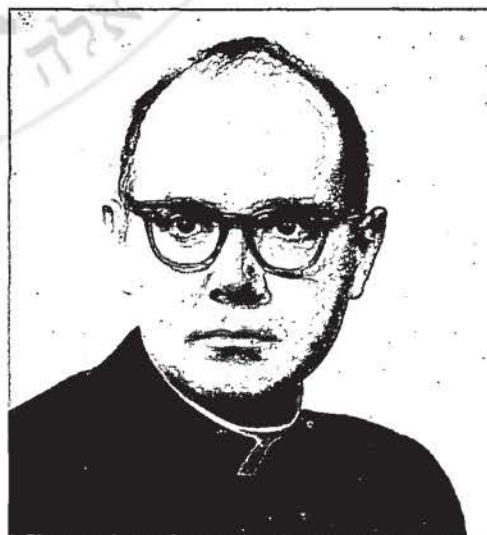
REVEREND WILLIAM A. NORGREN

Father Norgren, an Episcopal priest, is the Director of the Department of Faith and Order Studies of the National Council of Churches which parallels on a national scale the activity of the Faith and Order Commission of the World Council of Churches. Father Norgren devotes full time to the Ecumenical Movement. He was an advisor at the Third Assembly of the World Council of Churches at New Delhi, India, in 1961, and an observer at the Second Vatican Council. A native of Washington, D.C., he pursued his studies at William and Mary College, the General Theological Seminary in New York City, and Oxford University, England. There he majored in Patristics receiving his Bachelor of Letters in 1959. Since then he has occupied his present position.



VERY REVEREND WILLIAM W. BAUM

Since November 1964, Monsignor Baum has been the Executive Director of the U.S. Bishops' Commission for Ecumenical Affairs created to carry out the Decree on Ecumenism of Vatican Council II. He was a peritus at all sessions of the Council and was appointed a permanent consultant for the Consultation on Church Union with the Secretariate for the Promotion of Christian Unity. He is the only American Catholic representative on the Joint Working Group for relations with the World Council of Churches and the Lutheran World Federation. He was named in September 1964 to the Advisory Board for Project on Religious Freedom and Public Affairs of the National Conference of Christians and Jews. Monsignor Baum completed his pre-ordination studies at Kenrick Seminary in St. Louis, and received his Doctorate in Theology at Rome in 1958.

Dr. Miller, since 1963 the Horace Bushnell Professor of Christian Education at Yale Divinity School, is eminently recognized and regarded for his original work in Christian Education. Since 1958 he has been the Editor of the journal "Religious Education". Dr. Miller received his Ph.D. from Yale in 1936, a D.D. from Pacific School of Religion, 1952, an S.T.D. from Church Divinity School of the Pacific, 1952, and D.D. from Episcopal Theological School, 1961. From 1936 to 1952 Dr. Miller was successively Instructor, Associate Professor and Professor in Philosophy of Religion, Church Divinity School of Religion. Prior to filling his present chair he was Professor of Christian Education on Luther Weigle Fund, Yale Divinity School. He is a prodigious writer. Among his works are: "A Guide for Church School Teachers", "Education for Christian Living", "Biblical Theology and Christian Education", "Christian Nurture and the Church", "Your Child's Religion", and "Youth Considers Parents as People."

REVEREND EUGENE R. ZIMMERS, S.J.



Father Zimmers is a member of the Society of Jesus and a faculty member in the Department of Philosophy at the University of San Francisco. Since 1960 he has devoted all his time to directing the Institute of Lay Theology, University of San Francisco. The Institute provides a curriculum in religious education to prepare qualified laymen of the Catholic Church to engage full time in the teaching of religion. Under Father Zimmers direction, the Institute employs twelve professors of Protestant Theology from various Protestant seminaries as visiting professors. There are fifty-five graduates working in eighty-eight parishes and one military base in twenty Dioceses of the United States and Canada.

TOPIC AREA: "THE MINISTRY TO SOCIETY"

Discussion of the area of responsibility outside the religious institution where the impact comes through the application of vocation, citizenship, moral suasion, justice and love. Exposition of ways and means to bring the Church as a social institution up-to-date with the other institutions of society—home, school, government, economic life.

RESOURCE PERSONS

THE HONORABLE BROOKS HAYS

The Honorable Brooks Hays has spent his entire adult life in public service. During eight terms as Congressional Representative from the Fifth District of Arkansas, Mr. Hays was vitally concerned with social work, farm tenancy, and the extension of educational and economic opportunity for Negroes in the South. He was greatly influential in the adoption by Congress of the Bankhead-Jones Farm Tenancy Act. In 1961 President Kennedy appointed him Assistant Secretary of State for Congressional Relations and Special Assistant to the President. From his position as Arthur Vanderbilt Professor of Government at Rutgers University he continues to serve as Special Consultant to the President. Mr. Hays is a well-known Churchman. In 1959 he received the Churchman of the Year National Award and has served two terms as President of the Southern Baptist Convention. He is a member of the Board of Directors of the National Conference of Christians and Jews and serves on the Laymen's Committee on Religion in American Life.



DR. WILLIAM H. CONLEY

Dr. Conley is the President of Sacred Heart University, Bridgeport, Connecticut, the only Catholic institution of higher learning in the United States staffed entirely by laymen. In addition to a number of honorary degrees, Dr. Conley holds an M.A. from Loyola, Chicago and a Ph.D. from Northwestern. He has served as Chairman, Department of Education and Dean, University College, Loyola; Specialist in Higher Education HEW, Vice-President, Seton Hall University; Educational Assistant to the President, Marquette University; and Director, National Study of Catholic Education, University of Notre Dame, under financial sponsorship of the Carnegie Foundation.

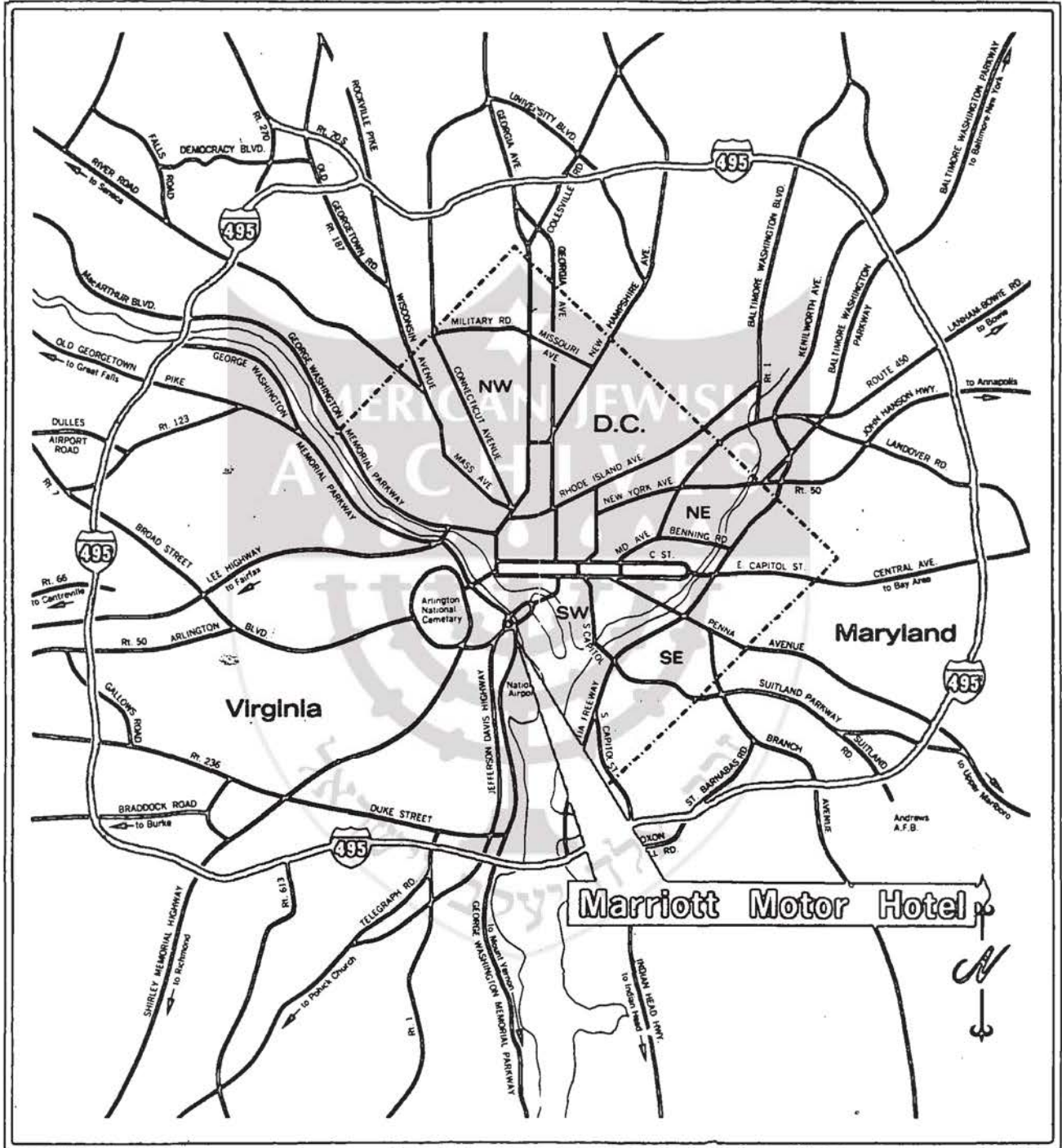

All men, especially Christians, must refrain from discrimination against, or harassment of, others, because of their race, color, creed, or walk of life.

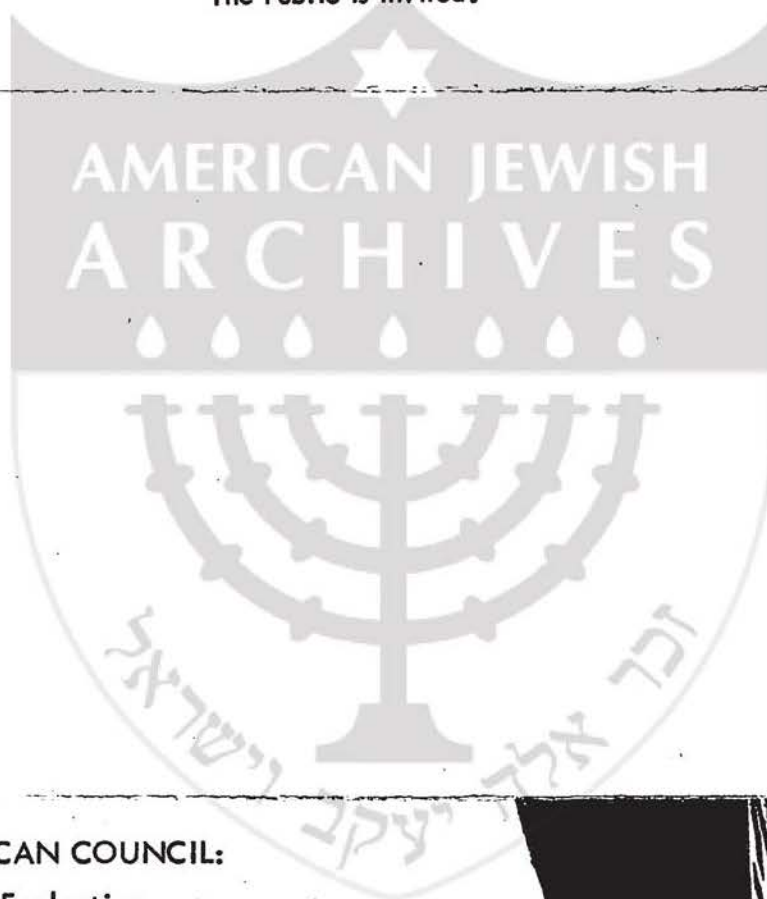

The Council will be either the fulfilment of a great hope or else a great disappointment. The fulfilment of a small hope would--given the grave world situation and the needs of Christendom -- be in fact a great disappointment. It is better not to nourish illusions. We have said that it would not be possible for this next Council, considering the vast and manifold difficulties in the way of reunion, to be a "Reunion Council." Our hopes cannot go as far as that. But the question is, Will this Council busy itself with mere proclamations, apologetics and matters of secondary importance (like, for example, the fruitless Fifth Council of the Lateran), which would be a great disappointment; or will it, by a bold and energetic renewal of the Catholic Church create the necessary conditions for reunion, which would be the fulfilment of a great hope.

ENCOUNTER: A Catholic - Jewish Confrontation

This symposium will bring together nationally recognized Jewish and Catholic spokesmen for a one-day program of lectures and open discussions. The purpose is simply to provide an opportunity for Jews and Catholics to explain themselves to each other—and to those of other faiths to whom this dialogue will be of interest.

Along with other, related phenomena—such as the holding of similar meetings elsewhere and the publication of articles, pamphlets and books on the same general theme—the symposium is an indication of the opening of a new phase in Jewish-Catholic relationships, marked by greater frankness, greater willingness to acknowledge past tensions and present problems.

But the symposium is not exclusively problem-centered; that is, it will not be concerned only with differences about interreligious and Church-State relationships. The speakers will try also to help both "sides" realize something of what they have been missing because of mutual ignorance. Life in a pluralistic society does involve the responsibility of resolving conflict; but pluralism also holds promise of adding a certain richness and interest and depth to the business of living.

COLUMBIA LECTURE SERIES THEME

In speaking to a French family movement John XXIII stated that the goal of each family should be to furnish a climate within the home which is conducive to enabling each member of the family to fulfill their respective responsibilities in the Church and in the world. To realistically strive toward this end, there must be a continuing effort on the part of all married people to keep abreast of the changing nature of the society in which they live, to understand and be sensitive toward the outlooks of others in that society whose view of life and man they may not share, and to recognize the strains imposed upon family life as a result of the efforts of family members (particularly the father) in fulfilling their respective responsibilities outside the home — all to the end that married couples will be competent to guide the direction of their own family life responsibility and to balance their various responsibilities within and outside the family.

The thrust of this seventh annual Columbia Lecture Series theme, entitled **THE IMPACT OF SOCIETY UPON THE FAMILY**, is directed toward a consideration of these and related matters.

American society was traditionally a predominantly Protestant culture. In recent years, because of changes taking place, religious sociologists began describing it as a "post-protestant" Judeo-Christian society having three basic forces molding its development — Protestant, Catholic and Jewish. Now scholars are stating that this description of American society is no longer accurate, that there has now emerged a large body of nonbelieving American people (often described loosely as "secular humanists") whose outlook toward life is determined without reference to God and without reference to a revealed theology in any traditional Judeo-Christian sense. One Catholic theologian has described this group as "The Fourth Conspiracy." American constitutional law is beginning to consider this non-believing secular humanist body as a "religion" whose adherents are entitled to religious liberty and the free exercise of their views — and whose adherents presumably are not entitled to any privileged or established position. The impact of this fourth group upon American family life is now increasing substantially as a result of recent Supreme Court decisions and other factors.

Lacking a general consensus among Americans regarding some common religious bond, America is now often described as a religiously pluralistic "secular society." In his recently published book, entitled "Religion and the American People," **Rev. John L. Thomas**, keynote speaker for this 1964-1965 Columbia Lecture Series, contends that one of the principal challenges facing all the major faiths is that of adopting and preserving a creative response to the "affluent secular society" which exists in the United States today.

Each of the speakers chosen for this series is uniquely qualified to contribute toward the development of this theme. Each of those introducing the speakers is a former Columbia Lecture Series speaker or a former Columbia Lecture Series Chairman.

Dr. George W. Forell

Dr. Forell, currently Professor of Protestant Theology at the State University of Iowa, was born in Germany and came to this country after completing college in the late 1930's. A JEWISH LEADER VIEWS FAMILY PROBLEMS

Rabbi Marc H. Tanenbaum

Currently National Director of the Inter-religious Affairs Department of the American Jewish Committee, and considered as one of the nation's leading Jewish leaders, Rabbi Tanenbaum was the only Rabbi in Vatican City when the Jewish decree was introduced at the Ecumenical Council and was consulted by numerous cardinals, bishops, and Protestant observers. Regarded as an authority and scholar on Christian-Jewish relations, he is the Jewish consultant to the Pius XII Religious Education Resource Center, was a founder of the National Conference on Religion and Race, and has participated in numerous White House Conferences. Rabbi Tanenbaum has appeared frequently on radio and TV, including the Today Show with Bishop Fulton Sheen in a TV series, and has been interviewed by Life and Look magazines. He has written for Catholic, Protestant, Jewish and general publications and has lectured before numerous seminaries, universities and other groups.
