Dear Marc:

I'm writing you and the rest of the Steering Committee of the Religious Alliance Against Pornography to fill you in on the process related to the full page ad N-CAP will be placing in U.S.A. Today.

In the conference call of the Executive Committee last Thursday, a number of suggestions were made and then assigned to Cardinal Bernardin and me for revision and submission to the entire R.A.A.P. Executive Committee for its final response.

My purpose in writing you at this time is to clarify the primary revisions so that you will be able to pinpoint them immediately when you receive the final copy. The word "lies" has been replaced each time it appeared in the ad by the word "distortions." In addition to that change, here are the other major ones:

- 1) The three boxes quoting Governor Martin, Bill Kelly and Jim Dobson have been removed.
- 2) The paragraph beginning "Individual members of the Meese Commission," two paragraphs above the Bill Kelly quote, has been removed.
- 3) Two sentences above has been revised to read as follows: "But even before the Meese Commission's final report was published, the pornography industry and its defenders launched a full scale attack against it".
- 4) The paragraph immediately above the Bill Kelly quote has been revised as follows: "Through a skillful public relations effort, the pornographers and their defenders have grossly misrepresented the Meese Commission's Report and have distorted the facts about pornography and the First Amendment."
- 5) The three headings in column 1 have been revised. Heading 1: "What Hardcore Pornographers Do" (remove question mark) Heading 2: "Hardcore Pornographers Are Distorting the Truth" Heading 3: "Distortions Hardcore Pornographers Want You to Believe - and the Facts You Need to Know"

We began 18 minutes late, with all present except Eileen Lindner. In order to guard your time for future conference calls, I will send you a separate sheet that indicates the exact time of the call in your time zone, and we will make every effort to begin the call on time so that you can count on that. We will limit the call to 30 minutes, unless you choose to extend it 10 minutes, but whatever business we're not able to finish in that length of time will not be included. I cherish you and your leadership and am committed to honoring this covenant.

1) Approval of Minutes of the Chicago Meeting: We acted to receive the Minutes as written with the assumption that if, after more careful study, anyone discovers an inaccuracy it will be raised at our next conference call.

2) Job description of Committees: Motion passed that the job descriptions of each committee be accepted.

3) Enlargement of the Executive Committee: Motion passed that we enlarge the Executive Committee to include greater balance and representation. Persons being added by action of the Committee are: Dr. Billy Melvin representing the National Association of Evangelicals, Dr. G. Raymond Carlson representing the Pentecostal movement, Archbishop Iakovos of the Greek Orthodox Church, and a representative of the Synagogue Council of America. It was also moved that another woman be added in consultation with Mrs. Eileen Lindner; that another black leader and an Hispanic leader be added in consultation with Matt Parker and others on the Executive Committee. Suggested were Bishop McKinney, Dr. William Jones, Rev. T. J. Jemison and Bishop James Hurst Adams, President of Black National Churches.

4) USA Today Ad: Motion passed requesting Joseph Bernardin and Jerry Kirk to work on a revision of the newspaper ad as per the extensive discussion today, and that the final draft be run by the Executive Committee before moving ahead with it.

5) Funding of RAAP: Motion passed to have N-CAP be legal custodian of funds to facilitate and enable the ongoing work of RAAP as guided by the Executive Committee, (i.e., to place funds into a special account under RAAP and to draw upon that account as needed and as directed by the Executive Committee.) Such monies are to be used for the cost of phone calls, correspondence, and other miscellaneous expenses.

6) D. C. Date: Jerry Kirk was requested to proceed with the White House through Carl Anderson in establishing a date as soon as possible. (I'm having difficulty getting through to the White House, but will continue to follow through.)

Additional Information: Thursday mornings were discussed as a good time for

our conference calls.

I will proceed with a follow up letter to all of our Steering Committee.

Future questions for your consideration: a) Should we have some stationery so that my correspondence for the Religious Alliance Against Pornography does not go out under N-CAP stationery? b) Should the stationery have the names of the Steering and Planning Committee on it? c) Should we enlarge the Inviting Committee, since there were some major denominations that were not involved in either the New York or Chicago meetings (i.e., presidents of Lutheran denominations, leader of the United Church of Christ and leaders of Black denominations, and a leader in the native American community, as per Matt Parker's suggestions)? d) Is there any other further guidance we want to give Bill Frey and the Program Committee relative to the Strategy Conference?

Plans are moving ahead powerfully for the ad.

I'm scheduling a conference call for Thursday, September 18th at 9:30 a.m. Eastern Daylight time. Please give the enclosed sheet to your secretary and reserve the time.




6) Under the heading, "Distortions Hardcore Pornographers Want You to Believe" - and the Facts You Need to Know", what was lie No. 2 has become distortion No. 1, what was lie No. 3 has become distortion No. 2 and what was lie No. 1 has become distortion No. 3.

7) The box that includes our names has a one sentence introduction about the Religious Alliance Against Pornography and our statement from Cardinal O'Connor's in New York City, rather than the abbreviated five statements formerly listed at the head of the box. (See enclosure.)

Twenty-four persons have already indicated their willingness to participate in the ad without these revisions. However, we have attempted to be sensitive to the concerns of each person and want to move ahead together insofar as possible. We hope these revisions will make it possible for you to participate with us. The printed full page ad as revised will be sent to you by Federal Express Thursday, and should arrive on Friday, September 12th.

CENTER BLOCK FOR AD

These religious leaders have come together to form the Religious Alliance Against Pornography (RAAP) and issued the following statement:

As religious leaders, we believe in the inherent dignity of each human being. Created in God's image and likeness, the human person is the clearest reflection of God's presence among us. Because human life is sacred, we all have a duty to develop the kind of societal environment that protects and fosters its development. This is why we address a broad range of life-threatening and life-diminishing issues. These assaults on human life and dignity are all distinct, each requiring its own moral analysis and solution. But they must be confronted as elements of a large picture.

The purpose of the RAAP is to bring into clear focus a major factor in the assault on human dignity and the consequent dehumanization that it promotes: hardcore and child pornography. This concern brought us together following the release of the Report of the Attorney General's Commission on Pornography. We are in unanimous agreement that hardcore and child pornography, which are not protected by the Constitution, are evils which must be eliminated.

As religious leaders, our primary responsibility is to teach and motivate. We can and must help people understand the moral dimensions of the problem of hardcore and child pornography and what their responsibility is in this regard, while fully respecting freedom of expression guaranteed by the First Amendment. In particular, we wish to make it clear that we do not and will not advocate "censorship". Our understanding of censorship implies actions being taken against materials which are protected by the First Amendment.

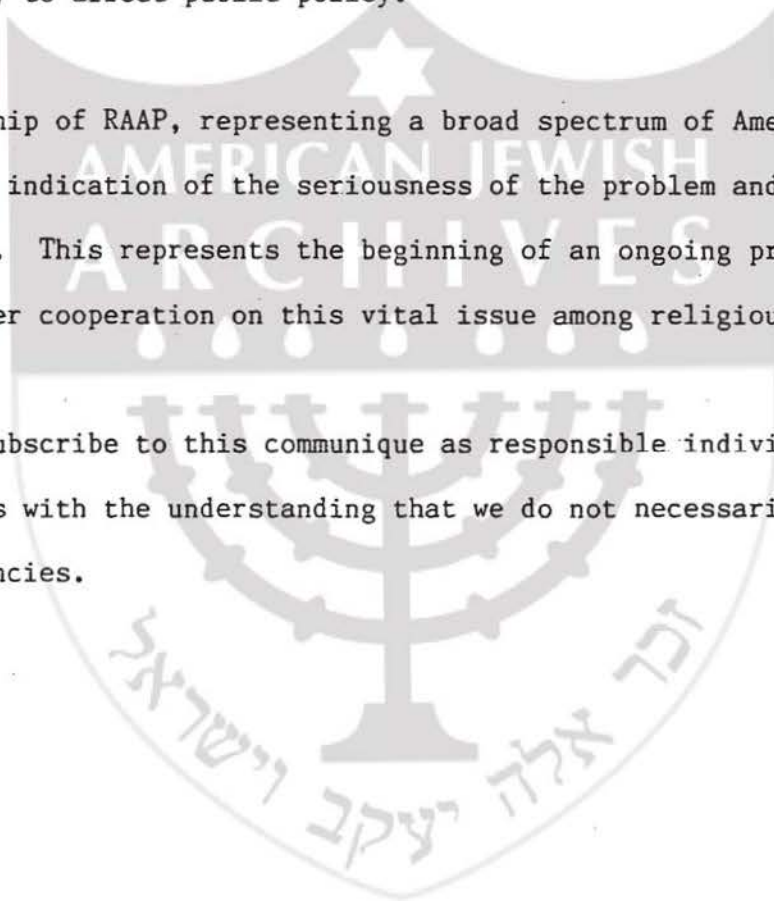

As teachers, we will do all in our power to proclaim the truth of human dignity and freedom, and to promote the God-given human values needed for the moral health of our society. Given the information and motivation, people will do what is necessary to affect public policy.

The membership of RAAP, representing a broad spectrum of America's religious community, is an indication of the seriousness of the problem and our commitment to addressing it. This represents the beginning of an ongoing process which will facilitate greater cooperation on this vital issue among religious bodies.

We hereby subscribe to this communique as responsible individuals and religious leaders with the understanding that we do not necessarily speak for our entire constituencies.

Dear Marc:

The enclosed Minutes from the Chicago meeting at Cardinal Bernardin's will bring you and each member of the Steering Committee (those who gathered in New York City at Cardinal O'Connor's) and the Planning Committee (those who gathered at Cardinal Bernardin's in Chicago) up to date on what was accomplished in Chicago. I want to express my own personal appreciation to you and to each person who is willing to serve on the Planning Committee. I believe that we have accomplished a great deal and that we are well on our way toward the conferences in Washington, D. C.

We are working diligently to establish dates for the Washington Conferences. We know how difficult it is for you to keep schedules flexible. Therefore, I am asking Cardinal O'Connor to call President Reagan personally to try to establish the date of our time with the President and the Attorney General. As soon as we have that date we will communicate to you immediately.

I am asking you to do three things as quickly as possible: 1) Please send me the names, titles, full addresses and phone numbers of persons whom you know personally and whom you believe ought to be invited to the White House Briefing (which is limited to 210) and to the Strategy Conference immediately following, in light of the guidelines which have been suggested. 2) Please notice in the Minutes the subjects that need to be dealt with and put into writing persons whom you believe could speak to those specific subjects. 3) Please indicate one or two ways that you believe you could help in preparing for and in leading those two conferences.

It will help me immensely if I can hear from you within one week. I am planning a conference call with the Executive Committee this coming Thursday, September 4. If you have special suggestions to come before that Executive Committee, please call Sarah Blanken or me at (513) 521-6227 by Wednesday afternoon or one of the other members of the Executive Committee, so that your thoughts can be brought before the entire Executive Committee.

In preparation for the conference call, I'm asking you as a member of the Executive Committee to please re-read items 8a on page 3 through item 13 on page 5 of the Chicago agenda (those pages enclosed), and be ready to make any specific suggestions that you want to make relative to those items. We will not discuss them in length, but we do want to receive any suggestions that you would have relative to any of those specific items. The conference call is scheduled for 9:30 a.m. Thursday, Eastern time.

You will receive under separate cover a copy of the proposed ad which the National Coalition Against Pornography is hoping to run in U. S. A. Today. As I wrote you earlier, we are hoping to include in that ad reference to our agreement at Cardinal O'Connor's home and five specific statements growing out of our communique, which we released to the Press as follows: 1) We celebrate the First Amendment and its protection of freedom of speech. 2) We are against censorship of legally protected speech. 3) We are for vigorous enforcement of the federal, state and local laws against illegal pornography that involves children. 4) We are for vigorous enforcement of the federal, state and local laws against illegal obscene materials that promote rape, degradation, and humiliation of women. 5) We invite all who love children, all who are concerned about violence toward women, all who care about the health of the family unit to join together against child pornography and illegal hard core pornography. I will be writing you and asking you to call our office if you do not want your name included in that ad and to check your title and spelling of your name for those of you who wish to be included. We believe it is essential that we get the word out to the entire nation about our concern and the unusual alliance that has come together.

God has given us an unusual bonding and friendship. I look forward to whatever it is He would accomplish through us.

Opening Preparation

Cardinal Bernardin opened the meeting by welcoming the attendees. He indicated that this Planning Meeting grew out of the New York meeting and was preparatory to a White House Briefing and a Strategy Conference.

Rev. Jerry Kirk read scripture, and Bishop Clyde Van Valin led us in prayer.

A motion passed that the proposed agenda distributed prior to the meeting become the working agenda.

Summary of Prior Actions

In Rabbi Tanenbaum's absence, Jerry Kirk summarized the actions of the New York meeting which was held July 25. He indicated there was unanimous agreement that our focus would be hard core pornography and child pornography. The New York group asked for a meeting in the White House for approximately 200-210 religious leaders for several purposes: learning about the report by the Attorney General's Commission on Pornography, learning the Attorney General's and President's responses, speaking about our concerns, and providing time for genuine interaction with the President and Attorney General. The White House gathering would then be followed by a Strategy Conference with a larger group meeting near the White House.

Importance of Strategy Conference

The question was then raised about which meeting we were keying our deliberations around — the White House meeting, or the Strategy Conference? Which would receive priority? There was extensive discussion on this issue, with general agreement that we must be flexible enough to make the White House meeting a possibility. A motion was passed that the primary emphasis would be on the Strategy Conference, but the meeting in the White House will be a corollary and important part of our work.

### We Move Ahead to Mobilize Denominations

The question was raised about who had ultimate responsibility for planning the meetings and setting dates, times, etc. After considerable discussion, there was general agreement that we should keep the initiative and not let someone else take charge of our efforts. The report by the Attorney General's Commission was a government report recommending action by government, and it should be their business to implement the recommendations in the report. Thus, our approach to the appropriate governmental officials is that: (1) we want to thank you for the work of the Administration against pornography and for the report by the Commission; (2) we support implementation of the primary recommendations by the Commission; and (3) we are eager to learn what you will do toward implementing those recommendations. Our philosophy should be that we are ready to lead and mobilize denominational leaders to focus on child pornography and hard core pornography that promotes the rape and degradation of women.

### Committee Responsibilities

The discussion then proceeded to the subject of establishing committees and sub-committees, with the first subject being a committee to plan for the Washington meetings. It was noted that many of the religious groups have offices in Washington that usually do the leg-work for larger meetings which occur there. We should use these resources.

A motion passed for Bishop Bill Frey to chair the Program Committee for the Strategy Conference.

### Executive Committee

A motion was passed to choose an Executive Committee from the Planning Committee to work on the White House Briefing plans and report back to the Planning Committee.

A motion was also passed authorizing the Executive Committee to determine policy matters after this meeting concluded. The Executive Committee will meet by conference call.

A motion was passed that Jerry Kirk serve on the Executive Committee. The question was raised as to whom the Executive Committee is responsible. It was assumed that the group which met in New York is the "Steering Committee." The Steering Committee authorized this meeting of the "Planning Committee." These two groups represent the moral authority for us all, and are the groups to which the Executive Committee reports and to whom they are responsible. A motion was passed that the Executive Committee was responsible to the Planning and Steering committees. It was suggested that the Steering Committee and Planning Committee should meet in Washington just prior to our White House Briefing in order to act upon any recommendations from the Executive Committee.

The membership of the Executive Committee was then discussed. A motion was passed that the following individuals will serve on the Executive Committee:

A motion was passed designating Jerry Kirk Chairman of the Executive Committee.

#### Relationship with National Coalition Against Pornography

There was general agreement that this group (which was named the Religious Alliance Against Pornography later in the day) should not be identified as an N-CAP group. It was noted clearly that the Alliance was working with N-CAP and N-CAP has been and is providing its staff resources, but the Alliance is broader than N-CAP. A motion was passed that the Alliance gratefully accepts and acknowledges N-CAP's staff resources. Clarification about financial matters needs to be developed more clearly in the future.

Lindner  
Motion

N-CAP staff expressed the commitment to be a servant in similar ways that others are called upon to serve. N-CAP is a participant in the team in the same way as any of the denominational and ecumenical groups can be participants. We are using N-CAP's staff to help facilitate the Alliance's work. The Executive Committee will use other people and resources as well, just as it is using the facilities of Cardinal Bernardin today.

There was general agreement with the foregoing ideas, and with the idea that N-CAP by necessity be the organization to receive funds to facilitate the Alliance's present activity. The Executive Committee is authorized to decide how these and other details are implemented.

After lunch, Jerry Kirk explained N-CAP's future work for our information in order to clarify the two hats he is wearing and in order not to produce questions and confusion in the future, including a direct mail campaign, an advertisement in the national news media, and a television special. N-CAP and the Alliance are going down parallel tracks -- months ago N-CAP had adopted a focus on hard core and child pornography, long before the report by the Attorney General's Commission was issued and long before the New York meeting on July 25. Therefore, the goals of N-CAP and this group are similar and N-CAP will also be pursuing its work which it has been planning for over six months, while being sensitive to the integrity of the two groups.

The meeting then broke down into committees, with the Program Committee for the Washington meeting and the Executive Committee holding separate meetings.

#### Program Committee Report

The Committee reported on the following:

"The purpose of our Strategy Conference in Washington, D. C. is to inform, mobilize and equip, through the religious communities in America, all conce

rned citizens in an effort to eliminate hard core and child pornography which depicts sexual involvement of children with other children and adults and depicts violence, rape and degradation of women. We make this statement with full commitment to the freedom of expression guaranteed by the First Amendment."

A motion was passed to adopt this statement.

We also want to give visibility to the Alliance and call together the higher echelons of denominational leaders, making sure the Conference has broad representation of all groups. The Conference is to be a consciousness-raising event, and at the same time mobilizing and equipping. Sociological, moral and First Amendment issues should be considered.

Suggested dates for the Conference: First Choice, October 23, 24; Second Choice, October 27, 28; and Third Choice, November 10, 11. Size of the Conference to be 300-400 persons, with opportunity for small group interaction. It should not be necessary to convince why, but instead to focus on how, with strategies for implementation to be a high priority. Jerry Kirk was appointed chairman of the event.

#### Executive Committee Report

The Executive Committee reported on its recommendation for a name, and the following title was adopted: Religious Alliance Against Pornography.

Purpose of the Alliance is contained in the attached Policy Statement.

The group expressed its gratitude to God for the gracious hospitality of Cardinal Bernardin, and requested that the Minutes reflect their appreciation.

A press briefing followed with these persons speaking for the Alliance: Jerry Kirk, Eileen Lindner, Mordecai Waxman, Adrian Rogers, Matt Parker, Bill Frey, Richard Lindsey and Cardinal Bernardin. Jerry Kirk moderated the press briefing.



POLICY STATEMENT OF THE RELIGIOUS  
ALLIANCE AGAINST PORNOGRAPHY

The Religious Alliance Against Pornography was formed by a broad group of religious leaders who represent approximately 150 million Americans. Each of these leaders respects the First Amendment to the United States Constitution and supports the protection it provides to legitimate speech as established by decisions of the U. S. Supreme Court.

All of the leaders have deep concerns about a number of issues facing American society. Coming from different backgrounds and philosophies, the leaders have a diversity of views on many of these issues. However, they are united on their view of child and hard core pornography are illegal and are evils which must be eliminated.

Thus, while acknowledging that they may have different views on some issues, they have agreed to take the extraordinary step of setting aside those differences and uniting as the Religious Alliance Against Pornography. The sole purpose of the Alliance is to mobilize America's religious community against child pornography which involves children sexually with adults and with each other, and pornography which promotes violence and the abuse, rape and degradation of women. Essentially, this is child and hard core pornography.

The ideological basis for their unity is contained in the attached communique which was issued in New York on July 25.

AGAINST PORNOGRAPHY

The Executive Committee is responsible for policy decisions not already established in preparation for the White House Briefing and Strategy Conference. It is also responsible for details related to the White House Briefing. Jerry Kirk, Chairman.

Dear Marc:

I am deeply thankful to you and praise God that you are willing to serve on our Planning Committee in preparation for the White House Briefing and the Strategy Conference immediately following. I believe that we are part of an unfolding miracle of God's grace and your participation with us makes it even more so.

I am enclosing a copy of my letter to Cardinal Bernardin summarizing our New York meeting and its decisions, a copy of our Communique, and a copy of our brain-storming suggestions by that Steering Committee to us. I believe that you will want to study these carefully so that you will better understand the roots from which we come to this meeting. This should make your participation with us most valuable.

I am also enclosing a suggested Agenda for guidance in our focus and use of time. Suggestions for changes and additions are welcome.

It has been suggested that I try to summarize the essence of our last meeting in writing. I believe that God has brought us together in a campaign of compassion out of concern for the well-being of children, young people, the safety of women, the sexualization of men, and the health of families. We have agreed to focus on child pornography which involves children sexually with adults and each other, and pornography which promotes violence and the abuse, rape, and degradation of women. This is essentially child pornography and hard core pornography.

Many of us, if not all, have deep concerns about all kinds of pornography, but we have purposely chosen to focus and unite the religious community around this focus in the context of our commitment to the First Amendment and its protection of legally protected speech.

We also believe, as the Gallup Poll proves, that the overwhelming majority of Americans agree with us. And we believe that if this is our focus, we can unite Americans of good will, decency and faith in this effort. It is no longer a conservative, moderate or liberal issue. It is for all people who care about children and family life.

And these concerns are very similar to the major recommendations of the Attorney General's Commission. While we have not agreed on all of the recommendations, we found an overwhelming consensus on the primary focus of the Commission's Report.

The White House Briefing is our attempt to bring the leaders of the denominations together with the President, the Attorney General and some of his commission to understand the Commission's Report, to share our deep concerns and request that the President and the Attorney General lead in the battle against illegal obscene material. Our Strategy Conference is to include additional leaders from the denominations who have primary responsibility for program and implementation in the areas of social concern, family life, and pornography. We, who gather together as a Planning Committee, have been empowered by the Steering Committee to act on their behalf in implementing these goals.

It would help if you can arrive shortly after 10:30 so that we can become better acquainted before our meeting officially begins. Please come prayed up and available for action. I believe we are going to have a special time together at Cardinal Bernardin's home and also in our meetings in Washington, D. C.

I find great joy in coming to know you and the others who will gather. There is a unique mix of gifts, backgrounds, and spiritual sensitivities of each.

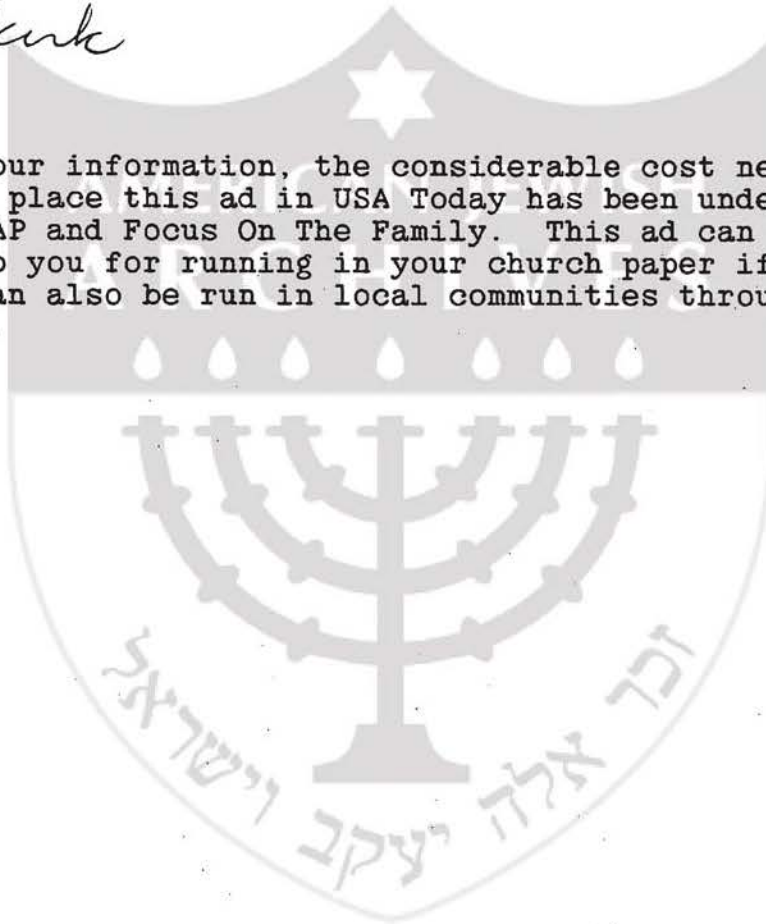

In anticipation of the meeting on July 25 to consider the report of the Attorney General's Commission on Pornography -- of which I was a member -- I enclose for your use a full copy of the central section of the Commission's report. It is that section which discusses carefully the rationale for, and the limitations of, governmental and private action against certain specifically defined categories of sexually explicit material. Drafted for the Commission by Professor Frederick Schauer of the University of Michigan, it represents, in my view, a balanced, thoughtful approach to an intensely difficult subject.

No commissioner agreed with every word of the report, and most of us filed separate "personal statements" describing our specific views fully. I enclose a copy of my own such statement, which explains my reasons for some of my more difficult votes, and which takes the Commission to task (in a kindly way) for avoiding moral and ethical issues fundamental to the controversy over pornography. Whether or not you are able to attend the meeting, I am deeply interested in hearing your own views on the Commission's report, my statement, or any other aspect of this all too familiar problem.

I eagerly hope to see you on the 25th, and hope as well that with God's help we can begin to chart an effective course for religious leaders in this area. Until then please accept my best personal regards.



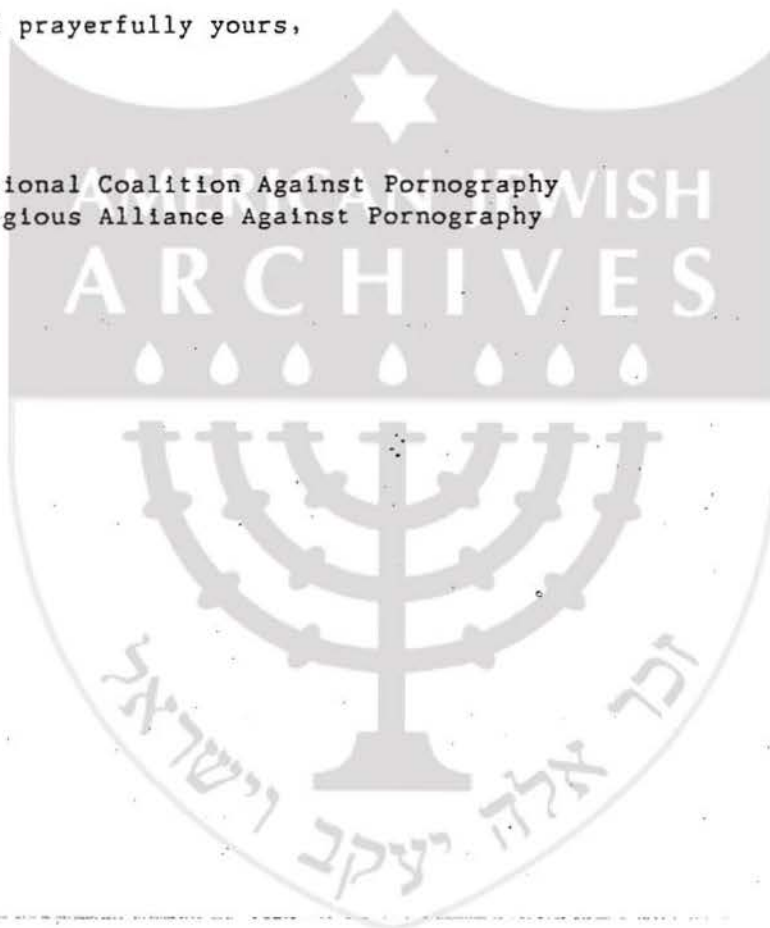

Dear brothers:

Please excuse the form letter. I wanted to get it in the mail quickly.

You will receive - or perhaps already have received - a letter from Cardinal Joseph Bernardin and the Reverend Jerry Kirk inviting you to a conference dealing with pornography and obscenity. I simply want to add a note of personal encouragement to accept. I really believe it be worth both the trouble and the expense.

Having Mother Theresa as our keynote speaker excites me. While obscenity might appear to be pretty far removed from her concern for the poor, I believe there is a connection. All of us are concerned about those things which distort the image of God in human beings - or, as the Baptismal liturgy puts it, those things "which corrupt and destroy the creatures of God." Poverty and disease are some of those things, and so is obscenity.

To be perfectly candid, I'd rather not be involved in a fight against pornography! I don't like to be labelled as a "bookburning extremist zealot" any more than you would. But people are being hurt because of it and I have become convinced that if we fail to face the issue, we are implying either that pornography and obscenity are all right, or that our theological framework is too weak to confront them.

I hope to see you in Washington.
