## Jews, Christians called to work together

Rabbi calls for reaffirmation of 'sacredness of life'

Jews and Christians have a moral responsibility to promote respect for humanity and to reaffirm the sacredness of life the two religions have always taught, a prominent rabbi said in Oklahoma City this week.

"It is absolutely essential that we begin together to promote an attitude of scorn and contempt for violence," said Rabbi Marc Tanenbaum, New York, national interreligious affairs director for the American Jewish Committee.

Rabbi Tanenbaum, an authority on Jewish-Christian relations and the only rabbi invited to the Second Vatican Council, was in Oklahoma City to deliver the third annual Sam J. Singer Memorial Lecture.

Sponsoring the lecture, held in Emanuel Synagogue, was the Oklahoma City unit of the AJC. Rabbi Tanenbaum also spoke at a breakfast for area religious leaders.

"I come to this subject with a genuine reluctance," Rabbi Tanenbaum said as he began his lecture on "Religious Values in an Age of Violence."

"Few people want to address themselves to such heavy and depressing issues. I come to this issue terror."

On the international scene, the nations of the world each year spend \$240 billion on non-nuclear weapons and support of military forces, Rabbi Tanenbaum said. In 39 countries are 445 nuclear installations established in the "Atoms for Peace" program.

These can be turned into forces of destruction, Rabbi Tanenbaum said, citing the case of India, "which is desperate for food," becoming a member of the nuclear club.

Recently, some Harvard professors said that "unless a miracle takes place, a nuclear war will break out in the 1990s," he said.

> While the 3 million Jews in the Soviet Union are being denied their religious rights, millions of Lithuanian Catholics, Ukrainian and Russian Orthodox Christians also are being oppressed, Rabbi Tanenbaum said. Currently, religious strife is most apparent in Lebanon, where Lebanese Christians, members of one of the oldest Christian communities in the world, are being killed, he said. "Tragically, as in other cases, it

Few voices were raised to protest the massacre of some 50,000 Kurds in Iran or a million black Christians and animists who were liquidated in the Sudan, Rabbi Tanenbaum said.

Idi Amin, the mercurial strongman in Uganda, is responsible for "the savage massacre of 55,000 Christians in that country," Rabbi Tanenbaum said, adding that Amin was received with a standing ovation at the United Nations.

Amin, a Moslem, in his UN address, "called for the extinction of the state of Israel, and then turned to the American people and said 'the Zionists control the wealth of the United States," Rabbi Tanenbaum said.

Amin told the assembly that if Americans wish to liberate themselves, they will "drive the Zionists from the country."

Rabbi Tanenbaum said he is pleased that several religious groups have spoken out against the recent United Nations vote in which zion-" ism was equated with racism.

After several leaders of Christian denominations protested the action, "German Protestant churches, the British Council of Churches, and the French Catholic and Protestant churches have made similar statements," he said. "This age, which has the capacity

for lethal destruction, cannot endure the lifting up of hatred of any people

and allow it to be placed in the arena of the UN."

Hatred "has become a luxury that can no longer be tolerated," Rabbi Tanenbaum said.

A Harvard professor who has made a study of violence in the United States has discovered that "in every case where lynching took place, it was always preceded by verbal violence

'What we are confronting is a verbal violence and a verbal rejection of the Jewish people," he said.

Rabbi Tanenbaum said he is disturbed by the fact potential assassins "are becoming celebrated on the covers of Time and Newsweek. and are becoming instant heroes."

Violence represents an assault on the basic dignity of mankind, and Judaism and Christianity have always stressed this dignity and the sanctity of life, he said.

"In Jewish teaching, there is only one symbol of God, and that is the human personality."

Rabbi Tanenbaum said the possibility of some kind of gun control in the United States should be explored, or "life will be increasingly perilous for all of us."

SUBJECT: Your Oklahoma City Agenda November 25 - 26

Just wanted to take this opportunity to brief you on what to expect in Oklahoma City.

#### I. Travel Plans

As the fundraising cocktail party begins at 6:00 PM Tuesday, you should plan to arrive mid-afternoon at the latest. (I urge you to make reservations as soon as possible. Flights in and out of Oklahoma City tend to book up.) One of our members will pick you up at the airport, so please let me know what your flight plans are. A reservation has been made for you at the <u>Hilton Inn Northwest</u>. Your departure should be anytime after 9:30 or 10:00 AM on Wednesday.

#### II. Fundraising

A cocktail buffet supper (kosher) will be held at the home of Mr. and Mrs. Robert Wasserman (7305 Lancet Lane) beginning at 6:00 PM. The agenda will be drinks and buffet followed by introductory remarks from the Chairman, Erwin Alpern. You will then be asked to speak on AJC; the problems, the needs -- as only you can do so well. Figure on about 10-15 minutes. At your conclusion, Erwin Alpern will then make the appeal for funds -announcing some gifts received and trying to prompt new gifts. We hope to adjourn no later than 8:00, in time to get to the synagogue for the lecture at 8:30.

You should know that Oklahoma City is relatively new fundraising territory for AJC. In 1973 we raised about \$10,500 (\$8,000 of that in 3 gifts). It's a small, wealthy but static and unphilanthropic Jewish community -a good portion of its money is in oil. About 95 couples have been invited

III. Sam Singer Lecture

At 8:00 PM we should leave the Wassermans' and go to Emanuel Synagogue for the lecture. (A Xerox of the invitation is enclosed.) Your topic is Religious Values in an Age of Violence. The entire Jewish community and a cross-section of clergy and civic leadership has been invited to attend. We think there should be a good attendance by Oklahoma City standards. I believe the press is being invited. This is the third Sam Singer Lecture and previous speakers have been Norman Podhoretz and Jerome Shestack. A reception will follow your address.

IV. Wednesday Breakfast Meeting with Oklahoma City Clergymen

Albert Janco is organizing a 7:30 AM Continental breakfast meeting at the Hilton Northwest to which a cross-section is being invited (I hope you're an early riser!). This will essentially be a time for you to talk on any topics you wish and to engage in a give-and-take discussion. Approximately 60 clergymen are being invited, so figure an attendance of 20 or so. The press may also be invited. If there are any people, clergy, etc. in Oklahoma City whom you've had contact with over the years, let us know and we'll invite them to the lecture and the breakfast.

I hope this answers all your questions but please don't hesitate to call me or Larry Cohen. The folks in Oklahoma City have been working very hard on this and are excited about your visit. I look forward to seeing you on the 25th. Needless to say, thanks again for your willingness to help out.

## Rabbi Sets City Talk

Rabbi Marc H. Tanenbaum, national director of interreligious affairs, American Jewish Committee (AJC), will speak on "Religious Values in an Age of Violence" at the third annual Sam J. Singer Memorial Lecture.

His address will be delivered at 8:30 p.m. Tuesday in Emanuel Synagogue, 900 NW 47, Oklahoma City, and is open to the public at no charge.

On Wednesday at 7:30 a.m., Rabbi Tenenbaum will meet at the Hilton Inn Northwest with a group of religious leaders of the Oklahoma City area to discuss Jewish-Christian relations.

Internationally known for his efforts to promote interreligious cooperation in the cause of social justice, Rabbi Tenenbaum is a founder of the National Interreligious Task Force on Soviet Jewry and serves on the religious leaders committee of the National Bicentennial Commission.

He also helped organize and served as co-chairman of the first International Colloquium involving Christians, Jews, Buddhists, Hindus and Moslems from the five continents which was held in Nov., 1970, at Hebrew University in Jerusalem.

A noted writer, lecturer and social commentator, Rabbi Tanenbaum is co-editor and a contributor to the justpublished, "Speaking of God Today in the Age of Auschwitz and Technology."

# Rabbi will deliver lecture

Rabbi Marc H. Tanenbaum, a pioneering leader and thinker in interreligious relations for almost 25 years, will be in Oklahoma City Tuesday to deliver the third annual Sam J. Singer Memorial Lecture.

Sponsored by the Oklahoma City unit of the American Jewish Committee, the lecture will be at 8:30 p.m. in Emanuel Synagogue, 900 NW 47.

Rabbi Tanenbaum, national interreligious affairs director of the American Jewish Committee, will speak on "Religious Values in an Age of Violence."

A religious historian and authority on Judaism and Jewish-Christian relations, Rabbi Tanenbaum has written and lectured extensively on the history, theology and sociology of

the two religions.

He is a founder and co-secretary of joint Vatican-International Jewish Consultative Committee and of a similar liaison body with the World Council of Churches.

Rabbi Tanenbaum was the only rabbi at the Second Vatican Ecumenical Council. He was widely consulted by Roman Catholic and Protestant authorities during deliberations which led to the Vatican declaration on non-Christian relations that repudiated anti-Semitism and called for fraternal dialogue between Christians and Jews.

Rabbi Tanenbaum, who has made several appearances on the "Today" show, has received numerous honors for his contributions to religious understanding.
