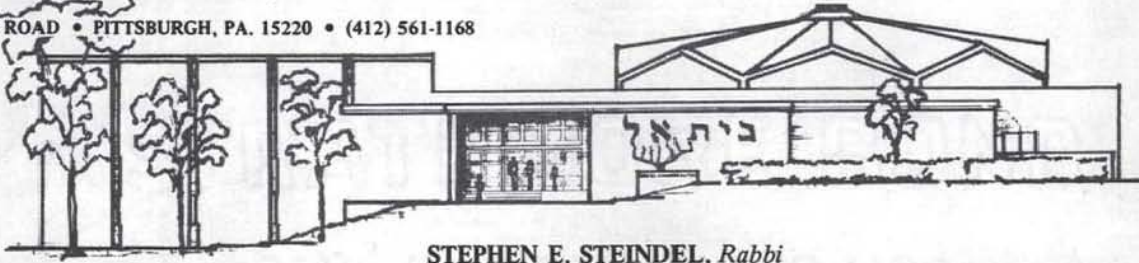


Dear Rabbi Tanenbaum:


Dear Rabbi Tanenbaum:

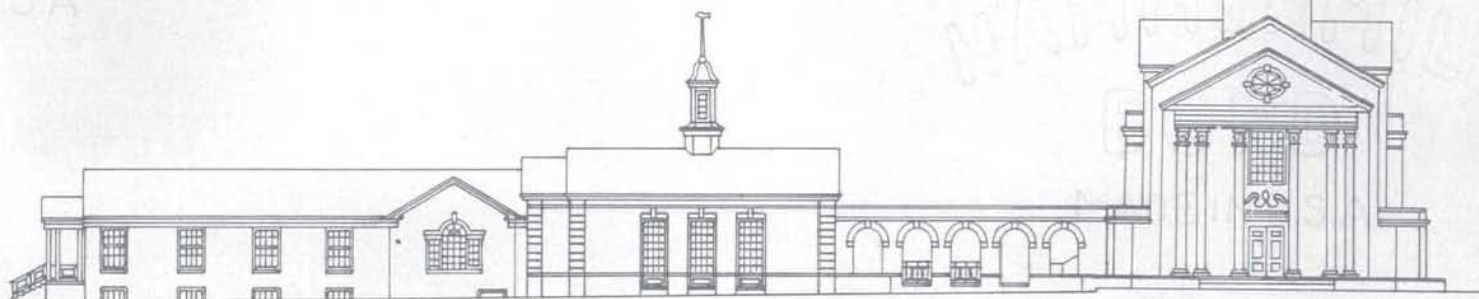

Dear Rabbi Tanenbaum:

Each year our congregation sponsors a theological lecture to an ecumenical audience. Two years ago Mike Novak spoke; this year, Bill Coffin. We would invite you to speak in early March of 1979 if you are available. In addition to a lecture at this church, there would be a second one at Pittsburgh Theological Seminary. The latter would be cosponsored by the Seminary and Christian Associates of Southwestern Pennsylvania (equivalent of the local Council of Churches). I would assume an audience of about 750 here at the church and three hundred at the seminary.

We have a budget of \$1,000 toward honorarium and expenses. Normally these lectures are Sunday night and Monday afternoon. Our preference would be March 3 and 4, with March 11 and 12 as second choice.

We were impressed with the content of your lecture at Beklar Lecture. We are pushing Amnesty International, and the human rights issue is one in which we have strong convictions.

We sincerely hope that you will be able to participate in what has become a very significant inter-religious experience in this community.
