Some time ago my wife, Francine, commissioned the painting of some porcelain from a very old lady who is a friend of hers in Grenoble, France. Herman Goldsmith of your office was helpful in organising the details and recently wrote to Francine that the parcel or package or box of porcelain is in his office in Geneva, and what does she want done with it?

The answer is we want it here in Jerusalem; and the favor I need is to ask you to help me arrange to get it here. I don't know how it is packed and therefore I don't know the best way to ship it without suffering breakage. The very hest way, of course, is for the next person flying from Geneva to Jerusalem to carry it on his lap.

Seriously speaking, take a look at the parcel and me an "eitza."

I'm writing to ask your advice on some Y.L. business, but first there is something personal I want to get off my chest.

I have heard that things are not going as well with Haifa as you had hoped. Hokey as it sounds, I just want you to know that if there is any way at all that I can be of service to you please don't feel hesitant about asking. At the very least, I hope to hell you know that there are many whose allegiance/loyalty/admiaration etc remain fierce, constant and unshakeable.

Business. Don is sticking to his guns and fighting to have Irwin as the next chairman. It has really taken much guts and some of his close friends are accusing him of very ugly things because of it. It's also been a tough period for him on other counts...his business has been slipping because of the inordinate amount of time of he puts in here and he's had some family problems that only help to further drain him. Anyway, you know how he feels about you and if you could find a few minutes just to drop him a note -- even nothing more than 'look forward to seeing you when the mission arrives' -- I think it would do a lot for him. 110 Wyoming Ave, Maplewood, NJ 07040.

Don and I were both unhappy with the mission itinerary vinitsky sent us and drafted one of our own. Before showing it to anyone we'd like your comments. Dear Herb,

Geraid Engman of Des Moines came in to see me last week (first to return a Zaritsky watercolour he had acquired from me some five years ago and then to decide not to do so when my lack of poker face showed how thrilled I was to see it and how ready to pay him three times what he had paid for it!) and he told me he and his family had seen you and you were about to assume the Presidency of Haifa University. I mourn your leaving Jerusalem but rejoice in the wonderfully open field this new appintment will give you for your creative response to challenge. For what it is worth, I still believe you were absolutely right in theory with regard to the potential of the UJA move but I honestly feel you failed to take into account minutae of the situation in Israel. I hope you and Fran are happy in the move and I am sure the children will adjust anywhere. If Gerald's news was premature or incorrect, forgive me and post this unseemly haste in writing you to a genuine involvement.

Mr. Max Karl's interior archiect had commited himself almost completely but he did come to the beautiful exhibition I now have in New York and loved Benni Efrat's monotypes on newsprint. I had two on the wall, each utterly different from the other. He said: "Of these, I could take two, four, six, even twelve." So I am leaving it to Benni, who is due in this week from London. Nothing else found grace in the architect's eyes but even what transpired is an "in" and I am extremely grateful to you for thinking about me.

I am cooperating with a charming yourquale socialite, Jewish to the hilt (writes very good "Jewish" poetry) but absolutely 'integrated into Centile society as few Jews are. Under his pressure, I agreed to stake three thousand dollars into trying out moving the art to a charming suite in the hotel I love the best - quiet, European in service and pace, the Volney, just off Madison at 74th St. The first seventeen works which sold went to Goyim! This gives me peculiar delight because it does seem to indicate that something is right with the art. But it is also a way in for these people to become aware of "my" Israel, the ecumenical fulfillment of prophecy and promise, one of the very few if not the only manifestation of the continuity of history and the relevance of the Bible. He has an "in" with the Israeli Consulare people here and they had him shepherd Zimra Peled around while she was in New York. She is utterly charming and fell crazily in love with the exhibition. Elad Peled followed and then bells began ringing: he told me you had talked of me to him. I picked up the story of the Israel Education Fund and the 1% of art. He said he was interested in getting that going and had other ideas for me. We promised to contact each other on my return. For that, too, as for so very much else, thank you, Herb. Without your help, what has been achieved for Israel in this (important) field could neverhave been achieved. I know now better than I did before although I always knew in general terms what this entire programme owed to your vision and complete absence of legalistic inhibitions.

I finally assembled sufficient courage to go to your old room to talk to Irving. I

Found him amazingly receptive but Paul Zuckerman refused any outlay of any kind not directly connected with fund raising. Irving confirmed my unofficial role of "ADviser to the UJA on matters art". He was gracious enough to say that I had been so reasonable in pricing my sales to the UJA that it has been remarked that people don't know how I did it. There are other ways of paying rent and saying "Thank you!" but I preferred this way.

Elad Feled also mentioned that you wanted another two paintings. I'm due home alas! not for Pesech but at the beginning of May.

Dear Mr. Vinitaky:

This is Dvora Sayag from Or Akiva writing to you.

Until a year ago, I received a monthly scholarship in the amount of U132.- a month, which coverednmy school expenses. This was surranged by Rabbi Herbert A. Friedman through the Jewish Agency. This year I do not get the acholarship any more. I am studying at the "Efratta" Teachers' Seminary in Jerusalem and have to pay E180.- a month for the dormitory, in addition to the tuition.

Three months have passed since the school year started and I have paid nothing for the dormitory because I do not have what to pay from. My father is sick and hence, does not work, and my brother Joseph (Mr. Friedman's friend) got married two weeks ago. Of course, the manimal financial support we get from the Welfare Bureau does not enable me to pay E180,a month.

I am writing to you because Mr. Friedman kept telling me that if I need anything as far as financial support for school, for the dormitory and for books is concerned, I can contact you (he even gave me your telephone number) and all will be arranged.

Moreover, the Director of the Dormitory does not agree to let me stay there for more than one more week, unless I pay at least a small part of the amount I awe.

I hope I will not have to miss school because of that, and that you will not disappoint me.

Please tell Mr. Friedman my brother Joseph and his wife Dvora thank him for his cable.

Please let me know his address in Israel.

Dear Herb:

I have decided to set forth in writing the areas of responsibility concerning your function in Israel, and that of Chaim Vinitsky. I think it is imperative that the delineations are clear, so that there can be no mistake, and so that cooperatively, the office will function at maximum efficiency. I don't intend to tell you how to run your office, but you have to understand that things in Israel just don't operate the same way as they do in America, and that there is a certain protocol and a certain <u>modus vivendi</u>, and you have to adapt yourself to it. Only with that attitude will this work.

Therefore, I have written to Chaim Vinitsky and set forth in detail what I consider to be his area and scope of authority, and as you can see, this letter has the approval and signature of Paul Zuckerman, the next Chairman. So that there can be no mistake in our understanding of Chaim's responsibility, I am enclosing two copies of that letter; one for your files, and one for you to sign where indicated and return to me.

The most important thing that you can do in Israel is to solicit gifts, and your principal role is to raise as much money as possible by contacting visiting Americans and obtaining their gifts while they are in Israel. The second most important thing that you can do is planning new programs and approaches for the United Jewish Appeal, using Israel as a base and effectively using Israeli personnel. I know that this is a generalization, but I am sure that you understand what is contemplated. Therefore, I would set forth the areas of your responsibility as follows:

- 1) Solicitation and obtaining gifts for the UJA.
- 2) Planning new programs and innovative ideas that we can use in Israel and, from Israel, in the United States.

- 3) Locating and training of speakers for the UJA.
- 4) Briefing of Israelis prior to their coming to America, and prior to their meeting here in Israel with UJA missions and/or individuals.
- 5) Appearing before the Operation Israel Missions and other missions UJA and city - and devoting as much time as is necessary in person in accompanying the missions and being part of them, to insure the maximum effect on fundraising.

I can't emphasize enough that the administration of the office, the areas of authority outlined in Chaim Vinitsky's letter, are things with which you should not be concerned.

If your efforts here result in increased giving, that is all anyone hopes for er expects.

As you can see, Paul Zuckerman has also signed this letter, and therefore it has his approval.

Dear Herbert,

This letter is an extremely difficult one for me to write. I don't know what you've heard about my dissociating myself from the mission and (ultimately I suppose) from the Committee, but I want to set down here my reasons for my actions--not for your approval or disapproval, but rather so that my true feelings toward our work, the UJA, and you will not become clouded in the thick air of rumor.

To begin with, I feel some regret that I was so late in making my final decision not to go along with the mission. However, as events ran their course, the UJA was in fact able to find a replacement for me, and hence, I feel that my tardiness is of no great importance in the overall discussion. This delay in announcement of my intentions was not a planned attempt on my part to sabotage the mission. Instead, it was a consequence of my own indecisiveness brought on by an inner struggle which had been going on for the past two months. You see, I was torn between two divergent poles. On the one hand, I reasoned that even though I was not particularly pleased with the structure and participants of the mission, these obstacles could be mitigated through proper training and leadership on the mission and that the mission itself was only one part of the entire student program and that the continuance and shaping of this program in the future was the important thing, and therefore, I should just ride the mission out, getting a few capable people offict and hoping to improve it next year. On the other hand, the argument ran that the mission was only symptomatic of the direction of the entire student effort which was becoming hopelessly "doomed." In a sense, this latter position won out, and since it did, I want to examine it more closely.

The thing that really got me interested in Israel and in the UJA was the mission I went on. But at the same time, the mission also clearly pointed out to me the problems of the UJA, and more than that, of the American Jewish community as a whole. And as I've said to you again and again (and as you've denied again and again), the community here is controlled by an oligarchy. Now there's nothing wrong with wealth <u>per se</u>, but the men who form that oligarchy by and large have all the vision, imagination, and dynamism of a bagel and lox brunch.(C'mon, I dare you. Go ahead and say that Ginsberg and Fisher are great leaders.) Anyway, the people who went on my mission were mostly the sons of these Jewish patricians. And I looked at them last summer and said to myself, "These are the future leaders that the UJA is pinning the hopes and fate of Israel and the Jewish People on?" So I answered my question by saying that really the UJA couldn't be held at fault because their campus program was not that strong since it all revolved around one rabbi's feeble attempts to reach students, an impossible undertaking due to the numbers involved and due to the inherent problem of having an adult who was essentially pretty far removed from the problem of Jewish youth on campus trying to pick student leadership to solve it. Thus, the mission served as the stepping stone to the Student Coordinating Committee for the Israel Emergency Fund, a body whose main efforts would be to try and involve a broader base of support among students for Israel and in the attempt to find a higher quality of leader than was previously active.

So now it's one school year later, and I look back on our work. I see that we raised four times as much money, opened up twice as many campuses, and that on most of these campuses, in terms of people contacted either through the establishment of a workers' core or during the course of solicitation, the campaign far outpolled any other Jewish activity. Furthermore, I have no doubt that all things being equal, the campaign next year should easily be able to double the amount of money raised this year. In terms of what the UJA does best, i.e. raise money, we were a success; in terms of what we set out to do as a primary goal, i.e. educate and involve meaningfully through presenting a new force on campus, we failed miserably. When I used to say educate, I didn't mean setting up a complex and expensive system of Jewish studies programs. I did mean, however, having an intensive speakers' program combined with a core of films so that a campus could have anywhere between two and four Israel-oriented meetings a month. If this kind of activity occurred, then I felt that interest in a campaign would be more natural and not the kind of hit-and-run hype Judaism that the Jewish fund-raising establishment has so often participated in. Well, in talking to a number of chairmen, I found that the only education occurring on campus occurred for the most part during a (in the sense of one) workers! training meeting or during a solicitation. If it were a good solicitation, it lasted between 20 minutes and a half hour. What kind of educational program is that? But the interesting thing is that in spite of the lack of education, the response from many students was still good. That is, often I or the workers in a campaign would go at random from door-to-door, talk to Jewish students for a few minutes, and walk away with \$20. I view this phenomenon from a number of perspectives: (1) the effect of Arab propaganda

is minimal; (2) Jewish students still have a kind of gut feeling, no matter how vague or ill-defined itymay be, about what it means to be a Jew in a non-Jewish world (3) they will fulfill their obligations to their people provided they are given a meaningful, concrete way of doing so;(4) but that this willingness to fulfill such obligations may only occur at a minimal level since I don't feel that we raised money; we just collected it from an as yet untapped source, and many students who gave \$20 were just giving Keren Ami at a higher level while refusing to take a more active or deeper role in the campaign such as that of a worker. Also, Lafter the campaign ended on most campuses, there was no follow-up Jewish activity in which students could become further involved, e.g. Soviet Jewry rallies, teach-ins, etc. Hence, these students were only involved as fund-raisers, an involvement which presents limitations in two areas. The first is that we once again offer hit-and-run Judaism. I sometimes wonder whether the effects of my going to a campus and making a fiery speech which brings in a lot of bread is a positive thing. Suppose a student gives a good gift at the meeting in the heat of the moment (and the pressure), then goes back to his dorm and reflects that he has been caught off guard emotionally and feels that he has been betrayed, deceived, or conned? Will he give next year? Will he come to another Jewish function for a long time thereafter (since most of the students contacted presumably haven't been contacted for any Jewish event for a long time preceding)? I'm not saying the student's logic in this case is valid, but the validity isn't important; the mental attitude is and mut be taken into account. The second areas of limitation is that under the circumstances where fundraising becomes the sole activity that we carry on, we can in no way consider ourself a movement, for a movement has a philosophical perspective and a historical direction, two things which we obviously lack at present. More practically, a movement must be a year-round sustained thing, and right now, all we're saying to people is "Thanks for helping us in the campaign this month, and we'll see you again next year." This approach causes an inversion. When we started out, the primary goal was education, and the secondary (or even tertiary goal) was fund-raising. Fund-raising was meant to be a handle or raison d'etre for talking to the students in the first place, so that you wouldn't find yourself talking to someone about the plight of Soviet Jewry and having him say at therend "So what do you

want me to do about it?" Fund-raising was a means to an end; now it's become an end in itself, and as such has no relevance to students, for while it is important that students <u>qua</u> moral human beings raise money as a form of moral action; it is not important that students <u>qua</u> students raise money since for the above-named reasons fund-raising can in no way be considered a student movement. Also, the amount of money raised by students is inconsequential compared with the overall campaign, and really potentially future big givers are not probably going to be found by merely going into their dormitory rooms to rap with them for a half hour when they're 20. If these kind of people are to be found, they will probably be found in business graduate schools, and I would suggest that in the terms of concentrated efforts of fund-raising for future leadership <u>for the UJA</u>, the Student Coordinating Committee should drop its activities for undergraduates and zero in on these graduate students, particularly in terms of their participating in missions.

Another thing that I look back on is relationship to the Establishment on the part of the Committee. We started out with an adult director, and we ended up with an adult director; we started out with an obnoxious working agreement (extant on paper only) with Hillel, and we ended up with this agreement more or less in tact; we started out with having to work with Federations who knew little or nothing about relating to campus youth (if they had known what to do, there would have been little need for the Committee in the first place) and we're still talking about working with them even though their general attitudes are still the same. All of these stagnant conditions come down to one point. As long as we are part of the UJA in the same way that Women's Division, Young Leadership, the RAC, and the West Coast Office are a part of the UJA, we are subject to the same structures and rules that define UJA policy. Within that framework, I completely understand and cannot find fault with not wanting to break with Hillel for fear of rending apart the Jewish community, or with not simply telling Boston to get fucked when they hassle us about Harvard for fear of jeopardizing the overall campaign there, or with not putting a student at the helm of our program for fear that the other Jewish organizations will get uptight if there isn't an adult there for them to complain to, or with not telling Elliot Gant to keep his daughter home this summer for fear of his cutting his gift further. No, as long as we work within the UJA, we must accept as the realities these limitations. But it occurs to me

that in each of these restrictions, we have one of the main failures for the organized Jewish community to reach its youth, and ultimately its failure to be able to assure its own continuation in the next generation. Hillel is a dead proposition, and everybody knows it, but the Federations and, now unfortunately, the UJA keep working to support it, as though moral support and money are the answers to bring it back to life (as though that would even be a good thing!). As I said before, the Federations, in both their lay and professional leadership, have failed miserably to involve any significant number of American Jews, be they young or older. But we continue to say "Work with them. Work things out." For what purpose? To what ends? To merely keep things peaceful? Bullshit. Most of the people that the Federations have to work with their college youth are less responsive to those students than college administrators whom these same students have already rejected. The only reasons that the Federations are interested in the students at the colleges in a particular area is for that regular fund money. These same Federations aren't willing to cough up money for Jewish day schools, for Jewish studies programs, for scholarship money to send students to Israel, to fund their newspapers, or to pay for speakers and other programs. I don't want to involve students in such a structure. As for the children of the wealthy, their parents are killing Jewish life here (as they have always done historically when they usurped leadership from the rabbis, the learned, the spiritual, the Jewish members of the community), and there's no reason to think that the offspring will do anything different. And as far as involving other people (particularly other students), talk to Jim Factor and ask yourself how many people of his age can relate to him. Then comes the point of the adult director. Sam's a nice man. More than that, he's one of the only decent people in the UJA. But the UJA owns him, and he'll dance for it. But Sam didn't raise a nickel of what came in from the campuses; he only served as a front man for you and for Irving to co-opt the "boys," and unfortunately, we served as the front-men, the puppets, for the UJA. The "student" in Student Coordinating Committee was by and large an illusion. You let us have the toys, but not the tools. I guess what it comes down to, Herbert, is this. To work effectively for the long range goals (as well

as for some of the short range ones), we just can't be a part of the UJA. You should just give us the money, and let us ride with it. And I bet we'd be pretty responsible with it. Set up programs at only 20 campuses. Speakers, films. Cost about \$30,000. Run trips to Israel with much scholarship available. Cost about \$60,000. Run workshops and conferences. Cost. Who knows? It may occur to you that these things are not much different in general from what we're doing now. They aren't; they're just stressed differently. I wouldn't bring over David Shenhaby (?) -- but Moshe Sneh instead. But any case, it would be students calling the shots, not for our egos, but because we want to reach people our own age -- something you can't do. You ran 4 summer missions, and got less than 15 people out of maybe 100 total participants doing anything at all (forget even talking about leadership qualities). To top it off, even their gifts shit. We ran 1. Sixty-seven people; forty-five active this year; mode gift \$125. How much money would we raise? Don't really care. Cared about that too much this year. You see, we knew that at the end we'd be measured by how much coin came in, so we thought we'd ride it out for a year and raise money to gain credibility. So we raised the money, but we never got the credibility, apparently.

And all this brings me back to the mission, and my reasons for leaving it. I suppose that I could have inspired and trained the Gants, the Factors, the Goldsteins, but I asked myself, for what? To fit into the same structure that's always existed and has proven itself not worth redeeming? To ride it out and wait for next year? But I can see the writing on the wall, Herbert. We're going to be told to work under the dictates of Boston, or L.A., or stay out altogether. And those dictates spell Hillel. And they spell money talks. So next year's mission will probably be like this year's. And so on. And I'm simply not interested in that or fund-raising alone. Because I've got too much talent for that. I was the one this year who designed the buttons, picked out most of the posters, found the better people on campus, gave the speeches from which the others copied theirs, and gave the brains to write the position papers and get the few concessions we did get. I am a leader, Herbert. And schare you. You did what was right for your times, and I have treasured knowing you and working with you, and I hope in spite of all this (including this some what bitter letter which I did not intend to be bitter), we will still call each other friend. But understand, I must do what is right for my time. I have some ideas, some "visions," some half-

seen memories of things to come. I have applied to the Reconstructionist Rabbinical College as a springboard to prepare myself intellectually and spiritually for the job ahead.

I know some of this, perhaps a lot of this letter, has seemed extraneous or not quite logically perfect. Yet it's not easy to put feeling into thought and thought into written word; it's not easy to put the turning point of your life on paper. Please let me hear from you, and please say hello to the Queen of the Jews (Mrs. Friedman) for me. I am expecting any day now transcripts of interviews which I taped at the end of the year with a number of campus chairman. I hope to evaluate them and send you some of my reflections on them.
