Dear Miss Lavie:

You will recall that when you were in New York recently you were good enough to tell Yael Dayan that you would be interested in helping the United Jewish Appeal make an hour-long presentation in Israel this summer for showing in 1966 on American television.

I write first to thank you for your kind offer to help us. I also write to tell you where we stand on the project.

First -- I am flying out to Hollywood tomorrow to meet with Kirk Douglas to see if he too will agree to appear in the presentation. Our thought is that the film would co-star you with Mr. Douglas.

Second -- as Yael undoubtedly explained to you -- Carl Foreman has told us that he would be ready to produce the picture, and to write and direct it as well. It was Mr. Foreman, incidentally, who suggested that you would be a very fine star for the presentation. I hardly have to tell you that he is universally regarded as one of the top film-makers of our time.

Lastly -- we have, at the suggestion of Walter Mirisch of Mirisch Brothers, discussed the project with the William Morris people. They have found considerable merit in it. There is even a possibility that they may assist us in arranging for it to be properly presented on television.

Many matters in connection with the making of the show still remain to be settled. As soon as we have reached the point where we know that we are definitely going shead with it, we will immediately inform you, with a view to settling the details of your own participation in the project. Our hope is that we will be able to do this before the end of April.

Dear Moe :

I am grateful for your kind reply and I shall try and make my point more clear. Otherwise I could be accused of trying to impose too much on J.D.C.

1. Supposed the "Alliance Israelite Universelle" would wish to educate Jewish children, displaced from Morocco and Tunis to France; and supposed the A.J.U. would approach J.D.C. to assist in such a program; would this not be in line with J.D.C. policy?

2. Supposed these nearly thousand of North African Jewish Intellectuals would decide to find in France their Second Home would not J.D.C. assist them in solving their cultural and social problems?

3. With these two premises I approached this situation. I felt that we owe it to those North African Jews with the lower I.Q. ve did import so liberally to import their complementary high I.Q. correligionists.

4. By undertaking a certain responsibility for such a group of migrants does not mean to establish a Second Wedical School. Admittedly it would contribute to such a School but is this not a plus when one spends money if it contributes to a lasting Institution of Higher Learning? Let us call it a Yeshivah but instead of Talmud and Naimonides one studies Ehrlich, Pasteur Roentgen and Wassermann to quote only a few.

It is with these considerations in mind that I contemplated proposing to Er. Jordan to convey to you my suggestion. I do hope that it might still evoke second thoughts as to how money spent should not remain completely anonymous.

Dear Chaim:

Now that I have your latter of July 8th I am convinced that you must have gone through a very good yeshivah before you went to medical school and became a very good doctor! Let me answer your two questions.

The answer to 1. is a decided <u>NO</u> and curiously enough the Alliance Israelite Universelle has asked the JDC to set up secondary schools in France to which request we have also said NO. The basis for our NO is that both public schools and public secondary schools are free and available to all North Africans who live in France. For us to duplicate such schools would be a waste of precious Jewish public money.

As to your second question. We do not pick out people from a community in order to give them special cultural and social programs. We are concerned at the present time in providing assistance to those North African Jews who want to continue to live as Jews and who require a synagogue, kashruth, and Hebrew schools which in France hold sessions on Sundays and Thursdays. This we are attempting to do, but we are not able to meet the great need of 150,000 new immigrants in France and therefore our progress is slow. Your assumption that 1,000 North African intellectuals represent a special group in the community for which we must feel a responsibility is not in accordance with the facts. These intellectuals find an intellectual culture in France, it is French, it is Jewish, it is whatever they wish to adopt. It exists in France. We cannot create such cultures made to order for separate groups of people.

Now as to your third and fourth paragraphs. I do not at all question the value of bringing into Israel the high I.Q. North African immigrants, but that, as you have undoubtedly gathered by now, is not a function of the JDC. Perhaps, if millions were at our disposal and we had no other place to put them, we would be interested in taking on your very worthwhile project. Calling a medical school a yeshivah and calling the study of Ehrlich, Pasteur, Roentgen and Wassermann a study of the Talmud does not solve my problem and your problem:

In the last few years, due to the influence of a remarkable pair of brothers, Leonard and Joseph Strelits, Norfolk, Virginia has skyrocketed in its support of Israel. As a matter of fact, this influence has spread throughout the entire State and the adjoining Carolinas. It is now one of the most important UJA areas on the entire Eastern seabord.

The Committee is desperately eager to have Governor Rockefeller address the large campaign opening dinner, which would embrace people from the entire state and region. Governor Linwood Holton of Virginia would be pleased to be at the meeting and to introduce Governor Rockefeller. The date is wide open, and could be any evening between the 1st of March and the 15th of April, excluding Friday and Saturday nights. The flight is just over one hour and the Governor could be back in New York the same evening. He could either arrange his own transportation or we would be happy to supply him with a chartered aircraft.

As you know, dear Lou, we try not to impose on the Governor. Dear Mr. Ambassadors

I noted with interest the Joint Resolution of the United States and Great Britain, as proposed by you, censuring Israel relative to the recent Syrian border incident.

I am far from an authority on the situation, but I have been in that area on several occasions, the most recent being January of this year. I thought that the Joint Proposal was a mistake at the time it was introduced, and at the time it was voted upon. My opinion was based upon the fact that Israel's actions were precipitated by Syrian activities which jeopardized Israel's security generally, and more specifically the security of the border villages and communities in the area of Lake Tiberias. I am sure that you are, and were, aware of the fact that the village of Ein Gev, located on the East shore of the lake, was subjected to a Syrian mortar attack prior to the time the State of Israel took action for which it has been condemned in the United Nations. Aside from this, I am sure you are and were aware of the fact that Lake Tiberias is entirely in Israel's territory, and citizens attempting to use the lake for fishing activities have been fired upon, some injured, some killed.

However, at the time the Joint Proposal was made. I thought that probably there ware facts and reasons that I was ignorant of, but which justified the action taken in the U.N. If there are facts and reasons, they have not been made known to the public, and therefore I must assume that there are no such additional facts. I find it difficult to understand any reasons not based upon fact, particularly where the moral issue involved is in conflict with the U.N. action taken. If Cuba were to shell the Eastern seaboard of the United States, or take some type of aggressive action against our base at Guantanamo (such action certainly would not effect our security nearly as much as the Syrian action effected the security of the little State of Israel) I am reasonably sure that the United States would,

and justifiably so, respond in an aggressive manner.

The reason that I have decided to write you this letter is because of a news item that I happened upon in last Thursday's paper. It is a UPI release dated April 26, from Amman, Jordan. The news release is quite short, and I will quote it in full. It states:

> "King Hussein of Jordan said yesterday that his country will act as a 'springboard' in any action to restore Israel to the Arabs. He spoke here to a group of Arab refugees from southern Palestine."

I do not know your sympathics to the State of Israel, nor to the Jewish people generally. But I do feel that whatever your personal likes or dislikes may be. as the representative of this country to the United Nations, it is your resposibility and obligation to the United States and its citizens, as well as to the entire free world, to stand upon the side of moral integrity. Considering the fact that the nations of the United Arab Republic are committed to the destruction of the State of Israel, and further considering the fact that ever since the cease fire was agreed upon in 1948, and later in 1949, there has been continuous violation by various Arab nations, I believe that an apology of some sort is due for the recent action introduced by you mentioned above. It is not a question of trying to soothe the feelings of Ben Gurion, or the State of Israel, nor is it for the purpose of trying to soothe the feelings of the Jewish community of the United States and elsewhere, but for the purpose of telling the free world that we here in the United States are hig enough to admit a mistake when we make one, and further, because of the moral issue involved, we must take a stand on the side of "right." The right and the wrong of this situation is apparent to anyone who has been in that area of the world, or anyone who has tried to keep abreast of what is going on in that area of the world. I sincerely hope that you will consider the contents of this letter, and that you will see fit to do everything in your power to remedy any mistake that you believe has heretofore been made by you or one acting through you.



P.S. I might add that I am aware of the fact, and I am sure you are aware of the fact, that the United States of America pours about a quarter of a billion dollars into the U.A.R. annually. I am further aware of the fact, and I am sure you are aware of the fact, that the United States has permitted private companies to sell weather rockets to the U.A.R. Of course, although these rockets are classified weather rockets, any sensible person knows that you can easily change the head of the recket and make it an instrument of destruction. Although in some respects the United States has helped Israel, by comparison to the help afforded the U.A.R., it has been little. The promises that the United States made but did not keep (I do not insinuate that you are responsible for President Eisenhower's actions) referable to the Suez orisis in 1956, coupled with the other items mentioned in this postscript, and those items mentioned above, strongly tend to make the rest of the world feel that the United States has lined up on the side of the Arab nations against the State of Israel. Such a feeling could prove disestrous to cur prestige abroad, because if this is the position of the United Staten, it is not based upon the facts, and most certainly not based upon the moral issues involved.

I feel that the likelihood of receiving any type of response, favorable or otherwise, is negligible. However, I wonder whether or not fifty thousand such letters, written by "interested Americans" would produce some effect. It seems to me that when situations like this develop, everyone interested should be urged by some central office to write a letter to their senators, congressmen, and anyone else involved. The need for a political action committee is, in my opinion, long overdue. I realize that UJA cannot, in itself, form such a committee, but your thoughts on how this committee could come into existance would be of great interest to me.

It was wonderful getting a glimpse of you Sunday morning, and I cannot tell you how sorry Toby and I were that the nature of the week-end schedule prevented our accepting any of the repeated invitations of the Ginsbergs that would have permitted us to spend some time with you.



## STATEMENT BY RABBI HERBERT A. FRIEDMAN EXECUTIVE VICE CHAIRMAN, UNITED JEWISH APPEAL

Speaking on behalf of a Committee of American Voluntary Overseas Aid Agencies on the occasion of the presentation of an award to the President of the United States, at the White House today, Monday, April 9, 1962.

Mr. President, we are representative of several associations of private citizens who have organized in voluntary fashion to provide relief overseas to human beings in need. Among us, in addition to the more general groups, are to be found the three major religious faiths of this land, working in closest union, crossing boundaries of race, color, and creed, seeking the goal of a brotherhood of man through service to others.

Our motivation in this work is spiritual and humanitarian. Our support in this work is drawn from combined memberships of tens of millions of Americans. Our goal in this work is to relieve misery and suffering.

We are deeply pleased that the policy of our government, as expressed through your words and deeds, Mr. President, as well as those of the Congress, coincides so closely with our own impulses. This is a happy harmony. Democracy in its deepest sense will flourish best when there is a blending of the ideals and actions which an enlightened government and a sensitive citizenry both deem to be desirable.

This nation, by virtue of its sentiments, traditions and self-imposed standards must always be willing to help overcome, through the strength of its generosity, the awfulness of hunger, the spectre of disease and the tragedy of homelessness wherever on earth these be the condition of man. Concerned with the pain and anguish is the hallmark of the civilized nation or person, whose deepest instinct will always be to share, to help, to bind the wounds and lift up the fallen.

This is our determined cause, adherence to which will forever bring us the respect of others, and earn for us that measure of self esteem which shall itself be the generating power for yet higher deeds of idealism and courage.

We have come here to thank you, Mr. President, for the inspiration you lend for this tradition to aid overseas, the faith you have in this program and to note, as well, with gratitude the material support afforded this work. Three billion pounds of food are being made available to our agencies each year through your Food for Peace Program. Benjamin Franklin said in 1771 "Men should show their gratitude to God by the only means in their power — promoting the happiness of His other children". This, you have insisted in your own Inaugural words, is the right thing to do. 

Born October 4,1904 in Lithuania, settled in the United States as a youth, is an American citizen. Married, has 3 children.

### Education:

Graduate of Howard College, Birmingham, Alabama ( now University of Birmingham), major subjects Administration and Economics. Has taken postgraduate courses in Administration of Public Welfare and in Social Work at the University of Cincinnati, Ohio.

## Employment History:

Until 1947, most of Mr.Lipian's work career was in positions of a public nature in United States government service, as statistician, economist or administrator.

He served first in various survey and consultative assignments in the various Emergency Relief Administrations in Ohio and West Virginia, then as State Statistician of the Works Progress Administration in West Virginia, and was then again advanced to State Director of Finance and Statistics of the National Youth Administration in West Virginia.

He was subsequently transferred to Cleveland, Ohio, as Regional Finance and Statistics Officer of the National Youth Administration, assuming responsibility for the finance functions of 12 states in that Region.

Mr.Lipian was then again transferred to Washington,D.C. to serve first as National Chief Statistician and Budget Officer, later as National Assistant Director of Finance and Statistics of the National Youth Administration. In this position, he assumed primary responsibility for budget and statistics functions for this agency for the entire U.S.A.

During World War II, Mr. Lipian moved to San Francisco, California, in 1943, where he became employed as Regional Director of Administrative Management for the National War Labor Board in that Region.

Shortly after the evacuation of the Japanese population from the West Coast during the war, Mr.Lipian was transferred to the War Relocation Authority and assigned as Assistant Project Director( Director of Administrative Management) for the War Relocation Center at Poston, Arizona, with a population of 18.000 evacuees. His next assignment was as Assistant to the Regional. Comptroller of the Federal Public Housing Authority for the Region headquartered in San Francisco.

Mr.Lipian left the Federal government service in 1947 in order to be able to work directly with the problems of displaced persons and refugees in Europe. He was employed by the American Joint Distribution Committee as Director for Bavaria, Germany, where he assumed responsibility for this organization's relief and rehabilitation program in that area, involving over 130.000 Jewish displaced persons in 26 camps and over 100 other displaced persons installations.

Following this overseas assignment, Mr.Lipian returned to the U.S. and was in business for himself during 1950-1953.

In 1954 he was appointed Northwestern Regional Director for the City of Hope, a national medical center located at Duarte, California, maintained entirely by private voluntary contributions. In this position he was in charge of all activities in connection with this organization( principally community organization, public relations, fund raising, and overall administration and coordination) in the states included in his Region. His headquarters were in San Francisco, California.

Mr.Lipian was re-engaged by the American Joint Distribution Committee towards the end of 1955 as Deputy Director for that organization's program in Iran, and subsequently became its Country Director. This position involved the administration of an extensive program, including medical institutions and services, sanitation, educational facilities, children's day care centers, feeding and clothing distribution, cultural, religious and recreational activities, direct social services to individual cases, community organisation and development of local leadership and local responsibility, as well as other facets of a large and varied program to raise the standards and improve the conditions of the approx. 80.000 Iranian Jews.

After 4 years in Iran, Mr. Lipian was transferred on February 1, 1960 to Austria in the capacity of Country Director for the American Joint Distribution Committee program in that country. This position involved the administration of programs of all types of welfare assistance to the remnants of the Austrian Jewry, and to needy Jewish escapees from countries behind the Iron Curtain; assistance to newly arrived immigrants to Austria in integrating into the economy of this country; close liaison with local Jewish community leadership in all phases of community and leadership development; and continuous guidance, consultation and financial assistance to the local Jewish institutions, i.e. schools, hospital, home for the aged, summer camps, loan funds, cultural and recreational activities, and related programs.

Rabbi Recalls Jews' Struggles

By Tom Haywood Town Talk Staff Writer The tragedy is beyond comprehension millions of human beings systematically destroyed by one of the most civilized countries of Western Europe, because they were Jews — a barbarism that is now known as the "Holocaust."

The horror Rabbi Herbert A. Friedman witnessed in Germany as a chaplain with the 9th Division in World War II "burned into my soul" and heightened his growing awareness of Zionism to a fever pitch.

The world renowned authority on Judaism moved to his beloved Jerusalem in 1971 and looks back over his years helping the victims of Hitler's Germany as a turning point in his life.

"It shook my faith in modern 20th century man," he says. "I had faith in man and then I see one do this to another one, and no one tries to stop them.

"It burned into my soul, but all you can do is try to pick up the pieces," he continued. "The dead are dead, but you can make damn sure it doesn't happen again."

The only way he believed that would be possible is if the Jews had a country of their own to protect them from "being chopped up and shoved into ovens against their will."

Friedman first became interested in Zionism in 1934 as a 16-year-old freshman at Yale It was the year after Hitler rose to power.

"I thought, 'My God, he'll do everything he said he would do in his 1925 book (Mein Kampf); he now rules the country!'"

His experiences among the dead and the barely living of postwar Germany made Friedman a more ardent supporter of the fight for a Jewish state.

"I worked for it all the time until it was realized in 1948."

As one of the persecuted, Friedman is not indifferent to the plight of the Palestinians who fled their country after the 1948 Israeli war for independence. Neither does he feel guilt.

"The question is, 'Did they have another choice?" he says.

It is analysis of Israel's needs is prefaced by a chronicle of Judaism's history in Europe and Palestine.

Immigrant Jews trickled back to their ancient homeland, part of the crumbling Ottoman Empire, in the late 19th Century. That trickle turned into a torrent in the 1930s as Jews sought refuge from Fascist persecution in Europe. By 1948, there were 50,000 Jews and 1,250,000 Arabs in the former Turkish province ruled by the British.

Following the partition of the country, open

war broke ou between the two factions. The Jews prevailed and the state of Israel was established.

Vast numbers of the Arabs then chose to leave their homes rather than live in the Jewish state, Fredman continued. Many today still live in the refugee camps surrounding Israel as unwercome guests of Arab neighbors, part of a problem that has "festered for the past 30 to 40 years."

Friedman summed up his feelings of the Palestinian question by quoting Israel's first prime minister, Chaim Weizermann, who said, "It is a human tragedy. It is not that we're right and they're wrong. It is a conflict of two rights.

A bi-national state could have been possible, Friedman believes, "but that's not the way it turnedput."

"They keep trying to knock us out of the box and they just aren't going to do it."

Friedman sees only two solutions, a Palestinian homeland on the West Bank or the settlement of the Palestinians in neighboring Arab countries.

The former idea would be totally unacceptable to Israel, Friedman concluded, unless they were willing to live in peace with the Jews, and give up the fight to "push us into the sea."

Friedman was in Alexandria this week to speak at the United Jewish Appeal fund-raiser.


