I wish to associate my colleagues and myself with the invitation extended to you by the Chairman of the Jewish Agency to attend the Conference on Human Needs, to be held in Jerusalem from June 16th till June 19th, 1969.

Over the past year we have held a number of conferences in Israel, dedicated to deepening the links between Jewish communities abroad and Israel, in the fields of investments and trade and in the fields of Jewish education and aliya. The Conference on Human Needs will be the final world-wide conference which we are convening within the context of Jewish unity. In the spirit of Jewish unity, which has reached unprecedented heights, I do hope to be able to welcome you at the Conference on Human Needs.

It was a pleasure having lunch with you the other day. I did not send you the memo which we discussed, because I later learned from Harman that he was scheduled to meet with you and discuss the North-African matter with you in detail.

Let me say this though: after our meeting I discovered to my consternation that a good number of your people talk publicly in the most unrestrained manner about operational and financial details which in Israel are known but to a handful of people. I had a report to that effect from Gershon Avner who attended a U.J.A. meeting in Philadelphia, as well as from others. I was not certain at all, to begin with, that it was necessary for all Cabinet members to know all the particulars, but I consider it even less appropriate - to use a mild term - that they should be so indiscreet with their knowledge in public.

This is merely a personal observation which I felt I had to get off my chest - I know that you agree with me.

Former Ambassador Abba Eban has requested that I summarize for a small group of Baltimore Jewish Leaders the development of Israel's relations with the new independent countries. He refers to the new states of Africa, Asia and the Caribbean as the most important advance that Israel has made recently in the international area. Israel has emerged from her regional isolation and has become a recognized factor in the evolution of the modern community of nations.

The role which Israel is undertaking in this domain is highly approved of by friendly governments, including the United States.

We have already reached a stage in which African nations support us in the United Nations against Arab attacks and exercise pressure on the Arab states in favor of peace. Israel's economy and commerce will also benefit from these relations. Hundreds of the future leaders of new Nations are studying in Israel and hundreds of Israelis are abroad, in the new States, in responsible tasks.

One of the results of this opportunity, however, is that an exceptional financial burden falls upon Israel. Israel maintains more missions in Africa than any, except the Great Powers. Israel initiates international gatherings, such as the Rehovot Conference of 1960, which launched Israel's scientific relations with the new States. At the United Nations Conference on Science in lesser developed areas held during February, 1963, we were more heavily represented than the normal budgetary provision allowed. It is vital that Israel continue to receive visits by African and Asian personalities and to pursue her educative role amongst the new leaders of nations.

In order to sustain this work over the next year or so, it is hoped to create a special fund of about \$500,000 to be contributed to by about two hundred leading friends of Israel, to whom Minister Eban talked in his recent trip here. It is a primary condition, that this

should not in any way be at the expense of U.J.A. This is why we must approach those in the higher brackets, for whom a contribution of \$2000 or upward is not too great a strain. Israel Bonds are acceptable; and in view of the cultural purpose of the fund, a tax-exempt instrumentality has been secured.

Some of those in the group to which he spoke, have already pledged \$2000 each to this cause. His request is for another dozen or so citizens to be told this story in confidence, so that a Baltimore contribution of about \$25,000 - \$30,000 might be achieved.

Mrs. Golda Meir is fully associated with this emphasis on the importance of this enterprise for Israel's internatinal future.

Rarely has so important an objective been attainable by such modest means. Minister Eban stresses that this request is made after straining his Ministry's budget to full extent.

During the Regional Conference at Del Corenado there were several discussions with Max and myself regarding the scheduling difficulties of the Los Angeles Welfare Fund with the Los Angeles Ternel Bond Campaign.

As you know, within a fee week period there was an important Bond meeting with Abba Eban as well as the Welfare Fund's opening meeting with Avraham Harman. It seems apparent that both meetings must suffer from competition with each other and the image of both must of mecessity be blursed in the minds of the Velfare Fund contributor and the Bond purchaser.

Max and I were made awars of the fact that there exists an understanding between the Los Angeles Welfare Fund and the Los Angeles Bond organization, as to calendar.

This calendar understanding does not take into consideration the change in the timing of the National UJA and Welfare Fund Campaigns which has taken place in the last few years. Due to the fact that the National Inaugural Meeting was held in December this year, the entire National Campaign has been accelerated. This acceleration will continue in the years to come. It is, therefore, important that the Les Angeles Welfare Fund by able to get sufficient breathing time from other communal campaigns to permit it to begin its campaign earlier in the year in line with the National Effort.

I am writing to you in your capacity as a member of the UJA Executive Committee to ask you to attempt to work out a solution of this problem. You are in a unique position to do this due to your leadership in the Los Angeles Welfare Fund as well as the Bond Organization.

Our suggestion is that the Israel Bond Organisation be given the months of July through December and that the Los Angeles Welfare Fund be slietted the months of February through June. The month of January should be assigned to neither so that the community can have a respite from public functions. January could be used quietly by both organisations - The Bonds to clean up, and the Welfare Fund to begin personal solicitations.
