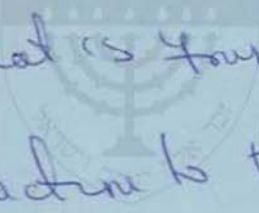

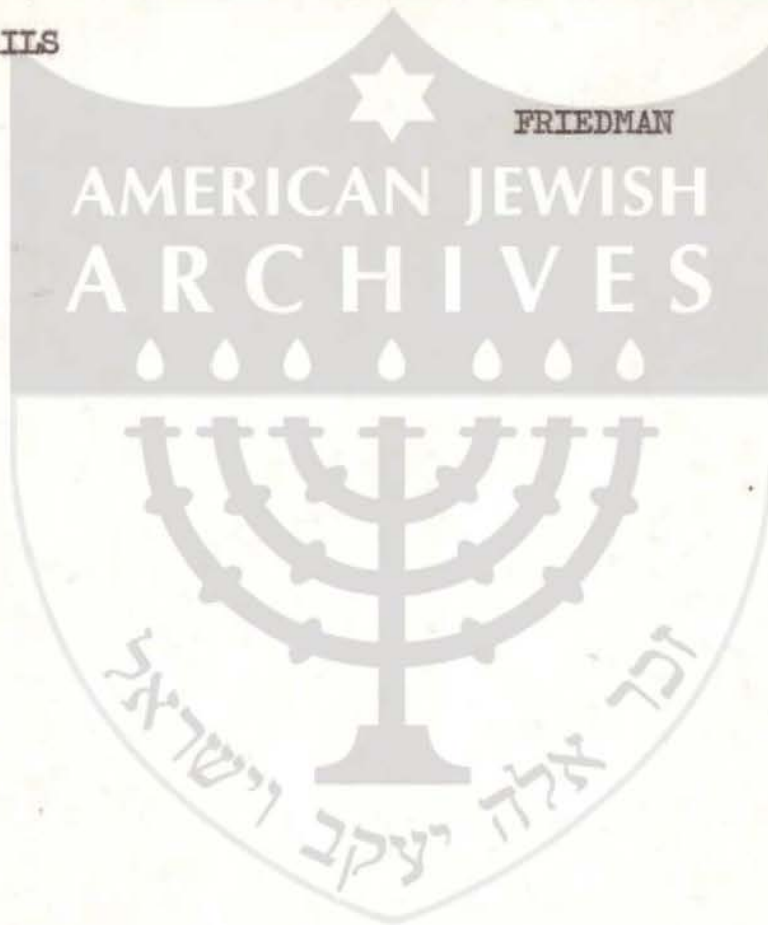

Dear Herb,

Since our exchange of cables several weeks have passed. I was glad to see from yours that the period of time, which I suggested in my second telegram, was acceptable. As you may recall I mentioned in our conversation over the phone that we are planning to have the Massadah exhibition in Stockholm, with the chance that the Swedish King would attend the opening. Within the hour of my first cable I received the information that this was going to be early February. In fact, in the meantime, I had a final confirmation that the King had set 8th of February as the date of his attendance of the opening of the Exhibition. Thus, I am able to get away from here within a few days thereafter for a period of 4 weeks.

You mentioned that you would want me to get proper briefing in Israel. For that I would be free from the middle of December. It now seems that the Middle East debate and the anti-Israel ritual will be through by about that time, since it is hoped to terminate the General Assembly in the UN by the 19th December.

Would you not think it a good idea that I should include a stop over in Vienna for two days, either on my way to Israel or on the return trip? I have not seen the "Aliya Gate" for quite a number of years.

Finally, I do not require a hotel in Jerusalem, thanks to our apartment.

I look forward to hearing from you soon, and also to see you again.

Dear Max:

I have your letter of 2 November. Your time table sounds just fine.

I think you should go through Vienna, and you can do it either on the way here or on the way back.

I will be going to the States the end of this month and expect to return to Israel 13 December. I will take a week's holiday at home in Caesarea with the family during Chanukah and expect to be back in the office in Jerusalem on 20 December. So, this coincides with your time table. We can arrange any tours you want, in order for you to refresh your knowledge and impressions. You might want to go through the Sinai and the Canal, or some absorption centers or the Beit Shean Valley, or anything else you feel you need.

Right now the thinking in New York is for you to begin in St. Paul around 13 February for two weeks and continue in Minneapolis for another two weeks.

Let me know your plans and I look forward very much to seeing you in December.

Dear Friends:

In keeping with the resolution adopted at the last National Conference of the United Jewish Appeal in Atlantic City, American Jewry is being called upon in 1950 to contribute to the United Jewish Appeal on a scale commensurate with the minimum needs of the agencies as represented in their total minimum financial requirements of \$272,455,800. It was also resolved at Atlantic City that the assumption of a fair and equitable share of the total responsibility be recommended to the communities so that "through the combined labor and generosity of American Jewry we may safeguard and consolidate the achievements in the regeneration of the remnants of our people".

The National Campaign Cabinet of the United Jewish Appeal, after due consideration of all factors, has recommended that Denver's fair share of responsibility toward the total needs mentioned above should be set at \$1,400,000.

I earnestly hope that in the planning of your campaign and in the setting of your local goal this responsibility will be taken into account and that we may have your assurance that your efforts will be directed toward the provision of a maximum amount for the extraordinary needs of the United Jewish Appeal in 1950.

It would not be feasible in a letter to present comprehensively the needs which make it imperative that your community provide the largest possible sum for the United Jewish Appeal in 1950. These needs were examined and assessed as to their urgency and validity by over 1,700 Jewish leaders representing more than 1,400 communities gathered at Atlantic City last November.

The United Jewish Appeal will welcome an opportunity to discuss with you and your colleagues your community's responsibility toward meeting the total requirements of the United Jewish Appeal agencies in 1950 as well as your campaign plans in general. I look forward to word from you in this connection.
