I look forward to hearing from you in the near future. I hope that we will be able to pursue some of these issues on the telephone as well, so as to insure that we cover all the programmatic pieces of what promises to be a very exciting Retreat. Many thanks.

Dear Rabbi Friedman,

On behalf of the LDC Retreat Planning Committee, I would like to thank you for agreeing to guide our retreat from October 23-25, 1981. We have tentatively selected as our theme "The Evolution of the American Jew". We hope this will allow discussion of historical information, the spiritual foundation of our Community, and the emotional components of being Jewish in America. Our preliminary questions are "What are we?", "How did we get here?", "Why are we ehat we are today?", "Where are we going?", and "How do we get there?". Obviously, this is a broad approach and, in view of your experience, we wish to be very flexible with regard to specific lecture topics and content. Please feel free to suggest any specific emphasis or changes which would be suitable to you.

We hope that our Resident Scholar will be available and become integrated in all the activities of the weekend. In general, previous Retreat evaluations have asked for more active participation by the membership in discussions, and so we thought that a small group approach at various sessions should be tried. Nevertheless, we do not want to impose a fixed structure upon you and welcome the opportunity to "negotiate" our format.

A tentative outline of our program includes the following:

Friday- Bus trip to Fallen Leaf Lake-Stanford Camp (South of Lake Tahoe). In the afternoon, after settling in, an opening ceremony and introductions/"ice-breaker", followed by a wineand-cheese reception, Shabbat Service, dinner, and an opening lecture (appx. 14-14 hours).

Saturday- A Morning Service after breakfast, followed by a lecture/ discussion (appx. 2 hours) and lunch. After lunch (and perhaps beginning at lunch) group discussions and another lecture/ discussion (appx. 1½-2 hrs.) followed by free time (with optional workshops), a reception, dinner, an evening entertainment program (singing and dancing), followed by an Havdalah Service.

Sunday- After breakfast, a lecture/discussion (appx. 2 hours) followed by lunch and a closing ceremony.

Our group will consist of approximately 100-115 people, predominantly couples, but with 15-20% singles. Almost all our members are in the 25-40 year age range, with a professional work background. For many young adults, our LDC is an entree to the Bay Area Jewish - Rabbi H. Friedman page 2

Community, and the Retreat sets the tone for the LDC year. Although we are an organ of the Federation and many of our members work in the Campaign, we are not a soliciting group <u>per se</u>. There is considerable diversity amongst us with regard to place of origin, religious affiliation and concern, political background and sophistication, and degree of participation in the Jewish Community.

If it would be convenient for you, we would like to telephone you in approximately two weeks time, or at some other specific time that you might find convenient, in order to discuss our plans and confirm our arrangements. Perhaps you could communicate this to us through the Federation and Rabbi Lurie.

Once again, I would like to thank tou in advance for your participation in our Retreat. Your presence will, I believe, make it for us an exciting and memorable experience.


