

Morocco 200 Tunisia 60 Algerian 135



Sam Haber

Rich, middle, poor (who are desperate poverty and are in fear) all feel that Jewish community of Morocco is coming to end. JDC program assists 40 m children and 10 m adults and this assistance is life or death. Without JDC these 50 m would have no bread.

Moroccan earth is not earth on which Jewish life can endure or prosper. 80m Jews have left Morocco since 1948. Year ago, Moroccan government stopped emigration but thousands got out anyhow. But now doors are really locked. 1,500 Jews stranded in Tangiers. Right to exit is in jeapordy.

On mid November, King of Morocco going to US
Jews should meet with him to impress him with these two demands:

1. right to exit

2. right of Jewish community to enjoy seffermanon

Economic conditions very bad. Jews losing jobs - even middle and rich are leaving. Prime Minister of Morocco says they will join Arab League
This is obviously very bad for Jews.

I see no other destiny for Moroccan Jews except Israel. This is desire of Jews. If you put boats into Casablanca, you would take out tens of thousands of Jews immediately.

- 1. Hemp them in Morocco
- 2. Help them get out.

C. Jordan

Border of Morocco is sealed - whole Moroccan border police is on alert for Jews. Jews are slipping through to Tangiers and are bottled up there. We simply must help these people keep alive. We are maintaining 1,500 at moment in Tangiers with the tacit approval of authorities in Rabat.

Jewish Agency has camp in Gibralta. Medical reports there are very bad. Children were emaciated, and some died on ferry from Tangiers to Gibralta.

H. Levy

June, 1956 Jewish Community of Algeria insisted that JDC open office. Problems of Morocco will become true in Algeria and in near future. All 130 thousand Jews are French citizens (except 3 thousan) and have same difficulties as Frenchmen, but additional troubles as Jews.

Rabbi killed in Medea by Arab terrorist and with loss of leader, the community disintegrated. people fled. When two rabbis of Algiers received threatening letters, they left for France in 48 hours - and Jewish life suffered.

Jews are being asked by Arabs to take sides. And some french elements (anti-Semitic) have also threatened Jews if they take sides.

) Jews lost citizenship in 1940)

Jews of Algeria are in suspense while they wait, steady trickle of 2,000 per year go to Israel. About 2,000 also go to France. Everyone is waiting to see what happens. There may be a repetition of mass flight, like Hungary and Egypt.

Egypt Miss Berche

(26,000 have left (of estimated 50) and mass movement has spent itself. Still 500 - 1,000 per month. Urgent pressure to leave has reduced (this is like 1933-38 Germany) Policy of Egypt is to make Egypt Judein-rein. Those Jews who remain are living in a fools paradise.

Three populations in Egypt -- Copts 4-6 thousand - old families-- Arabs 18-20 thousand foreigners and Jews (considered as one group from govt point of view

I went to see particularly the aged

Jewish community huxkingxof Cairo owns 47 buildings, all but few in ruins and unsalable. Jewish quarter empty and occupied by Arabs, except for few old Jews like specters.

Children attack old Jews with support of adults, throwing dirt, etc. Many (saiss Greek Copt) fled told me Egypt would soon be a country behind the Iron Curtain .

62 men and 49 women in aged home, all ill, many blind, paralyzed, cripples.

Alexandria very different from Cairo. Community in Cairo broke down, but in Alexandria a council of 3 men took responsibility. There is one school, one trad e school, one hospital (requisitioned by Egyptain army), two homes (30+7 patients) 80 indigents.

Macabre mood - when a funeral took place, people said 'soon it will be our turn'

Prolongation of "residence" is terrible problem. Prison is alternative. No medicines are coming in and Egypt medicines are no good. Supply mission for medicines to satellite countries also produced nothing.

Jews have absolutely no possibility to work.

E. Laor

14,000 Egyptain Jews went to Israel. Thus 11 or 12 went elsewhere. There might be another 25 in Egypt of which major part will be leaving. Last month 500 to Israel and 200 elsewhere Jews are leaving slowly because they know the ICRC is still there, but if ICRC should ever withdraw, there would be a disorderly panic rush.

Lou Horwitz

Brazil and other SA countries - already have taken 2,000. and 200 per month present rate 1958 - US will also take some (probably 2,500) 1958 - probably take 4,000 Egyptain Jews, both from E itself and from western Europe.

E. Laor

Syrian Jews (5,800) living in most dire plight and poverty. We tried to get them into Turkey - but probably no luck Katzki says JDC sends regular relief funds.

Leavitt says there are impoverished and in danger of lives.

Something must be done for them. Their plight is the worst of any Moslem country.

Relation of regulations in Egypt might refer to a small group and these might even remain, until there is actual physical danger.

Only 2,000\$\oldot\$ Jews in Austria at present time. Report on historic handling of Jan. Feb. 1957 **Mex Jewish Agency moved 25,000 Polish Jews. Through Vienna during same year. Marvelous achievement.

Same cars which took Jews to death decade ago, from Poland to Mathausen, now taking Jews to life and freedom in Israel

UHS

assisted 11,000 Hungarian Jews paid tribute to organization of communities all over the world who took in refugees.

Poland -- C. Jordan

travelled 10 cities - talked with hundreds - asked repatriates how they got along - the said they got help from Dr. Heyman, whom they never met, but called him a Tsadik.

Described program of JDC in Hungary until 1953, when doctors plot make work impossible. After that we worked through desirous means - never stopped for one day. Gave material relief and saved souls as well as bodies, because Jews knew we were there and this aided morale and kept faith and hope alive.

By 1955 our supplies began to run out and we formed a new organization to provide a relief program. This was called the SSE and Heyman is president

Dr. Heyman is busy lawyer

There are 8 kitchens in Budapest - 3,000 aged receive warm kosher mean per day Aged homes (average age78 without dependents)

SSE operates with Kadar approval, which is willing fur us to do welfare job because it means dollars for Hungarian govt (which is acceptable to US State Department which knows about it)

If forces of revolution are ever again unleased, what will immediately follow will be a progrom. This was barely avoided last time. Will not be avoided this time. The place is loaded with dynamite.

Jews left Hungary legally until 1957-June- now administrative difficulties. Jews of Hungary are yearning to leave. The revolution ended too soon.

Czecholsovakia

We have also worked there. Dr. Heyman has offered help in Prague, but it was refused by govt because of connection between SSE and JDC.

In June 1957, Prague and Bratistava Jewish communities asked for help from Claims Conference. Otto Heim went in as rapportedr.

There are 80 Jewish community associations in Czecho under 2 main communities - Prague and Batislava. Both communities have rabbis, schools and synagogues. Both secretaries are communists, but good Jews.

All officials say anti-semitism is not very strong.

orthodox

Synagogue in Bratislava full of Yom Kippur - more/than Prague - real good Jews. They were happy at my visit want help from outside. Want no subvention from JDC - but feel that as Nazi victims, they have a right to Claims Conference help. Bohemia Moravia (Prague) Jews are assimilated; Slovakin (Batislava) very Jewish.

Poland

First country to open doors officially to JDC

Repatriates since last October 14,000

Emigrants to Israel from Poland since last October XXX 35,000 (including 4,500 repatriates) 6 March 57 -- Poland stopped emigration of repatriates, under Russian pressure.

JDC was called in to help with the bottled-up repatriates. Why special help? Non-Jewish repatriates are absorbed by their relatives in towns and villages. Jewish repatriates come back and find nobody - only the askes floating in the mid-puddles.

There is no one to help them adjust.

Poles never had any intentions of holding the repatriates - plan was to let them pass through Poland on way from Russia to Israel. But with Russians pressing there is now a problem. JDC has agreed to assist repatriates with immediate living problems, until Poles will let them go. They are all sitting on packed bags.

KATZ

A sad tale in a condensed form

1. Number of Jews

until year ago people were in hiding as Jews and we didn't know. Now we know (matzo count at Pesach). Since last October 34,500 left. Present population is 33,000 Polish and 10,000 repatriates.

2. How many would like to leave

Practically all repatriates would go to Israel. Among Poles 30 who already left (4,500 repeats) were those who always wanted to go to Israel and grabbed first chance. Now the balance of 33,000 Poles, perhaps 8-10 will remain (devoted communists) and old tired without will to start new life and balance will go to Israel (90%)).

3. Why has Poland allowed emigration

Gomulka understands Jews cannot take root in Poland. He knows the Jewish will to go to Israel is strong. He believes in principle of re-union of families.

4. Are we satisfied with present emigration

No

Why are Jews leaving Poland - because of anti-semitism. But this is inadmissable to communist theory. Therefore some communists try to stop emigration, in order not to besmirch the precious theory.

Also, philo-semites say don't leave Poland without Jews

A large migration always creates unrest in a country, because others want to go. So there may be a date given by which Jews must choose to go or stay. No complacency is permissable.

Notes made during Trip to Europe and Israel, October/November, 1958 by Herbert A. Friedman

SHLOMO LEVY -- J.A. - Naples

(This whole interview quotes Levy in first person)

Trains from Vienna (lv. 9.30 p.m.) arrive following midnight in Naples (27 hours). Hotels are taken near Railroad station in Naples, so no need for trucks or buses. Porters carry baggage -- people walk. Cheaper this way. Rumanians bring 70 kilo per person. Hand baggage is carried -- boxes are also shipped to Naples. Agency cost 1700 lire daily for hotel and full pension for adults; 1500 for adolescent; 1200 for children; zero for child up to one year.

On average, olim remain in Naples five days.

Rumanians come without a . People arrive without toilet articles, extra shirt, or any amenity.

Poles come with everything.

Two groups must be kept separate -- and we use separate hotels.

This works, because the two groups have no particular interest in each other.

This is good -- because they don't compare.

I can only give the Rumanians 500 lire pocket money -- whether they stay in Names one day or ten. Maximum is 1500 lire per family. I have no money. I know you will laugh at this.

The Rumanian Jew has no money-0- but he has no longer any fear.

He knows he is going to Israel. His only fear is that he will have to wait too long in Naples without any money. He is impatient to get to Israel. A few want to wait, for relatives to come.

While they wait, I give them Hebrew films in hotel teach them

Hebrew songs -- and if they are going to wait 10 days or two weeks, I give them

simple Hebrew lessons with few necessary words. I have three personnel -

myself, one from who investigates professions and trades to compile a dossier on the people, so that on the ship decisions can be made as to where to send the people; and a third who is responsible for Kashrus. This meshgiach teaches singing. Besides these three Israelis, I have 1½ local personnel. help That is the entire staff. The locals are Italians, who keep with contacts with port officials, etc.

There are two couriers who accompany trains back and forth.

We use Artza, Jerusalem, Pace, other Italian ships.

All immigrants go through a medical exam in Naples, including X-ray and blood. We have an arrangement with local authorities. It costs us each 450 lire per person. We use autobus, from hotel to clinic. We have an talian Jewish doctor who gives us the results of the examination, and the papers accompany the olim. Each person carries his own envelope, together with his port pass, and his passport. Each person also receives vaccination in Naples. All medical stuff can be done even in one day. If the emigrant is in Naples less than one day, all we do is vaccinate.

I do not know the reason why they were allowed out. No one knows.

Some have waited eight years for exit permits -- some applied fax only few months

ago. Some have relatives in Israel -- some have none.

Don't know how long it will continue -- the people believe it will go on for some time.

(end of Levy interview)

Met with Rumanians in hotel. One family -- husband and wife,
both dental surgeons, one son going to be Bar Mitzvah 25 October. Second family -husband, woman's tailor; wife, housewife -- two sons, 13 and 10. First family
had sister in Israel -- second family had mother. Both families had waited eight
years for permission to leave. Both violently vociferous about wanting to leave
for freedom and national Jewish feeling. Lived in slavery. Worked clandestine
to make ends meet. Used to listen to Kol Zion Lagolah. Hungered to get out.

Will do anything in Israel. Dentist said he would go anywhere to practice his profession. Tailor said he would build houses. Feeling was obviously strong and sincere.

I asked about fear of going in to Israel surrounded by enemies.

They laughed. Mother of two boys said she would bring her sons to the army herself to defend Jews. They had enough of being killed without chance for self-defense.

Biggest problem is buying oneself out. Average cost for family of three is 10 - 12,000 lei (average wage of tailor was 500 per month -- so this is two years' earnings). The papers require plam-greasing. Renunciation of citizenship costs 1,000 lei per person. The tax departments must all be cleared -- and exorbitant fees are levied -- also telephone, electricity, etc. To make a box for belongings costs 500 lei. Three months rent must be paid in advance. Etc., etc. There is a real problem of people who do not have the money, and whose pass expires before they get the necessary papers. The people sell their belongings frantically -- a television set costing 4,000 lei sells for 800, etc. To get the necessary money together is terrific problem.

Young girl, student of philology (French and English), came to table. Her father, mother, etc. all went to Israel in 1950. She couldn't get out then, because she was young (20) and waited all these years. Said it cost her 4,000 lei. She didn't want to tell her name, because she was afraid, and had family still behind in Rumania.

Reported anti-semitism, nothing official -- nobody says "ditty Jew" -- but one feels it all around -- in university.

Of group of 48, who came on one frain from Vienna to Naples, were 4 doctors, 2 or 3 small businessmen, few artisans, several plain workers.

One man came over -- 37 years old -- worker in factory (tin roofing) -came from province. Worked four years for Germans under forced labor. Had
enough -- wants to get to own land. Kept repeating that everything was fine in
Rumania (afraid to say otherwise) -- wants to get to Israel to see old mother.

Very shifty about where he got money to pay for papers and finally whispered
"legation". This is answer to money question. The people are helped.

All reported that they had been very well taken care of on the road -coffee and rolls in Rome, etc. Worker wanted few lire to buy cigarettes -otherwise he has everything. Worker was rough, crude, but spoke with vox populi.

POLISH IMMIGRANTS -- another hotel

Repatriates are coming out as invalids. Any paper can be bought for money. Poles apparently have no central control -- they aren't adding total number of invalids.

One man -- chemical engineer -- old inhabitant -- tried since

April 1957 to get pass -- refused -- finally wrote that he was willing for wife

to go alone -- she got it -- he returned to Ministry four times -- finally got his.

Economist -- young man -- said Poland is not interested in holding

Jews. Sooner or later all will come out -- not as invalids.

Whole group (5 people -- all different backgrounds) agreed that all Jews would come. Polish government knows that this invalid business is a pretext -- they look through the fingers and want to permit Jews to go.

Beginning this month, the Poles have been accepting applications, even without the invalid document.

No limit on baggage.

Still shipping out pianos, etc.

We have read the bad letters from Israel, but we are going anyway. We feel we can make it.

I've made three beginnings but I'm willing to try another.



HAR-EL -- Minister to Buchearest

Encounters of legation personnel with local Jews limited.

But powerful.

Once we came to Jassy on occasion of anniversary of 1943 pogrom.

Communist officials were present. Nevertheless Jews followed our car and cried

"nimmt uns weck."

Another time, in small town, hundreds of Jews surrounded our car, and children touched our flag on the fender. Some adults, afraid, said to kids "stop" -- other adults said, "let them have the pleasure".

Another time, in a synagogue on Sabbath, an old rabbi gave a speech saying that Jews always had a hope that they would come to their own land. This was very courageous for him.

In one synagogue there was once a recitation of the prayer for the government, in which the rabbi said "we pray for the success of our beloved country (and) the People's Democracy of Rumania." By adding the word "and" he gave the true feelings.

50% of Rumanian Jews would try to leave. At present 250,000 we think.

38,000 adults have already registered for aliyah: Rate of registration in July and August, rose. Jumped to 3400 in one day last week. At this rate, by end of November if registration continues it will be 50 - 60% of population. Balance will probably register later, if they see that aliyah really continues.

Impossible to say why Rumanians permit it, and therefore how long it will continue. We live in legation in tension. One day last week they stopped issuing passports. We lived through 24 hours of panic and hysteria. Can't describe how people besieged us.

In four or five days, man must get exit papers, ^Israel papers, plus three transit visas -- Hungarian, Austrian, ^Italian. We do administrative preparation for these three embassies.

Cost of leaving is not cheap.

1,000 lei to renounce Rumanian citizenship

315 for passport

500 for ticket

6 per kilo baggage.

AMERICAN IEWISH

Family of four is approx. 7,000 lei. This is approx. \$600. -- expensive for poor people.

No one stays because property must be sacrificed. All are willing to leave everything without a second thought. This fact impresses us with the idealistic calibre of this aliyah. 70% are under 50; 30% are under 18.

Professional training is high -- many doctors, etc.

Two problems -- how steady and how permanent will be this new policy of Rumanian government; and how good will the adjustment of the first groups be in Israel. If there are many returnees, those in Rumania who want to stop this aliyah will use this as the strongest argument.

There is no reason to assume that aliyah should stop within newt few months.

Question -- why do they leave if they can have Jewish religious and cultural
life in Rumania? Only thing I have heard is bad economic conditions.

Answer -- they feel insécure about future as Jews. They remember pogroms of past. They are not adjusted in communist economy. They think of their children.

Of the five conductors of the Bucharest Opera, three are Jews and have registered to leave. This is not for economic reasons, because they are very well off.

GENEVA -- 31 ctober

Charlie -- Relief-in-Transit

We have 26 people working inside these countries. They have recruited larger local corps of volunteers. We get money into those countries -- not legally. Spending three million on this program.

Hungary -- 20,179 families got food parcels

3,000 " assisted with cash relief.

Rumania -- (uncooperative) (no parcels from organ.)

Individual senders found in Israel -- we send \$800,000 worth per year.

We could triple the volume of help, with more money. The contacts and organization exist.

Our assistance has moral as well as material meaning.

Russia

We can only reach 2,870 families k, with money available. We send cloth, which they can sell.

Total is 30,000 families in all Iron Curtain countries, which we have carefully selected. This is really nothing.

Hungary -- Dr. Heymann

Jewish situation has deteriorated. 55% of lawyers have lost right to practice. We give minimum of \$13 per month. Clothing distribution is most important. 72% of our proteges are over 65 -- mostly womet. Young people left Hungary -- old are left alone. Our kitchens (8 in Budapest) feed 2-3,000 Kosher meals daily. They bring can and take food for evening or bed-ridden.

We have hospital of 100 beds -- only one not belonging to government. We have five old people homes. We take care of religious needs. More than 25,000 people are getting help from us. We send # 320 kids to summer camps.

Poland -- Haber

Why did Polish government invite JDC back? Because she would not handle the repatriates.

Why don't repatriates want to stay in Poland?

- 1. Poland is a desert
- 2. Antisemitism, under new freedom
- No Jewish life -- organization is Communist.
- 4. Irrational Fear, insecurity.

AMERICAN IEWISH

Our program is not long-range.

We are working on a temporary basis, to help people now, in transit. We are helping 15,000 people, with a tiny subsidy (\$13. per month), in a private social security system.

School lunches (12 c. per child) in seven Jewish schools.

3,000 Jewish kids in summer camps -- learned they were Jewish again.

3,000 people in ORT schools.

Re-entry of JDC means big moral support to Jews -- they know they are not alone.

Henry Levy -- NORTH AFRICA

1. Integration -- "become like us."

Pressures on Jewish organizations, changing form of community councils, no mail to srael, Zionist background dangerous, two JDC personnel expelled from Morocco.

2. Emigration -- Tunisia free -- assisted -- in growps.

Morocco -- closed -- but this doesn't mean no Jews travel. Bedders don't stop them.

If a person has no money, and can recoup nothing from selling property -then he goes (according to his own words) to the "Legation" and "one hears"
that money can be obtained.

Dear Erich,

You may have heard by now that I am planning a trip to Rumania, for the same purpose as the trip to Poland last year -- namely, to accumulate human interest stories and to gather the general mood and atmosphere of the Jewish community, so that I can report first-hand impressions to cam paign leaders.

Naturally, I queried Israel and received a reply from Shimoni that the trip was OK. I have put in a request for a visa, as a tourist, with no official status. If the visa is granted in the normal course of events, I will go. If it is not granted, I do not intend to make any fuss or protest, but simply to forget the project.

If it materializes, I will leave New York on 3 January and will be in Paris or Geneva on the 4th; then plan to go to Vienna on the 5th and go from Vienna to Bucharest on the 6th. Naturally I want very much to see you before going in. I am prepared to meet you anywhere at your convenience on the 4th or 5th. If you happen to be in Paris on the 4th I will see you there, and will then not go to Geneva. If you happen to be in Vienna, then we can meet there and I would not stop in either Paris or Geneva.

If you could let me know your plansfor those two days and where you would suggest we meet, then I will make my travel plans accordingly. As you can see, there is not much time left. Also, if the visa is refused, then of course the whole deal is off and I will not be coming at all. Let me hear from you as soon as possible.

I might have to be in Geneva on the 5th, while on 6th I have to proceed to London. Anyhow, upon your notification I shall let you know my program.

As to my further movements, I shall leave London on the 9th or 1oth of January, going straight to Vienna, where the Keren Hayessod is holding its European Conference from the 10th to the 12th of that month.

I have not cabled you the emigration figures of Roumania on the 10th instant, because Dr. Joseph came through Paris on that day, so I gave him all the details. You probably obtained them from him. I cabled him on the 15th, giving the total for the first fortnight of this month.

The total figure until today, the 18th, both through Vienna and Athens is 3092, for this month.
