

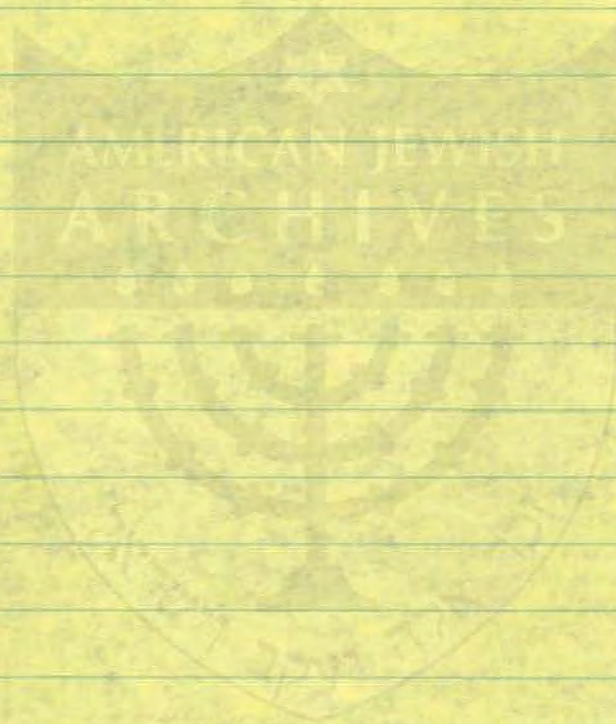


Dear Mr. Crown:
