

### Rabbi Jack Bieler

Rabbi Jack Bieler, as of the beginning of the 1988 academic year, will be assuming the position of Coordinator of Judaic Studies Curriculum, Supervisor of Instruction and Teacher Trainer for Judaic Studies, as well as occupying the Hebrew Academy Talmud Chair of the Hebrew Academy of Greater Washington in Silver Spring, Maryland.

Rabbi Bieler's particular curricular interest is in the area of interdisciplinary studies both in terms of Jewish as well as secular subjects, and has written and lectured about integrated learning in the Yeshiva day school.

Rabbi Bieler has received a Gruss Excellent Teacher's Award as well as a Jerusalem Fellows Fellowship under whose auspices he studied in Israel during 1985-6.

Rabbi Bieler is a public school graduate, received A.A., B.A., and M.S. degrees as well as Ordination from various schools of Yeshiva University, and studied in Israel at Yeshivat Kerem B'Yavneh and Hebrew University. He is married and has four children.

## BIOGRAPHICAL SKETCH

DR. NORMAN LAMM  
President, Yeshiva University

Dr. Norman Lamm, <sup>WHO</sup> elected president of Yeshiva University in August 1976, has brought to the office a sensitivity to the University's strengths and needs gained as a former student and faculty member and as a parent and distinguished alumnus whose travels and writings have earned him a prominent position in the Jewish community.

A rabbi, philosopher, teacher, and author, with a background in the natural sciences, Dr. Lamm's wide scope of scholarship and interests ranges from religious philosophy to the areas of human rights and the seeking of solutions to modern problems in light of Talmudic law.

The first American-born president of Yeshiva University, Dr. Lamm succeeded Dr. Samuel Belkin (1943-1975) and Dr. Bernard Revel (1915-1940).

Yeshiva University, in New York City, is America's oldest and largest university under Jewish auspices, tracing its origins to 1886. An independent institution chartered by the State of New York, it is accredited by the Middle States Association of Colleges and Schools and by specialized professional agencies and offers programs leading to bachelor's, master's, and doctoral degrees for 7,000 men and women. It has a \$219 million budget for its extensive teaching programs and maintains a network of affiliates, issues publications, conducts a widespread program of research and community service efforts, and has a museum. Under its admission policy, there is no discrimination in regard to sex, religion, age, race, color, or national origin. Yeshiva University's Main Center is in Manhattan's Washington Heights with three other major centers in Manhattan and the Bronx, and affiliated campuses in Los Angeles and Jerusalem.

### A Tradition Nurtured in America

Dr. Norman Lamm has brought to the presidency the vigor of Jewish tradition nurtured in American soil. Born in the Williamsburg section of Brooklyn, N.Y., December 19, 1927, the son of Samuel and Pearl Baumol Lamm, he received his elementary and high school education at the Yeshiva and Mesivta Torah Vodaath.

To further his Judaic heritage and scholarship and expand his own horizons through a liberal arts education, he entered Yeshiva College, the liberal arts unit of Yeshiva University, in 1945, majoring in chemistry. The Israeli War of Independence in 1948 was to test his skills learned in the laboratory when, as a student, he was asked to work on a secret munitions project for the struggling state. The project was headed by Dr. Ernst D. Bergmann, who was later to become head of Israel's Atomic Energy Commission. In 1949, Dr. Lamm was awarded the bachelor of arts degree summa cum laude from Yeshiva College and was class valedictorian.

Upon graduation, Dr. Lamm continued his scientific studies at the Polytechnic Institute of Brooklyn while maintaining his Jewish studies at Yeshiva. He was ordained a rabbi at the University's affiliated Rabbi Isaac Elchanan Theological Seminary in 1951 and earned a Ph.D. in Jewish philosophy at the University's Bernard Revel Graduate School in 1966.

While at Yeshiva University he studied under two scholarly giants: Dr. Samuel Belkin and Dr. Joseph B. Soloveitchik. Under their guidance, Dr. Lamm was able to focus more clearly his interests and aspirations. And it was Dr. Belkin, Dr. Lamm has pointed out, who aided him in choosing the rabbinate rather than science as his career.



### In The Pulpit

Prior to his election as President of Yeshiva University, Dr. Lamm was spiritual leader of The Jewish Center in Manhattan and had been affiliated with the Center since 1958.

He was also the rabbi of Congregation Kodimoh in Springfield, Massachusetts, from 1954-58, and assistant rabbi at New York City's Congregation Kehilath Jeshurun in 1951-52.

### Alumnus Joins the University Faculty

Dr. Lamm was appointed to the faculty of Yeshiva University in 1959, serving first as an instructor of philosophy. Rising through the ranks, in June 1966 he was appointed Erma and Jakob Michael Professor of Jewish Philosophy, a University appointment. His teaching career was augmented by his efforts at Brooklyn College of the City University of New York, where he was visiting professor of Judaic studies in 1974-75.

### Acclaimed Author

Dr. Lamm has gained wide recognition for his writings and discourses on interpretations of Jewish philosophy and law in relation to problems involving science, technology, and philosophy in today's society. A man of faith who has written sensitively of doubt, he has published extensively on Talmudic law, in particular in comparison with American constitutional law.

His major work, *Torah Lishmah* (1972), deals with the religious philosophy of the Hasidim and their opponents, the Mitnaggedim, in eighteenth and nineteenth century Europe. It is to appear in an updated English edition in October 1988.

Another of his many works, *The Royal Reach: Discourses on the Jewish Tradition and the World Today* (1970), deals with a variety of themes, offering Jewish viewpoints on such issues as violence, law and order, space exploration, and parent-child relationships in the contemporary world. His book, *Faith and Doubt* (1971; 2nd Ed. 1986), deals with such subjects as religious doubt, privacy in law and theology, the moral revolution, the religious implications of life on other planets, ecology in law and theology, and a Jewish ethic of leisure.

In another book, *A Hedge of Roses: Jewish Insights into Marriage and Married Life* (1966), he calls for a return to traditional rules regarding marital sex as a means for reversing the trend towards an increasing number of failed marriages. Since 1966, it has been published in seven editions, three in the U.S.A. and one in England, and translated into Hebrew (2 editions), Russian, and Portuguese. Dr. Lamm is also co-editor of *The Leo Jung Jubilee Volume* (1962), *A Treasury of Tradition* (1967), and *The Jubilee Volume in Honor of Rabbi Joseph B. Soloveitchik* (Hebrew, 1984). *The Good Society: Jewish Ethics in Action* (1974), spells out the moral teachings of the Jewish tradition in the areas of the individual, the family, and society. He has published a number of articles in the *Encyclopedia Judaica*, and his pieces have appeared in a variety of Hebrew and English journals, both scholarly and popular, throughout the world. "Judaism and the Modern Attitude to Homosexuality" appeared in the 1974 *Encyclopedia Judaica Yearbook*. Dr. Lamm was the founder and first editor of *Traction*, and he has contributed articles to it at various times during the past 30 years. He was also associate editor of *Hadarom*, a journal of Jewish law.

In recent years he has published extensively in "pure Halakhah" (Jewish law) in such journals as *Hapardes* and *Torah She'be'al Peh*. Most of these articles originated as the annual Halakhic lectures (*Sheur Kelali*) delivered every spring before the entire Talmudic community at Yeshiva University—faculty, students, and alumni alike.

The Library of Jewish Law and Ethics, edited by Dr. Lamm since 1974, encompasses a series of works concerning contemporary ethical and Halakhic problems. Fourteen volumes have appeared to date. He is also editing another series, "Studies and Sources in Hasidism, Kabbalah, and Jewish Thought."



## Jewish Law and Jurisprudence

Dr. Lamm's writings have been quoted in landmark decisions of the U.S. Supreme Court. In the 1966 "Miranda" decision regarding police interrogation of detained persons, Chief Justice Earl Warren, in delivering the opinion of the Court, referred to Dr. Lamm's "The Fifth Amendment and Its Equivalent in the Halakha," published in *Decalogue* magazine. The same work was referred to in another landmark decision by the Supreme Court, delivered by Justice William O. Douglas who, in 1967, quoted sections of the article concerning constitutional guarantees against self-incrimination.

In 1967 Dr. Lamm was invited to testify before a U.S. Senate subcommittee on the right of privacy from the point of view of Jewish law. His testimony, and his article, "The Fourth Amendment and its Equivalent in the Halakha," from *Judaism* magazine were published in the *Congressional Record*.

In 1970, during a half-year sabbatical spent teaching and lecturing in Israel, Dr. Lamm proposed a solution to the recurring religious issues surrounding leisure and the Sabbath observance in a modern, technological state. Known as "The Rosh Hodesh Plan," Dr. Lamm proposed that the first day of every Hebrew month—Rosh Hodesh—be declared a legal holiday so that Israeli Jews would be free from work and able to participate in public or private events without desecrating the Sabbath. The plan was submitted to the Knesset, the Israeli parliament and, although tabled for further study, evoked much comment throughout Israel and in other parts of the world.

Dr. Lamm's close association with the law was again evidenced at a University convocation in May 1977 in honor of his inauguration as president. At the event, the University awarded honorary doctoral degrees to the Chief Justices of three nations: Warren Burger, U.S.; Bora Laskin, Canada; and Joel Sussman, Israel. The event drew international attention.

### A Traveler and Lecturer

Dr. Lamm has traveled over much of the globe, lecturing in nine countries on five continents. In 1961 he spent a month in India and Pakistan on a special religious mission to the ancient Jewish communities there. In 1964 he toured South Africa for one month, lecturing on behalf of Jewish education and identity. He also made trips to Australia and New Zealand in 1973, spending six weeks lecturing to the Jewish communities of those nations. In 1975 he participated in an international colloquium of political, scientific and religious leaders of all faiths, held in Italy, which sought ways by which faith might contribute towards solving the problems of poverty and hunger in the 20th century. Prior to assuming the presidency, Dr. Lamm was a member of The Jewish Center Lecture Bureau, and he has also lectured on behalf of Yeshiva University service units.

Since 1985, Dr. Lamm has delivered the annual Kinus Teshuva lecture in the period during the High Holy Days. It is a tradition that was begun by Rabbi Joseph B. Soloveitchik. At the University, he occasionally gives courses in Talmud and Jewish philosophy and thought.

In his position as President of Yeshiva University, Dr. Lamm has addressed himself to contemporary issues within the framework of Jewish tradition. For example, in 1979, in an address to the Rabbinical Council of America, he averred that "essential pluralism is the very heart of Halakha." In another speech, delivered in 1980 to a National Rabbinic/Scholar Conference, Dr. Lamm discussed the "Jewish Value of Labor in an Era of Leisure." In March 1985, at the CLAL Critical Issues Conference, he addressed the problem of internal religious dissensions in the Jewish community.

In July of 1986, speaking before 1,000 alumni in Jerusalem, Dr. Lamm condemned religious extremism and called for moderation in an historic speech titled, "Do Not Let the Center Collapse." In September of 1986, at the University's Centennial Convocation, Dr. Lamm delivered a major address titled "The Next Hundred Years." The President said that a "modern university can and should foster a moral climate that elicits respect for the human spirit, for honor, for law, for the pursuit of knowledge and love of learning, for the human capacity for self-transcendence." The Convocation was attended by U.S. Secretary of Education Dr. William J. Bennett, leading educators, and University representatives. An adapted version of Dr. Lamm's remarks was published on the October 14 Op-Ed page of *The New York Times*. That piece, "A Moral Mission for Colleges," stirred discussion around the nation as religious and educational leaders pondered Dr. Lamm's views.

Dr. Lamm assumed the role of a moderating force in Jewish tradition by urging various branches of Judaism to end their battling. His highly acclaimed speech on Centrist Orthodoxy was delivered at the Fifth Avenue Synagogue on March 24, 1988.



### Within The Community

As a community leader, Dr. Lamm is active in many educational, religious, and humanitarian endeavors. He is a director of the Union of Orthodox Jewish Congregations of America; a trustee-at-large of the Federation of Jewish Philanthropies of New York; a member of the Halakhah Commission of the Rabbinical Council of America; a charter member of the Board of Governors of the Association of Orthodox Jewish Scientists; a member of the Board of Trustees of the American Zionist Youth Foundation; honorary president of Camp Morasha; a director of the Brith Milah Board; former chairman of the New York Conference on Soviet Jewry; and former chairman of the Board of Education of the Manhattan Day School. He is former chairman of the Advisory Board of Yavneh (National Religious Jewish Students Association), and a member of the Advisory Council of the World Jewish Congress, of the Honorary Advisory Board of the Greater New York Conference on Soviet Jewry, and of the Publication Committee of The Jewish Publication Society of America. In 1978 he was elected a member of the Board of Directors of the American Friends of the Alliance Israelite Universelle.

In May 1988 he was appointed by Gov. Mario Cuomo of New York to be a member of the five-member state ethics commission, which is charged by law with monitoring compliance with the state's ethics laws.

In November 1978 he was appointed by President Carter to the President's Commission on the Holocaust, to advise on an appropriate memorial in the U.S. to the memory of the six million Jews killed during the Nazi era.

In 1976, Dr. Lamm became chairman of a public committee which successfully fought the extradition of Elijah-Ephraim Jhirad, former Judge Advocate General of the Indian Navy. Jhirad, an ardent Zionist and anti-Communist, was being sought by the Indian government for alleged misappropriation of funds, and it was widely believed he was the victim of political persecution.

### Honors and Awards

Dr. Lamm received the Abramowitz-Zeitlin Award for Religious Literature in Jerusalem in 1972. That same year he was designated an "Outstanding Educator of the Year" in the U.S.

He was awarded the honorary Doctor of Hebrew Letters degree by Hebrew Theological College, Skokie, Illinois, in 1977.

In 1979, Dr. Lamm received the Silver Medallion Award at the national convention of American Mizrahi Women.

In 1983, he received the Katz Prize for the application of Halakhah to modern life. The ceremony took place in President Chaim Herzog's home in Jerusalem, and was attended by Israel's chief rabbis.

At the 1986 annual meeting of the Commission on Independent Colleges and Universities (CICU), Dr. Lamm was awarded the Corning Glass Works Higher Education Leadership Award.

Dr. Lamm is listed in *Who's Who*, *Who's Who in the East*, *Contemporary Authors*, *Men of Achievement*, *Dictionary of International Biography*, *Who's Who in World Jewry*, *Israel's Who's Who*, *Who's Who in Religion*, and the *Encyclopedia Judaica*.

### A Man of Action

Since assuming the presidency, Dr. Lamm has taken on the monumental task of reexamining the institution's total operation to explore the future of the School. In one of his first acts as president, he established the Presidential Planning Commission, an eight-member board of outstanding educators from outside the University, overseeing a number of task forces in the various disciplines, with committees consisting of representatives from the University's academic and service units.

The Commission's charge was to gather data on all areas of University life, evaluating the academic, administrative, and service operations, to provide recommendations for the continuing course of the institution.

As part of a continuing examination of the total University operation, Dr. Lamm has moved in a number of areas, such as the appointment of university-wide deans in the sciences and mathematics, behavioral and social sciences, the humanities, and Jewish education. He has brought a new cadre of administrators to the institution, effected a consolidation of University resources, and has sought to unify various inter-related programs and services.



During Dr. Lamm's tenure as president, the University was part of a dispute that resulted in one of the U.S. Supreme Court's landmark decisions. In 1980, the Court upheld a ruling by the U.S. Court of Appeals for the Second Circuit that faculty members at Yeshiva University are managerial personnel under the National Labor Relations Act and thus are not able to engage in collective bargaining. The case, *National Labor Relations Board v. Yeshiva University*, was the first involving collective bargaining in higher education to reach the Supreme Court, and the Court's decision set a precedent in such cases.

Dr. Lamm has led Yeshiva University during a period of troubled finances that threatened its very existence. On June 14, 1980, a debt-restructuring plan went into effect—a plan in which Yeshiva University was called upon to pay \$35 million by Feb. 2, 1982. Dr. Lamm organized a Special Campaign to raise the necessary \$35 million. Although most observers thought that such a drive surely would not succeed, the money was paid on time. On Feb. 2, Dr. Lamm presented a check for \$35 million to David L. Eyles, chairman of Chemical Bank's Credit Policy Committee. The historic presentation was viewed by New York Governor Hugh Carey, Hon. Herbert Tenzer, chairman of the University's Board of Trustees, and many other friends of the University. After making the presentation, Dr. Lamm said, "The private sector must know that it is absolutely indispensable to the survival of higher education. Government must learn very quickly that it has pushed universities as far as it can, and that, if its policy of reduction continues, no private or corporate philanthropy will be able to save higher education as we know it or ever put Humpty Dumpty together again."

On the day that the \$35 million debt was paid, Dr. Lamm also unveiled a six-point plan to help insure long-range financial stability and expand and intensify the academic offerings of the University.

After that historic day, the leaders of the Century Campaign moved on to seek \$65 million more by the University's 100th birthday in 1986. This \$100 million drive was successfully concluded at the Centennial Hanukkah Dinner on December 14, 1986.

As president, Dr. Lamm has sought to meet with the entire University family, to gain a greater insight into their needs and goals, and to better his administration of the institution. He has been prominent in a number of University functions, traveling to many parts of the nation to familiarize himself with the University's wide range of friends and supporters.

Dr. Lamm was invested as president before some 3,000 persons at the Main Center on November 7, 1976, in a colorful ceremony which included a number of outstanding academicians and government officials.

He presided at his first commencement June 8, 1977, standing, as it were, in the same place where he had received his bachelor's degree nearly 30 years before.

Dr. Lamm was married on February 23, 1954, to the former Mindella Mehler. They have four children: Mrs. Chaye (David) Warburg; Dr. Joshua, married to the former Rebecca Stern; Shalom, married to the former Tina Senders; and Mrs. Sara (Mark) Dratch. They are proud and doting grandparents, a role they very much cherish.



## **Seymour Martin Lipset**

Seymour Martin Lipset is the Caroline S.G. Munro Professor of Political Science, Professor of Sociology, and Senior Fellow of the Hoover Institution, Stanford University. Before moving to Stanford in 1975, he was George D. Markham Professor of Government and Sociology at Harvard. He has been co-editor of the Journal Public Opinion since 1978. His major work has been in the fields of political sociology, social stratification, public opinion, and the sociology of intellectual life.

Professor Lipset has been elected to memberships in various honorific societies in the U.S. and abroad: the National Academy of Sciences, the American Philosophical Society, the National Academy of Education and the American Academy of Arts and Sciences, for which he served as Vice-President for the Social Sciences from 1974-1978. He is a Fellow of the American Association for the Advancement of Science and was Chairperson of its section on the social and economic sciences from 1975-76. He is a Foreign Honorary Member of the Finnish Academy of Sciences and of the Spanish Institute of Politics. He has held office in a number of academic organizations. Currently he is President of the World Association for Public Opinion Research, and Vice President of the International Political Science Association. He served as President of the International Society of Political Psychology from 1979-80, of the American Political Science Association from 1981-82, and of the Sociological Research Association from 1984-85.

Professor Lipset has received the MacIver Prize for his book, Political Man, the Gunnar Myrdal Prize for his work, The Politics of Unreason, and the Townsend Harris Medal. He has been awarded fellowships by the Social Science Research Council, the Guggenheim Foundation, the Ford Foundation, and the Center for Advanced Study in the Behavioral Sciences (twice).

Professor Lipset has authored or co-authored 19 books and monographs. Translations of some of these have appeared in 18 languages. In addition, he has edited 20 books, and has published over 300 articles.

Professor Lipset has also been active in public affairs on a national level. He has been a member of the U.S. Board of Foreign Scholarships, a consultant to the National Endowment for the Humanities, the National Humanities Institute, and the American Jewish Committee. He served as Co-Chairperson of the Committee for an Effective UNESCO from 1975-80. He was National Chairperson of the National B'nai B'rith Hillel Commission from 1976-80, President of the American Professors for Peace in the Middle East from 1977-81, Chairperson of the Faculty Advisory Cabinet of the United Jewish Appeal from 1981-83, and is currently the Co-Chairperson of the Executive Committee of the International Center for Peace in the Middle East.





## DOCTOR ISMAR SCHORSCH

### Biographical Sketch

Dr. Ismar Schorsch is Chancellor and Professor of Jewish History at the Jewish Theological Seminary of America. He assumed the position of Chancellor on July 1, 1986. As Chancellor he leads the institution which is the spiritual center for the 1.2 million Jews belonging to the Conservative movement.

Prior to his election as Chancellor, Dr. Schorsch served as Provost of the Seminary - the institution's chief academic officer - from 1980 to 1984, directing and coordinating policy among the Seminary's Rabbinical School, Graduate School, undergraduate List College of Jewish Studies, and The Cantors Institute and Seminary College of Jewish Music.

From 1975 to 1979 Dr. Schorsch was the first Dean of the Seminary's Graduate School, which soon achieved the status of the largest school of higher education for the training of teachers and scholars of Judaica outside of the State of Israel.

As one of the world's foremost academicians in the history of European Jewry, Dr. Schorsch has published extensively on this subject. Immediately preceding his appointment as Chancellor, he was absorbed in the research and writing of The New Jewish Learning, a book which explores the meaning of modern Jewish works of scholarship. His other works include a translation of The Structure of Jewish History and Other Essays by Heinrich Graetz, which Dr. Schorsch also edited and introduced.

In May 1985 Dr. Schorsch was elected President of the Leo Baeck Institute, a post in which he served until May 1986. He has served on the Board of Directors since 1976 and on the Executive Committee since 1980. In addition, he is a fellow of the American Academy of Jewish Research, to which he was elected in 1977. In 1969 Columbia University Press gave Dr. Schorsch the Clark F. Ansley Award for his dissertation on "Organized Jewish Reactions to German Anti-Semitism, 1870-1914." The work was published in 1972. In 1979-80 he was a recipient of a National Endowment for the Humanities Fellowship.

Born in Hanover, Germany in 1935, Dr. Schorsch came to the United States with his family in 1938. He grew up in Pottstown, Pennsylvania.

Dr. Schorsch joined the Seminary faculty in 1964, after having served in the United States Army as a chaplain. One of those years in the chaplaincy was spent in Korea. He was named a full Professor of Jewish History in 1976.

Dr. Schnorsch holds a B.A. (1957) from Ursinus College, and an M.A. (1961) and Ph.D. (1969) from Columbia University. He received a Master of Hebrew Literature degree and rabbinic ordination from the Seminary in 1962.

The Jewish Theological Seminary of America produces leading scholars and teachers in all phases of Jewish studies. It is also the Conservative movement's official arm for the training and ordination of rabbis and cantors.



DANIEL S. SHAPIRO

On June 30, 1986, Attorney Daniel S. Shapiro finished a three-year term as the 25th President of Federation of Jewish Philanthropies of New York. On that date the Federation merged with the New York UJA; Mr. Shapiro played an important role in the merger. He has been a member of Federation's Board of Trustees since 1974, and has served as a Vice President for six years. From 1978 to 1982, he was chairman of Federation's Communal Planning Committee, which is responsible for determining future Federation policy.

He has published numerous articles on tax advantaged investments and has lectured on this and other taxation subjects before a wide range of organizations and institutions, including the Practicing Law Institute, N.Y.U. Real Estate Tax Institute, St. John's University and the New York State Bar Association.

He is a director of (1) Ampal-American Israel Corporation, an American Stock Exchange company that invests in Israeli businesses, and (2) Harris Steel Group, Inc., a Toronto Stock Exchange company engaged in the steel fabricating business.

BIOGRAPHY OF PEGGY TISHMAN

May 1988

Peggy Tishman became the first President of the newly-formed United Jewish Appeal-Federation of Jewish Philanthropies in July 1986.

Mrs. Tishman is a long-time leader of both Federation and the UJA-Federation Campaign. She recently served as vice president of Federation and as chairman of its Committee of Legacies and Endowments. From 1974 to 1978, she was chairman of the Communal Planning Committee, which studies communal needs and trends, and designs and recommends policies to meet those needs.

She is a vice president of the UJA-Federation Campaign, a former co-chairman of its Women's Campaign, and a past chairman of Major Gifts.

She was president of the Jewish Community Relations Council of New York from 1983 to 1986, is a director of the Jewish Theological Seminary and the Wurzweiler School of Social Work of Yeshiva University. In May 1988, she became the first non-Christian to be appointed to the Board of Trustees of the Union Theological Seminary since its founding in 1836.

Mrs. Tishman served as vice president of the Private Industry Council of New York, and is a director of the New York City Police Foundation, the United Way of New York, and the Bank Leumi Trust Company of New York. ## ISADORE TWERSKY

Nathan Littauer Professor of Hebrew Literature & Philosophy  
(Biographical Sketch to March, 1985)

Isadore Twersky, who is an authority on Rabbinical Literature and Jewish Thought, became the second Nathan Professor of Hebrew Literature and Philosophy at Harvard University on July 1, 1965. The chair was formerly held by his Mentor, Prof. Harry A. Wolfson, from its establishment in 1925 until 1958. Prof. Twersky served also as Chairman of the Department of Near Eastern Languages and Literatures from 1963 to 1969 and is on the faculty of the Department of Comparative Literature. He is an Associate of Dudley House, one of the undergraduate houses at Harvard. He has been a member of the Committee on Educational Policy and the Faculty Council as well as the Standing Faculty Committee on Medieval Studies, of which he was also Chairman. In 1978 he was appointed Director of the new Harvard Center for Jewish Studies.

Born in Boston on October 9, 1930, Prof. Twersky attended the Boston Latin School and received the A.B., magna cum laude (1952) and M.A. (1953) from Harvard. After studying as a special student at Hebrew University, Jerusalem (1949-50), he received the M.H.L. degree in 1951 from Hebrew College, Brookline, and the Ph.D. degree in 1956 from Harvard. He also has rabbinic ordination and is heir to a very famous rabbinic-hasidic tradition which he continues.

In the year 1956 to 1965 he has been Instructor, Assistant Professor and Associate Professor of Hebrew and of Jewish History at Harvard.

Dr. Twersky is the author of "Rabad of Posquieres: A 12th Century Talmudist" (Harvard University Press, 1962, reissued 1980 by the Jewish Publication Society with a new preface, addenda and bibliographical supplement), and of "A Maimonides Reader" (Behrman House, 1971). "An Introduction to the Code of Maimonides (Mishneh Torah)," published by Yale University Press (640 pages) as the introductory study for the 14 volume "Mishneh Torah" translation, appeared in April, 1980. A plenary session of the World Congress for Jewish Studies, August, 1981, was devoted to an assessment of the book's importance. Professor Twersky also received two awards for this book: The Jewish Book Council Award for a book on Jewish Thought, and the Kenneth Smilen Literary Award for the Best Book in Religious Thought, given by Present Tense Magazine. His "Studies in Jewish Law and Philosophy" (Ktav Publishing, 1982) collects in book form some important articles, in Hebrew and English, dealing with major aspects of Jewish intellectual history which are set in perspective in an introduction especially written for this volume. He is presently working on a book entitled "Halakah, Philosophy and Mysticism: The Quest for Sprituality in Judaism."

He also has written articles for Tarbiz, Proceedings of the Israel Academy of Sciences, Journal of World History, Proceedings of the American Academy for Jewish Research, Jewish Social Studies, Judaism, Tradition, The American Jewish Historical Society, The American Jewish Yearbook and various Festschriften in honor of Harry Wolfson, Salo Baron, Jacob Katz and Alexander Altmann. Together with Professor

George Williams, he edited and wrote an introductory essay to H.A. Wolfson, "Studies in the History and Philosophy of Religion," Volume 1 (1973). He also wrote a preface to Professor Wolfson's posthumously published "The Philosophy of Kalam" (1976) to the second volume of "Studies in the History and Philosophy of Religion" (1976) and to "Kalam Repercussions in Judaism" (1979). He edited "Harvard Studies in Medieval Jewish History and Literature" V.I in 1979 and V.II in 1982. He is editor of the Harvard Judaica Monographs and the Harvard Judaic Texts and Studies series. Recently he was named associate editor of the Yale Judaica Series, Yale University.

Professor Twersky is a Fellow of the American Academy for Jewish Research and the American Academy of Arts and Sciences, and a member of the steering committee of the Jewish Publication Society of America and of Phi Beta Kappa. He is a member of the Commission Francaise des Archives Juives, and an honorary member of the Mekize Nirdamim Society in Jerusalem. In November, 1969, he was among the first recipients of the Morris Kaplan International Prize for distinguished Research and Scholarship awarded by the Hebrew University of Jerusalem. In 1977-1978, he was a Fellow of the recently established Institute for Advanced Studies in Jerusalem.

Professor Twersky, his wife and three children live in Brookline, Massachusetts.



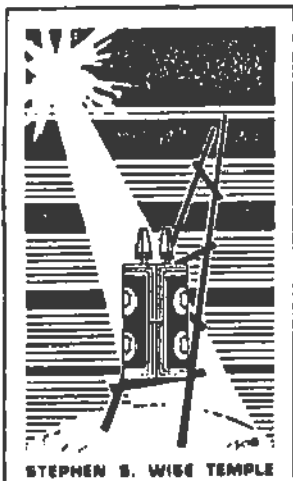

## RABBI ISAIAH ZELDIN

Rabbi Isaiah Zeldin was born and educated in New York City and received his Bachelor of Arts degree from Brooklyn College. While in college, he was president of the student Zionist society and was instrumental in introducing Hebrew and Jewish studies into the college curriculum. He received his Masters and Rabbinic degrees from the Cincinnati School of the Hebrew Union College, and at graduation was awarded the Lazarus prize for being the academically outstanding student in the graduating class.

Upon graduation, Rabbi Zeldin became the assistant rabbi of the largest Reform congregation in New Jersey, Temple B'nai Jeshurun, now in Short Hills.

For the next five years, Rabbi Zeldin was in academic life, serving as Assistant Dean of the New York branch of the Hebrew Union College. He also served as spiritual leader of Temple Beth Shalom in Bayside, Long Island. In 1953, Rabbi Zeldin came to California to serve in the dual capacity of Director of the Union of American Hebrew Congregations, Western Region, and Dean of the Los Angeles College of Jewish Studies. One year later he became Founding Dean of the Los Angeles branch of the Hebrew Union College.

From 1958 - 1963, Rabbi Zeldin was spiritual leader of Temple Emanuel in Beverly Hills. After a philosophical disagreement in early 1964, he left and founded the Stephen S. Wise Temple, which has become the largest Jewish congregation in the West and the second-largest Jewish congregation in the world. The Stephen S. Wise Temple is a complex of nine buildings on an 18-acre mountaintop property, which serves more than ~~2800~~ families, with approximately 2000 children in its various programs, including a full-time Day School with grades K-9.

Rabbi Zeldin is Past President of the San Fernando Valley Synagogue Council, the American Zionist Federation of Southern California, the Pacific Association of Reform Rabbis and the American Zionist Council. He sits on many national and local Boards, including the UCLA Medical Ethics Committee, the Board of Governors of the Hebrew Union College and the Zionist Organization of America. His wife Florence has written many children's books, including WHAT'S THE BIG IDEA, THE IMPORTANCE OF ONE, and a series of nursery school booklets for the Jewish child.
