Reading the comments by Commission members who expressed appreciation to you for the bound volume of A Time to Act inspires me to add my voice to the others.



I have reached the stage in my research project in which I am negotiating with a publisher about publishing the book that will report the research.

My first choice in publishers is the Jewish Publication Society (JPS). They do high quality books on Jewish subjects and market those books to a Jewish reading audience. To reach rabbis, educators and lay people, JPS is the best publishing house.

I have submitted a book proposal to their new editor, Ellen Frankel, who is quite interested in the book. In going to her board chairman, a question arose. Is this research applicable only to the Reform synagogue or to any synagogue which sponsors a supplementary school?

I have argued that my choice of two reform synagogues was only incidental and I am writing with the generic synagogue in mind. But that is only my say so. They want the opinions of others, and especially that of the commission which originally sponsored the research.

The full board will be meeting in two weeks. Ellen Frankel has asked if I could get letters of support for my contention from the Commission (as well as from Conservative and Reconstructionist rabbis) before the board meets.

Yesterday I spoke to Ginny who suggested I write to you. Do you think that as director of the Commission you could write a letter that explains that my research was commissioned to examine the potential of the synagogue school, broadly understood, that I looked for the best synagogue schools I could find in my area and they happened to be affiliated with the Reform movement? I think the Commission paper, which is the basis for the book, has been well received and that no reader has said in criticism, this is not applicable to non-Reform synagogue schools.

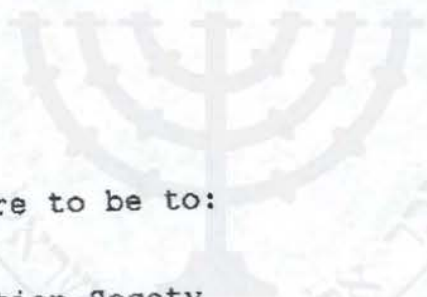


Dear Dr. Frankel:
