Memorandum

I had hoped to see Bill Berman in Florida but he left for Detroit. two days before I arrived there.

We spoke twice on the telephone - once before he received the board materials and then again, after he received them. We began, what I hope will be, an ongoing conversation about the CIJE and the educational projects in which he has very specific interests-Jewish family education and programs for college students.

I began my conversation by voicing our pleasure that he had agreed to join the board and by expressing our delight that he was planning to attend both the annual and the board meetings.

I. On the CIJE

He asked me to review for him the names of members of the board. He inquired specifically about Eli Evans and Zalman Bernstein. He feels their foundations are significant players in programs for Jewish education. I did not comment as to why they were not on the board. I wasn't familiar with the selection of members. It. may be that this does- or does not- require some follow-up with him by either Steve or Mort.

2. On the Lead Communities

I reviewed our progress to date and prepared him for the materials which were to arrive two days after our conversation. He had few questions/concerns and I decided to give him the benefit of the full presentation that I knew Jack was going to make at the meeting. Later in the discussion we again turned to lead communities and the integration of family and college programs into the "required" list.

3. Best Practices/Programmatic Options

Most of our conversation centered on the model programs developed in Detroit for family education. Bill would like to see each lead community undertake a similar effort. He arranged for me to receive a packet of materials from Harlene Appleman and I promised to make an appointment to meet with her. (She was a Covenant Award winner and is a consultant to the Whizin Institute. She spoke at the Whizin and Covenant Foundation sessions at the GA and is an outstanding spokesperson for her programs.) I plan to keep my promise as I make my rounds and will also suggest to Barry that he keep her in mind as a resource.

Bill also sent me materials from Hillel and the University of Michigan where the Hillel House bears his name. I am familiar with the programs there. My nephew was- and my niece still isactive in Jewish life on the campus and I met the Hillel director and program staff when I attended the Hillel Professional Conference last month. During this discussion I told him of my meeting with Marty Lipset and how his findings to be presented at the forthcoming annual meeting also would suggest the campus as a significant setting for dramatic intervention.

4. Board/Annual Meeting

I was pleased that he attended and I hope that he will remain interested in what we are doing. I plan to let him know when I've contacted Harlene and I will also do my best to keep in touch with him. I know that he is in New York with some regularily, so I'd like to arrange a meeting in New York.

I mention this to support what you all already know and that is my clear preference is for face-to-face meetings with campers. I think that even the reports reflect how much more productive they can be than telephone conversations.
