

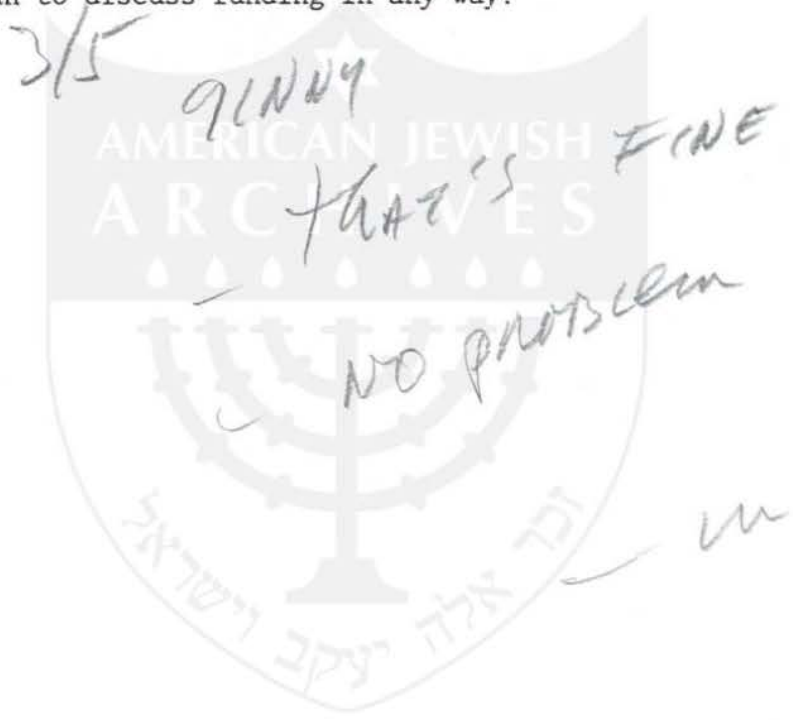

I met with Mr. Scheuer at his office in New York last week. It was my first CIJE contact with him though I have known him for many years as a grandparent of students enrolled at the day school in Washington. I think Mr. Scheuer is genuinely pleased to have been asked to serve on the board.

I told him about some of my own CIJE activities that have involved the Reform education community, including my trip to Cincinnati and the participation of Sara Lee, Daniel Syme as well as Isa in our work. He was pleased that the professionals are so involved. It was a nice coincidence that I could tell him that just the previous day I arranged for a teleconference with Rabbi Jonathan Stein (of Indianapolis), the chairman of the Reform Commission on Jewish Education, and some of the key leadership that Rabbi Stein will identify. This is in connection with my assignment to develop the approach to utilizing the resources of the movements and denominations in the lead communities.

I wanted to know more about some of Mr. Scheuer's specific interests. They include the nursery/pre-school established at HUC in Jerusalem and that has now expanded to the elementary grades and now occupies a former public school in Bayit V'Gan. He is also interested in the recruitment of female students for the HUC School of Sacred Music. This led to a discussion of the need for a program for the recruitment of young people for careers in Jewish education and communal service.

While I was there Alfred Gottschalk called for Mr. Scheuer. He took the call and told him that he was meeting with me about the work of the CIJE.

When I made the appointment I knew that he would have an hour for me - we more than filled the allotted time and there were many more things that we could have talked about.

I think it important to inform Board members very soon of our next meeting. I want very much to have him at our next Board meeting and so before I left I gave the date to his secretary so that he would hold the date on his calendar.
