Re: Your Visit to the 3 Lead Communities

December 1992

In our conversation in New York last week, we agreed that it would be important for you to visit each of the lead communities at the earliest possible time, in order to discuss next steps with community leadership (both lay and professional) and to get actual work underway in each community.

I cannot tell you how pleased I was to learn that you have in fact found the time to go to the communities this week and next — I believe your visit will be of significant benefit to the process and the project. The following notes may be useful for your visit.

A. DESIRED OUTCOMES

Optimally, your trip would have the following outcomes:

1. You would help lay and professional leadership identify next steps in the process. This would result in full-scale operation of the local commission (e.g., preparation of the 5-year plan; decision on an action plan for the current year including pilot projects). It would also pave the way for Barry and Shulamith to begin work with the educators and the rabbis (e.g., the best practices project for supplementary school teachers) and allow the field researchers to carry on with their work (the feedback to communities). In other words, the CIJE could then make its full contribution to the community (see details below).

2. An early step might be the proposed meeting between key CIJE board members and top local leadership to discuss the project, the role of the lead communities and of the CIJE, leadership

mobilization for the local commission, funding, staffing, etc.

- 3. Negotiate further the letter of understanding (separate memo forthcoming).
- 4. Get the planners further on board. We need to find a way for the planners to encourage the actual intensive launch to take place, even before special staff is hired -- or to hire immediately staff that could dedicate all their time to the project.
- 5. Further the joint agreement and understanding as to the following steps in the process:
- a. Staff the project locally with paid, dedicated staff -- planner or educational planner -- at least half-time, but preferably full-time.
- Set up the local commission and if it already exists, ascertain the calibre of leadership.
- c. Review the commission's assignments:
 - 1. Prepare an action plan for the current year that would include pilot projects in the areas of personnel and community leadership (these would be defined and designed with Barny Holtz, but might include, for example, a summer leadership seminar in the U.S. or in Israel; an in-service training program for principals and directors of educational institutions; a leadership training program for members of school boards).
 - Begin addressing the content and its application in specific settings; introduction of the best practices project -- beginning with supplementary schools and early childhood programs (Barry Holtz).
 - Prepare a 5-year plan for dealing with the enabling options and with the Israel Experience (see A Time to Act).
 - 4. Assessment of the community's Jewish educational system—its resources, strengths, weaknesses. Begin perhaps with a survey of the educators (their qualifications, numbers, scope of positions, training needs)...

 Guides are forthcoming for the 5-year plan and the assessment of the community's educational system.

 (Ukeles and Meier.)
- 6. In sum, your meetings might include the following items:
- a. Getting the leadership further onboard, comfortable with the recommended process (see "c." above) -- the current year being a planning year and a year for pilot projects; joint design of the lead communities project by the CIJE and the communities through

an ongoing planning effort throughout the year. A desired outcome of your visit would be the possibility for local and CIJE staff to systematically introduce the idea of lead communities to the various actors in the community.

- b. The content: preparation of a 5-year plan that focuses on dealing with the shortage of qualified personnel (e.g., strengthen in-service training opportunities; new hires) and on community mobilization for Jewish education. This would include:
 - 1. Pilot projects for immediate, or early, implementation!
 - Introduction of the best practices project to the educators, rabbis and to leaders in the community.
 - Discussion of the vision and goals for Jewish education at several levels in the community.
 - Monitoring and evaluation with the purpose of giving feedback to the community and the CIJE as to how work is progressing and what the impact of the effort is.

B. BACKGROUND NOTES:

- 1. Since selection of the communities, the contacts with the CIJE have dealt with the following: the letter of understanding, the field workers (monitoring, evaluation, feedback loop), the November Planners' Workshop in New York, selected contacts with local organizations. These contacts have involved Shulamith Elster and Jack Ukeles in 1-3 meetings in the communities plus a large number of telephone contacts and of course they have involved you in many contacts.
- Important beginnings have taken place. We now want to move towards an action plan for the current year.
- 3. In each community one or more federation planners have been appointed to be currently the key local professionals for the lead communities project. They do this in addition to their normal workload, and until paid staff is hired. This places a limit on the amount of work that can be done at the present time.
- 4. In each community, a lay person has taken the leadership position, to be the Chair of the Lead Community Committee or Commission. The calibre of leadership needs to be ascertained (are these the "champions" that will give leadership and resources to the project?).

- 5. In each community there is a commission or committee, completed or in formation. It was not clear how effectively this group has been convened at the present time.
- 6. Leadership mobilization: lay, professional, educational and rabbinic leadership needs to be brought on board. It is not clear at the present time what the needs of each of these groups is and we ought to devise ways of finding out. Key CIJE leadership, such as MLM or CRB, might help in finding this out for lay leadership.

First steps have already been taken as regards federation planners, local leaders who are CIJE board members, and additional individuals.

It is clear that there have been good beginnings and that certain people have been informed of the project. Our challenge now is to find the appropriate venues to discuss with the communities what the project entails, why it holds the great hopes it does, and how we will jointly move shead with it.

Re: Contacts between CIJE and Lead Communities

This is a summary of contacts to date between the CIJE and the Lead Communities -- to the best of our knowledge.

1. Preliminary contacts during the selection process:

During the final round of the Lead Communities selection process a site visit by a CIJE delegation took place in each of the lead communities. This included a lay person (MLM for Atlanta; Charles Bronfman for Baltimore; Chuck Ratner for Milwaukee), a professional and Shulamith Elster. During that site visit the delegation met with leadership and professionals in the community. During this period there were ongoing phone contacts between Jack Ukeles, his office staff, Shulamith Elster and the lead communities.

- 2. Since the selection of the communities (End August 1992)
- a. One or two meetings between the planners in each of the 3 lead communities and Jack Ukeles and Shulamith Elster to discuss a proposed letter of understanding. In some cases lay people were present part of the time. The letter of understanding was never finalized. It is a problematic document partly because it is not the result of jointly developed understandings between the CIJE and Lead Communities.
- b. Ongoing telephone contacts between community planners, Federation execs and Art Rotman; community planners and Shulamith Elster. These are many administrative. recently these have included concern about the lack of follow-up on process and materials, by the CIJE.

Shulamith will undoubtedly be in touch with you about an idea which I shared with her as a result of my meetings with Joel Zaiman and his educational staff, all of whom are rabbis. It has the ability of demonstrating how the lead community initiative could work to bring together national and local forces. It addresses personnel development and a key programmatic option.

The principal of Chizuk Amuna's synagogue school is Rabbi Stuart Seltzer. (As indicated in the best practices study, Chizuk Amuna has succeeded in developing a quality synagogue school side by side with a day school.) Stuart Seltzer is brilliant in family education. We have constantly gone to him for programming ideas for our periodicals.

We, the United Synagogue and JTS would find a graduate of the masters program to work with Stuart Seltzer on family programming for two years. This person would help Stuart further develop classroom based family education programs. S/he would assist in developing a curriculum and materials -- for use in classes and with families. S/he would during this time prepare a manual for publication. S/he would learn family programming from a person who understands its potential for synagogue and school. Joel is ready to fund 50% of such a position. If the lead community/CIJE could come up with 50% of the position we would be in business. United Synagogue would commit itself to publishing the manual on classroom based family programming. JTS and United Synagogue would supervise the development of the curriculum and the materials. We have found a very fine candidate for the position. The idea could now move forward with funding.

Looking forward to hearing from you about the matters we've discussed.

Dear Shulamit, Lin

It was nice to see everyone again and to hear what's going on. While I too was somewhat disappointed about the pace as well as the apparent acceptance or lack thereof of the various "stakeholders" of the concept of working jointly for some greater good, nevertheless progress is being made and hopefully breakthroughs of a more profound nature are in the offing. I also was glad to hear from Barry that he will be in touch with me regarding the Day School Division of the Best Practices project. However, listening to the number of visits that Carol made to her institution gives me pause about the amount of time that this might require.

As for Ellen's questions:

a) As I indicated yesterday, the idea of community history powerfully influencing a community's ability to change their approaches or attitudes is quite interesting to me. To understand which events or series of events seer themselves into the communal consciousness to the extent that it looks everyone into certain practices and assumptions would make for a fascinating study. How is history created, can we create an alternate history, how do we cope with an existing negative history are all questions that are not only interesting in a theoretical sense, but also have practical ramifications. I am also concerned about whose perspective a particular history reflects. Who determines who is (are) the local historian(s) and what their biases may be.

From an Orthodox perspective, to learn that a significant number of those associated with the Orthodox world are not going to play much of a role in the deliberations or development of programs, is very discouraging to me. To simply give up and accept their non-involvement in my opinion dooms the project to reflecting "left-wing" branches of Judaism's desparate attempts at stemming intermarriage and assimilation, rather than a wholescale project to enhance Jewish education for its own sake. Even the decisions to approach day schools within the context of the best practices project down the line, after supplemental schools, early childhood, Israel programs, etc. also sends a message to the Orthodox community which is most heavily invested formally in day schools, that this is not a priority. While I understand some of the pragmatic and political considerations, nevertheless I am concerned that there might not be enough Kiruv Kerovim (as opposed to Rechokim) taking place. I need a model of a community really working together in order to further my own

vision of what Jewish education ought to entail. It didn't sound to me that this is as yet happening. As I told Jack, I had always thought that such an attitude was to be the price of admission to the project. While the diverse cultures matter is a real issue, I would have liked to think that the denominations had to demonstrate that they could work together.

I would like careful records kept of the type of publicizing and advertising that have various effects upon the communities. The extent to which innovative and effective publicity could be devised and then executed would be of interest probably to many of us in the field.

b) At one of our Jerusalem Fellows get-togethers, we tentatively agreed to write case studies of our various experiences and I think that this would be an interesting means by which the material could be disseminated. In other words, the research should generate finite papers on various issues and problems, reflecting the means by which problems were framed, the interventions attempted and the results. Readers could then be invited to comment based upon their own experiences. In this manner, at the same time that the gestalt of the community project can be considered, the various pieces are also given their respective dues.

c) It seems to me that evaluation of "messy situations" must be undertaken by a number of evaluators with different points of view. Frankly, I am not sure that enough different perspectives are reflected among the evaluators regarding even non-messy situations. While it is clearly not practical to have more manpower than is necessary, there is a lot at stake here and it is important that as much as possible is don't in order to try to "get it right." Again how much trust will someone have in someone not from his/her world when it is assumed that they simply can't "understand" what is involved? Should the researchers of the project give the impression that they are members of a particular world view and have sympathy only for it? From Steve Hoffman's comment, it appeared that it's not so easy to properly perceive the Federation world. The various religious worlds would also appear to demand specific perspectives and evaluators.

At any rate, the discussions were interesting I dertainly don't have such discussions with anyone and hope that I have something to contribute to these deliberations.

As you requested, I am sharing some observations about the Lead Communities Project, based on meetings held in Atlanta and Baltimore with professional and lay leaders of the Reform Movement.

- In both cities, there was little awareness of the nature, structure and purpose of the Lead Communities initiative. To date, there appears to be little engagement of the Reform leadership or institutions in planning, decision-making, or even orientation about the Lead Communities Project. It is not clear whether this situation is the result of some systemic flaw in involving denominational educational institutions or merely indicative of the fact that the project is at a very early stage. In any case, it does suggest that attention needs to be paid to inclusion of denominational leadership, both lay and professional, at the very early stages of planning, including their representation on central decision-making bodies.
- As a result of our two meetings, the Reform leadership is developing a set of their educational priorities in both cities. Such priorities might be consonant with those identified in other segments of the educational community or generated by the core planners for the Lead Communities Project, but they may be quite different, as well. In both communities, this list of priorities will be discussed with the "federation" team responsible for the Lead Communities Project. The question that emerges is how the Reform priorities get negotiated within the overall agenda of the Lead Communities project. Is there a plan or sense for how such negotiation is to take place? One clear result of the movement meetings is the mobilization of the Reform leadership in both communities to advocate for their educational interests.
- My personal impression is that the Lead Communities Project is viewed as a "federation" operation, leading to the conclusion that the Lead Communities Project is no different from other federation involvement with Jewish education. Such an impression can undermine the sense that the Lead Communities Project is truly a unique and profound attempt to bring about the enhancement of Jewish education through community-wide engagement with the issues and the development of systemic responses. As you know, there is constant discussion across the continent about federation-synagogue relations, and the Lead Communities Project is regarded as a litmus test of the viability of a new and more productive relationship between these two worlds.

In conclusion, the Reform Movement meetings in Atlanta and Baltimore point to some critical issues that should claim our attention, if the Lead Communities Project is to actualize its potential for change.

It was a pleasure speaking with you regarding the Jewish educational program Gesher L'Kesher. Sharon Powell, the president of the Princeton Center for Leadership Training, has previously met with Dr. Shulamith Elster and we are anxious to continue developing our relationship with CIJE.

Gesher L'Kesher was designed in response to the challenges of post-Bar/Bat Mitzvah and post-Confirmation education. The purpose of the program is to promote greater participation of young people in secondary Jewish education and in the Jewish community in general.

The program is designed to keep older students (11th and 12th graders) involved and interested in their Jewish heritage and to provide appealing and relevant role models to their younger peers (8th and 9th graders). Gesher L'Kesher combines a proven team mentoring model with a Judaic curriculum utilizing the texts How Do I Decide? by Roland Gittelsohn, Great Jewish Thinkers by Naomi Pasachoff, and the Gesher L'Kesher Handbook written by consulting Jewish educators and Princeton Center staff. Furthermore, Gesher L'Kesher provides professional training that instructs Hebrew school administrators and their staff on how to implement this program in their congregation.

Gesher L'Kesher is currently in place in five temples in New Jersey and New York, and we hope to start a pilot program in Baltimore within the next few months. In final evaluations at the end of the first year in New York and New Jersey, most youngsters have reported an increased pride in being Jewish and a strengthening of their connection to their Jewish faith. The Gesher L'Kesher teachers also found that the program had strengthened their students' ties to Judaism and their religious training, and had enhanced their development as individuals.



Dear Alan:

Since we met several weeks ago, I have been working on the concept we discussed regarding the role of resident camping in Jewish education and Jewish continuity. The ideas that you gave me have lead to a series of meetings which has helped me strategize an approach which I would like to discuss with you when next you are in Milwaukee.

In brief, our idea is that the JCC in Milwaukee, along with the JCC of Atlanta and perhaps one or two other cities that have resident camps, would work together to develop a task force that would identify the components that make resident camping such a powerful Jewish experience and to help develop the programs and the knowledge base that will not only enhance and build upon what the resident camp experience currently provides, but make sure that other communities can share and benefit from that knowledge and experience. I have talked to Jane Gellman, Tzivia Blumberg and Barry Chazan. Tzivia, Barry and I spent about 45 minutes at the Biennial discussing the idea and focusing on the role that Jewish resident camping can play in terms of Jewish continuity.

I would like to suggest the following to you:

- That when next you are in Milwaukee, we get together to discuss a 2-4 city effort that would identify the strengths of Jewish resident camping and focus on the concept of building Jewish continuity through camping experience that is strongly related to Jewish community.
- 2. In the interim, I will speak to Harry Stern of Atlanta and perhaps one other city to see if we can get at least three or four camps involved. Chicago, and Camp Chi, is very interested in participating. My feeling is that we should do it with more than just Milwaukee and Atlanta, because there are different resident camps and experiences. Therefore, we need a broader base so that the recommendations will be applicable to all of the resident camps provided through the Jewish Community Center network.

Dear Seymour:

Thanks for the alacrity of your fax. Here is the situation. I spoke to Bill at length yesterday. He had intended to send me his own thoughts about the piece, provoked by our previous conversation, but he is meeting today with the Chinese dissident Harry Wu to explore a book possibility and that has taken up much of his time. Bill remains interested and believes that even if the Wu book, or another, materializes soon, he can also work with us, as long as he's not given a very stringest deadline by his publisher.

I suggested that it was now important for him to assess the financial side of this--and proposed that he give me a minimalist and maximalist view of the time/money quotient. That is, what would it cost for him to prepare a literate draft and do X number of revisions. (As I said in my last note, it does take time and work to arrive at a final version that meets all the standards and criteria we hold for this piece.) I know from 20 years of experience that a top professional will cut the project time in half, and that the result will be polished, readable and, above all, finished. Even with Bill's draft/s, however, I will need to do editorial work in clarifying, challenging, and reminding us of the large framework that needs to shine through the individual components.

The reasons I think this is worth the investment on all our parts are: a) the staff told me so; and b) it's clear that we need a "dugma" document in our Widener Library of Vision/Goals, and it doesn't sound from what anyone has said that such a document in Jewish education (for N. American Jewishness) exists in a usable format.

As for the timing in October: As Bill said, he's either free until the end of the century or he's not free at all. But he is proceeding on the assumption that he's going to go ahead with us, in which case he is happy to move the starting date to Oct. 25. I would prefer not to begin as late as the 30th because that our staff meeting is on the 31st, and the steering committee and board meeting follow on Nov. 1st and 2nd. I feel strongly that I should be in the room for the first day or two of this process—and am fully confident that I won't be needed after that until there's something on paper. (At this point I know a lot more than the average intelligent reader about Jewish education, and although I do pride myself on being able to edit and publish books on subjects I know nothing about, in the case of the Ramah piece and its relationship to Goals, my knowledge base can only be an advantage. Bill's immersion in Ramah is also a substantial bonus.)
