I believe I have held my final editorial conversation with Seymour. I never thought the following words would leave my lips, but it has all been worth it, because the piece is SUPERB. I got tears in my eyes reading it (for the millionth time); I really believe it illuminates complicated educational issues in a very accessible way, without intellectual compromise.

SO: Now I have a few minor items to clean up, and then: off to the designer. (Seymour will see pages one last time before we print.) My question to you, patient patron, is: Can you now give me a sense of how many copies you think you would like initially? My goal is to publish before the big Ramah meeting Seymour will address in March. I also hope it will be used in the curricula of your various institutions.

*** I need some help here. Our mailing list - some of which overlaps with yours - holds under 1000 names. I usually print 2000 copies, the second thousand serve as teaching and pr materials. If needed, I go back to press for more - not a big deal. Because of the friendliness of the topic, I would want a total of 2500 this time.

*** You should figure out how many the CIJE will want for its purposes, and add to that the number needed for the Ramah convention.

*** Regarding dates: I have a Board meeting in Mid-March. Having it by then would get many points to our operation - and some attention beyond Israel-USA.

*** Will you please express mail to me a complete copy of the text so that I can have it translated into Hebrew.

*** Are we listing officers (Board/Staff) of CIJE and MI - or nothing?

Onward and upward. In 1997, at the very least, I am hoping to be a midwife with you to the Agnon case study, which holds the possibility of being one of the very few contemporary case studies in this field. And perhaps other intriguing projects as well.

*** Sounds good. CAPE, which has just completed its pilot year with a seminar for 10 of France's key education people (formal, informal, schools, CC,
→ central organizations), has a growing amount of materials (written and visual) that should be

worked into publications. If and when time is right, we should talk about this. Altogether, CAPE has developed into a very exciting place. As usual, we are not doign a brilliant job getting the story out, though participants are doing a good word-of-mouth job for us. We have close to 200 candidates for the Jerusalem

Fellows' class starting in September - more than in any past year!

→ Do your plans include a visit here? Will you come in the Summer?

I am shocked that the essay arrived: We've been strong-arming Fedex here to promise me Sunday and not Monday! That's wonderful.

Just wanted you to know that Karen began our staff meeting yesterday by saying that she had read the Ramah piece the previous night (for the first time) and: "I couldn't put it down. I wanted to send it to everyone I knew, saying: This is why I work here."

Distribution: We have sent you your copies--by fedex, air mail book rate, and regular book rate, in the numbers we spoke about. We have sent Ramah in Wisconsin its copies. After speaking to Karen, we have sent Shelly Dorph 1500 copies for key people in his system.

Shelly loves the look of the publication. He will think about his initial, much larger proposal of possible recipients and decide what he wants to do about it. (We printed 7500, total for MI and CIJE, and he asked for 8500!)

Next week, we will mail to your database and ours (scant overlap). We have decided that your idea, Annette, is correct and have created simple joint stationery with both logos (as on the cover of the Ramah essay) at the top. We will print, on bond paper, the text of the letter I sent you and sign it from Mort, Annette, and Alan. (And we will get all titles right!)

Annette: Isn't the next step for me to send you a master copy of this joint letterhead, with the letter formatted on it as we will send it out, so that you, too, can xerox on bond for your distribution? Or would you prefer a blank master of the joint letterhead, for you to format yourselves?

Finally, please let me know how the essay is received as people begin to respond to it. I'm a proud midwife!

Re: Ramah reply

Thanks for your promptness and praise. Both are appreciated.

Mailing list: Our mailing list is certainly no larger than yours. (After two years of my advocacy, 1997 is the year of getting serious about it.) We will need to think about the overlap issue, since the North American educators you have and we have are presumably the same (Jerusalem Fellows, etc.) This is yet another reason why I dream of the big-picture job, a coordinated effort of publication and dissemination, wherever appropriate. Let's talk about the overlap question when we get closer to March.

Shipping: How have you shipped large quantities from here to there in the past? Certainly, I'll send you by air enough copies for your board meeting. Let me know how many you need immediately, and how many can wait for the larger shipment, as well as any ideas you have about the technicalities of the latter. Otherwise, I'm assuming we'll ship "book rate." I believe it no longer takes months, as it used to. But I'll ask Chava to look into that.

I am expressing Seymour a complete copy of the final text tomorrow, providing he signs off on the material I'm about to fax him now. I've already told him to get you a copy immediately, and I'll enclose a reminder to that effect with the text.

Officers: We have not in the past listed officers in our publications, because our board is in flux. I am disinclined to do it, because the names keep changing. (I did it on the policy brief because it was the first CIJE publication and I thought it was important for many reasons.) Also, when I visualize our two institutions' lists on the back cover, some names overlapping, I think it might look silly. For this publication at this moment, I think our two institutional descriptions will suffice. But I'm happy to revisit this one at each subsequent joint publication.

I am, of course, very intrigued by the challenge you pose at the end of your e-mail, re CAPE's materials. I'm not scheduled to come to Israel, but I am scheduled to meet with Seymour in February.

I had a meeting today, with the Jewish Museum's director of education, that made me think of both you and CAPE. I framed the challenge of Jewish arts education very differently from the way she was thinking. I kept forcing the philosophy/goals question, and insisting that unless we took on the challenge of "Jews and seeing," and the centrality of seeing to creation and theology ("atem re'item" etc.), we would not be able to make real cultural change in the way Jews think about the arts and imagination.

I was also thinking about the way you, Annette, could contribute to this discourse because of your background. (Right now, Jewish arts education is focused on programs and audiences: "How can we get more kids to come? How can we get the organized Jewish community to understand what the arts can do for Jewish identity?" instead of on what I think are the important "framing the problem" questions.) That is, it's time to take the discussion from the "aesthetics vs. Judaism" debate or the "Hellenism vs. Judaism" debate and address it from within Jewish thought and thinkers at the highest level of discourse.

Then I was thinking about how frontal and sit-on-our-chairs last summer's (undoubtedly terrific)

goals seminar was and I thought how the form (ultra-textual) and the content (the role of other ways of learning, illuminated but not determined exclusively by text study) were so antithetical. I believe this issue is very connected to the Jews and landscape; Jews and the environment issue, which was brought to life so beautifully by our trip to the desert in July. And I'm sure that early Zionism must have had a lot to say about Jews and seeing; about looking up from books to life. America was also founded on a "wilderness" encounter.

I think it's a profound philosophical/educational challenge. So now I've given us the subject of our next meeting!

Dear Annette:

I wanted to outline the next steps from my office to be sure I understand your needs correctly.

Publishing: I'll be looking at the "blues" tomorrow. Then it's off to the printer, for a total run of 7500 copies. I hope the printing will be complete by Friday March 7. At that point, I will:

Fedex you 100 copies (or close to that number, according to how they're packed by carton).

Send you 100-150 copies by air mail, book rate.

Send you 1500 copies book rate. (But if we implement the mailing plan for N. America below, you may want to leave more here.)

Hold for you in storage: The 750 (approx.) remaining copies of your 2500 order. (The cost of 2500 copies will be approximately \$3000. Do you need a formal bill for that amount from me?)

Dissemination:

The cover letter: Seymour and I spoke about creating a cover letter from Mort. We agreed that I would write a draft based on Seymour's comments to me on 2/14. I'll try to get that to you this week; and you should then feel free to adapt or redo it.

The mailing:

Outside of North America, you should send. If we have anyone beyond this continent, I'll check with you first before mailing.

Inside North America: My main concern is that we not duplicate mailings. There is nothing donors hate more than getting two copies of a publication. It would be confusing to professionals, too. Let me make a proposal, which you can shoot down if it doesn't work for you. What about your sending us your N. American labels and sufficient MI stationery for them? We would send out your list from here (cutting your postage costs). And we would mail to whomever on our list does not appear on yours. (That is, the letters to the Jerusalem Fellows and Melton Senior Educators who live here would be sent on your stationery, since you already have those names in your data base.) Since our initial mailings jointly will be relatively small, we should be able to "eyeball" your list to know who's a duplicate. It would help me if you could let me know what your North American "universe" is; that is, the total number of North American addresses you would mail to.

hundred number of North American addresses you would mail the whole list: The people; Here with others e-mail: Estelle am ish @ ywas. huji. 11

Wider dissemination: My first stop is Shelly Dorph. I have asked him to figure out who his key people are in the Ramah system, and how many numbers that is. I've also asked him to discuss this when he meets with Seymour. Who in the Ramah system needs to know AND will learn from this essay?

Finance database / tach.

At the same time, you, Seymour and I should jointly discuss who else on the North American landscape needs to see this work. I'll then figure out how to make it happen. Israel and the

rest of the world I'll leave to you!

SPECIAL NOTE FOR SEYMOUR: Seymour, I'm assuming that you will send personal notes with copies to people like Marshall Smith and David Cohen (and other living members of the bibliography). They are a small but absolutely critical audience.

Thinking aloud: I will propose sending copies to the 80 or so people we interviewed for the strategic planning process, which was an "A" list of thinkers on the Jewish scene. Also, all participants in TEI and Harvard. We can also send to the professors and to Goals Seminar participants, because we have their records in our data base.

Bottom line: I am trying to find a way to check in with each other so that as few people as possible get doubles, which is viewed as a waste of philanthropic money by recipients. That is why I thought that if you send us labels and stationery, we can double-check to be sure we don't send to those on your list.

How does the above sound to you? Do suggest an alternative approach if one seems simpler. Whatever approach you decide on will have an impact on the number of copies you want me to send you there.

On a future note: I am looking forward to receiving materials from Seymour as soon as possible so that I can get to work. Seymour, please let me know when to look out for them.

Dear Seymour and Annette:

Here is my attempt to create a cover letter from Mort that explains to recipients why this essay matters.

When you have revised--or replaced!--this text, what are the steps in getting Mort's approval? Seymour, will you speak with him about it directly to get his sign-off? Or do you want me to fax your revised version to him from here?

Since the essay will be printed a week from tomorrow (Friday), we need to take care of the text and approval of the letter next week.

So there are three items to be resolved:

1. Your answers to my question about the dissemination plan. Deadline: Wednesday March 5, since I must ship your copies directly from the printer. (The first recipients will be members of your board, for your March meeting; members of our steering committee, for our April 9 meeting; and attendees of the Wisconsin weekend.)

Repacking time and possible damage in handling.

Delivery time would be 5 to 7 weeks (as opposed to 7-8 days by "air freight"). Unlike "air freight," "book rate" has no tracking system. Each lost carton would cost \$3 to trace-and there would have been 75 cartons, instead of 17 by "air freight" = greater risk of loss.

John Colman has provided me with a copy of "Vision at the Heart," which, as a former Ramahnik (1954-1958), I read with much interest and pleasure. John offered to share the monograph with me after I told him that, outside of family and home, I regarded Ramah and the University of Chicago to have been the major institutional influences on me. The publication evoked many warm memories and offered insights into the goals and methods of the founders of an important force on the Jewish educational scene.

John and I had our conversation at a meeting of the visiting committee of the U of C's Divinity School -- where my membership (owed to John) represents a sort of rounding out of a circle of its own. It was not long after my summers at Ramah came to an end that I entered the U of C as an undergraduate -- and I might add that I found the monograph's description of Ramah's ties to figures at that institution to be particularly illuminating. (I had the privilege of having some exposure to Joseph Schwab, who, as I recall, had the unique distinction of having taught every single class in the core curriculum of the College.)

Following the U of C I went elsewhere for graduate work, got a Ph.D. in English Literature, lived in Israel for 11 years (1968-1979) while teaching at Tel Aviv University, then came back to the States to begin a career in Jewish communal service, which I've been maintaining at the Chicago Federation since 1988. I have no doubt that many of my career choices and life decisions were significantly impacted upon by the Ramah experience and am grateful that I had the opportunity to spend those summers up in the North Woods of Wisconsin.

I've just finished re-reading the booklet you sent me, Seymour Fox's "Vision at the Heart", about the educational vision of the Ramah camps. You were quite right, that his essay is a great match with the mission of our organization. I would love it if you could send me two more copies, for me to share with our co-Presidents, Rob and Elisa Bildner.

Two of Dr. Fox's statements, if juxtaposed with one another, essentially articulate our Foundation's mission. He asserts (p. 36) that "Judaism's and Israel's best asset is a Jewishly educated Diaspora, and that American Jews should be investing significantly in Jewish education....Jewish education has now been raised to the very top of the agenda of most Jewish organizations and institutions."

Elsewhere (pp. 10-11) he notes that "the founders of Ramah could have invested their energy in a cluster of day schools. Ultimately they chose camping, because the issues that they believed needed to be addressed could not be addressed by a school, not even a day school." A camp, he asserts, is a more powerful educational vehicle than a school, because it can "create a real and total society that would respond to the whole person, twenty-four hours a day....."

Since Jewish education is at the very top of the Jewish communal agenda, and since camping is an incredibly powerful educational vehicle, it follows that the Jewish community ought to be investing heavily in its camps. To spread this message is precisely the mission of the Foundation for Jewish Camping.

Unfortunately, the importance of camping is not self-evident to some of today's Jewish leaders. Too often, leaders who don't understand camping view it as "mere recreation" or as an "optional enrichment" activity, and thus not worthy of much communal support.

I would hope that for major forces on the Jewish educational scene, such as the Mandel Foundation under Seymour Fox's leadership, it <u>is</u> self-evident that the growth of camping is a high priority of the Jewish communal educational agenda.

One challenge we face is how to apply the educational power of camping to camp systems whose educational vision is less well formulated and articulated than that of Ramah. I have in mind the various JCC camps, to choose but one example of a system with which the Mandel Foundation has some directly relevant experience.

I would love the opportunity to sit with you, and with Dr. Fox as well, to begin to think through some of these questions.
