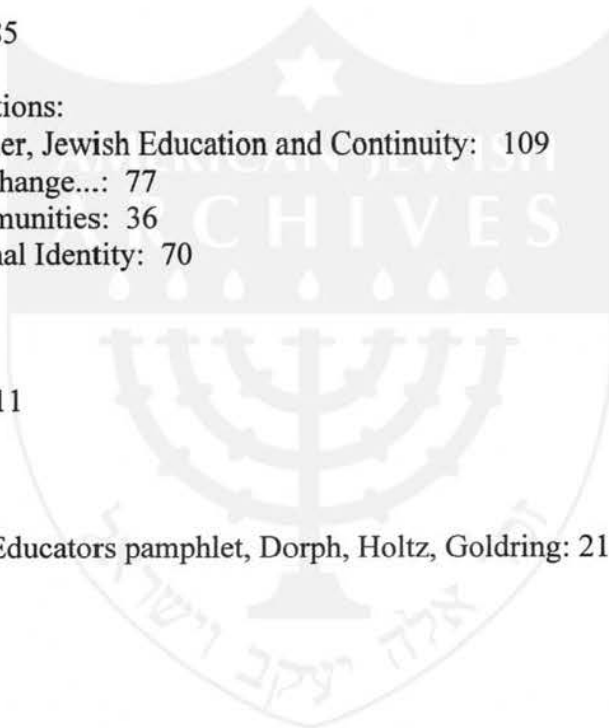

We're doing the inventory and I hope to have an answer by tomorrow, if possible. Your minutes didn't specify which publications, so I'm assuming MI/MF monographs, "A Time to Act," CIJE publications, etc.?

There were approximately 250+ people sent the newsletter in Hebrew (limited to MF/MS staff and faculty, current JF and SEL fellows and SEL grads, JF grads living in Israel, plus the few other Hebrew speakers on our list, e.g. Menachem Magidor). We assumed that many JF grads don't have Hebrew software and/or have English over Hebrew and sent in English only to native Anglos living in Israel (although I'm tempted to send both to all Israelis next time as they ought to know we are doing it).
