OVER HUNDRED MILLIONS JEWISH CAPITAL IN PALESTINE

A Tentative Estimate of the Capitai Investment in the Jewish Homeland

> By A Cambridge Economist (From the New Palestine)

An accurate estimate of the annual national income is the greatest desideratum in realistic economics. It is re-quired in most countries by practical statesmen as well as by academic economists. In no country, however, not even in the most advanced, where statistics have reached a comparatively high stage of development, is there anything approaching agreement amongst the va-rious estimates made. Much less is there agreement as to the national capital or national wealth. Notwithstanding special censuses of production and estimates of the values of capital. equipment, etc., there are wide margins between the views of different authorities.

And yet in spite of these differences, such estimates have some value and serve many purposes. They at least convey some measure, they indicate the order of magnitude, and the margin of error. Thus it is useful to know that the British national income is estimated by some at three thousand millions sterling per annum and by others at four thousand millions per annum. If, as is frequently done, the national income is multiplied by ten to give the national capital, then again we have some impression of what has been accumulated in the past, even when the differences between the various estimates are not inconsiderable. The actual error might conceivably be greater than the 25 percent difference in estimates.

In the case of Palestine many of the most elementary statistics are still lacking. A complete census of capital or of production has never been attempted. We have few figures for the country as a whole, or for the Yishuv. Little wonder then, that no serious attempt has hitherto been made to estimate the value of the Jewish capital already invested and deposited in the banks. And yet in this field it is desirable that some start should be made. Criticisms will be inevitable and will suggest refinements of early estimates. And even if the first effort should be buried under a heap of abuse, it will be possible to claim for it the merit of having challenged others, including Government Departments, local bankers and statisticians to attempt something better. Both the method suggested to include the different items and the estimated figures it is readily conceded ought to be and doubtless will be challenged.

A country's capital investment can be conveniently divided, it is suggested, into three classes:

(1) Fixed Capital. Investment in fixed capital may be comprehensively defined as work of construction, installation, maintenance and repair, with regard to buildings, plant and machinery, transportation, equipment and roads, electrical, telephone and other public utility systems. In the peculiar circumstances of the Jewish National Home land colonization constitutes indeed the largest.

(2) Working Capital. Investment in working capital consists of net additions to the quantity of stocks in trade and work in progress at all stages of the industrial process. It will be seen that working capital incorporates all the wage payments that have been made in advance of the final realization of the product, as well as the amounts expended on raw materials. At all times big purchases of producers' goods are being' made which are simultaneously used up in production.

(3) Foreign Investment. We need not enquire how to measure this, since we are interested primarily in the capital invested in Palestine.

JEWS ARE LEADERS IN ITALIAN ARMY

Rome—Guido Jung, Mussolini's former Jewish Finance Minister, has just arrived at the headquarters of the Italian army in Ethiopia to assume the post of Colonel. He is said to be the second Jew to occupy official rank in the Italian army. General Rudolfo Graziani, of the high command of the colonial troops, is reported to be a Sephardic Jew from Bucharest.

Meyer Attias, an Egyptian Sephardic Jew, has been appointed commander of a newly-formed legion known as "Tiberius" that is to embark for the war area in Ethiopia. Attias, who was selected for the post by Mussolini, has been the recipient of numerous other military honors.
