#### OVER HUNDRED MILLIONS JEWISH CAPITAL IN PALESTINE

A Tentative Estimate of the Capital Investment in the Jewish Homeland

#### Land Ownership and Property

The Jewish National Fund owns 340.000 dunams of rural land, and 20,000 dunams of urban land. It has been estimated that the value of this at present prices is over five milion pounds. The Fund estate constitutes under one third of the area of land owned by the Jews. Its large holding in the Emek is below the average value of agricultural land, and whilst its Haifa Bay lands may one day be very valuable, they are not so today. It owns comparatively little in Tel Aviv. It may therefore be fair to assume that the land in Jewish hands is of somewhat higher average value than the National Fund land.

About half the value of this land is agricultural, ie. an area worth some  $\pm 12,500,000$ .

Another average figure must guide us in estimating the value of the housing, equipment, machinery, live stock, etc., sunk in rural land. It is generally estimated that land constitutes fifteen to fifty per cent of the cost of a farm. Supposing then we take the average value of the land as one quarter that of the colonized land. If the land alone is worth  $\pounds 12,500,000$ , the colonization costs, etc., constitute  $\pounds 37,500,000$ .

Urban land belonging to the National Fund amounts to  $\pounds 2,500,000$ . It is safe to place other holdings at four times this amount, making a total of  $\pounds 10,-000,000$ .

#### OVER HUNDRED MLLIONS JEWISH CAPITAL IN PALESTINE

Total £105,000,000 According to these estimates, the value of the agricultural and plantation property amounts to roughly a third of the amount of the Jewish capital in the country, whilst, if houses are added, half the total is covered.

#### Estimates of Capital Imported

Mr. A. P. S. Clark, the Manager of Barclays Bank, Ltd., lent the weight of his authority by quoting "it has been conservatively estimated in the ten years 1919 to 1929 the amount of capital brought into Palestine by Jews alone amounted to no less than  $\pounds P40,000,000.$ " Allowing that between 1929 and today another  $\pounds 40,000,000$  were introduced by Jews and that the pre-war investment amounted to  $\pounds 10,000,000$ , then we have accounted for  $\pounds P90,000,000$ . There remains an additional  $\pounds 15,000,000$  to account for. This may be assigned to local saving and to rises in values.

#### Relation of Capital to Income

The great transformation which has taken place in recent years is evident to the visitor. He sees the great expansion of physical assets, both in rural and in urban areas. Farmers' savings have been invested in their holdings. thus making them richer. Rises in values have taken place in the case of small houses and shops in the towns, and especially in Tel Aviv, whose owners have improved and enlarged their premises. This explains in part the phenomenon of a modern town and local industries being constructed without much aid from foreign credit institutions.

If Jewish capital is estimated at about one hundred and five million pounds, it may be reasonable for some student to inquire whether the annual income is about ten or eleven million pounds, or whether the relation between income and capital is different from what it is in Great Britain. In a new country it is more likely that capital is only four or five times the national income.

This note makes no pretence at being anything but a first approach to a problem of the utmost importance. When we have different reasoned estimates and, above all, when we have more exact figures which it is the purpose of this essay to elicit, we shall have guidance on some of the basic economic problems of the country. It is to be hoped that the new Department of Statistics of the Palestine Government and the Research Department of the Jewish Agency will soon shed some light on this field.

#### HASHOMER HATZAIR PLANS "NESHEF"

A "Neshef" (evening) of artists and other entertainment will be presented by the Hashomer Hatzair on Sunday evening, December 1st at the Jewish Center.

The Hashomer Hatzair is a National Zionist Youth Movement which endeavors to create and foster among its members the spirit of "Chalutziut." It conducts a program of diverse activities of a general educational nature as well as preparation for ultimate settlement in Palestine.

In Cleveland there are ten such groups of various ages.

The program of the "Neshef" includes: One act from Stefan Zweig's famous play "Jeremiah," a Palestinian ballet, Hebrew Mass Recitation, several musical numbers and an atheletic exhibition.

The proceeds of the affair will be divided between local needs and the Jewish National Fund.
