# TEMPLE ISRAEL NAMES CINDY LAZARUS AND M.D. PORTMAN HUMANITARIANS OF THE YEAR

On February 5, 1993, Temple Israel will honor Council President Cindy Lazarus and Councilman M.D. Portman for their service to the community.

Cindy Lazarus was elected to Columbus City Council in 1985 and became President in January, 1990. She has chaired the Council's Finance Committee and served on a number of other Council committees.

Council President Lazarus' legislative initiatives have focused on ridding our schools of drugs, curtailing crime, helping senior citizens make their homes more safe, and addressing the problems of homelessness and affordable housing. She formed a Task Force in 1989 to study affordable child care.

Ms. Lazarus is the Executive Director of the Leo Yassenoff Foundation, a philanthropic organization. She is married to Stuart Lazarus and they have a five year old daughter, Frannie.

M. D. Portman was first elected to City Council in 1965 and served as its President from 1972-1983. He is Chairman of the Council's Development Committee and a member of the Franklin County Solid Waste Management Authority, which he helped establish.

As Executive Assistant to former mayor M. E. Sensenbrenner, Mr. Portman began the first investment program and capital improvements budget for the city.

Councilman Portman serves on the Board of Downtown Columbus, Heritage House, Opera Columbus, the Columbus Historical Society, and the I-670 Development Board.

Mr. Portman has been recognized by the Columbus Community Congress, AFL-CIO, Anti-Defamation League, JNF, and others for his dedication and service. He is married to Alice and they have three children, Fred, Jeff, and Judith.

We will begin this Friday evening with a dinner at Dr. Steven and Judith Tuckerman's home, followed by a service, the presentation of the awards, and special oneg at the Temple.

# Information Regarding Charitable Contributions

The Internal Revenue Service is looking carefully at what taxpayers claim as charitable contributions. We remind our members that payments to the Temple which are charitable donations are indeed tax deductible, but those that are for goods and services are not. A charitable contribution is a gratuitous payment where the donor receives no material benefit.

Fees for classes, purchase of gift shop items, and cemetery plots (payment for which value is received), are not deductible. Dues payments, outright donations, special dedications are deductible. Payments for events such as the New Members Dinner, which have some food cost, are partially deductible. Any payment over and above the cost of a dinner would be considered a charitable contribution, but the cost of the dinner itself is not. The Temple will try to guide you where only part of the event is tax deductible.

We encourage all members to consult their tax advisors if there is any question about payments to Temple Israel.

# FRED SUMMER SERVES ON REGIONAL BOARD

At the Northeast Lakes Council UAHC Regional Biennial, recently held in Ann Arbor, Michigan, Fred Summer was reconfirmed as a member of the Regional Board. Bunny Cowall, Beverly Shafran, Ernest Stern, and Cantor Vicki Axe also serve on the Regional Board.

Meeting in plenary session, the more than 250 delegates from Michigan, Indiana, Ohio, Western Pennsylvania, and Western New York re-elected Leon Plevin, of Cleveland, President of the Region. The Regional Social Action Committee proposed and the delegates approved a resolution urging the leaders of congregations in the Northeast Lakes Council to be on the alert to the threat posed by the Religious Right.

All the participants at the Biennial agreed that this was the most stimulating and challenging UAHC Conference they had ever attended. Many new programs and materials were shared, and a wonderful feeling of warmth and inspiration prevailed. All agreed that the members of Temple Beth Emeth in Ann Arbor had done a superior job in handling the program and arrangements.

The next Regional Biennial, celebrating the 25th Anniversary of the Northeast Lakes Council, will be held in Columbus, Ohio, November 4-6, 1994.

## UAHC SPIRITUALITY CONFERENCE FEBRUARY 14

"Spiritual Energy: How Does Judaism Teach Us To Live Out Our Spirituality" will be the topic of the second annual one-day conference on Sunday, February 14, 9:00 A.M.. to 3:15 P.M.. at The Temple-Tifereth Israel Branch, 26000 Shaker Boulevard, Cleveland, Ohio.

The event, sponsored by the Northeast Lakes Council of the Union of American Hebrew Congregations, is open to all members of Reform Congregations. The keynote address will be given by Rabbi Jack Stern, past President of the Central Conference of American Rabbis and Chairman of the Task Force on Jewish Ethics for the UAHC, who will be scholar-in-residence for the program.

Small group sessions in the morning and afternoon will explore questions such as:

· How can I gain spiritual insight?

· What does Judaism teach me about spirituality?

• What does it mean to be "spiritual" in relationship to our family and living with others?

• Is there a spiritual dimension to study, prayer, and doing justly? After the keynote address, the conference will feature a parallel track for area Reform Jewish educators and teachers.

#### KAREN ELSON AWARDED TITLE

Karen Elson, Temple Israel's Religious School Director, was honored by the National Association of Temple Educators (NATE) and awarded the prestigious title of Reform Jewish Educator (R.J.E.)

NATE is the professional organization of over 800 Reform Jewish educators from Australia, Canada, England, Israel, and the U.S. and includes the educators, principals, rabbis, and cantors responsible for providing the leadership in religious congregations and day schools affiliated with the Union of American Hebrew Congregations (UAHC).

The RJE title is granted only by the Reform Jewish Educator Title Granting Commission, composed of representatives of the American Conference of Cantors, the Central Conference of American Rabbis, the Commission on Jewish Education, Hebrew Union College-Jewish Institute of Religion, the National Association of Temple Educators, and the Union of American Hebrew Congregations. The title is granted to educators, rabbis, and cantors who have fulfilled extremely stringent academic requirements in education/educational administration, Judaic studies, and a supervised educational internship and/or experience in position.

Ms. Elson holds a Master's Degree in Judaic Studies/Jewish Education from Hebrew Union College in Cincinnati and has served in Jewish education for more than 20 years. She is a member of the Coalition for the Advancement of Jewish Education (CAJE), where she served as chair of the Small Schools Network; NATE; the Council of Jewish Educators (of Columbus); and Tri-state Area Reform Temple Educators. Karen spent 13 years as a teacher and 9 years as Educator at Temple Emanuel in south Texas before becoming the Religious School Director at Temple Israel.
