

Members of the Congregation, Fellow Officers and Members of the Board:
Welcome to the 107th Annual Meeting of Congregation Rodef Sholom. Tonight marks
the completion of my third year as your President. When I was elected to serve as a
member of the Board in 1961, I had no idea that I would one day serve as President of this
renown Congregation. Although I take my formal leave on a note of sadness to join the
ranks of Past Presidents and elder statesmen of the Congregation, I promise to avail myself of the opportunity to sit with this group as a duly qualified "maven".

I would like to call your attention to important projects which have or soon will be completed, all adding to the beauty and dignity of our temple. The back basement hall, which had been an eyesore, has been carpeted, panelled, and installed with a new ceiling. This gives a beautiful approach to Strouss Hall from the educational and office sections of the building. The continuation of the panelling on the first floor from the Rabbi's office to the chapel was completed this year. You will also be happy to learn that members of the Tamarkin family have undertaken the project of refurbishing the Tamarkin Chapel.

Work has already been started and should be completed by the middle of June. We are most grateful to the members of the family for their desire to make the Tamarkin Chapel a lovely and inviting part of our building. As part of our renovation program, the portico of the Temple was sand-blasted and some pointing was done on the outside of the building along with necessary painting and restoration.

During this past year it was agreed by the Board that we would begin to look for some property in Liberty Township, not to be used at the present, but to be placed in our portfolio, in case of future needs of the next generation, just as our forebearers provided for us.

Two special projects were presented this year, both with great success. First, an 8-week study course was held during the months of October, November and December. The first four lectures dealt with Psychology and were led by Mrs. Susan Roth; the second four lectures, dealing with great Jewish personalities in history, were presented by Dr.Berkowitz The second innovation was a voluntary Modern Hebrew Class which has been meeting during the week. It is taught by Mrs. Zahava Yehudai and numbers 20 students, most of whom are in the 3rd to 7th grades. It is a non-structured course in Modern Conversational Hebrew.

Our Religious School, under the guidance of Cantor Ehrlich and Dr. Berkowitz, had a successful year with approximately 250 students in attendance. The Congregation will note that there is a drop in enrollment, which does not reflect upon the growth or strength of our Congregation but rather on the reduction in size of Jewish families. The usual programs were carried out for the Religious School during the year and, on the 26th of May we will confirm a class of 24.

My last year as President began with a very loud but sad report - the Yom Kippur War and its aftermath! I am very proud of the part that the members of Congregation Rodef Sholom played in raising emergency funds for the United Jewish Appeal and also the resolution of the Board and the Congregation to purchase a \$250,000 Bond. I am most grateful to the officers and members of the Board who secured the signatures of over 100 members to off-set the difference in interest to be paid the Bank for the quarter of a million dollars borrowed to enable us to purchase that Bond. The highlight of the Bond Purchase, aside from the Bonds purchased during the High Holy Days, was the special Rodef Sholom Bond Dinner at which the Gates of Jerusalem Award was presented to Dr. Morris S. Rosenblum. I am deeply indebted to the Brotherhood and the Sisterhood, to Dr. and Mrs. Mervin Kohn, to Mr. and Mrs. Phelps Kurjan, to Dr. and Mrs. Edwin Brody and particularly to our Vice President, Mr. Sidney Silverman, and Mrs. Silverman, for their heroic work in coordinating all the arrangements for this very special occasion. The affair was a great success and paid an honor justly due to one of our Past Presidents.

Last December, at the 100th Anniversary of the Union of American Hebrew Congregations, Congregation Rodef Sholom participated in a special gift that was given to the Union by the 100 founding congregations. In appreciation of our contributions and in recognition of our status as a Founding Congregation a numbered, colored lithograph, "Shma", by Chain Gross was sent to Congregation Rodef Sholom. This lithograph will be hung in an appropriate site.

During this past year our Congregation was pleased to join with Cantor Ehrlich in the joy that came to him on the engagement and marriage of his daughter, Harriet, to Rabbi Seymour Klein. The Cantor tendered a beautiful reception in her honor in Strouss Hall.

I would like to pay special thanks to my fellow officers and Board Members, for their generous gift of time, effort and allegiance to the family of Rodef Sholom. I am most indebted to the Secretary of our Congregation, Mrs. Nat Glassman, and to her assistant Mrs. Mimi Berkowitz for keeping me aware of my programmed activities, while maintaining a dedicated awareness of the minutize of details that necessarily pass through their office.

No report would be complete without expressing my thanks to Cantor Ehrlich for his efforts to provide both the traditional and unusual in music and to bring modern educational methods to our Congregation.

To the Rabbi, the pivot, the heart of our Congregation, my deepest thanks for his constant support, his enthusiastic response, his sensitive awareness of the needs of his Congregational Family.

No President could conduct the business of a congregation this size without the supporting arms of the Sisterhood and the Brotherhood. The Sisterhood under the Presidency of Mrs. Mervin Kohn, has been both supportive and inspirational, and the Brotherhood, under the Presidency of Mr. Phelps Kurjan, has performed its duties with complete devotion to the ideals of our Congregational life. I would like especially to commend Mrs. Kohn and the Sisterhood for providing a most memorable Sabbath Service this past year. The participation and conducting of this provocative service by the women of our Sisterhood added a new dimension of Sabbath enjoyment to the Congregation.

I extend my thanks also to Mr. and Mrs. Dennis Frenchko, the Youth Group Advisors, and to David Bloch, President of the Youth Group, for a job well done.

In the past 3 years, there were many tasks brought to fruition; there are still many tasks to be completed, projects for my successor to fulfill. My sincere thanks for your understanding and your help during this past year. I look forward to the continued strength and importance of our congregation in the religious and communal life of this valley.

Thank you again for giving me the opportunity to serve you as President.

For those who carry on, may God bless you with health and with strength.
