Dear Dr. Mertas,

I was looking forward with much pleasure and anticipation your coming to New York on September 26th through the 28th. [02:00] I do hope that there will be another opportunity in the very near future for you to spend some time in New York, when our schedules will allow us to arrange for an appropriate reception. I am most eager that our top national leadership be exposed to your views that you so magnificently addressed during your address at Ottobeuren.

If you have some idea as to when you next plan to be in New York, I hope you will let me know some weeks in advance. [03:00] It would be wonderful to spend some time with you. Perhaps you might be free to have dinner with Mrs. Tanenbaum and myself at our home, in connection with your next visit.

In the meantime, my warmest good wishes to you and Mrs. Mertas.

You will be hearing from us shortly about these several levels of development.
