Since you have been especially creative on this front, I would appreciate if you would drawing up a list of the background materials that you and Sidney [02:00] have prepared in recent

months dealing with the UN, Soviet Jewry, and human rights issues.

Once I have your material as a model, I will ask others in the department to do likewise.

I do want to keep in mind that this should be planned in the context of your other commitments that you have with Sidney.

If you have any questions please talk to me about them.

This is a letter to Mrs. Shoshanna S. Cardin -- C-A-R-D-I-N -- in [03:00] Baltimore, Maryland.

Dear Mrs. Cardin, several years ago, I had the privilege of meeting you while I was in Baltimore addressing a meeting of the American Jewish Committee.

Dear John, it was wonderful seeing you yesterday at the reception for Norman Lear and People for the American Way. Both Georgette and I deeply appreciate your taking the time out of your busy schedule to spend those profitable hours with us in behalf of this important cause.

I have been meaning to write you for some time now to [06:00] express my deepest appreciation for the magnificent achievement of your series on "Inside Russia." The conception that you and Chris Jones developed was probably the most penetrating and

insightful grasp of the actualities of what is taking place in the USSR that I have yet seen in many years. You really set a very high standard of profound [07:00] journalistic grasp of one of the most important issues of our time, namely, building understanding regarding the relationships between east and west.

Paul Smirnoff mentioned to me that you are planning a series on religious and political fanaticism in many parts of the world. I have spent a number of years studying this problem from an audiological, historical, and religious perspective and I would love to talk with you about it when you are ready. [08:00]

As I hoped you sense, the leadership of AJC [12:00] deeply appreciated the forthright analytic statement that you offered regarding America's foreign policy in relation to Lebanon and the Middle East situation.

I have assumed the position of director of international relations of the AJC [14:00] since that time and therefore I'm undertaking to respond to your letter to Abe.

In view of the conflicting claims which you so rightly describe in your letter, the American Jewish Committee has determined to undertake two objectives: Number one we have sent a telegram to the Bermuda government asking them to extend the [15:00] work permit of Dr. Neville Marks in the interest of simple justice until the case is fully adjudicated;

Number two we have decided to send a representative of the AJC to Bermuda to meet with the principal parties concerned in order to get a firsthand understanding of the facts of the situation.
