Dear Rabbi Tannenbaum:

1974 marks the Centennial year of Chautauqua Institution whose influence on American life is a well-documented record. It continues today as a center for human enrichment through broad-based programs in education, religion, the arts, and recreation. While the summer of 1974 will appropriately be a unique historic occasion, it will also mark the beginning of a second century of service. Hopefully, the season will set new norms of excellence in all the areas of Chautauqua's programs. Such considerations as these prompt this inquiry in which I seek your participation as a 1974 Lecturer in Religion.

The foundation of this Institution is the Christian faith, in terms of which all religions are regarded as relevant to and expressed through all dimensions of human experience. The Centennial will afford opportunity for us to reaffirm this heritage even as we continue the search for new ways to express our faith in this modern or post-modern world. The enclosed statement about the Institution, prepared in support of the request for a commemorative stamp, provides an historical interpretation of what Chautauqua is all about. The 1973 program book, also enclosed, illustrates the kind of programming built upon the foundation of religion, education, and the arts.

The duties of the Lecturer include five afternoon presentations at 2:00 p.m. and concluding at 3:00 p.m. in the Hall of Philosophy. Teachers, professional people, and generally interested individuals constitute the audience of several hundred. They are a mixture of Christians and Jews who like to ask the Lecturer specific points about his presentation. Overall, it is an exciting exchange with very perceptive individuals participating.

In return for your contributions, we will pay automobile transportation costs to and from Chautauqua, calculated at 12¢ per mile; provide full hospitality for you, your wife, and any accompanying children; make available to you the full program resources of the Institution; and compensate you in the amount of five hundred dollars.

We will be launching rather soon an extensive national promotion of this special Centennial program, necessitating our confirming by January 21st the major program leaders. Because you are among the first to be asked, it would be helpful if you indicated your availability for July 15 through 19. The overall theme of the season's lecture program in religion will be the future of Christianity in a post-modern world. Projected topics would likely be Church unity, biblical authority, culture, the American church issue and challenges of modern thought, Eastern religions, the future of Jewish-Christian relationships, third-world issues, and like concerns.

Your participation, urged as it is by many colleagues, will surely contribute significantly to this historic season. In such confidence I extend to you this invitation with hope and anticipation.


We are delighted to receive your acceptance of our invitation. I hasten to respond to your inquiry as to the time we want you here. You will be asked to deliver five lectures on Monday through Friday afternoons, July 15 through 19. I am sorry if my letter did not make this clear.

Dear Sylvan:

Thank you for your recent note regarding my comment on a "Jewish version of Chautauqua."

Of course, I am very much aware of the Jewish Chautauqua Society and its program of lectures and related activities throughout the country. In fact, I have been invited by your group on a number of occasions to be one of your lecturers at various universities and seminaries.

I think that you and others who reacted critically to my comment missed the point that I was making. The entire story was devoted to a description of the 100 years of the existence of "The Chautauqua city-state." To my knowledge the Chautauqua village, which combines such a diverse blend of recreation, culture, and religion, is unique and does not have its counterpart in the Jewish community. I do know of the existence of Jewish summer camps, including those sponsored by UAHC. To my knowledge, however, these are not constructed on the same order of magnitude of programming, nor do they involve so many thousands of people as does the Chautauqua in upstate New York.

If I am wrong about this point, I would certainly welcome your enlightening me.
