Dear Marc:

I have been wanting to write to you for a few days, since our Community Leadership Program had reports of an encounter with a group interested in proselytizing of Jews. I was further impelled to write this letter by the recent communication from Gerald Strober with regard to Billy Graham's new film "Time To Run." Let me start from the beginning.

Three of our young leaders were invited to the home of a prominent Baptist businessman who heads a large title company here in Houston. He also is a Board Member of the Billy Graham Crusade and supposedly a close friend of Billy Graham.

Ostensibly, they, along with some other jews, unknowingly, were invited to the home to celebrate Israel's 25th Anniversary. At the home, a film was shown which apparently was "Time To Run," at least it was described as a film designed to bring Jews to Christianity. Luckily, these young leaders, who are articulate and sharp, were able to present to their host their views on why they should remain Jewish and their views about being proselytized.

It should also be noted that a man named Eddie Wexler, originally from Detroit and who claims to be a Jew and has "come" to Jesus, was at the meeting.

The main purpose of my letter is to raise some questions with regard to this whole approach of inviting Jews to a meeting under one guise wherein actually the purpose is to utilize evangelical techniques in attempting to convert Jews, since this is what the meeting turned out to be.

Further, based on your tape "Religion Commentary" which is a conversation with Billy Graham, he states "the proselytization against an entire group is absolutely off limits and impermissible." This position should now be seriously studied.

While I realize that local churches and groups have wide latitude, perhaps some clarification can be made as to the role Dr. Graham plays with regard to meetings when his film is shown. Also, when members of his Crusade, such as Mr. Wexler (who may or may not be associated with the Crusade) and other approaches are utilized, there is some question as to how this jibes with the views now being expressed by Dr. Graham.

It would appear that if Billy Graham does not wish to single out Jews as part of his evangelical approach, the Crusade itself, in addition to Dr. Graham, should make a statement on this matter. It is especially true in view of the meeting mentioned above, the broad distribution of the film "Time To Run" and the tactics utilized by those who serve on the Board of Directors of the Crusade and may be very close to Dr. Graham himself, such as the businessman who serves on his Board.

I hope this information is of interest to you and that the matter can be pursued.

Dear Gerald:

Warmest greetings to you and your associates. Gerald, it's always so rewarding to be able to discuss with you our mutual aims, and our common concern for the most open discussions to improve relations within the various communities we are closely connected with. It's encouraging to work with "Men of Good Will", thanks!

Recently we have had posed to us some reaction within the Jewish community to our release of TIME TO RUN in the Philadelphia area. The reaction was not presented to us, but was to the theater operators in Philadelphia via a local news release and an open letter from Mr. Margulies, President of the American Jewish Congress, Philadelphia chapter.

Although this was not presented to us directly, we certainly want to be responsive in any way possible. As I mentioned on the phone, it seems that some of our smaller newspaper advertisments deleted the term, "Special Screen Appearance by Billy Graham". This was done only because of copy space. We are, however, presently revising these ads to reinstate this copy. Hopefully, this will help to be more informative for not only the Jewish theater goers, but for the entire community. We have, however, been running two column ads in local newspapers over Billy Graham's signature giving his viewpoint on the content of the film. A sample is attached. This we did in the Philadelphia area and plan to continue. Gerald, we only want the best of understanding between our communities. We do, however, feel we must continue to present our message, and hope to present it clearly. But we feel it must be done in love and without coercion - "really who knows all that the Spirit is doing".

From a World Wide Pictures Distribution standpoint, we would however be happy to present our schedule for the next year as soon as plans are complete to you and any other part of the Jewish community so that they might alert their constituents of the films content and its planned release. This way no one would be surprised to know when and where we are playing our film.

Dear Reverend Strober:

I read with interest your memorandum of April 3, 1973, regarding the evangelical film, "Time to Run". I was pleased to learn that World Wide Pictures will identify "Time to Run" in such a way as to make clear its evangelical nature. However, I thought you would be interested in knowing that Sanford Weinreb, Regional Director of the American Jewish Congress in Philadelphia, was in touch directly with World Wide Pictures regarding the problem. He spoke to an official in Minneapolis prior to the release of the American Jewish Congress statement.

Also, not a single ad published in Philadelphia newspapers, at least in the dailies, carried the term, "Special Screen Appearance by Billy Graham". Indeed, this was a suggestion that we had made to theater management, and the request was rejected because of an agreement the theaters had reached with World Wide Pictures. In addition, the two-column ad over Billy Graham's signature never appeared in any of the Philadelphia papers, or at least the dailies. It is possible that it appeared in a neighborhood newspaper, about which we were not aware.

Nevertheless, I am, as I indicated, pleased that the advertisements in the future will carry the proper identification.
