Dear Mr./Ms.___:

We would like to invite you to participate in an international forum on "Society, State, and Religion: The Jewish Experience", to be held in Jerusalem from February 15-17, 1988. The forum will be attended by noted Jewish scholars, persons active in Jewish communal life in Israel and the Diaspora, and prominent Israeli political and religious representatives. The conference is to be opened by the President of the State, Mr. Chaim Herzog.

One of the strengths of the Jewish people in the face of oppression and assimilation has been the ability to adapt to changing conditions while preserving ancient values and traditions. Evolution has continued to the present day: contemporarily Jewry contains within it a broad spectrum of movements, cultures, and lifestyles. Although various groups interpret the faith in different ways, the Jews have maintained their solidarity and unity of spirit.

The State of Israel has been charged with a formidable task: creating at the same time a Jewish state and a modern, pluralistic democracy. Over the years, unity xh has been maintained while competing groups attempted to mold the character of the state. In recent years, however, the delicate process has been disturbed. Burnt Torah scrolls and vandalised bus stations are grim reminders

that some have lost sight of "Ahavat Yisrael", preferring violemnce over a peaceful continuation of the process of self-definition.

It is within this new climate that we have organized the forum, seeking new ways to increase mutual understanding and hopefully to help bridge the gap among the diverse elements of Judaism. Participants, expressing their own personal beliems, will be presenting varied (and often conflicting) points of view. We would be pleased if you could be present, making your own unique contribution to the understanding of society, mak state, and religion in Jewish life.

DISTURBANCES IN GAZA, JUDEA AND SAMARIA:

THE ISSUE OF JOURNALISTIC COVERAGE

The following is an interview with IDF spokesman, Brig. Gen. Ephraim Lapid (on educational TV's 'New Evening' program, 16 December 1987), in which he elaborates on the issue of media coverage of recent events in Gaza, Judea and Samaria.

Q: Why limit the correspondents' freedom of movement?

A: First of all, you're assuming that we're limiting the correspondents, and that isn't so. I can say that for 20 years, operational activities have been carried out in Judea, Samaria and Gaza while being covered by the media. There is no change is this policy, the last few days included, despite what has been published here and there in the newspapers. It's difficult to carry out the operational activity with media coverage on top of you. Actually, this condition doesn't exist in any other country. Israel has the third-largest community of foreign correspondents in the world. Following the U.S. and the USSR: over 200 foreign correspondents closely cover a very small country. Only yesterday and, generally speaking, within recent days, dozens of foreign IV crews were running around in Judea, Samaria and Gaza. This fact definitely has an effect on the operational activity and occasionally hinders it.

Q: What is your view of Prime Minister Yitzhak Shamir's proposal to protect journalists?

A: I read (about it) in the newspaper. The fact is that media coverage for foreign and local crews remains completely unchanged. Certainly there are limitations, which are attributable to operational activity. One should bear in mind that we're not attending a show (in the territories). The IDF is there for the purpose of ensuring the well-being of the population and in order to allow a return to normal life. This is the top priority of the IDF forces in the field. This should be carried out with media coverage, but in that particular order of priority: first operational activity, and then media coverage.

Q: The bleak pictures transmitted abroad might conjure a very gloomy image, even one comparable to the situation in South Africa.

A: First of all, we haven't become a (second) South Africa. There are disturbances of the peace and riots in the field. Only those who are observing them close at hand -- such as some of the foreign correspondents and some of the Israeli correspondents who saw what it means 'to throw a stone at someone' -- know that this is a most serious threat. Only a few moments ago we heard on an IDF radio broadcast that an IDF soldier was stabbed today in Gaza. His injuries were defined as light to moderate. The threat to the lives of IDF soldiers in the field is real. We take every possible precaution so that live fire is used only as a last resort. Q: How do you resolve the dilemma of a foreign photographer who, whether or not the picture is 'objective', photographs those subjects which selectively interest him?

A: First of all, we are aware of the principles which guide the press. Any network which presents a 90-second segment -- such a segment allows for only a few scenes, generally those with the most action and which are most provocative -- does not give a picture of the full scope of life in that same area or at that particular time.

Q: Aren't you sometimes tempted to say that you refuse to give permission to let out pictures which depict us as a brutal occupier?

A: We are sometimes faced with the consideration. But it is transitory, like some of the illusions in the field. We have to allow reasonable media coverage in the field. I don't delude myself into thinking that we will ever appease the journalist community. It's obvious that we're talking about hundreds of people. Bear in mind that we also have to add the hundreds of Israeli correspondents. I'd like to remind you that we have ample opportunity -- in addition to the 'New Evening' program -- to hear the correspondents' opinion of the coverage. The media's coverage of subjects connected with the IDF is carried out under the best possible circumstances.

Q: It's no secret that you worked in military intelligence. Perhaps the person who heads the IDF spokesman's office should be a professional publicist, free from all other outside pressures?

A: First of all, I take pride in having been a member of military intelligence. I have no compunctions about the matter. Anyone who knows me can attest to the fact that after three years in this post, my having been a member of intelligence only adds to the quality of my performance in this job. Perhaps in contrast to other persons who work in public relations, the nature of this position is meant to guarantee the connection between the IDF and the media, and between the media and the IDF. I do not deal in imaginary public relations. I am connected with an organization which most closely unifies all this country's residents (and) whose message must be conveyed to those living in Israel and abroad, including the Arab world, in the most credible and available manner.

The violence that is breeding more violence in the West Bank is creating an imbroglio of interpretation, if not an outright embarrassment of affairs. memorandum

Not as important as the loss of life, nor even the loss of face, some of the discussion, in print and on the TV screen (both foreign and domestic) are getting downright silly. Questions about the Geneva Convention, international law, law and order, the rule of law, human rights - all intrude on a variety of actions taken by the Israeli authorities that includes abbreviated trials, alleged maltreatment, the drawing of inferences from the whitewash of the Shin Bet, and the fanciful elaboration from the mistake of serving inadequate food to a prisoner, turned into a charge of beastiality. (A good case in point is a letter appearing in the January 10 issue of the New York Times by Father Hamilton, Canon of the Washington Cathedral whose charges of maltreatment by Israeli soldiers of Palestinians somehow wind up as being violations of all the canons of international law: isn't on the brink of being wicked; it is wicked). 11.2

These events have led to consider the need for providing our members and friends with clear guidelines as to what is and what is not permitted, under international law, as seen by our specialists here. This being so, I sought out and met with someone who has spent some 15 years serving in the State Attorney's office and is a specialist in international law at the Ministry of Justice. His gredentials are first-rate and having recently left the ministry, he is free to explain, and to write without any restraints imposed upon senior givil servants.

He is prepared, at our request, to provide short, pithy statements of elaboration and interpretation to help our members and friends better understand the legal issues involved in the occupation and the variety of corrective actions being taken by the Ministry of Defense at this time. Fees that will be charged are comparable to what we now pay for weekly summaries. He has agreed to write such statements for us, at our behest. I show below a sampling of the kind of topics about which he is prepared to write at once and would seem to me to be quite relevant for our purposes. I present these ideas to you for your response and reaction and approval, if you so decide. Thinking ahead, such commissions could be undertaken at your directions. Certainly there would be no obstacles in initiating such a series starting March 1. Let me know.

Dear AJC Leader:

The current volatile situation in Israel and the occupied territories, which you have been reading and hearing about so much these past few weeks, has been of overriding concern for us here at AJC. It continues to be one of our highest priorities, occupying much of our time. More than likely, it promises to do so for a long time to come, at least until there is some end to the violence and steps are taken for a lasting peace.

Let me assure you that we have never wavered in our support of Israel. Some aspects of its actions, as they have come through to us, understandably have been disturbing. But at all times we have been mindful both of the historical context in which events have taken place and of the on-the-scene provocations by the Palestinians. Whatever positions we take as an agency arise out of our firm commitment to Israel and our concern for its security.

As soon as the disturbances first reached our attention, we moved on a number of fronts. Let me summarize some of these activities:

- U.S. Administration. We have met with a wide range of top U.S. officials central to Middle East policy, from Secretary of State Shultz and key members of the State Department and the National Security Council. In each instance, we expressed our solidarity with Israel, and urged that U.S. initiatives be taken that would use the current disturbances as incentive for renewed peace activities. We are happy to note now that the U.S. seems to have begun just that.
- 2. <u>The Israelis.</u> Both in the U.S. and in Israel, AJC officers and staff have conferred regularly with Israeli officials to present our viewpoint, to suggest alternatives where that seemed called for, and to offer our assistance in interpreting Israel's difficult problems. To give you a measure of what we have done: on three separate occasions in a matter of ten days, we met with the busy Israeli Ambassador to the U.S., both in his offices and in ours. Further, we sent cables to Prime Minister Shamir, Foreign Minister Peres, and Defense Minister Rabin, expressing our concern over some of the measures used to bring stability to the troubled area.
 - The Jewish Community. We have kept in close touch with other major organizations in the American Jewish community, particularly with the Conference of Presidents of Major American Jewish Organizations (which is headed by our Honorary President, Morris B. Abram), so that a unified approach would be preserved in these difficult days. We joined with them in missions to Washington as well as in drafting common statements.

- 4. <u>The American Community.</u> AJC's International Relations Department has prepared a series of background memorandums on the situation, keeping them continuously up to date. These have been widely distributed, and hailed as the best and most useful analyses extant. While we have not sought out media contacts, in an effort not to enflame an already volatile situation, we have responded to calls from the media. Our President, Ted Ellenoff, and others at AJC have appeared on numerous radio and TV programs and have been quoted in newspapers and magazine articles. Where that was deemed to be called for, we have arranged meetings for representatives of the American Jewish community with key executives at ABC and other major media, urging them to place the situation in Israel into fairer perspective. And we have started a series of consultations, in Washington and elsewhere, with officials of religious, ethnic, civic, and communal organizations with which we normally deal, helping them to understand the complexities of the situation in Israel.
- 5. <u>The AJC Community.</u> All the materials that we have produced have been shared with our area offices, and our chapter leadership has been urged to pursue locally our efforts of constructive interpretation. We are now duplicating our meetings with Jewish and general groups across the country, and we are certain they will add to a more general sympathetic understanding of the difficult position of Israel.

I am enclosing a copy of an Open Letter to the people of Israel from Ted Ellenoff that has appeared in the *Jerusalem Post* and in the Hebrew-Language paper *Davar*. I think it accurately reflects the views of AJC's leadership.

Obviously we are far from the end of this drama. We believe we have been effective, but there is a long way to go. Over the years we have consistently advocated direct negotiations for a peaceful solution between Israel, the concerned Arab states, and appropriate Palestinian representatives – even if necessary under some kind of international umbrella.

I assure you again that AJC will continue to be a major player here. I welcome your views and comments, and will report to you again as events unfold.

My organization, and many other American Jewish organizations, communicate directly with your government, both publicly and pri-vately, and we will continue to do so. But it is, I think#important for you to know what our organization feels and believes about the current situation, for not only are we important to one another, we are, in dif-ferent ways dependent on one an-other. Two intensely democratic communities - in that respect, major *Jewish* communities, which are also linked as much by our values as by our common history;

We stand with you profoundly syman pathetic to the dilemma which you pathetic to the unemant face in con-and your government face in con-fronting the upsurge of violence in

the territories. We know that Israel never sought to be an occupier, that the main-stream of Zionism always sought co-operation and coexistence, that at every painful juncture of cholos, the Jewish leadership in Mandatory, Palestine and the State of Israel recog-nized and accepted Palestinian Arab rights and presence. From the Peel Commission in 1937 to the UN-Partition Plan in 1947; from Israel's of-fer to repatriate 100,000 Palestinian refugees after the War of Independence to her plea to King Hussein not to join Egypt and Syria in the 1967 war; from the offer of "territory for peace" after that war to the Arab League's declaration at Khartoum - no recognition, no negotiation, no peace with Israel - to the extraordinary sacrifices you made in extraordinary sacrifices you made in securing peace with Egypt. Israel's record of seeking peace is extraordi-nary and we have presented it with pride to our fellow Americans. We know, as well, that the cur-rent manifestations in the territo-

rics, as much as they are express pons of despair, anger and frustration, are not benign. The words that ac-company the stones, Molotov cock-tails and knives bear the same intolerance and hatred that has brought the Arabs to wage war and terrorism on you. We understand that you regard this new cycle of violence ast an attack on Israel's national security and that these attacks must be stopped - that tranquillity and civil order must be restored. Indeed, most Americans, both in govern-ment and influential circles, have understood this and been genuinely sympathetic to Israel's dilemma. THE IMAGES projected from Isra-el have been harsh. Because we

We do not expect you to be nice so as to satisfy some of our illusions about Israel, but we do expect a certain level of decency from a country with whose fortunes we are so intertwined. But there are some forms of force intrinsically intolerable and unacceptable in the kind of humane society Israel has

always sought to be. "We trust that the excesses are now behind us, but we have no illusions about what now lies before you. What the Palestinians have done the power they have now discovered to disrupt - should hardly increase your confidence (or ours) in the fact You should know, first and most your confidence (or ours) in the fact importantly, that the events of the that they are not ready to embrace past six weeks have not divided us; peaceful, co-existence with Israel. Yet we can hope that the Palestinians have at last found their own voice, even if the best they can do now is mimic the sterile, uncompromising fulminations of the PLO;

We may hope that they have, by these violent expressions of self-assertion, begun to separate them-selves from the Arab mythology of their perpetual martyrdom. We can hope that out of this raw and bitter confrontation they will discover that they can and must take responsibility for themselves, acknowledging finally that the Arab states have been cynically manipulating them for their own purposes and have be-trayed them. We can hope that they will seek to translate their now-exwill seek to translate incli now ca-plosive energies into coherent politi-cal goals, realistic demands which Iareel has, always proclaimed its readiness to negotiate. Will the Palestinians draw these lessons? I don't know. But that, of

course, is only half of the equation. How will these events - perhaps these new realities - be interpreted by you, the people of Isrsel? How will they affect the engraved positions, the paralysed peace proposals? The answer to these questions are

no more apparent to me than those I pose' about the Palestinians. One can, at least, observe that the current situation has, for the moment anyway, opened all these issues to new and hopefully fresh debate. We

hear that in our conversation with your government's highest leaders and we are encouraged by their growing sense of pragmatism. Something fundamental has changed, they say. The situation will never be the same again. We hope and trust this candid realism will now and torencoming consensus on the future of the territories. But that depends not on us, nor even on the good offices of the U.S. government. It depends on you: hence, this open letter.

As you begin this national examination and quest for answers, you should know that we continue to interpret your agony and dilemma to our community, to the mass media, to our elected government offi-cials, in the most effective and sympathetic manner we can. But, in turn, our ability to do this will depend on the vigour and dedication with which you approach the hard questions of how Israel and its peole will relate to the three-quartersof-s-million Arabs who are your coequals as citizens of Israel, and the 1.4 million whose fate is so intimately tied to yours.

Thank you for entrusting the with a copy of the draft program of the scheduled "International Forum on Society, State and Religion".

As agreed between us, 1 gave some thought to the topics and the speakers and I would like to propose three names:

- 1. Rabbi Dr. Mordechai Halperin. He is a doctor of medicine, teaching at the Faculty of Medicine in Jerusalem, Head of the Schlessinger Institute at the Sha'arei Tsedek Hospital and editor of the medico-halachik periodical "Asia". I heard him lecture in a quite satisfactory English. Above all he is an excellent Talmid Hakham. He also had a brilliant military past, as commander in the parachutists. The subject he is thinking of proposing is something like "Medical Ethics Bridging Social Gaps".
- 2. Rabbi Schlessinger, former Rabbi of Kibbutz Sha'alabim (midway between Tel-Aviv and Jerusalem) and now the head of the Yeshiva in the same kibbutz. I had a lengthy conversation with Yaakov Pnini on the details of the Forum on Society, State and Religion.As hinted in his memo to Bert Gold of today's date, there is a real problem of authority.

Pnini does not feel competent to make the necessary decisions and follow up with the Hebrew University. He requested that I come over immediately to take charge. I told him that this was impossible because of my commitments here.

I asked why Bernie Resnikoff could not take charge of this while Samuels was away (at the Israel Forum and then in US)? Pnini replied that <u>Resnikoff told him</u> that he would not touch this conference unless he received formal direction from Bert Gold or Bill <u>Trosten</u> to assume charge of the office. (Between the Times I got the impression that Bernie does not want to act unless and until Shimon Samuels is formally out.)

The forum, which is being cosponsored by the Leonard Davis Institute for International Relations of the Hebrew University and the International Relations Department of the American Jewish Committee, will be attended by noted Jewish scholars, persons active in Jewish communal life in Israel and the Diaspora, and prominent Israeli political and religious representatives. The conference is to be opened by the President of the State, Mr. Chaim Herzog. (A general outline of the program is attached.)

One of the strengths of the Jewish people in the face of oppression and assimilation has been the ability to adapt to changing conditions while preserving ancient values and traditions. Evolution has continued to the present day; contemporary Jewry contains within it a broad spectrum of movements, cultures, and lifestyles. Although various groups interpret the faith in different ways, they have generally sought to maintain solidarity and unity of spirit. The state of Israel has been charged with a formidable task: creating at the same time a Jewish state and a modern, pluralistic democracy. Over the years, unity has been maintained while competing groups have attempted to mold the character of the state. In recent years, however, the delicately balanced process has been disturbed. Burnt Torah scrolls and vandalized bus stations are grim reminders that some have lost sight of "Ahavat Yisrael", preferring violence over a peaceful continuation of the process of self-definition.

It is because of our concern over the increasing signs of polarization that we have organized the present forum. Our objectives are to explore ways to increase mutual understanding and to foster a spirit of tolerance and respect among the diverse elements of contemporary Judaism. Participants, expressing their own personal experience and beliefs, will be presenting varied (and often conflicting) points of view. The discussions may become heated, at times, but we are confident that the rules of civility and propriety will be maintained.

In addition to the major speakers, there will be a "second circle" of other concerned scholars, and religious and communal leaders who we hope will take an active part in discussions generated by the presentations. Our "third circle" will consist of an invited audience of educators, columnists and others actively concerned with state-religion and Israel-Diaspora issues. We would be pleased if you could be present, making your own unique contribution to the understanding of society, state, and religion in Jewish life.

In response to your memo of November 26, I spoke to Marc and he agrees to Zalman Abramov's suggestion to invite Pesach Schindler to participate in the closing session.

Re: the problem of Kashrut at <u>Mishkenot Sha'ananim</u>, Marc has asked to underscore that we must be scrupulously careful that all food served during the forum and at any receptions given by us be strictly Kosher. Charney Bromberg adds that NJCRAC was also very careful about this.

Marc suggests that Yaacov Pnini should be able to be helpful to you in checking out the Kashrut arrangements. I don't quite understand your statement that Mishkenot "does not prepare food on the premises for the reception. They use only prepared foods." Does this mean they have an outside caterer who provides his own dishes? If so, is the caterer under Rabbinic supervision? What kind of arrangements do they have for breakfast at Mishkenot, since we will have Rabbi Lamm, Rabbi Kelman and others who keep Kosher?

Since we seek to foster tolerance and mutual respect, we should not let ourselves be open to the charge of insensitivity to the requirements of Orthodox and Conservative participants.

I thought Golda Meir put it well when she was asked many years ago why she advocated having Kosher facilities at Histadrut enterprises when separate dairy and meat facilities seemed an unnecessary expense and the majority of the workers were not religious. Golda replied that she did not want workers to be together only on the assembly line but also to socialize. A Kosher kitchen was the answer, she said, "since my Orthodox colleague can't eat treif and it does not violate my Socialist Shulhan Aruch to eat Kosher."

Dear George,

CONFERENCE ON SOCIETY, STATE AND RELIGION:

In response to your July 1 fax, as you know, Ga by Sheffer was absent from Israel for a lengthy period and then completely taken up by his annual conference. We got together at his first opportunity. He is now in Toronto until July 18 and will be in Madison, Wisconsin from July 20- August 15. He can stop in N.Y. on his return, if you are available. Please let me know so that I can inform his office accordingly.

55

We first discussed format and agreed that the present program outline allows for five sessions, each of three speakers (ideally an American, an Israeli and another). This would provide for 15 papers over a period of two and a half days (two sessions per day). If we were to include a second circle of discussants, which would include political activists, then we thought appropriate two discussants (one Israeli and one foreigner) per session; thei would mean bringing 15 people from aproad.

On cost, we agreed that the Israelis would not be paid and that the 15 foreigners would each cost \$70 per day for 5 days = \$5,250.

Assuming that 10 of the guests are from the U.S. (\$1000 each for fare) and 5 are from Europe, (\$600 each for fare), total fare would be \$13,000. Total expenses (not including publishing of proceedings) would be under \$20,000.
