Dear General Haig:

I was delighted when General Elvy Roberts informed me that you might find enough time to be interviewed by me in the future.

I was saddened and also rather elated that you had by-pass surgery. I was saddened that it was necessary but elated that you came through it apparently quite beautifully. I can only hope that you will do as well as I did following by-pass surgery in 1972. I might say in this regard that every one of my patients who has had by-pass surgery has not had a return of their angina. I believe that it is not simply due to the surgery but to the sort of medical advice that they have received. This advice had not been generally given throughout the country and perhaps accounts for the 50% recurrence of angina in five years following this operation. Now I believe Dr. DeBakey and also Dr. Cooley are pretty much convinced of certain post operative living habits that should be changed if the surgery is to be more than palliative.

I am coming to New York from Washington on June 5 after interviewing Secretary of Education Hufstedler and also Mr. Hugh Sidey of the Time Magazine Bureau. I was wondering whether I might be able to interview you in Connecticut on June 6 or Saturday, June 7. Will you be back from Florida by that time? If these dates are not convenient, I will again be in New York in the last week of August and I
