Dear Rabbi Tanenbaum:



of this. They are planning to republish a phamplet he wrote called the "Jewish Jesus and The Christian Christ" and give it to people on that day. I have heard you speak at dinners of the American Jewish Committee. I am looking forward to knowing you.
