Dear Rabbi Tannenbaum:

We want you to know that it was with considerable reluctance that NBC decided to postpone the Conference in Ft. Lauderdale planned for December 6-9. The decision was particularly difficult because we appreciated the inconvenience this step might cause you. Moreover, the American Values Institute and the Planning Committee of Voluntary Organization leaders had already done extensive and effective preparation for the Conference.

Our goal has been to make the conference the best possible. Unanticipated situations that developed last week led us to conclude that the best way to assure that the meetings would be as productive and rewarding as possible was to reschedule them. For one thing, the Conference had taken on such significance that our top Program Department executives, whose presence would add measurably to the discussion, had asked to participate. The first week in December, however, is precisely when the selection of new program material requires their presence on the West Coast. Dear Marc:

Last January we organized a conference of major voluntary organization leaders and NVC-TV executives. The meetings were held in Ft. Lauderdale, and were very successful in terms of opening up understanding.

Thirty-five groups were represented, most of them by chief officers. The conference grew out of our work for NBC in "valuing" on the local level.

We are now planning a second conference to be held in Ft. Lauderdale again, beginning Thursday evening Dec. 6 and ending Sunday afternoon, Dec. 9. We would like very much to have you join us this year.

A small group from the first conference is meeting to help plan the agenda. Our basic purpose is to have a free exchange of ideas about television. In our first meeting we discussed values, sterotyping, sex, commercials, racism, violence, children's programming, and the nature of television in our society. Again we hope to explore the degree of consensus and of conflict in these and other issues as they relate to values in American life.
