Dear Rabbi Tanenbaum,

Arrangements for the February 17 Interfaith Conference are now complete. A descriptive brochure is currently being prepared and a copy will be sent to you as soon as it is ready. Meanwhile, I would like to outline the format to help you in your preparation.

The program will run from 9 a.m. to 4 p.m. Your presentation on "Jews and the Political Process" will be the second (following Dr. Cynthia Wedel on "God or Caesar?" and preceding Sister Clare Dunn on "Ministering to the Body Politic"). As I described in my July 23 letter, we have allocated about an hour to your presentation, of which we expect 30-45 minutes to be your remarks and the remainder question and answer. The audience will be primarily local clergy although academics and laity have both been invited. In the afternoon you and the other two speakers will join on a panel in responding to the description of Evangelical Perspectives on the issue by Barbara Hargrove, a professor of the sociology of religion here in Denver; this is intended as a vehicle for the three of you to interact and for the audience to engage in discussion with you on the topic.

If you wish, we would be pleased to handle your travel arrangements so that it will not be necessary for you to await reimbursement. I will need to know which airport you prefer to use and when you wish to travel. Alternatively, please let me know what arrangements you choose to make so we can be sure to have someone here pick you up and the like. We will also take care of a room for you here once we know when you are coming; as far as returning to New York, you will be able to be at the airport by 5 p.m. if you so wish (although you are of course welcome to set your own schedule). If you have any questions, please do not hesitate to let me know. I will look forward to hearing from you shortly.

Dear Rabbi Tannenbaum,

I was thrilled to learn of your willingness to take part in our planned Interfaith Conference on Tuesday, February 17, 1981. Allow me to take this opportunity to describe bfiefly the program.

The Interfaith Conference is an annual event, attended primarily by local clergy but with other interested individuals as well. It is sponsored by a coalition of approximately 20 groups here in Denver and brings speakers of different religious traditions together to address a specific issue from their various perspectives. I have enclosed a copy of last year's program to give you an idea of how it is all set up.

Our topic this year will be "Religion and the State" (although the exact title may be changed to something a little less imposing). The choice grows out of the perception that this issue has arisen in a variety of different forms lately - e.g. Catholic priests' exclusion from politics by the Pope, fundamentalist Protestant quasi-religious pressure groups, Jewish lobbying on behalf of Israel, abortion, parochial schools, and possibly again the issue of the draft.

We would like for you to plan on taking part in two segments of the program: First, a presentation of 30 to 45 minutes on a related subject of your choosing in which you would outline a Jewish perspective pertinent to the issue. Secondly, we intend to have the three speakers (including yourself) on a panel in the afternoon at which time all would respond to an individual topic intended to present the opportunity for discussion among the speakers as well as with the audience.

I am going to leave things a little bit vague at this point so that you and the other speakers will have the opportunity to gravitate in whatever directions you are most comfortable. I would appreciate your letting me know the title of your remarks as soon as possible. We are in the process of finalizing arrangements with the Protestant and Catholic participants; I will let you know who they are and their topics as soon as possible. I will also keep you informed of plans regarding the afternoon panel as they develop. Its main purpose is, as I have implied, to create the opportunity for discussion and interaction.

The program will run from about 9 a.m. to 4 p.m. We will be pleased to make your travel arrangements should you so choose or to reimburse you if that is easier. When you let me know which approach you would prefer, please also tell me when you will be arriving and leaving so that we can set up hotel and transportation arrangements.

As I mentioned, I very much appreciate your interest and look forward to your participation in our program. If I can provide any information or assistance throughout the coming months, please do not hesitate to be in touch. I will look forward to hearing from you soon.
