I just had a rather lengthy [07:00] and friendly conversation with Ambassador Meir Rosenne, whom Shimon Samuels gave to us as a reference.

Rosan was quite positive about Shimon's qualifications. He said that he found Samuels to be thorough and reliable, that his reports on the French-Jewish situation have been honest, and knowledgeable.

He said, also, that Shimon [08:00] was not in a comfortable situation, that in fact French Jewry, French-Jewish leadership, tried to prevent the ADL from coming into Paris, but in that tough situation, Shimon managed to do a number of positive things. He said that he did not make many enemies.

He also said that he attended some meetings that Shimon had arranged, that they were well prepared, and that he did thorough research in preparing these meetings.

He added that [09:00] he is not a high-profile person, and is not a schvitzer.

He had nothing negative to say about him. That was an altogether positive report.

Number one, [Futot?] Yisrael. We are very much -- We share your concern about the breakdown in communication between [Aymanan?] Hadari, and Dan Elazar. On my return, I plan to discuss this question thoroughly with David Gordis. [19:00] David will likely be in Israel the third week of August, and I'm sure that he can be helpful in trying to straighten out the kinks in this relationship.

Number two, Nissim Rejwan. I'm not altogether up on all the details of that complicated relationship, but plan to do so on my return after August 15th. In the meantime, I am sharing this information with David. Perhaps [20:00] you can discuss this with him as well when he visits Israel.

Number three, AJC mission to Israel - Many of us share your concerns about the *hefkerut*, H-E-F-K-E-R-U-T, that has developed among a number of our departments and field offices in relation to separate missions to Israel. We plan to discuss thoroughly how we can bring better coordination into this area, as well as into others. It will be essential [21:00] that we develop some organized strategy for our relationship with the Israel office,

as well as with regard to other concerns which fit into our international relations programs.

The substance of that conversation is contained in the enclosed press statement.

Beyond that, as soon as I return in mid-August, I will respond [34:00] to the several excellent suggestions contained in your May 13th letter. In the meantime, my warmest good wishes to you and your family.

- M1: He's right to a point there. We have a budget in American Jewish Committees. Now, you tell me what item in our budget we should reduce to give it for this purpose.

TANENBAUM: Can I respond too?

M1: Yeah.

TANENBAUM: I think Mr. Shimel is addressing the question to our AJC procedures. I think you're right [37:00] in asking a question about priorities. Let me say to Mr. Shimel, with a very deep appreciation for all your dedication over the years. I think one of the real characteristics of AJC has been its ability to respond to crises in Jewish life, and emergencies, and not to be locked in to commitments we had

made a year ago, two years ago. For myself, and I want to share this on a personal level, the life of a Jew in Ethiopia is as precious to us as the life of a Jews --That's right. But I'm talking priority.

M1:

TANENBAUM: Right. Now, my own sense is, and one of the reasons why I felt it was important to put this issue on the agenda is that while we had paid a great deal of attention, given a great deal of priority [38:00] to the survival of the Jews in Israel, rightly so, and to the survival of the Jews in the Soviet Union, and have created all kinds of major organizations, with millions of dollars to help save them, and keep the issue of their survival before the Jewish communities of the world, we really have been terribly neglectful of a community, at one time, was over a million people, and because of our neglect, has now been reduced to a pitiful number of 25,000 people. What are we going to do? Wait until they are all converted into Coptic Christianity, because we are not paying attention to them? Or wait until they're all sold into slavery? The issue for me now is to clarify the practical question -- I have no question about the priority. The fact that they have been neglected for a hundred years by American Jews to our shame, not to our credit, and the issue is for us giving them a number that are still there surviving, what

we do [39:00] to find a way to -- The one thing that I'm not clear about as a result of our conversation is that apparently, something has begun to happen in the past two years with (inaudible), especially in which the (inaudible) acknowledged that some significant activity is taking place, and the question is, how significant is that? How real is that in terms of getting through to the Jews of Ethiopia? If it is not significant, there is the possibility there of really trying to make a difference in their lives, then I think we ought to look at that now, and see what we ought to be doing to go beyond this. I really don't want to get locked into the business of whether they have a claim for their conscience. I have no question about that they have a (inaudible), perhaps a greater claim than many other Jewish communities to whom we have given necessarily, and rightly, a great deal of attention. I mean, I think personally (inaudible), and I personally have not paid attention to this issue, [40:00] while I've paid attention to many others, and now I'm going to try to make up for that now.
