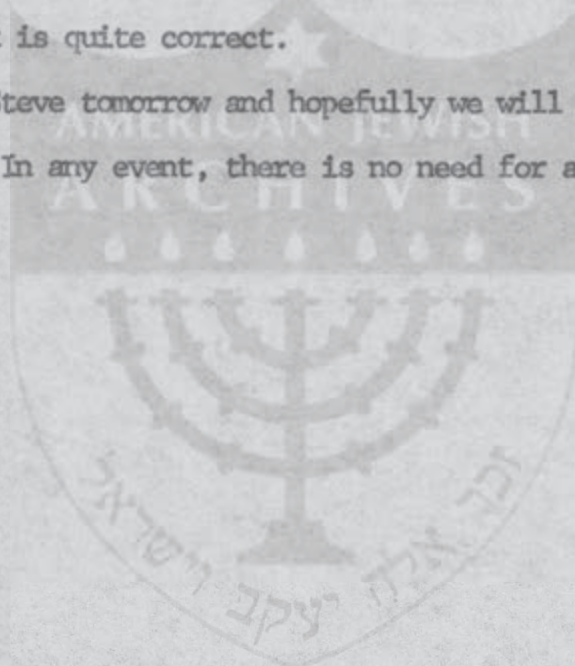

Subject STEVE SCHAFER'S/INTERNATIONAL EDUCATION FUND ARRANGEMENTS WITH UAHC

Alex, Josh Dwork has at your suggestion, discussed with me his rather acrimonious and difficult conversations with Steve Schafer concerning the transfer of the \$400,000 from the International Education Fund to the UAHC, and the terms and conditions thereof.

I am very clear in my memory of exactly what was to happen. The \$400,000 was called in the discussions an "advance." It was not stated what it was an advance against. It was an "advance" against nothing. Merely an "advance." The words "advance against expenses" were never uttered.

It was never contemplated that these funds would be advanced to the Union and that Steve would then charge off expenses against that "advance" because if that were the case, we would have nothing left in a year or so.

It is my clear recollection that the word "advance" was used instead of "loan" only because Don, Gil and I felt very strongly that it was in all cases the Union's money and therefore you were "advancing" money from one UAHC account to another. A loan would imply that the International Education fund was something different and apart from the UAHC, i.e. the affiliates, the World Union, etc., to which you would have a "loan."

Therefore, the word "advance" was used instead of a loan but it was not an "advance" against anything. It was merely a different word then the word "loan." It should be treated as a non-interest bearing non-callable loan. For our sole use, Steve, in my judgment is obligated to continue paying his expenses as he has heretofore.

I am prepared to defend this position in any confrontation with Steve and I'm also prepared to discuss this with Don and Gil if you approve.



The following is a summary of the decision that we made at our meetings yesterday concerning IED Funds.

1) The UAHC Kibbutz Yahel Fund money will be deposited in the UAHC Endowment Fund account and accrue the prevailing interest. At the moment there is approximately \$40,000 in the UAHC general fund which belongs to the Kibbutz Yahel Fund. This money has accrued some interest. Fred has the formula for determining the amount of interest. This approximate \$40,000 plus interest plus the approximate \$11,500 in attached checks (already having figured a 20% discount for the Canadian dollars) is to be included in the initial deposit in the UAHC Endowment Fund earmarked for Kibbutz Yahel. Please note that the approximate \$40,000 figure mentioned above does not include February Kibbutz Yahel Fund deposits. I would like to have a final total by March 20. Meanwhile, all these monies should be deposited in the UAHC Endowment Fund.

When the amount in the Endowment Fund reaches \$100,000, a Certificate of Deposit should be purchased in the name of Kibbutz Yahel at the prevailing interest rate.

2) International Education Department Funds accruing from this date will be deposited in a separate savings account in a bank to be chosen by Josh Dwork. The interest which accrues to this account are to be given to the UAHC general fund as the International Education Department's contribution to the general fund.

Funds of the IED which are currently on deposit in the UAHC general fund will be used to pay ongoing operation costs of the IED. It is understood that if cash is not available in the general fund to cover IED operations, then it will be necessary to withdraw some funds from the savings account. The purpose of this process is to reduce the debt of the UAHC general fund to the International Education Department. A monthly accounting of the funds on deposit in both the savings account and the UAHC general fund IED account are to be given to Rabbi Schafer.

It is our intention to avoid surprises concerning availability of funds and projected expenditures. Rabbi Schafer will give as much lead time as possible to Accounting concerning expected expenditures. The months of heaviest expenditures are April through July.

Rabbi Schafer is to be notified in writing about withdrawal of funds from the savings account.

Dear Shuka,

It was good meeting with you last Thursday. I understand that Michael has set up an additional meeting between himself and you to clarify further details of his Aliyah work. Michael has achieved a basic understanding of the nature of the Reform Movement and Reform Jewish institutions. He is deliberately and carefully publicizing the reasons for which he came to the Union of American Hebrew Congregations. He is laying the groundwork for support for Aliyah by meeting with individual leaders of the Reform Movement as well as speaking at the various conventions and meetings of Reform Jewish lay and rabbinic leaders. I appreciate and respect the way he is creating the proper climate for his work before announcing specific programs and processes. Of course, the establishment of the Reform Jewish Kibbutz is an exception to this. That program has been widely publicized, and we are in the process of recruitment.

On behalf of the Union of American Hebrew Congregations, I must express the hope that the agreement which we reached with you in February, be executed. We do feel that Michael Langer's tactical approach to the implementation of that agreement is the correct one. I would also like to call your attention to the fact that the agreement which we made in February actually went further than the original agreement with Uzi Narkis, reached at his meeting with Michael Langer and Rabbi Allan Levine in Jerusalem on January 9th.

As I explained to you last Thursday, and also at our meeting with Chaim Ganel and Schraga Milstein some months ago, the Youth Division of the UAHC will hire an additional staff member in order to facilitate the work of Michael Langer, in particular, and in support of all of our Israel programs, in general. It is essential that you meet your financial commitment to us in the same punctual manner that we have so far met the obligations that we undertook when we originally committed ourselves to accepting a shaliach and to establish an Aliyah desk.

Memo of Understanding

February 6, 1975

The meeting was attended by Rabbi Alexander M. Schindler, President of the Union of American Hebrew Congregations; Rabbi Stephen A. Schafer, Director of Youth Division, UAHC; Mr. Yitzchak Yadlin, Aliyah Department; and Mr. Schraga Millstein, Youth and He-Chalutz (AZYF).

The purpose of the meeting: The establishment of an Aliyah Desk by the Reform Movement (UAHC, CCAR and HUC-JIR). The agreement includes the following:

- a) A desk will be established at the UAHC House of Living Judaism, 838 Fifth Avenue, New York, N.Y. 10021;
- b) The Director of the Desk will be Michael Langer, Sheliach, under the supervision of the Director of the Youth Department, Rabbi Stephen Schafer;
- c) While on a staff level Michael Langer is responsible to Rabbi Schafer, his function will not be limited to Youth but will extend to the full range of Aliyah activities, according to the job analysis prepared by the Aliyah Department of WZO;
- d) The WZO Aliyah Department agrees - upon confirmation by its Treasurer, no later than April 1, 1975 - to provide a sum of \$20,000 for this desk and its related activities. \$8,000 of this sum is to go to Michael Langer for maintenance expenses in the United States and Canada. The balance is to be made available for the implementation of the Aliyah Desk;
- e) While Michael Langer is under the supervision of Rabbi Schafer, it is understood that he will be guided in his activities by the responsible WZO office in New York.

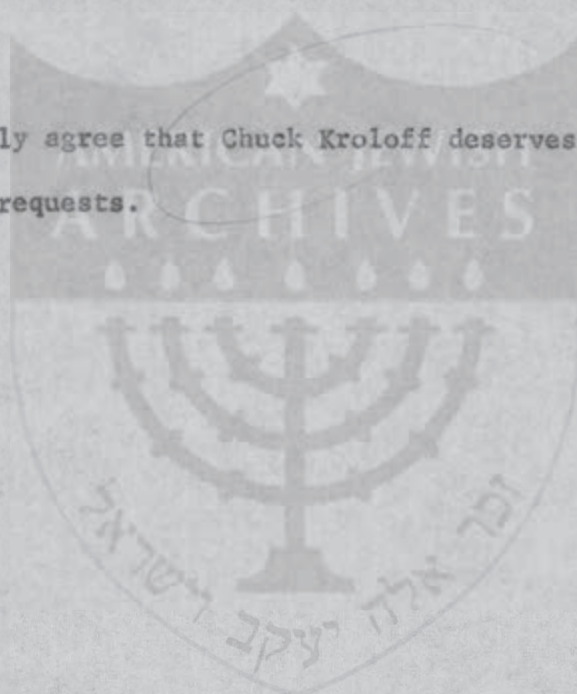

I agree with you fully -- or almost so. This is precisely why I have been pressing for a total review of our financial situation as well as for the including^{OP} of \$15,000.00 in the budget to allow for the borrowing of money, and this is also why I set up the meeting with our treasurer. In one way or another this financial mess has to be straightened out, although I am afraid the mess is caused principally by the absence of a cash reserve and not by any sloppiness or irresponsibility.

Once we have a cash reserve, the co-mingling of funds would present no difficulty and would be the easiest way of handling the matter.

And even with a shortage of funds, the co-mingling is not really wrong. After all, would it not be wrong to borrow money and to pay interest on it while we have other money sitting in a checking account unused? This is an injudicious use of money.

The only thing really that is wrong here is not ^{the} a co-mingling but the planning. Did Dwork and Fred Cohen know, were they told by you, that these funds would be needed for such-and-such a time, so that they could plan for the availability of funds -- doing the best they can?

As of this date, I have accepted 17 applications with 4 more in the process of being accepted making a total of 21.

A number of serious inquiries which I had expected to become applications are no longer live prospects due to concern over the security problem in Israel. I believe this is the single reason why we do not at this date have 30 applications.

In the past 10 days, both applications and inquiries have dropped to almost zero. It is difficult to tell to what extent this is a result of recent tensions.

I estimate we will end up with 30--after cancellations. Our date for cancelling at Kfar Galim is April 5. In view of the number of applications we now have, I assume that we are now prepared to commit ourselves to the program. In the event we end up with less than 30 applications, we will have an even greater deficit than the budgeted deficit of about \$2000. I presume this is a risk the UAHC is prepared to take.

Perhaps we will reach 35 or 40 by June--but I think we have to be brutally realistic in view of recent events. If there is any desire to re-evaluate, and I hope there will not be, it would have to be done within the next few days. If I do not hear from you, I shall assume that you are committed to going ahead based on the above numbers.

I am still personally very enthusiastic and confident. But I want to be conservative in the prospects I offer so that you do not say to me in June, "You should have warned us that it will cost us more than we anticipated."

I assume that the Israel Committee is prepared to back us up financially.

Spoke to Wiche. We agree that you should proceed.

Subject Camp-Institute in Israel

Attached please find revised tentative budget for our Camp-Institute in Israel. The most tentative part of the budget is the Trans-Atlantic fare. If our California group produces, we shall have to add an additional staff fare. But this ought to be compensated for by additional income.

Also, we shall have to confront the possibility of the 5% travel tax. I would appreciate Dick's opinion as to whether this will go through as proposed by Johnson. I am strongly opposed to raising our price. We are already \$100 over comparable programs and I do not want at this time to issue any statement regarding an increase in price. I would also appreciate Dick's opinion considering whether we can obtain a ruling on our "package" which would put us under the \$7 a day limit. It would be unfortunate if parents had to pay a tax on top of it. While our per diem expenses to Kfar Galim are only \$6.50, the total cost if administration is included will be well in excess of \$7 per day.

I believe we will have many things to talk about by February 19. Could I ask that Hank Skirball plan on joining Dick and me for discussion and evaluation on Monday, February 19 at 10 a.m.? Hank: Would you invite anyone else you feel should attend?

Financial control of National Committee on Israel

Your memo of December 19th puzzles me. Part of the reason may well be that I did not see Selma's memo which gave your words occasion. Still, I do believe that it reflects some misunderstanding on your part.

Obviously you are right, and I agree with you that the budgetary controls for the Israel project -- as for any other aspect of our work -- should be as tight as they possibly can be.

Your confusion arises from the fact that you confuse the Israel Camp project with the Israel program in its entirety. The former is not an aspect of the latter; if it were, we could not have initiated it -- not before the Committee had its meeting.

This project receives its authority as an extension of our ongoing youth program in Israel. It is but a variation of a melody which we have been playing for a long while. This project is not unauthorized. I authorized it -- after I examined a carefully prepared budget, submitted by Rabbi Skirball, which demonstrated that the project can be self-sustaining and that the risks of loss are minimal.

As far as budget controls (for the camp) are concerned, a special meeting has been set up involving the principals and Ted Broido. Because it will be held on January 4th, after your departure, you were not involved. Nonetheless, you have been told concerning this meeting.

As far as the Israel Committee itself is concerned, there has been no "mush-rooming of budgetary decisions." Some small expenditures were authorized by me -- required for the mailing of fund-raising materials designed to effect our Montreal decision. These small seed funds had to be expended -- we couldn't expect our congregations to respond without being prodded. We couldn't steal this money from other departments, and had to charge it against future income. The 2,000-odd dollars since received cover these costs tenfold.

Subject Mrs. Meyerson's December 18 memo re financial control of National Committee on Israel.

Before we can decide who will have control over the budget we must first arrive at a budget. I recommend that a budget be formulated as quickly as possible before people continue to run off in different directions and spend monies which have not heretofore been budgeted.

This entire Israel Committee program, in fact, has mushroomed altogether too haphazardly, with many administrative and budgeting decisions having been made in meetings of small groups to satisfy immediate needs, without thought having been given to the overall future scope of this entire program. For example, we have already received notice that monies will be spent on a UAHC camp-institute in Israel. No budget, however, has ever been established for this, yet a staff member has been appointed with authorization to hire a secretary, etc. Has formal approval been obtained for this? - it is not included in any budget.

I certainly recognize the importance of this program, and I, too, am just as eager to start it as are other members of staff, but let's start it properly lest we jeopardize it completely by making costly mistakes due to hastily made decisions. I think you realize, as do I, the need for exercising tight financial control over this project, as we do in all other programs of the Union. I'll be glad to help formulate a budget, if you feel it necessary, in the few remaining days before I leave.

Financial control, once a budget has been established, should be exercised from 838 and not from Washington, with all due respect to Dick. He can control the RAC easily, since that is his base of operations. The Israel Committee, however, due to its very nature, base of operations, far-flung staff and sizeable revenue (hopefully) must be controlled by a staff member assigned to this purpose only at 838. I suggest that this task be assigned to a fiscally-oriented individual.

Subject Fees for K'far Galim

In working out the finances for our proposed project at K'far Galim for the summer of 1968, we reached an expense figure which includes New York - Tel Aviv - New York transportation, leader's salary, promotional stickers, travel and office expenses, contingencies, etc. of roughly \$800 per youngster. This means that we could not pay the K'far Galim the figure you discussed vis-a-vis K'far Rarok charges and still break even on the project.

As you know, we have no guarantee of any subsidy from the Union and ~~xxxxxx~~ have not received a mandate to plan a program which would yield a deficit. From this point of view it seems to me we have to re-think our finances vis-a-vis K'far Galim.

From another point of view, it seems to me that the K'far Rarok's figures are way out of line. I say this after having spoken to Israelis in both the consulate and the Sochnut. I think you should know some of the following:

- 1 - For room, board, and supervision at Ben Shemen this summer for a group of 30 NFTYites, we are paying 8 and 1/2 Israeli pounds per youngster per day.
- 2 - The Jewish Agency offers a 5-month Ulpan -- classes, room and board for a total of \$184 U. S. for the whole 5-month period. This is, of course, subsidized.

Our people suggested a fee of 10 Israeli pounds per day per youngster which would not include tiyulim.

I would appreciate your discussing this with the Director at K'far Galim in hopes that through adjusting the fee, we can be enabled to hold the program this summer at this fine institution.

The basic problems are that we cannot use UAHC personnel and departmental budgets for this project -- coupled with a very small volume (25 youngsters) -- so that prorated administrative costs are very high.

Dick Hirsch spoke of paying K'far Galim \$8.40 per day for 45 days plus \$60 for trips. This would come to \$10,950. In our budget, we could only offer half (\$5,035) or roughly \$200 per youngster. This would be over 600 pounds (with the new devaluation) or about 13.3 pounds per youth per day -- perhaps 15 pounds with the devaluation).

If we can count on a \$5,000 subsidy from our campaign, then we could pay K'far Galim what Dick discussed with them vis-a-vis K'far Yarok's fee.

- - - - -

The only element of competition this will have with NFTY would be that seldom will a youth go on a NFTY Israel summer program at age 16-17 if his parents sent him on one at age 14-15.

If we enlarge the camp to 100 in the future, this will have its effect and we should consider if a youngster will go once during his mid-teens -- whether it is better for him to go to camp at age 14-15, or to a Mitzvah Corps, Torah Corps, Dig, or Tour at 16-17.

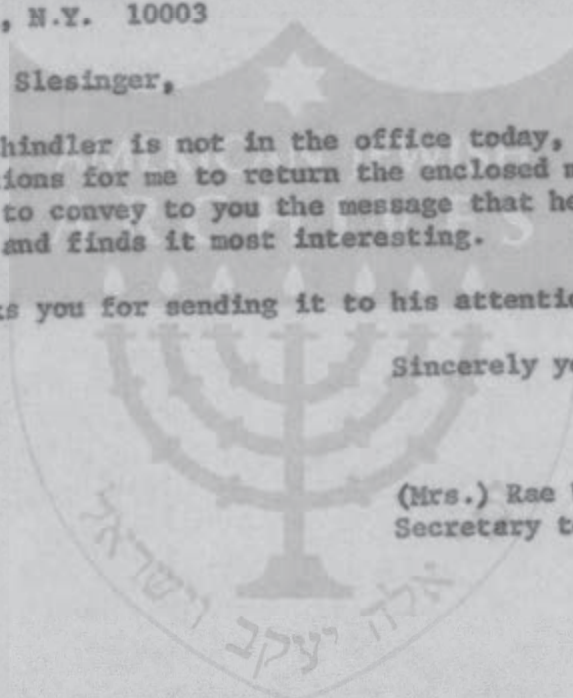

As an educator known for your dedication to the cause of the furtherance of cultural ties between the United States and Israel, I am taking the liberty of asking your counsel and cooperation in the initial planning and development of a new program of educational exchange: a project whereby American tenth year high school students will be offered the opportunity to spend a year in one of two leading Israel secondary schools. In the past, such year-long programs have been limited to the college level.

I therefore invite you to be my guest at a planning luncheon on Monday, October 31st, with a small and select group of educators, to be held at 1:00 p.m. in the top floor conference room of the Jewish Agency, 515 Park Avenue.

The Israel Ministry of Education, and leading Israeli educators, have been working on this project for several years, and have even discussed it with Dr. Bernard Donovan, the New York City Superintendent of Schools, and a few other American educators who have visited Israel. The year in Israel will include a preparatory period in an ulpan for the study of Hebrew, with the balance of the year devoted to an academic program which will fully meet American curriculum standards, as well as providing ten to fifteen hours a week in Israel studies.

It is our hope to establish an American group to plan and further the development of the program from this end. In Israel, the project is being set up by Hamekhez Hameshutaf Latfutsot, a joint body of the Israel government and the Jewish Agency operating in the field of cultural and educational programs. The two schools currently cooperating with this project are at Alonai Yitzhak and Shafrir.

There are many problems to be considered: the curriculum, accreditation, and the development of interest in the program. We know you will want to help.

Camp in Israel

I read your proposal for a Summer Camp in Israel with a good deal of interest and I must say that I was not at all surprised; after all, great minds think the same thoughts.

Accordingly, it should not surprise you to learn that we explored this possibility some time ago, two years in fact, and had many meetings discussing the various problems attendant upon such a venture. Norman Buckner was involved, Hank Kirball, Levi Smolar and Ben-Horin.

As a matter of fact, we went considerably beyond the talking stage. Day by day schedule was drawn up of activities which aimed to fulfill precisely what you have in mind (we found some difficulty in developing a program of sufficient interest to both American and Israeli youngsters); and once Ben-Horin went to Israel he visited several kibbutzim and similar places in the hope of finding a site.

Following these explorations we did nothing; not that we vetoed the project but simply left it in abeyance, and this for several reasons insoluble:

a) Financial. The costs which are involved are considerably greater than you think. No, it cannot be done for "little more than our youngsters spend for camp here in the United States." To begin with, there is the cost of transportation; moreover, the other kibbutzim and places of residence do demand money, not much less in fact than many a camp which we rent here; lastly, there is the cost in transportation of the staff members which we would send along with our group. Certainly we cannot depend entirely on resident Israeli staff, and here is a sizable cost chunk which has to be distributed on a per capita basis.

b) Supervision: A summer program does not involve test work over the summer. It takes months of careful, pains-taking preparation. Where, oh, where, will we find the staff and procure the money to obtain it?

Your Idea of August 22.

I was going to write you a lengthy memo in response to your travel suggestions but in the meantime received Ruth Bookbinder's and concur in general with her reactions that the program you envisage would be impossible to implement on such a grand scale.

I do see the validity in organizing separately most of the programs you have reference to. For example, there is no reason why we could not have a seminar on government for a select group of leaders for a week (during the winter incidentally, and not during the summer), or a program at the camp, or a visit to New York, or a visit to Cincinnati. Each of them would have to be a separate kind of attraction.

The other aspect of it which is most important is that the people who participate in such a program would have to be properly motivated and if possible people with some kind of responsibility in their congregations. For example, I would not want to go through the effort of organizing a program here in Washington for just anybody. It would not be worth the effort, because there would not be the necessary follow through to make the program meaningful. The people who come would have to be people who have some kind of record of participation, or who are at least, members of a social action committee.

As long as you are throwing out ideas I want to put in writing the idea I suggested to you a couple of weeks ago.

For some years now I have believed that Israel offers the greatest potential means of enriching the life of American Jewish Youth. A sojourn in Israel properly guided and directed can be a history lesson, a Hebrew lesson, and a spiritual experience wrapped into one which nothing in the United States can parallel. I think that the experience of our NFTY Pilgrimages and our Eisendrath Exchange programs bears this out. However, these programs are geared for post confirmation youth. We have no Israel program for children of religious school age and we have no really effective Hebrew program in our educational system.

Even though our UAHC camps have achieved a great amount of success, we are only reaching a small percentage of the membership of our congregations who send their children to summer camp. We are especially failing to reach those who want to send their children for the entire summer. My suggestion, in brief, is to establish a UAHC Camp-Study Program in Israel for children between the ages of 10-15. Here are some suggested factors:

1). Program

In order to achieve the objective the program would have to be related in an integral way to a program with and for Israeli children, especially since a primary objective would be acquiring a facility in Hebrew. At least half the day would be spent in ~~study~~, ~~work, travel, and the~~ study, using the latest ULPAN methods. The rest of the day would be spent in play, work, travel, and the normal aspects of camp life. The program would be based on the hope, at least, that the children would spend more than one summer and would return in consecutive years to build on their backgrounds. Also it would be desirable to integrate the summer experience with a "back-home" experience, if that is possible.

2). Physical facilities

We should not purchase land or invest in a physical plant, but rather should establish a relationship to an existing institution, such as a kibbutz like K'far Blum which has a fine educational system, or a children's village like K'far Silver, or an ULPAN. If the program is successful we may want to expand by having groups (Garinim) in several places rather than concentrating a large group in one location.

A number of Kibbutzim conduct camps for Israeli children during the course of the summer. This might well be an additional program and if arranged properly with the Jewish Agency and the educational institutions in Israel could be a highly significant undertaking, which would be to the advantage of the Israeli institution, not only culturally but also financially.

3). Cost to UAHC

I do not think that originally any substantial investment would be required by the UAHC, anymore that we needed a substantial investment in the NFTY pilgrimages or Eisendrath Exchange program. It would require someone on the spot to deal with formulating the program and administering the details, and someone here in the Department of Jewish Education to coordinate the enterprise. Negotiations with the Jewish Agency and with whatever institution we associate with in Israel should result in establishment of a package deal which would include some means of covering our administrative expenses.

4). Cost to Parents

The cost would be no more than that of a good private camp which I am told averages \$80.00 - \$100.00 a week. With the cooperation of the Jewish Agency the program could be kept to a maximum of \$800.00 and given the fact that some of the children would come within the half-price air travel, might even be pared down to \$500.00. At any rate the cost would not be prohibitive, and considering the educational value, would even be attractive.

5). Attendance

The attendance would be limited at first to a small group; preferably on a select basis as a reward for achievement in the religious school. I would imagine that 30-40 would be maximum for the first time.

6). Staff

The staff would consist of both American and Israeli educators. Opportunity would thereby be given also to enrich the background of our own UAHC educators and their families.

7). A Possible World Union Dimension

In addition to children from the United States it might be deemed desirable to invite students from other countries as well, which would result in an even richer experience.

I am just tossing out the idea for further discussion. I have not worked out the details at all, because I think this should properly be within the hands of the Commission on Jewish Education, but I do think that the idea is worthy of further discussion. Incidentally, I understand that the Conservative movement is in the process of establishing a RAMA camp in Israel. As a starter, in case you are worried about customers, I offer the four Hirsch children.
