# American Jewish Communal Camps To Have 75 Israelis on Their Staffs

Interviews will begin this month for the selection of approximately 75 Israelis who will work this summer as counselors and specialists at Jewish Community, Federation and other Jewish community agency camps throughout the United States. Asher O. Melzer, director of Surprise Lake Camps, Cold Spring,

N.Y., will be in Israel for this purpose, from February 15 to March 15, representing JWB in a camp staff program conducted in cooperation with the Jewish Agency for Israel.

Last summer, 49 Israelis served 8 camps under the program which is intended to enhance the Jewish program element of the participating camps and to provide the Israelis with a better understanding of the American Jewish community.

Michael Reiner is director of the Camp Shlichim Department of the Jewish Agency. JWB's responsibility for the program is being handled by Mrs. Roslyn W. Kriegsfeld, director, Part-Time Personnel Bureau, JWB's New York Metropolitan Region. Arthur Brodkin is JWB Camping Consultant.

Subject Administrative Responsibilities Concerning Camps

I am writing this myself on Sunday afternoon.

If you will recall, when we chatted briefly on Thursday, I mentioned that I was handling quite a bit of administrative work for the camps, and that Chuck has been doing almost nothing. Since these administrative matters were really little "nothings", it was easier to do them than to ship them to Mintz. (see enclosed memos)

However, I found the enclosed pile of materials on my desk when I came in this afternoon dealing with Shlichim. As you can see, Chuck has dropped this whole thing my my lap - without a hesitation.

Dealing with the Shlichim is ONE of the things which Chuch was supposed to handle - this was clearly defined. And now - Schoolman handle it!

At the present moment, I am overloaded with Israel Committee, and MOST IMPORTANT, the work of the Department of Education. I am striving madly to get some substantive materials into the hands of our directors for this summer, and to have some camp-related materials in the hands of rabbis and educators for the Fall, 1970 season.

Jack Spiro asks me to do a large amount of manuscript reading - and I consider it within the responsibilities of my Department - my primary job.

Now, Mintz is relieving himself of all administrative work vis a vis camps.

I refuse to be another burden on you, and telling you how much I am doing, or how hard I am working. I confess that I enjoy my work - and don't mind the long hours or heavy responsibilities. This includes Israel Committee.

But, I do mind being a kapara.

Dear Mr. Gluck:

In response to Mrs. Weil's call, I am sending you the enclosed two packets which will amplify the procedure for bringing Israeli specialists into the United States.

The packet that begins with the letter of May 4 is the first step we take. These documents are sent to the <u>local</u> office of the New York State Employment Service. The local office approves it and sends it on to the New York <u>State</u> Division which approves it and sends it on to the Regional office of the <u>Federal</u> Bureau of Employment Security. The Federal Bureau issues a "clearance order" which means that the candidates listed will be permitted to work here, and sends this to us. Please note that the clearance order must be obtained from the State in which the employees will work. We say that all our people will be working in New York State and therefore, we fill out forms for only this State.

Once we have the clearance order, we can file with Immigration and copies of those documents are included in the packet beginning with the June 14 letter.

The enclosed documents are confidential, of course, and I know that you will handle them accordingly. Should you have any questions regarding this information or procedure, let me know.



#### STATEMENT OF EMPLOYMENT SITUATION

The National Ramah Commission under the direction of the Teachers Institute of the Jawish Theological Seminary operates experimental Hebrew speaking summer camps for qualified students, aged 10-17, of the Conservative Hebrew Schools who wish to combine intensive religious study with the classical camping program of crafts, athletics, the arts, etc. Our campers number approximately 3,500 and our staff, including professional and non-professional workers numbers approximately 1,500.

With the growth of our Movement, our camping program has expanded. We need additional qualified personnel to meet vacancies which have arisen because of our expansion and because several former staff members are unable to return due to personal reasons. Although we conducted a very wide recruitment program by sending letters and flyers to Rabbis, Hebrew educators and students throughout the United States, we find that we still require personnel to fill the positions itemized and briefly described in question #22 of Form 1-129B. This situation is temporary and seasonal and may or may not recur next summer.



Just a quickie to accompany the enclosed. Should you have any questions about any part of the enclosed budget, please let me know. While there is a certain amount of conjecture on my part in preparing fixed figures for a fiscal period, there is also a certain degree of forethought in terms of knowledge of some costs and anticipated programs and activities.

Manufacture (Masses Provide

I can be more specific in the future, if you want, about some thoughts with regard to programs. As for salary, I would anticipate a \$500.00 per annum increase with the stipulation that if after the first year of employment the stated salary presents certain personal difficulties, it be reviewed to make whatever proper and agreeable considerations effective.

The transportation and moving allowance, not to exceed \$5,000, should certainly come well under that figure, but as you suggested, above the figure of \$2,500. that I initially thought would be possible.

There are some other points that should be spelled out with regard to the total financial arrangement, but these are relativley minor and can be detailed after review of the enclosed budget.



Just a quickie to accompany the enclosed. Should you have any questions about any part of the enclosed budget, please let me know. While there is a certain amount of conjecture on my part in preparing fixed figures for a fiscal period, there is also a certain degree of forethought in terms of knowledge of some costs and anticipated programs and activities.

I can be more specific in the future, if you want, about some thoughts with regard to programs. As for salary, I would anticipate a \$500.00 per annum increase with the stipulation that if after the first year of employment the stated salary presents certain personal difficulties, it be reviewed to make whatever proper and agreeable considerations effective.

The transportation and moving allowance, not to exceed \$5,000. should certainly come well under that figure, but as you suggested, above the figure of \$2,500. that I initially thought would be possible.

There are some other points that should be spelled out with regard to the total financial arrangement, but these are relativley minor and can be detailed after review of the enclosed budget.

Confirming our telephone conversation, I met with all of our rabbis in Israel and with Ezra Spicehandler, collectively and separately, to discuss Irv Kaplan. The following are some of the thoughts they have: On the pro side, the fact that Irv is not a rabbi, may give him a certain freedom of movement which the rabbi does not have. We also have a guarantee that he will not be "seduced" into taking a pulpit, as Bob was. They all felt, that on adult one to one relationships, Irv was very good and had a certain manner which went well in Israel. Especially, they all felt he must be quite good, judging from the wonderful results he has had at Oconomowoc. They also felt, that since he is going on aliyah on his own, that there are no problems of a brief stay, or of a tentative commitment to Israel. He would become an Israeli of American extraction. Financially, they thought that perhaps we owe it to our own people to find work for them in Israel if they decide on aliyah.

On the negative side, they felt he was not as conversant with reform or progressive Judaism, nor as sympathetic to it as might be one of our rabbis. Offsetting this, however, is his experience and commitment to conservative Judaism which in the last analysis may be closer to the Israeli progressive form, than would be an American reform. Irv also seems to be able to gather around him fine spokesmen, thinkers and performers. His ego is not such that he has to be in the limelight. I stress these points, since my meetings with Israeli youth seem to leave me with the impression that what they really want from a youth movement is discussions on Jewish theology, sociology and the like. This is what they feel lacking in their school curriculum.

Incidentally, there are no more youth associated with movements today in Israel, than there were in 1948. The prize ligatof youth belonging to movements has fallen to about 25%. Thus, we would have to bring in something guite new and different than the old hoof and mouth Judaism, camping, etc.

Also, on the negative side is the fact that Irv is not easily supervised. His creativity and energy are such that he will not be hampered by supervision, which tend to slow him down.

The final negative point is that Irv does not function well as a "wet mouse" for youth. His patience and temperament do not seem geared toward this sort of activity. This, in itself however, is not crucial since when he ferreted out such cases, he could refer them to our rabbis.

Bob Samuels wanted Irv to come to Haifa and work at the new Leo Baeck Youth Center which will probably be more elaborate and ambitious than the present Rothchild Center on the Carmel. Bob got the feeling, however, that Irv did not want to do this, since it would be "reverting" to his job at Beth El in Highland Park which he held prior to coming to Oconomowoc. On speaking to Irv about this, I got the impression that he would not mind doing some work at the Beach Center for a year of two, but would not want to see this as the limit of his activities.

Mel Zaeger would like Irv to live in Tel-Aviv and work throughout the whole area, organizing youth in Tel-Aviv, Ramat Gan and Hertzaliah -- not only at our congregations, but through schools, youth movements and even kibbutzim. Mel pointed out that there was no value in bringing in a national youth director if there were no local youth groups.

Tovia Ben Chorin would like Irv to come to Tel-Aviv and also work at Ramat Gan.

Ezra Spicehandler feels that language is essential before Irv begins to work with any Israeli youth, with the exception that this is already affiliated with our movement. He emphasized that Irv should spend six months to a year at an ulpan and travel around the country visiting various youth programs for at least a year before launching on any new projects outside of our family movement. He pointed out that Israel is a small country with good memory, and that we would have to live down any "booboos" which we make.

Shimeon Chasdi would prefer Alan Levine for the EIE and other youth work in Israel. I get the feeling that Bob and Mel possibly feel the same way. On balance, everyone felt that we should bring over Irv in some capacity.

My recommendations is that we bring over Irv as of June, 1969 and let him begin living at Kfar Galim with his family. He could help with the Kfar Galim program and also travel around the country to observe the various nifty programs. He would then go to the family ulpan (Ben Yehuda) in Netanya for six months, ending in late February. By then, we could decide whether he would go to Haifa, to Tel-Aviv, or to a point between them. I think we all reluctantly agree that Jerusalem is not the place for him at this time.

Bob Samuels and I had a meeting with Avraham Maron and Benjamin, the Business Manager of Kfar Galim. I let them know at the beginning that I was not empowered to make any commitments or agreements, but that I would transmit the contents of our discussion, with the hope that we can immediately confirm details of Avraham.

It is my understanding that Irv Kaplan has committed himself to supplying a group of 17 youngsters. It is Avraham's understanding that we are looking for a total of 70 youngsters for the younger camp, making a total of 87 from the Union. Since they house 80 in a block, we could have separate quarters for our 2 groups if we reach 70 or possibly 60, since we are going to have Israelies with us as well. If we have less than 60, then our kids would have to live with the Kaplan kids.

The latest that we could give them the number that we are sending, is the end of February. At this point, we are committed to that number whether or not we supply that number. Thus, we should give a conservative figure, and if we find we could send more, we can write and see if they could make more room for us.

I want to emphasize that this is a "labor of love" for Kfar Galim. They could easily fill their plant with kibbutz youth who pay ILlO a night. This does not include linen, program, tours, counselors, etc., which they supply. In other words, Kfar Galim can just sell beds and have absolutely no program worries. They are budgeted to fill these beds all summer. Thus, we must tell them by the end of February how many beds we shall take.

We discussed the fee, and I asked Avraham to give me the minimum fee which he can break even on. I told him that I personally would not "handle" with him, and that we wanted the minimum fee. He gave me the fee of \$7.50 per youngster per night, for a 45-day season. Unlike last year, this will include medical insurance and the entrance price for all sites visited on tours (this was not done at the beginning of last summer), which includes all trips, all meals on all trips, including one hot meal a day on the road. It will include salaries for Israeli Hebrew teachers from the University of Haifa Ulpan and for Israeli counselors of our choice at the ratio of 1 to 20.

Kfar Galim would charge us \$3.00 a day for our own adult staff such as Marc Rosenstein, Sue Lorge, etc. If there are staff children, they come free, I make the latter point, since Bob Samuels is considering being the director this summer. He will give us a decision in a week.

The program would entail spending the first two weeks at Kfar Galim with no major trips. These trips would take place pretty much as they did last year; also hopefully, many of the "punctures" would not reoccur. Amnon Avramson would agin coordinate the program, along with Marc Rosenstein. The trips would follow two main threads -- one is the Bible, and the other the Roman Rebellion, ending at Massada. Avraham will have an active part this summer, but will not spend as much time as he did the pioneering year. It is also contemplated that we should engage an HUC couple presently in Jerusalem. The wife would teach English to the Israeli campers. The husband would assist in programming. The Israelies again would come for three week periods and the advertisements which went out two weeks before the camp started last year, would go out Pesach time this year. Bob Samuels will interview the HUC students in Jerusalem.

I suggest that we immediately make a budget which would include all salaries, transportation, etc. as well as Bob Samuel's salary if he is to work for us.

We should include in this budget, money for extras, since Kfar Galim is not responsibile for extra bus or truck rides, or any "goodies" which we decide upon. They also ask us to bring walkie talkies for interbus communication.

Per my memo, on Irv Kaplan, there is a chance that he and his family will be living at Kfar Galim this summer; also he would have to be free to travel around a bit to visit other nifty summer programs. I recommend that a letter of agreement pursuant to the above points be sent as soon as possible to Avraham with carbon copies to Rabbis Bob Samuels, Chuck Kroloff, and Messrs Marc Rosenstein and Irv Kaplan.

So many things have happened and there are so many things in the works that I do not know where tobegin this letter.

First of all I hope that you have fully recovered from the H.K. Flu. Hope you are well and going strong again.

# (1) Leo Baeck School :

Both Alex and Hank have been here and we have had some important discussions with them. With Alex I discussed the whole matter of the relationship between the Baeck School and the UAHC. We were surprised to learn from Alex that he did not know of the meeting that we had this summer with you, Dr. Shankman and Judge Baar, and he also had not heard of the moral undertaking of the World Union to cover a total deficit of up to \$50,000. He was also not aware of our agreement to add important members of the World Union from outside Israel to the Baeck School Board. We are anxious for this agreement which we came to this summer to move from a moral to a legal arrangement. Would you suggest to Judge Baar that he draw up such an agreement between the "orld Union and the Baeck School on the basis of the points we worked out this summer. I also discussed with Alex the problem of furnishing and equipping the School. I filled him in on the background of the relationship between the School and the UJA and of Maurice's commitment to help us raise the capital funds through the Israel Education Fund. I told him that following the meeting which I was having with him I would have a meeting on that day with Eliezer Shmueli, the Head of Secondary Education at the Ministry of Education, and that I would write to him and tell him where we stand on this. It seems to me at the moment that we will be able to raise addition. al funds to complete the building and furnish the School through the IEF, and not through the organization of the Israel Committee. However, this is by no means sure, as we have not been able to meet with Herb Friedman. Alex told me that Maurice had written to Herb but as yet has received no reply. In any event we do not see how it will be possible to plan to enter our new building at the beginning of the next academic year without settling this matter during the coming months. Since this is not a small project it looks to me how that either Dr. Elk or I will have to make a

trip abroad to have the right decision made quickly.

Both Hank and Alex were apprehensive that the NATE Baeck School Fund might suffer this year because at the NATE Convention a new project "Neoth Kedumim" was adopted for all Keren Ami Religious School Funds. Are we right in assuming that one of the ways you had in mind for helping us cover our deficit was to up the NATE Fund? Heinz Warschauer will be in Haifa between Purim and Pessach for a week and we will discuss this with him. Perhaps it might be worthwhile to meet with him prior to his departure from the States.

#### (2) Capital Fund Drive:

I continue to have correspondence with Kivie Kaplan, Joe Klein and Roland Gittelsohn regarding the possibilities inherent in establishing an organization for the capital fund drive for our congregations. I realize that the wheels of organizations grind slowly and that fund raising in the U.S. is a full-time job which is not connected with this. However, as I wrote you recently, we are now labouring under most difficult circumstances. I spoke with Alex about this. He listened, made notes in his little book and did not comment. I would appreciate it if you would discuss this with him at the earliest possible moment. A number of people here in Haifa have suggested that we put our fund raising on a profressional basis. Mr. Isidor Bernstein, who is a business consultant from Canada and is on the Board of our Congregation, has spoken with Murray Greenfield. Murray feels that it is very possible to do this, and he has contacts in the U.S. We would like to ask Murray on his coming trip to the States to make enquiries after consulting with you. Why not use this as a catalyst for beginning our program of capital fund raising in the U.S?

# (3) Brandt Project:

I have received several letters from Brandt giving reports on his plans for the progressive settlement. He has asked that we get Bernstein to be his liaison in Israel. Meanwhile I have spoken to the latter, but because of his own business which he has just begun here he is unable to give it the time and attention which it would need. I spoke to Alex about this. Alex's position is that the whole thing is a dream which is not based on reality. I am hoping to go to Jerusalem to speak with one or two candidates which Mr.Bernstein and I have in mind who could serve us as liaison persons. However, I am reluctant to do so unless and until I know whether the project

has any backing from the Movement or not. What is your position on it?

# (4) Allan Levine:

Both Hank and Allan have communicated to me that Allan is ready to come here but is having difficulty in working out an arrangement with the World Union. Hank indicated to me that certain people have reservations about Allan. I think that I am aware of his plusses and minuses. Taking all these into consideration we are anxious for him to come. Hank made a suggestion which makes sense, and I have spoken to Dr.Elk about it. He suggested that Allan come to Haifa and work with us teaching and doing youth work at the new Baeck School and help me at the congregation. This is crucial because of the fact that there is a synagogue in the new Baeck School and we will develop a religious program there. In addition, we still do not have a person who can help with the E-I-E Program. The advantage of this program for Allan would be that he would be able to work under our guidance during the first couple of years of his adjustment to Israeli life without making a special commitment to a new community. He can overlook the Nazareth congregation from afar and perhaps eventually move into that community.

# (5) Irv Kaplan:

When Irv was here he spoke to me about the possibility of his Aligah. I asked him if he would want to come to the Baeck School to direct the vouth program there. His answer was: "No". He feels that he can do something big\_ger than that on a national level. I am wary of people who only want big national jobs from the very beginning, especially when they don't know Hebrew and conditions in the country. I communicated this to Hank and suggested that though it would be a shame to lose Irv from the point of the Movement, he should definitely work under one of us and with limited responsibility until such time as he is ready to be a national youth director. "nother aspect of Irv's Aliyah is that if he wants to coordinate our youth programs he could not live in Jerusalem as he would be completely cut off from what is happehing in Haifa, and would be no practical use to us where most of our youth activities are taking place. In my opinion there is a need for three regional youth coordinators in Haifa, Tel-Aviv and Jerusalem. However, this is not a full-time job. Thanks for your letter written while in Jacksonville on vecation. The program which you are working out at Tample University makes sense to me. As a matter of fact it sounds exciting. I will be interested in your comments on the way the reconstructionist seminary is going once you have gotten into the program.

Hank and I went to see Avraham last week and firmed up a number of details regarding the program for next summer. Hank seems to believe that because of the way our security situation is blown up in the U.S. it will/be difficult to get to the desired number of 70 in the national group. How does it look at the moment? At the moment I am toying with the idea of directing the program there this summer. It will depend on what progress is being made with the new Maeck School building and the negotiations we are holding regarding furnishing and equipping the new School. I talked to Mank about this and he will relay the information to you. I have made arrangements for four of our former Israeli E-I-E students to act as counsellors during the summer. There are problems because they will be taking examinations at the beginning of July, but we feel that those problems are worthwhile overcoming so that we shall have young Israeli counsellors who are with us heart and soul. Thank you for your recent letters. I have spoken with Mr.Miron, the director of Kfer Galim, and we have the following proposal to make for your group which will be coming to Israel this summer. We suggest a period of 9 days, from August 22 (Friday evening) to August 31 (Sunday morning) after breakfast). That would give the group an opportunity to have two Shabbatot in the villags and a full week of programs in and around Haifa. The cost would be AL/15 per day per person, which includes room and board and directing of the programs, i.e. IL. 135 per person for the whole stay in Kfar Galim. This would not include trips from the Kfar. The program which we would envisage would be twofold:

(1) to familarize the group with the whole concept of purpose, types and values of agricultural settlements in largel. This would include working in the fields, lectures and trips to two or three kinds of settlements in the area.

(2) some short project in connection with the new building of the Leo Baeck School.

We believe that this could be a very good beginning for the kind of deep relationship which we would want to eventually develop between young people of the progressive movement in England and Israel.

We await your comments, and would suggest that you sit together and discuss this program with Rabbis Gryn, and Brandt, and Richer and Miss Hilds Shindler, all of whom are deeply interested in developing the relationship between the progressive youth in England and Israel.


The nature of her work in Israel and her support during the year there was not raised at this meeting. You may have intended to raise it, but you did not. Ted substantiates my recollection of these discussions.



I had a lengthy telephone conversation with Sidney Akselrad regarding his group from California who are planning to go to Israel this summer. In my opinion, we should do everything possible to engage this group to affiliate with us. Sidney also feels this & way. He has a woman in her early 40's who was planning to lead their group . Sidney indicated that he would hope that she could foin our staff if sufficient numbers from his area came. I have discussed the woman in detail with Sidney and am satisfied she would work into our program. ( Although, frankly, we do not actually need any additional staff members.) The additional cost to us of a single additional staff member from the United States is approximately \$650. However, every additional youngster over our minimum of 30 yields us \$200. over our fixed expenses. This means that if the & California group were to brong us only three youngsters that we dould not otherwise get, we would break even of the additional staff member. My arrangement with Sidney is that if he can deliver 12 or more students, we will include Mrs Mintzer on our staff. The question of her husband was raised, and we both agreed that we would defer this matter to a later time. (We might be able to provide some add assistance there but only if Sidney produced really large numbers for us.) m Thus, our only committment now would be that Mrs. Mintzer joins us if they produce 12 or more. I believe that this is not only a good risk but, as Alex said, in his letter to me, it just might mean the difference between success

Dear Alex:

I was most pleased to receive your letter with respect to the first Camp-Institute in Israel for boys and girls 14-15 years of age. Our Congregation has been considering such a program for the exact age group for several years. In fact, when your letter arrived today we were in the process of preparing a letter to our members inviting them to enroll their children in a similar program that we have developed with the Jewish Agency. However, the advantage of our contemplated program would be that we would be able to send our own staff at a price some \$200 less. Hanging over our heads is the question of youngsters we might be able to enroll to guarantee the trip. Your program could fit right in with our goals and could possibly take those who were interested in a trip this year if we are unable to get the required number for our own particular project.

Let me ask you two questions. Number one-we have an outstanding individual whom we had expected to lead our group. Her name is Mrs. George Mintzer. She studied at Hebrew Union in New York and has been our youth director for several years. Our Youth Group incidentally was recognized by CAFTY as the outstanding youth group of Northern California. Mrs. Mintzer is also our Religious School principal which has an enrollment of 600 and a teacher in our Hebrew School. If we join with you we would like her to accompany our children. If feasible, her husband could also come along. He has chaperoned our Youth Group and has taught in our Religious School. Would it be possible for Mrs. Mintzer to be a member of the staff?

Question number two-how are you going to reconcile the differences in Hebrew knowledge and inclination among the students? Dear Mr. Krueger,

As you may know, our family of congregations, of which you are a cherished member, has initiated a program of Israel activities of major consequence in the effort to strengthen the bond which binds us to the world Jewish community. At the Montreal Biennial a resolution was unanimously adopted calling for the extension and intensification of our efforts in this realm.

One of the projects which we hope to effect this coming year is a camp program for our pre-confirmands at Kfar Galim in Israel. Some forty to fifty of our young people from religious schools all over the land will be brought to Israel to live and study and work with their peers. In many ways this is a unique experiment, for while there are many <u>American</u> Jewish camps in Israel, there are none which provide for the intermingling of Israeli and American youngsters.

Obviously we need someone of exceptional caliber to lead this pioneering effort. It may give you some pride to know that our first and only choice is your own Rabbi Charles Kroloff. Our regard for him is as high as yours must be, and if anyone is capable of bringing this program to its hoped-for fruition, it is he. In order to serve us, he would have to be in Israel for seven weeks, a time span greater than that which, so I assume, you customarily allocate. I may be wrong here, for a good many rabbis receive the two full months of the summer as respite from their congregational activities.

This, then, is the reason for my letter to you: Is it possible for you to grant him this release? I earnestly hope so, and if you do, not only he but we all'will have occasion to be grateful to you.

I have communicated the gist of our conversation to Rabbis Shhindler and Skirball and you are to meet with both of them next week in New York and afterwards all of us will get on the phone to try to come to some kind of final understanding, prior to Hank Skirball's trip to Israel.

Enclosed is a copy of a letter from Rabbi Kroloff to Avram Miron which I thought you should have for your background.

Doar Avram:

I have just received your letter regarding Mr. Waldman.

Obviously, there was a misunderstanding between us. You indicate that you had assumed that I had met with Mr. Waldman and that his proposals were generally acceptable to ms. Actually that was not the case. Mr. Waldman wrote me in September asking if I could meet with him at sometime in the future. I said I would be happy to meet with him in New York City or in New Jersey, but he never arranged such an appointment. We have had no discussions or substantitive program pueposals.

That is the reason I was surprised when, in copies of your exchange of correspondence, it appeared that you were close to finalizing an arrangement with him. It all seems very theoritical now, since Mr. Waldman has recently indicated he probably will not be sending a group this summer. Nonetheless, I want you to know that both Rabbi Hirsch and I feel that there are many dangers in such an arrangement. We had a difficult time this past summer with two groups, ours and Irv Keplan's, from the same movement with different goals and backgrounds. I would anticipate even more problems with a group sponsored as a commercial venture.

In other words, we are not happy about the idea of bringing a commercial group.

You mentioned in your letter that Mr. Waldman's group might be beneficial since last year we failed to meet our quota in campers. Our plans at present call for bringing 70 and an extensive nation-wide publicity campaign is now underway to achieve that goal. There is great interest in the program and we do have every expectation of signing up that number.

I have not had an opportunity as yet to speak with Irv Kaplan since he returned a few days ago, but I look forward to talking to him about his latest trip to Kfar Galim.

How wonderful it is to be able to write to you about these things with the background of our fine relationship this summer. It is so much different than last year when we did not know each other. I hope you can understand our hesitation with regard to an outside commercial venture over which we would have no control and with whom many conflicts would surely arise.

That's all water over the dam now, and I suppose these mistakes can happen, but you can imagine my chagrin, since I dragged myself out of bed against the doctor's advice in order to make this conference.

In this connection, I still have not heard a word from Shimon Chasdi or from you relaying the information concerning which you spoke better than a month ago when Dick, you and I met in your office.

While I have you on the line, as it were, how is Warwick's budget for next year proceeding? Josh tells me that you have not been in touch with him on this score yet we agreed that you would be working with him to amend this budget in order to come as close as possible to a break-even point -- through the raising of dues and the cutting of expenses. I do vaguely recall one memo from Dave Davis which spoke to eliminating some of the HUC students so that you seem to be on your way in this realm, but I want it clearly understood that no final decisions are to be made, no camp fees announced, no budget submitted to any Camp Committee, etc. -before your budget is thoughtfully considered on a Staff level by all those (including Broido, Dwork, and me of course) who have responsibility in this realm. 4 . . 90
