

My dear Alex: As you can see from the enclosures--particularly the catalogue of Evelyn's exhibition which is already seen as a definitive text on village genizot--the work of the HIDDEN LEGACY FOUNDATION has shown extra-ordinary results in 1992/3. Evelyn and her scholars work without remuneration; but she has raised ca. £80,000 to pay for the cost of the exhibition which is currently receiving great acclaim in the UK and in Germany. She has just returned from the USA where she is planning shows for 1994.

At this point, she does have to look for extra funding for the work which is detailed in the enclosed brochure. The history of the Village Jew in Germany and elsewhere is often ignored, since many prefer to emphasize great cultural and economic contributions as against the picture of the poor and pious Jews who created an atmosphere of Jewish communal life which is now forgotten.

I hope that it will be possible for you to ask the Jewish Memorial Foundation to allocate some funds for the work of the Hidden Legacy Foundation for the year 1994. It would be a great encouragement for a small and dedicated group which, in its own quiet way, has already made a contribution to Jewish life and thought. The concept that "small is beautiful" should not be left out of the deliberations of the leaders of Jewish life in the coming weeks--and some of the funds to be expended do relate to that vanished Jewish world in Germany!

Re: Proposal to Renew Lease at 15 East 26th Street

Dear Dr. Hochbaum:

Per our numerous conversations, I have enclosed three spreadsheets which should enable you to analyze the value of a proposed deal to retroactively renew the lease for your current space as of January 1, 1993.

There are two major factors to consider in evaluating the merits of remaining in 15 East 26th Street. First, it is necessary to look at the deal as negotiated and determine whether it is an acceptable deal on its own merits. Second, you should compare the costs of this deal with the immediate savings by retroactively renewing as of January 1 and a potential deal for space in another building commencing September 1.

1) Proposed Deal

Between May 15th, 1992, when you first met the Landlord to discuss a renewal, and early October, when you began to focus more closely on the issue of a lease expiration, 15 East 26th Street has had great success in leasing new space and in retaining existing tenants. The building in now 85% occupied as opposed to 65% occupied in May of 1992.

Based upon my knowledge of deals which have been done in the building recently, including the JWB, I am very confident that the terms we have structured are good and fair. Three major components are worth noting that were difficult to achieve: retroactive rent commencement, a ten-year lease and a free rent/work concession worth \$20 per square foot.

Should the Memorial Foundation decide to proceed with this deal a \$58,000 immediate cost benefit will occur. This amount does not take into account a \$56,000 allowance for work. Though not discussed, we have always proceeded on the assumption this money will be given to the Memorial Foundation regardless of whether or not you use it for renovation.

2) Comparison to Other Market Deals

I have attached a spreadsheet of a proposed deal in a comparable building on Park Avenue South. The deal is based on my knowledge of the market and other deals done in this building. Considering the lack of up-front savings between January and September 1993, moving expenses and additional work requirements, the deal to stay in 15 East 26th is less expensive both up-front and throughout the term.

Below, in outline form are the terms currently before the Memorial Foundation for Jewish Culture for its consideration. It is my opinion there is no more room to negotiate with the Landlord. I believe this to be your best and most economically advantageous deal and recommend moving forward with this transaction.

Work Allowance: \$56,715 Full Service: Office cleaning, normal rubbish removal, and maintenance of air conditioning will be provided by Landlord. Relocation: Landlord shall have the right to relocate Tenant to comparable space at Landlord's expense. Sublease: Tenant shall have the right to sublease the premises.

RE: Office Space

The Foundation's lease at 15 East 26th St. expires on October, 1993. Under the direction of a Committee chaired by Rabbi Alexander Schindler, a committee of experts on New York real estate have been assisting the Foundation in exploring other sites and options for the Foundation, and also meeting with our current landlord. The experts have concluded that the attached proposal is in the best interest of the Foundation, and the Foundation's Committee has endorsed that position.

As you will note from the attached proposal, by renewing our lease on January 1st we will have achieved savings of \$58,000, which includes several months of free rent. By staying in the same site we also would reduce the cost of moving and the attendant disruption, in addition to the other savings they have negotiated with the landlord.

Ordinarily we would have brought this proposal to the meeting on Committee on Administration next year. However, in order to assure the arrangement, we must sign our new lease with the landlord by January 1, 1993. I am therefore requesting that the Administrative Committee decide on this matter by mail ballot.

May we ask you to advise us on the attached form whether you agree with the Committee's proposal that we sign the proposed lease. Please return the attached forms to us no later than December 20.

Should the Memorial Foundation decide to proceed with this deal a \$58,000 inmediate cost benefit will occur. This amount does not take into account a \$56,000 allowance for work. Though not discussed, we have always proceeded on the assumption this money will be given to the Memorial Foundation regardless of whether or not you use it for renovation.

2) Comparison to Other Market Deals

I have attached a spreadsheet of a proposed deal in a comparable building on Park Avenue South. The deal is based on my knowledge of the market and other deals done in this building. Considering the lack of up-front savings between January and September 1993, moving expenses and additional work requirements, the deal to stay in 15 East 26th is less expensive both up-front and throughout the term.

Below, in outline form are the terms currently before the Memorial Foundation for Jewish Culture for its consideration. It is my opinion there is no more room to negotiate with the Landlord. I believe this to be your best and most economically advantageous deal and recommend moving forward with this transaction.

Thank you for your response to my query regarding the Memorial Foundation.

I was not concerned regarding the scholarships. I am sure that any student we propose will receive funding.

I was more interested in the funds being received directly by the Union of Synagogues. I simply find it hard to believe that these funds are the direct result of elaborate proposals prepared by Union representatives according to formal Memorial Foundation rules, which means the proposal would have to be turned in approximately one year before the money would ever arrive and would have to include a detailed two year budget.

Rather, as evinced in the wording and the timing of the comments in the last <u>Briefing</u>, it is clear this funding is the result of active and ongoing collaboration between the Union and the Memorial Foundation. I have no problem with that. I just want to know how we can get a piece of the action as well.

I do not find the answer "just apply" satisfying, because I do not think that is the principle being applied to the Union of Synagogues.

I realize you wear two hats in this arena, so I am especially grateful for any guidance you can provide.

In re your September 30th memo, I investigated Memorial Foundation procedures regarding the former Soviet Union and here is what I learned:

In Eastern Europe the Memorial Foundation has operated in a special way to strengthen local indigenous groups. This approach utilized in all the other East European countries under Communist rule is now being extended to the CIS as well.

Thus, in Hungary the Foundation worked with MIOK, the Neological (Conservative) movement to publish books. In Yugoslavia it worked with the Federation of communities there, a largely secular instrumentality to develop educational and cultural programs. In Russia, the Foundation is now doing the same thing with the established indigenous regional groups that engage in cultural and educational work - the Va'ad, the Association of Jewish Culture and the Union of Jewish Communities. The Foundation is not working with the numerous and growing number of external groups that operate there, e.g. Chabad and others.

Jerry has initiated the beginnings of a similar process with Martin Horowitz and his group, as I indicated in my earlier letter, which undoubtedly will bear fruit in the near future.

Dear Cliff:

Let me respond to the questions you raised about the <u>Memorial Foundation</u>, and Jerry Hochbaum's recommendation to you.

The training programs which you note in your letter are undoubtedly the Memorial Foundation's International Community Service Scholarship Program.

That program probably has the largest Russian component among the Memorial Foundation's programs. For this reason, Jerry Hochbaum recommended it to us as a resource for our programs in Russia.

I was involved several years ago in the re-formulating of that program from grants to institutions to individuals. The system has worked rather well. The various Orthodox groups have their students apply; the Conservative Movement has utilized it for their rabbis in South American and their teachers in Hungary. We have used it for our movement in Western Europe via the Leo Baeck College for many years. Jerry reported to me sometime ago, after his visit to Russia, that he met with Martin Horwitz, and they worked out that Martin would identify who could apply to the Foundation from Russia for studies at Leo Baeck.

That is a good route to take, from a long-range perspective, as the grants are renewable up to four years.

Please keep me posted on the applicants who will be applying to the Foundation from Russia through this Community Service Scholarship Program.

In Russia itself, the Foundation generally works in indigenous groups and as well as via the Va'ad and the Union of Communities who are member agencies of the Foundation. Once we create indigenous regional institutions there, there is no reason why they cannot apply via the Institutional Program, within the parameters of the Foundation's guidelines.

Dear Jack:

I had a meeting with Jerry Hochbaum today to go over agenda items and to receive his report on the summer's activities. In the process of our conversation, I asked him whether salary adjustments have been made, only to discover to my surprise that we really have not acted on this at all and the year 1992 is virtually gone.

This embarrassed me to no end because Jerry assumed that I am the Chairman of the Committee and he hoped that the initiative would come from me. I in turn, assumed that you had appointed me as Chairman last year, but that doesn't mean that I still serve as Chairman.

But whatever the reason, something has to be done. Jerry is knocking himself out and doing effective work to boot, and the other staff members on the whole are doing well.

Please tell me what you think. My own suggestion would be that you allocate a lump sum for salary increases for the current fiscal year and then that we distribute it, not on a per capita basis, as it were, but on the recommendation of the Director with the understanding, of course, that everything will be cleared with you.

The sum I have in mind is a 5% figure of last year's salary which seems a fair increase and that is the sum which we allocated to the UAHC staff for the 1992-93 calendar year.

I eagerly look forward to hearing from you. If you have not made any changes in the Committee structure, I assume I will be the Chairman and that Carmi constitutes the third member of the Committee along with you.

I also questioned Jerry about the Pension Plan and he told me that the plan itself is adequate but he was a little vague in terms of what his own income will be should he retire or for one reason or another be forced to retire. He is going to check this out. I think we have to get this in order because we have to make certain that these pensions are adequately funded.

May I take this occasion to wish you and yours a happy and healthy New Year. Above all, a year of health.

Eric, I just returned from an Allocations meeting of the Memorial Foundation and I noticed that there are two institutions in Israel, the Yeshivat D'var Yerushalayim and the Ohr Somayoch, which have received \$3000 to \$5000 in grants for "Religious and Cultural Activities Among Russian Jews."

When Ismar Schorch remonstrated that Orthodox institutions are already getting too much money from the government for such activities, and that these grants ought to be denied, the response affirmed by the preponderant majority of the people was: "Why don't Reform and Conservative institutions with similar programs apply for grants. We certainly will be more than eager to approve such grants, even in higher amounts since non Orthodox institutions are clearly disadvantaged."

As I recall the discussion around the table at our recent Grants Committee meeting, we do have a number of organizations that have activities in this realm. If I am not mistaken, though, they were not really for spiritual absorption, but to help the absorption generally and I even recall saying something to the effect: "Why don't we utilize these activities to propagate Reform Judaism among Russian immigrants."

Be that as it may, there is money available and all our institutions in Israel ought to make application. I know that the sums involved are not significant, but every thousand dollars help, don't you agree?

Please bring this matter to the attention of our Israel leadership, have them send me copies of any and all applications made and, of course, I will support the request once it comes before the Allocations Committee.

I don't know if you have returned from the States but wanted to get this information to you since you asked Edie to bring you up-to-date.

The Claims Conference is deeply involved in negotiations but this matter will take a long, long time before it is resolved. The Conference is working not only with the German government but with the Central Council of German Jews who insist that they are the sole heirs to any reparations which may be forthcoming.

We must permit the Claims Conference to continue their negotiations but make certain our representatives are fully aware of what is transpiring. The UAHC is not a part of the Claims Conference, the WUPJ is and they represent the total Reform Community.

It is important for us to create as complete as possible a list of those institutions and properties which belonged to the Liberal/Reform/Progressive Jewish Community in the territory which became East Germany. Your comments in your original letter to me indicate a start has been made in this regard but we must make certain our data is as fully detailed and documented as is possible. The Claims Conference has some of the information but not all I am certain. This roster is to be sent to Sol Kagan, Claims Conference, 15 East 26th St. New York, NY 10010, as well as to the WUPJ delegation to the Conference.



RE: Reparations from Germany

Enclosed is a copy of my correspondence with Deputy Minister Menachem Porush of Agudat Yisrael, and a copy of a news item that appeared in <u>Yediot Achronot</u> on March 27, 1991, regarding an attempt to gain compensation for public Jewish property that was destroyed by the Nazis and that had existed in former East German territory.

Reading about Porush's attempt to gain access to funds for building synagogues and educational institutions that would bear the names of the destroyed German-Jewish institutions naturally raised my interest. I wrote to Shalom Ben-Chorin and Tuvia Ben-Chorin, as well as to Herbert Bettelheim, trying to get more information about Liberal institutions that existed prior to the war in the area that later became East Germany, and was advised to contact the Leo Baeck Institute in Jerusalem.

I spoke to Prof. Yosef Valk who, on the one hand, expressed his outrage at Porush's attempt to work outside the International Conference and the existing vehicles that receive and distribute reparation funds from Germany, but at the same time has verified that the number of Liberal synagogues and educational institutions was at least as large as the community Orthodox synagogues.

He felt that detailed information could be obtained, and referred, for example, to a synagogue catalogue that was published in 1932-33, with an introduction by Leo Baeck, that provides ample information about synagogues in Germany. By comparing lists of Rabbis of those synagogues with a list of those Rabbis that belonged to the Liberal Rabbinic Association, one could arrive at a reliable and comprehensive list.

Realizing that this is a very sensitive issue, with a long history, and organizational complications, you might have even begun pursuing this avenue without our knowledge, following the reunification of Germany. In any case, it intuitively seems to me an area worthy of exploration, and perhaps this could be a joint venture that would help our world institutions and Rabbinic Seminary, bearing in mind the Hochschule that existed in East Germany, as well as our institutions and synagogues in Israel which would be likely beneficiaries of such reparations.

Please let us hear from you whether there is already work in progress in this regard, and whether you think there is room to further pursue the matter.



Dear Rabbi Schindler:

In this my first letter as President of the Memorial Foundation for Jewish Culture I address myself to you and the other Board Members above all to express my profound appreciation for honouring me with your summons to assume such a leading position in contemporary Jewish life. The privilege you have conferred on me is enhanced by the realisation that I succeed such illustrious predecessors as Dr. Nahum Goldmann and the Hon. Philip Klutznick who have shaped our Foundation to become an international Jewish organisation with unique features - in its composition, in the cause it serves and in the recognition it enjoys throughout the Jewish world.

Very great as is the honour done to me, so is the burden of responsibility the office imposes. Already bearing extremely onerous duties as Chief Rabbi of Britain and the Commonwealth, with additional obligations as President of the Conference of European Rabbis, and lately some further exacting parliamentary demands as a member of the British House of Lords, I was naturally extremely reluctant to accept this further assignment. In the end, I did so only in response to your unanimous call, on the acceptance of certain stipulations I had to make, including relief from administrative responsibilities, and above all the invaluable encouragement and support of my esteemed friend Phil Klutznick. His agreement to assume the key role as Chairman of the Executive was indispensable to my affirmative decision.

I hope to assemble around him a small team of world Jewish leaders and thinkers with whom I can consult on charting the course of the Memorial Foundation for the years ahead.

At this time, I would like you to share some thoughts on the tasks and opportunities before us as I expressed them in the enclosed Address delivered to the Foundation in Geneva nine years ago. They still reflect my general assessments and visions to the present day, though of course they require some up-dating. Following the consultations to which I have already referred, I hope to let you have an outline of some more specific schemes and projects I have in mind to pursue. In particular, I will continue to advocate creativeness, originality, and the popularisation of Jewish literacy, as well as the recruitment and development of the best talents among our people as leading criteria in the application of our resources. I also want to act on the decision already adopted in principle to augment our existing assets by building up a new fund out of contributions solicited from other major trusts and foundations to enable us to embark on some significant new pioneering enterprises at present far beyond our financial means.

In the meantime, I want to assure you that I will do my utmost to preserve and develop the sacred trust handed to me, to merit your partnership, and to promote our enormous potential to the full. I am firmly determined to maintain the precious reputation for integrity earned by the Foundation and its strictest independence from all politics and partisanship.

I also hope you will share my belief that there is something even more important than the support we give to the advancement of innumerable individual and institutional Jewish cultural and educational endeavours in Israel and throughout our Dispersion. It is the opportunity we have, as the only Jewish organisation in the world to represent the totality of our people in its rich diversity, to set the tone and the example for the top priorities which ought to engage our minds and resources as the supreme cultural instrumentality of our people. We should respond to the challenge of restoring the Jewish people's foremost commitment as custodians of the priceless spiritual, moral and cultural values which have sustained us over our incomparable history as spiritual pace-setters and moral pioneers.

May I add heartfelt good wishes for the New Year, praying that it may bring the blessings of peace to Israel and the gifts of every success to the community you represent.

SUBJ: CONFERENCE OF JEWISH MATERIAL CLAIM

In my conversations with Saul Kagan regarding Germany and material claims; he informed me that a signed agreement with the German Government places the Claims Conference as the Primary agency to deal with such matters.

To date, some 500,000 claims have been filed with them and they in turn have channeled these claims to the agency in Germany dealing with this matter. In his words, it will take years to process all of thes claims.

The thrust of my memo is geared toward the <u>tons</u> of Judaica and memorabilia that was in East German holding pens and could be ripe for some chicanery by the existing German Jewish community.

If the German Jewish community claims all heirless property as theirs, this would be a tragedy. (You can see the implications)

Something must be done to set up a process of identifying material that belonged to Reform - Liberal synagogues so that it will not fall into other hands. Great works of art, (paintings) family heirlooms, and priceless manuscripts as well.

The Hochschule Building in East Berlin which we dedicated in November of 88, falls under another part of the agreement, namely, "Found Property". Who will claim that building? I have heard that the Leo Baeck Institute in New York and Baeck College in London may want to claim it. It has been used over the years as a Social Service agency for East Germany.

I thought you might want to know about this for future reference.



In the case of the American Jewish Committee, they may well only want to lease to a non-profit to maintain their real estate status, and should particularly prefer one, such as the Memorial Foundation, of which they are part.

Herbert Berman has indicated his great familiarity with real estate in New York... if you feel he can be helpful.

I am writing pursuant to our conversation in Mexico City about the Contact program in St. Louis and your letter to me about the same subject.

The Foundation was very concerned about your statement that the program was not worth an "oizgeblozen eye". Let me advise you of the steps that I have taken and what I have learned to date.

1. I talked to the members of the Committee and officers who had visited St. Louis and who have had direct contact with the program. While all, of course, are aware that this is a pilot program and a difficult one, they expressed positive feelings and support for the results of the program to date.

2. I visited St. Louis in early September and addressed and discussed with more than 50 leaders of the community the renewal of the program for an additional year I found no evidence of the type of criticism that you raised. Indeed, the community seemed to be very proud of the program.

3. I also followed up with the community itself following our meeting. They advised me that four Reform rabbis from St. Louis sit on the committee overseeing this project. Indeed, the Chairman of the Professional Advisory Committee is also a Reform rabbi. There was no evidence that these people shared the severe criticism that you called to our attention. In fact, these representatives from the Reform movement have played an important role in the planning and implementation of the project and are also supportive of the efforts to date.

4. It appears that the source of the criticism is Rabbi Jim Simon. I have been told that he allegedly sent you a memo criticizing this program. What is surprising in the eyes of the community is that he met twice with Nikki Goldstein, the program's professional worker, and never raised anything negative with her about the program. The community was equally surprised that his criticism would be channeled via you. They thought this rather unprofessional.

In sum, the Foundation recognizes the great challenges and difficulties facing this type of program, the first of its kind in the United States. The review that we have undertaken indicates that the community is supportive and indeed proud of the program, and looks forward to making it a permanent community program after the funding by the Foundation ceases at the end of this year.


