Dear Malcolm:

Thanks for your communique re: MCC. After checking, I was informed of the following by Rabbi Potasnik. Inmates on various floors may not be brought together in one place for a service. Each floor conducts a service by itself. Unfortunately, no one floor numbers enough men for a Minion (perhaps fortunately). Catholic and Protestant inmates, too, are permitted to gather for services only on their respective floors. Kosher food is provided for inmates; however, there is no guarantee that it will not be touched by non-Jews. As you well know, for these prisoners to render food touched by a non-Jew as trefa is a fixation or some kind of phobia. There is no basis for it in Halacha. The arrangements for kosher food was guided by Jacob Hoenig who is a full-time Jewish Chaplain with the federal system.

With regard to personal problems and Goldstein's wife who is in Israel, he will continue to complain until such time when the Jewish community transports his wife and child to the United States. There is a strong possibility that they prefer living in Israel.

I assure you that everything is done within the realm of possibility for inmates at MCC. They have a kosher microwave oven, special utensils, and other kosher accommodations. While I am still unhappy about their inability to serve the 32 Jewish inmates kosher T.V. dinners, I am trying to get the federal government to supply such. The warden at MCC has been quite flexible in working with Rabbi Potasnik and Rabbi Hoenig.

Thanks for bringing this to my attention. If there are other matters pertaining to chaplaincy that you wish to call to my attention, please do not hesitate to do so.

Dear Rabbi:

I am taking this time to write to you, to let you know a few things, and as a Jew, I feel that it should be brought to your attention, and I think that as a Rabbi and a Jew, and since you are the head of a Jewish Organization, you will understand what I am about to tell you.

I am in here due to some problems, I have gotten into with the U.S. Government, but as to the problems of my case, I will not go into details with you, for it will not be of any interest at this time, but I will say this much, the U.S. Government is Violating most of my CIVIL, HUMAN, RELIGIOUS, PERSONAL, and MEDICAL RIGHTS etc. the main thing I am writing

to you about is my rights that they are Violating, which are the RELIGIOUS and PERSONAL items, I will detail them for you:

- 1) Jews in here are not permitted to hold Jewish Services, if we wish to attend any services, it must be on Sunday, with the Christian Minister, The Rabbi attached to this place, comes in to see us only once per Week, and even in this he is helpless to do anything.
- 2) The Kosher food problem, is very bad, we do not get enough to eat as it is, and when we do get our Kosher food, it comes up with the regular food cart, and it is touched by Non-Jews.
- 3) When a Jew here has a personal problem (When he does get a chance to see the Rabbi) the Rabbi never does anything about it, my wife and child are in a very dangerous area of Israel, and I worry about them, I have tried to speak to the Rabbi about this, but he doesn't care to hear about it.

Can you sir send someone to see me here, about this whole problem, it would be good if a Rabbi, can come to see me, please let me know (Fast) as soon as you get this letter, it would be a good "MITZVAH" if someone can come. Thankyou for all your kindness in the above matter, (it is Urgent please)

Dear Harold:

In response to your letter of April 14, I hasten to advise that the UAHC passed a Resolution against gambling in the synagogue at our 1959 General Assembly in Miami Beach. A copy of the Resolution is enclosed herewith.

I must be frank, however, in noting that we have not been successful in attaining total cooperation from our member-congregations. They are all autonomous and the ultimate decision on program and policy lies with the leadership of the individual congregations. We cannot enforce policy, we merely advise and counsel. In these difficult economic times, it has become increasingly difficult to get our congregations to cease and desist from allowing gambling in the synagogue. And I assure you, Harold, we do continue to try.

Our congregations are most cooperative in regard to allowing community and special interest groups of worth to utilize temple premises. Many of them have groups such as Weight Watchers, Overeater's Anonymous, Parents Without Partners and the like meeting in the synagogue building. A Jewish Alcoholics Anonymous chapter is now meeting in Central Synagogue of New York City. I am confident our temples will be just as hospitable to Gambler's Anonymous and by means of our regional offices I will alert the congregations to the need. The New York City area may need this kind of program more than other areas of the country so we will place special emphasis on this need in contacting our local congregations.

ing family of congregations---grown from 300 at the end of World War II to nearly twice that number at the present time---the Union and the College-Institute shall break down under the cumulative weight of their tasks and responsibilities.

At the same time, we are deeply mindful that the Development fund will--- for a time---be conducted concurrently with the regular Combined Campaign for American Reform Judaism, which is the Reform Jewish Community's traditional vehicle for assuring the annual budgetary requirements of the UAHC and the HUC-JIR. Nothing must take place that will diminish or endanger either of these efforts.

Therefore be it resolved, that we pledge our fullest support to the Development Fund and call upon all in the Reform Movement to contribute to it in sacrificial degree. We accept the proposition, moreover, that a gift to the Development Fund shall not be deductible in any part for crediting to the Combined Campaign, and that a gift to the Combined Campaign may not be fragmented in any part for assignment to the Development Fund.

Be it further resolved, that our heartfelt gratitude be extended to the consecrated men and women who have accepted responsibility for guiding the Development Fund to success. We note especially, and greet, the action of the Honorable Herbert H. Lehman in accepting the Development Fund's Honorary Chairmanship; and we extend our most sincere wishes to Max L. Koepfel, a member of the Board of Trustees of the UAHC and Chairman of the Union's Building Committee, in his towering responsibility as the Development Fund's Chairman.

#### 8. GAMBLING IN THE SYNAGOGUE

Be it resolved by this 45th General Assembly of the Union of American Hebrew Congregations that the use of gambling as a means of raising funds for the Synagogue and the practice of gambling on synagogue premises is not compatible with proper Synagogue standards.

#### 9. HIGH SCHOOL

Whereas the senior high school years afford the religious school a unique opportunity to convey to rapidly maturing minds the depth and scope of Jewish belief and practice, and

Whereas the principle of a continuing, life-long practice of the practice of the study of Torah is one of the major objectives of our religious education program and is a basic commitment of the believing Jew,

Be it therefore resolved that the Union of American Hebrew Congregations calls upon our rabbis and congregations to establish and implement a fully integrated program of Jewish religious education for its high school youth, incorporating both a complete high school department and an active youth group.

#### 10. HOUSING DISCRIMINATION

Because of our profound commitment to the equality of all men under God, the Union of American Hebrew Congregations has consistently opposed every form of discrimination.

Out of this conviction, we have supported the decision of the U. S. Supreme Court in the school segregation cases and have pledged to do all within

Dear Harold:

I chanced to be the guest preacher at the Stephen Wise Free Synagogue last Friday night and learned from my colleague, Rabbi Sally Priesand, that the New York Board of Rabbis has neither cashed her check, submitted with her membership application, nor indicated that her application has been accepted or rejected.

I am eager to learn of the status of Rabbi Priesand's application, especially so since I have just heard that it was not included in the discussion of your Executive Committee, which met today. Rabbi Priesand is a respected colleague, a member of the Central Conference of American Rabbis, and her ordination by the Hebrew Union College-Jewish Institute of Religion was confirmed by the Union of American Hebrew Congregations. We assume that her application to the New York Board of Rabbis will be treated with the same respect and consideration as the application of any other member of the Reform rabbinate.

Dear Mr. Siegel:

We were astonished to read the prominently displayed report on the front page of THE NEW YORK TIMES of Thursday, January 28, that the New York Board of Rabbis has gone on record in support of government aid to parochial schools. We the undersigned are members of the New York Board of Rabbis, two of us past presidents, and are fully cognizant of the procedures of the Board in arriving at decisions on public policy. The fact is that the question of government aid to parochial schools was not even considered by the membership, or its duly constituted administrative bodies. The only action taken, on which the report was apparently based, was an address by the president. But in a democratic body, which the New York Board of Rabbis is, the president's views do not create policy.

There are undoubtedly some members of the Board of Rabbis who would favor government aid to parochial schools, while many others would surely oppose it. Only after formal consideration of the question and a vote, will it be possible to ascertain the official view of the Board.

In the interests of truth and fairness toward both sides on a highly controversial issue, you owe the readers a correction of a misleading report.

Rabbi Eisendrath shared with me your letter to him making inquiry concerning the International Synagogue Committee which solicited a gift from you.

The New York Board of Rabbis undertook a project which has some divergence of opinion in the Jewish community. There were those who felt that a synagogue was not required for the New York International Airport and if one were erected it would always be empty.

While there are great numbers of Catholic employees at the airport, daily Mass being a requirement for them, their church is essential. The Protestant church does not serve quite the same purpose and there are questions as to whether it will be filled or used adequately. However, the great number of Protestants at the airport does make the construction of their church meaningful. It is true that employees of the airports are at work early in the morning and frequently on Sundays and so a purpose could be served by these two Christian institutions.

Few of these reasons apply to a synagogue. However, it has been stated that the synagogue would serve many splendid ceremonial and official purposes. In addition, it was thought to be the height of impropriety to have a Catholic and Protestant sanctuary and no Jewish synagogue. We Jews have been accorded equal status and the absence of a synagogue when the three faiths should be represented, would be a shabby piece of community relations. Occasionally, a Jew will be enroute and wish to say kaddish or use the synagogue for some other purpose and so it will not be erected in vain.
