The best way to go ahead with this important project is to organize a Coordination Meeting of all interested organizations, under the leadership of Rabbi Schindler and Dr. Parnes.

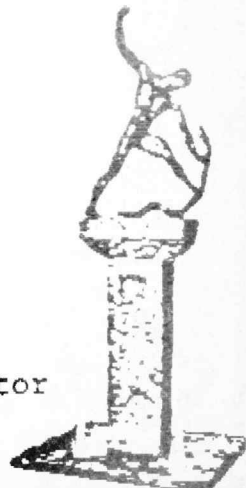

The Raoul Wallenberg Society of Moscow has put forward an initiative to mark the eightieth birthday of Raoul Wallenberg (August 4, 1992) on an international scale, which this outstanding humanitarian of our century deserves. Such a celebration will give everyone an opportunity to express gratitude to this hero who, by his own efforts, saved 100,000 lives. He did this at constant risk to his own, when virtually the whole world, though horrified by the monstrous atrocities of the Nazis, was ready to abandon them. Wallenberg showed us that even in the darkest time one individual can make a difference, can confront tyranny and prevail. An example of selflessness, courage, and determination, he won a place in the hearts of millions of people who stand for justice and humanity.

Our Society suggests that his eightieth birthday should be marked by organizing "The Wallenberg World Movement for the Ideals of Humanity". It cannot be a one time only event, but a mass movement, because many questions regarding him must be settled before more precious time is lost.

We ask you to support the Wallenberg World Movement in any possible way. We especially need financial support so that the Organizing Center of the Movement can begin its work without delay.

IN THE FRAMEWORK of the Wallenberg World Movement, we must

- 1) help Raoul Wallenberg if he is still alive and rectify the injustice done to him;
- 2) advocate awarding him the Nobel Peace Prize;
- 3) make his name and great deeds widely known in order to inspire people everywhere "to defy totalitarianism and to defend human life," in the words of President George Bush;
- 4) strengthen the process of democratization using the Wallenberg name as a symbol of justice, dignity, and humanity that will help us to oppose a new wave of fascist ideology, racism, and anti-Semitism and to fight against dictatorship and for human rights;
- 5) use Wallenberg's name for humanitarian educational aims, spreading knowledge and promoting understanding of the Holocaust, heightening social consciousness through the example of one man's extraordinarily heroic deeds, and encouraging active participation in the fight for human rights.

To fulfill these tasks, we plan:

- 1) to address many influential people and organizations with a request to press the KGB to disclose the complete Wallenberg file, which will give us all the necessary information about his life in confinement and his fate;
- 2) to address the Nobel Prize Committee;
- 3) to organize an international TV and radio transmission devoted to Wallenberg in order to spread knowledge of his deeds and of the activities of those organizations and individuals who are deeply involved in this effort;
- 4) to suggest that all Ministries of Education should include in their school and college programs, "Sixty Minutes for Humanism," devoted to Wallenberg and his ideas and to ask Raoul Wallenberg scholars for assistance in this campaign;
- 5) to organize art competitions devoted to Wallenberg and competitions for best badge, medal, and answer to a question, such as, "What do you know about Raoul Wallenberg and how he was honored and rewarded in different countries?"
- 6) to try to have sovereign governments issue special stamps, postcards, and envelopes on the occasion of his eightieth birthday and to publish a booklet and bibliography about him.

We plan to set up a special Organizing Center of the Wallenberg World Movement for the Ideals of Humanity, with a centralized list of all the participants. This Organizing Center will publish the Bulletin of the Wallenberg World Movement to disseminate information about the activities and acknowledge the work of every participant (both organizations and individuals) and provide ample technical support for them. It will consist of two full-time staff members.

More detailed plans, including symposia, concerts, exhibitions, evening gatherings, Wallenberg recordings, films, and so on, will be sent later.

TO PRESIDENT OF THE USSR

In connection with your highly respected decree about rehabilitation, The All-Union Raoul Wallenberg Society asks you to revise the case of this Swedish diplomat which is a black stain on the conscience of our country.

Raoul Wallenberg is known throughout the world as a great humanist of the XX, th century. He, alone, saved from death tens of thousands of Jews from Budapest, who were persecuted by fascists during World War II. Among them were girls and fellows, women and men, aged people and children.

On the 17 th of January, 1945, after the Red Army came to Budapest, Raoul Wallenberg and his driver Wilmos Langfelder found themselves in hands of Soviet agents. Since then they have not been seen.

In 1957 Andrey Gromiko informed the Swedish Government that Raoul Wallenberg had died in the Lubjanka prison in Moscow on the 17 th of July 1947. He expressed the Soviet Government's regret about this happening.

World public opinion didn't accept this information. The motives ^{for} of the arrest of Raoul Wallenberg and his driver were left unknown. There was no information given about their being sentenced. The persons who committed this criminal act haven't been exposed up until now. There isn't a document in which our Government revealed that Raoul Wallenberg and his driver Wilmos Langfelder were arrested illegally.

Raoul Wallenberg has been made an honorable citizen of the USA, Canada, Israel. Raoul Wallenberg committees and societies have been established in a number of countries including the Soviet Union. This was a response to the rude violation of human rights by totalitarian regime.

On behalf of the All-Union Raoul Wallenberg Society we address you with a request. Please, acknowledge the guilt of the state officials in the illegal arrest and repression regarding Raoul Wallenberg and Wilmos Langfelder.
