Minutes

April 9, 1996 Board of Trustees Meeting

Chairman Harvey Schulweis called the meeting to order at 12 noon on Tuesday, April 9, 1996. The following trustees were present: Steve Fadem, Paul Goldberger, Roman Kent, Paul Konigsberg, Elaine Merians, Hannah Waldman. Participating in the meeting via conference call were: David Belin, Robert Goldman, E. Robert Goodkind, and Rabbi Harold Schulweis. Also present was the Foundation's Executive Director Stanlee Stahl and a guest, Sherry Goldstein.

Separation Agreement

Harvey Schulweis reported on the status of the Separation Agreement with ADL. He had just come from a meeting earlier in the morning with Peter Willner and the ADL attorney, Jill Meltzer. Harvey distributed a revised Separation Agreement which had been prepared by Ms. Meltzer following their meeting. Harvey believed that most of the concerns raised by the JFR Board have been addressed. He said that he would distribute the revised agreement to the JFR Board and would specifically seek the advice of David Belin and Mark Goldsmith before finalizing the agreement.

Roman Kent moved and Hannah Waldman seconded that following a review by the attorneys, the JFR move to execute the agreement and authorized Harvey Schulweis to sign the Separation Agreement on behalf of the JFR Board. The motion was passed unanimously. Harvey announced that once the Separation Agreement is signed, there will be a joint JFR - ADL press release announcing the separation.

Public Relations

Harvey Schulweis reported that we are working with Rubenstein Associates in developing and launching a public relations campaign. Paul Goldberger, chairman of the Publicity Committee, reported that we have engaged a graphic designer. Paul distributed a letter which will be mailed to the Foundation's mailing list announcing the separation.

Board Recruitment

Harvey Schulweis reported on discussions that he has held with Bob Goldman who has agreed to spearhead the recruitment of new trustees, with an emphasis on creating geographical diversity on the board. In addition to identifying new individuals, efforts will be made to reach out to former trustees. Harvey cited a request by Harvey Sarnier to hold meetings on the west coast and that Harvey would like to see that occur. The following trustees agreed to serve on the Committee on Trustees: Robert Goldman, E. Robert Goodkind, Elaine Merians and Harvey Schulweis.

Rabbi Schulweis indicated that he had several people to recommend from the Los Angeles area and that he would forward the names to Bob Goldman. Once trustees have been identified, they will be

placed in classes. Harvey Schulweis will speak with Mark Goldsmith, Board Secretary, to have classes incorporated into the JFR's by-laws if not already included.

Financial Report

Harvey Schulweis reviewed the financial reports. Several budgets were presented. The first was for the period July 1, 1995 to June 30, 1996 which corresponds to the ADL 1996 fiscal year. The second was for the period July 1, 1996 to December 31, 1996, which completes the JFR 1996 fiscal year. At the previous board meeting, it was decided that the JFR fiscal year would be January 1 to December 31. The third report was for fiscal year 1997. Harvey remarked that he found the budget estimates for fiscal year 1997 to be on the conservative side and realistic. He believes that the JFR can expand its fund raising and stressed the need for each trustee to make his/her gift to 1996 campaign as soon as possible. Harvey pointed out that the 1996 budget includes \$225,000 in estimated revenue from the Board.

Harvey Schulweis said that if the estimates for income and expenditures were on target, the JFR would end the fiscal year with approximately \$850,000. Paul Konigsberg reported that these numbers were contingent upon the independent audit being conducted by Peat Marwick of the JFCR/ADL accounts. However, he did not expect these figures to change significantly. Steve Fadem asked for an integrated 18 month budget for the period July 1, 1995 to December 31, 1996.

In reviewing the fiscal year 1997 budget, Roman Kent reported that we may have to increase the cap on the amount of funds which are allocated to support of rescuers. The current cap is \$575,000 which includes both on-going support and one-time grants to rescuers. Harvey mentioned that the Board was not approving the budget for fiscal year 1997 at this time, and there would be opportunity to make revisions to the 1997 budget in the fall.

Space

Harvey Schulweis reported that there are two viable locations. The first is 165 East 56th Street, the American Jewish Committee (AJC) building. While the space is tight, 600 square feet, it is fully useable space. The cost is \$22 a square foot and is all inclusive. In addition the JFR would have access to meeting rooms and other services. The second location is 2 Park Avenue. The JFR's law firm has expanded its space and would be willing to sub-let space to the JFR at rates comparable to those of the AJC. After some discussion, it was decided that the JFR would pursue space with AJC. Bob Goodkind was asked to see if he could obtain a better rate. Hannah Waldman agreed to handle the review of the lease. The Board authorized Harvey Schulweis to proceed with the AJC location and to obtain a lease. Roman Kent said that B'nai Zion may also have space which the JFR could rent and that he would check with them should the AJC space not work out. The move will occur by July 1, 1996.

Staffing

Stanlee Stahl reported that she and Bela Spivak have decided to remain with the JFR. Resignations will be submitted to the ADL effective the date the separation takes place. Stanlee announced that

Alice Schoen had a baby girl, Jessica Leigh, on February 25th. Since Alice was on maternity leave, we did not have a decision as to Alice's status with respect to the JFR.

Fund Raising

Steve Fadem reported that the JFR's fund raising efforts would be focused and tightly managed. The Foundation would continue its Board Campaign, direct mail initiative and annual New York dinner. Steve urged those present, if they have not already done so, to make their gift as soon as possible. The Foundation's direct mail program has been successful and will be continued and expanded.

The dinner is set for Wednesday, November 22, 1996, at The Pierre. Mr. Al Lerner and Mr. Charles Cawley will be our honorees. A dinner chair and tribute book chair need to be identified, hopefully these individuals will be in place by May. A save the date card will be mailed in May. Steve urged those present to become actively involved with the dinner by selling tables and to have individuals participate in the tribute book, which is an excellent fund raising vehicle.

Rabbi Schulweis asked if a decision had been made with respect to which country or rescuer would be honored. As no decisions have been made about the program, he recommended that consideration be given to former German president Von Weisacker. Roman Kent suggested that consideration be given to honoring Polish Ambassador Bartoszewski, the only living leader of Zegota, the Polish underground organization established to help the Jews. Rabbi then suggested there be a high ranking official from the Catholic church. Paul Goldberger said that we needed to maintain a balance between the men who were being honored and the program, we do not want one to over shadow the other.

The Honor a Rescuer program was discussed. A mailing will be sent to rabbis across the country informing them of the separation and asking them to participate in the Honor a Rescuer and Twinning programs. At the February Board meeting, it was decided that the Honor a Rescuer program would no longer be a priority of the JFR.

Steve announced that the JFR would be initiating an industry campaign with initial focus on accounting, investment banking and law. The goal would be to hold, in each area, three to five programs in firms during the course of the year. The events, which would be no more than 90 minutes, would have a speaker and a JFR representative. There would be no solicitation of funds. Harvey Schulweis has also agreed to hold a series of briefings/educational programs in his office. Paul Konigsberg volunteered to head up the accounting area.

Allocation Committee Report

Roman Kent reported that Claims Conference has awarded the JFR a \$100,000 grant to provide on-going support to rescuers on the waiting list as well as those currently receiving monthly assistance. Roman distributed a summary, by country and age, of those on the waiting list. Hannah Waldman moved that the JFR initiate on-going support to all 98 rescuers on the waiting list who are over 70 years of age, effective July 1, 1996. The motion was seconded by Elaine Merians and was passed unanimously. A funding plan is enclosed. Additionally, all 103 rescuers who are between the ages of 65 and 69 will have their file reviewed on an individual basis by the Allocation Committee.

Bob Goodkind asked how far the \$30 monthly award in Poland went. Roman responded not as far as it did in 1991, when the Foundation raised the award from \$20 to \$30 a month. Roman reported that The Ostberg Foundation made a gift of approximately \$50,000 enabling the Foundation to issue a special Easter check of \$40 to 890 rescuers in Poland as well as rescuers in several republics of the former Soviet Union. Roman reminded those present that in lieu of increasing the monthly award to rescuers in Poland, the Foundation has given special grants at Christmas and Easter which have the effect of increasing the overall dollars being received by the rescuers, but not committing the Foundation to a funding level which it may not be able to meet.

Stanlee Stahl reported that the JFR was preparing for its annual review of country stipend levels. This review is done with JDC staff. Pension and cost of living information is obtained by the JDC country directors on behalf of the JFR. There was a concern that the stipend for Slovakia, which is \$75 a month, may be too high. Following the review of country award levels, staff will begin its annual certification of rescuers. All information will be presented to the Allocation Committee.

There was discussion of the JFR making a commitment to increase the number of rescuers being supported and that every consideration be given to increasing the monthly stipend to rescuers in Poland. The addition of more than 100 "Righteous" to those receiving on-going support will be acknowledged in our letter to our donors and other materials.

Education Committee Report

Hannah Waldman reported that Mark Goldsmith was in the process of negotiating a contract with Deborah Dwork's agent. Everything was on track and Hannah did not anticipate any problems in executing the contract. The "Resource for Teachers" would be available for distribution by next December/January. Deborah would be meeting with Hannah and Stanlee in early May to review the project.

Adjournment

There being no further business, Harvey announced that the next meeting would Monday, June 10th at noon. The meeting was adjourned at 2:00 p.m.

Our name has changed. Our mission has not.

For ten years we have been raising funds to support many hundreds of brave Christian rescuers all over the world who saved thousands of Jews during the Holocaust. We have helped give these people, *who are aged and, in many cases, deeply in need*, the lives of dignity they deserve. And we have become an important force in Holocaust education, using the remarkable stories of the rescuers to inspire junior and senior high school students and teachers throughout the country.

We have pursued this mission with the support and help of the Anti-Defamation League, which provided the Jewish Foundation for Christian Rescuers with administrative and program support it needed for the first years of its existence. Without the ADL as our partner, we could not have accomplished what we have in our first ten years. Now, however, with this productive first decade behind us, our Foundation's leadership and the ADL have agreed that our humanitarian programs can be even more effective if we function independently. Our new name - the Jewish Foundation for the Righteous - connotes our new independent status.

Nothing else will change. We will continue to support all of the Righteous Gentiles who we have supported in the past, and hope that we will be in a position to assist an even larger number of them in the coming years. We will continue to conduct our Holocaust education programs, and hope to establish an even larger presence in the growing field of Holocaust education. Our impact in the first decade of our existence, both in the lives of individuals and in the conscience of the community, has been vast. We are committed to making it larger still as we move into our new phase as an independent foundation.

As the Holocaust recedes into history, it is more essential than ever for us to meet the moral obligation we have as Jews, and help the some 1,200 rescuers of our people -- heroic men and women now in the sunset of their lives. And telling their stories to a new generation is more urgent now than it has ever been before.

Your help has been crucial in allowing us to accomplish what we have during our first decade. We look forward to your continued support now, as we continue our mission under our new name.

SEPARATION AGREEMENT

AGREEMENT made this ___ day of _____, 1996 between the Anti-Defamation League of B'nai B'rith, a Washington, D.C. not-for-profit corporation, duly registered to do business in New York ("ADL"), the Anti-Defamation League Foundation, a New York not-for-profit corporation ("ADL Foundation") and the Jewish Foundation for the Righteous ("JFR"), a New York not-for-profit corporation.

WHEREAS, the Jewish Foundation for Christian Rescuers ("JFCR/ADL"), for a number of years has raised substantial sums of money which have been primarily used to support Rescuers who risked their lives to shelter Jews during the time of the Holocaust and which have also been used for educational programs to help foster altruism and courage; and

WHEREAS, prior to this date the JFCR/ADL has been operating with a Board of Directors and Officers who have had the primary responsibility for raising funds for the JFCR/ADL and for directing the operations of the JFCR/ADL; and

WHEREAS, Officers and Representatives of the JFCR/ADL have met with Officers and Representatives of ADL and ADL Foundation and it has been agreed that it is in the mutual interest of all concerned that there be a separation of the JFCR/ADL activities from ADL and ADL Foundation and that the JFR undertake the primary financial responsibility to provide support to Rescuers; and

WHEREAS, the parties agree that it would be desirable to have certain assets in the ADL Foundation which have been set aside from the funds raised by the JFCR/ADL for the support of its programs transferred to the JFR and that certain of these assets shall be retained by ADL and ADL Foundation, upon the terms and conditions hereinafter provided;

NOW THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth, the parties hereby agree as follows:

1. The JFR charter and By-Laws shall provide that the primary purpose of the JFR is to provide financial support to needy Rescuers throughout the world who have been certified and documented by Yad Vashem. The JFR shall provide documentation of the incorporation, corporate name, and recognition of JFR's nonprofit tax exempt 501(c)(3) status to ADL and ADL Foundation and shall maintain the corporation's 501(c)(3) status in good standing.
2. JFR shall have all rights to those aspects of the JFCR/ADL program which pertain directly to individualized financial support for the Rescuers. As between the parties to this Agreement, ADL shall retain the sole and exclusive rights to the Courage to Care award and program, and ADL shall continue to engage in Holocaust education programming, including subjects pertaining directly or indirectly to the Rescuers. JFR shall have the right to undertake

educational programs and disseminate educational materials either independently or in concert with ADL or other organizations.

3. ADL and ADL Foundation shall bear the cost of an independent audit of the financial records of the JFCR/ADL program by KPMG Peat Marwick. ADL will undertake to have KPMG Peat Marwick conclude such audit within 90 days of this Agreement. ADL and ADL Foundation shall transfer to JFR the fund balance of the JFCR program held in the ADL Foundation endowment, as determined by the final audit report as of the date this agreement is executed, such transfer to occur within sixty (60) days of the final audit report. ADL and ADL Foundation shall transfer the balance of the separate JFCR/ADL checking account to JFR as soon as possible after the date this Agreement is executed, but shall reserve sufficient balance to honor outstanding previously-issued checks.
4. JFR shall assume and agree to pay and discharge all those liabilities and obligations of JFCR/ADL which are reflected or reserved against in ADL's, the ADL Foundation's and/or JFCR/ADL's balance sheet according to the final audit report. The parties shall mutually seek to agree upon the specific liabilities and obligations which JFR will assume.
5. ADL shall transfer to JFR, as of the date this Agreement is executed, all files and records of the JFCR/ADL program that relate to individualized financial support for the Rescuers, including Rescuer information, financial data, documentation records, donor lists and databases. ADL shall retain copies of this material for its records, which it shall prepare at its own cost and expense. The parties shall share the cost of preparing or obtaining duplicates of all books, films, tapes, photographs and other media presentations which were created or acquired by JFCR/ADL, ADL and ADL Foundation to pay half this cost and expense and JFR to pay half of this cost and expense. ADL shall retain all rights to the physical and tangible property owned by ADL and heretofore used by or in connection with the JFCR/ADL program, except that JFR shall be entitled to all assets set forth on Exhibit A annexed hereto representing (i) assets purchased from the reserves of the JFCR/ADL from donated funds, rather than from funds advanced by ADL, and (ii) all physical assets donated to JFCR/ADL [Subject to ADL review of Exhibit A proposed by JFR]. JFR shall bear the cost and expense of the physical transfer of any assets to JFR.
6. The parties acknowledge that no agreement has been entered into between JFCR/ADL and Professor Deborah Dwork and each is free to retain professor Dwork for the creation of an education "Resource for Teachers," as outlined in Exhibit B or for any other work. JFR agrees that if it retains Professor Dwork for the creation of a "Resource for Teachers," upon completion of the work JFR shall provide to ADL a nonexclusive license for the work at no cost, giving ADL full and complete rights to reproduce and distribute the work.

7. ADL and ADL Foundation agree not to engage in efforts to disburse individualized financial support for the Rescuers, and shall not seek donations, grants, or other contributions for the this purpose. In the event ADL or ADL Foundation receives contributions designated for the support of JFCR/ADL for a period of six months from the date this Agreement is executed, ADL and ADL Foundation agree to transfer such contributions to JFR upon receipt. After six months from the date of execution of this Agreement, in the event ADL or ADL Foundation receives contributions specifically designated for the individualized financial support of Rescuers, such contributions shall be returned to the contributor accompanied by the letter contained in Exhibit C, advising the contributor of the separate existence of JFR.
8. JFR recognizes that the names "Anti-Defamation League," "ADL" and "Jewish Foundation for Christian Rescuers" are the exclusive property of ADL. As such, JFR agrees that it: (a) shall not use the names "Anti-Defamation League," "ADL" or "Jewish Foundation for Christian Rescuers" in any way except as permitted in this Agreement; (b) shall not permit JFR to be known or referred to as "Jewish Foundation for Christian Rescuers/ADL" or "Jewish Foundation for Christian Rescuers" or to be referred to in any way as affiliated with or sponsored by ADL or ADL Foundation other than in the past tense in order to explain the history and origins of the JFR. ADL recognizes that the name "Jewish Foundation for the Righteous" is the exclusive property of JFR. As such, ADL and ADL Foundation agree that neither shall use the name Jewish Foundation for the Righteous in any way except as permitted in this Agreement, and shall not permit JFCR to be referred to in any way as affiliated with or sponsored by JFR, other than to explain the current location of the rescuer program.
9. JFR shall be permitted to use the JFCR name until June 30, 1996 solely in connection with fundraising.
10. JFR recognizes that during the period of the JFCR/ADL program, certain JFR officers, directors and professional employees dealt with confidential information, inventions, trade secrets, and processes which are ADL's property and are used in the course of its business. JFR will direct its officers, directors and professional employees not to disclose to anyone, directly or indirectly, any of such confidential matters. **Further, ADL and ADL Foundation agree not to merge the JFCR/ADL donor lists with any other ADL donor lists, and agree not to reference a donor's prior contributions to JFCR/ADL in any future solicitation of a donor from the JFCR/ADL donor list. JFR acknowledges that ADL may keep a copy of the JFCR/ADL donor list for its records and may solicit donations for ADL and/or ADL Foundation from among donors on the JRCR/ADL donor list.**
11. ADL shall give the current staff of the JFCR/ADL, namely Stanlee Stahl, Alice Schoen and Bela Spivak, the option of remaining on the staff of ADL under the current terms and conditions of their employment.

12. JFR shall not affiliate the JFR program or any similar program with any other organization or institution for a period of three years. After such time, if JFR desires to align the program with another organization, the Board of Directors of JFR shall first offer to ADL the right to affiliate with or sponsor the JFR program.
13. ADL, ADL Foundation and JFR shall issue a joint public statement **upon execution of this Agreement** to announce the establishment of the JFR program and the separation from ADL. The parties shall work cooperatively on such statement to present the new arrangement in the most positive and productive manner possible.
14. In the event that JFR is dissolved at any time within three years from the date this Agreement is executed, all financial assets of JFR (after payment of all outstanding debts and liabilities) shall be transferred to ADL. ADL agrees that in the event of such transfer, these funds shall be used solely for Holocaust-related programming. **In the event that JFR is dissolved at any time after three years from the date this Agreement is executed, the JFR Board of Directors agrees to transfer all financial assets of JFR to one or more organizations engaged in Holocaust-related programs. Further, in that event, in recognition of the initial sponsorship, development and implementation of the JFCR/ADL program by ADL and ADL Foundation, JFR agrees to give ADL full and fair consideration as an organization which would receive the assets of JFR.**
15. Each party has taken or will take all corporate action necessary to authorize the execution, delivery and performance of this Agreement, including Board of Directors' approval and the Corporate Secretary's certification of the Board's resolutions. This Agreement, when executed and delivered by the parties, shall constitute valid and binding obligations of ADL, the ADL Foundation and JFR, enforceable in accordance with their terms.
16. JFR hereby agrees to hold harmless, defend and indemnify ADL, ADL Foundation and their affiliates, directors, officers, employees, agents and representatives from and against all damages, expenses, causes of action, suits, claims, penalties, judgments and/or liabilities by reason of any act or commission or omission directly or indirectly attributable to any of JFR's undertakings and obligations arising under this Agreement. ADL and ADL Foundation hereby agree to hold harmless, defend and indemnify JFR and their affiliates, directors, officers, employees, agents and representatives from and against all damages, expenses, causes of action, suits, claims, penalties, judgments and/or liabilities by reason of any act or commission or omission directly or indirectly attributable to any of ADL's undertakings and obligations arising under this Agreement.

17. This Agreement constitutes the entire understanding and agreement between the parties and shall supersede any prior agreements, whether oral or written. This Agreement shall not be modified or amended except by a written agreement signed by all parties.
18. No waiver of any breach or default hereunder shall be considered valid unless in writing and signed by the party giving such waiver, and no such waiver shall be deemed a waiver of any other or subsequent breach or default.
19. This Agreement shall be binding upon and inure to the benefit of and be enforceable by the parties hereto and their respective heirs, administrators, executors, successors and assigns, however JFR may not transfer or assign any of its rights or obligations hereunder without the express written consent of ADL and ADL Foundation as provided herein.
20. This Agreement, all amendments hereof and the rights and obligations of the parties hereunder shall be governed by, and construed in accordance with, the laws of the State of New York.



The National Christian Leadership Conference for Israel (NCLCI) announces the appointment of David Blewett as its Executive Director. He succeeds Sister Rose Thering who recently retired but will remain active with the NCLCI as one of its Vice Presidents.

His commitment to the State of Israel began in high school and has grown consistently since. Today, he is a seasoned advocate for Israel in national and state legislatures, church headquarters and local congregations, as well as in schools and community civic organizations.

David Blewett is a graduate of Biola University, in Southern California, and of Luther Northwestern Theological Seminary, in St. Paul, Minnesota. He has also studied at Talbot Theological Seminary, in Southern California, and at Seton Hall University, in New Jersey.

Sister Rose Thering, one of the founding trustees of National Christian Leadership Conference for Israel in 1978, has served as its Executive Director for the past six years. She has been and continues to be, one

of the most eloquent Christian voices for the people, land and State of Israel. "NCLCI has benefitted immeasurably from her years of dedicated leadership and will continue to enjoy her involvement as she remains active as one of the Vice Presidents," Mr. Blewett said.

To the best of my knowledge, no firm decisions were made regarding the cutting of \$2 million dollars from the allocations budget from the September meeting. I received full reports, made subsequent inquiries from people who attended the meeting, and there was only a general, not a specific discussion concerning this matter.

Be that as it may, Dick and I discussed this when he was here, and I asked him to set up a series of meetings with Lipoff, Cardin and Abe Gafni and perhaps one or two others while I am in Jerusalem. Even though I don't customarily come to the October sessions before our Biennial, I will do so this time and for the express purpose of helping to protect these grants.

Nonetheless, it would be important for others to speak to these people too. As I recall it, we do have a resolution from the Jewish Agency Assembly (last July's meeting) which reaffirms the desire of its delegates to maintain these allocations at least at the present level. That should be of some help.

Be that as it may, I hope that Ammi and Phil Meltzer and perhaps Fred and Eric meet with these people here - the more the merrier and if it can be done jointly with the Conservatives, all the better. Eric and I will be meeting with Martin Kraar and Brian Lurie and of course we will try to enlist their support. Alan Ades, of the Conservative movement, will be joining us at this session too.

Re: Jewish Agency Stream Allocations

Message:

I am very concerned over persistent reports that the Jewish Agency Executive decided during its September meeting to cut \$2 million from the allocation budget. The allocation budget for 1995 was \$4.9 million which was distributed to 152 different projects plus another \$1.113,000 for what is called standing allocations to institutions. These are grants left over from the days of the constructive funds and are unlikely to be pared down much because of political party pressure. On the other hand, Burg is unlikely to be willing to substantially cut the creative and innovative projects. This leaves the stream grants as targets for cuts. A \$2 million cut in a total budget of \$6.033 million could be very serious for us.

We should probably be teaming up with the Conservative representatives and speaking with Shoshana Cardin, Norman Lipoff, Judge Abe Gafni who is chairman of the committee and others of the UIA to make sure that the streams do not fall victims to large cuts. It is too soon to claim that now that we receive some government funding JAFI can reduce support for the Reform and Conservative projects. This lobbying must be done before the Board of Governors meetings at the end of October.

There can be no better way to preserve the sorrowful memory of the 1.5 million Armenians who perished in Ottoman Turkey during World War I, than to establish a memorial museum in Southern California -- at the heart of the largest Armenian community in the diaspora. As an institution dedicated to the remembrance of the first genocide of the 20th century, the significance of the museum transcends the Armenian community, because it symbolizes the preservation of the memory of the victims of all genocides, as the best means to prevent the occurrence of future genocides the world over. Hence the principal aims of the museum are remembrance and education -- to remember the tragic past in order to educate future generations to build a humane future.

The Armenian Genocide Memorial Museum shall house under one roof five institutional units.



Memorial Museum

The central unit will be a memorial museum that would display various artifacts, heirlooms, photographs, paintings, khachkars, coins, garments, utensils and memorabilia pertaining to the Genocide and its era. It will depict displays of the daily life of victimized Armenian communities -- churches, libraries, schools, cultural centers, businesses and living quarters.

Library

The library shall house an extensive collection of books, documents, maps, oral histories and testimonials on the Armenian Genocide. The book collection will include books authored by the victims of the Genocide as well as those written by survivors and scholars.

Audio-Visual Center

An Audio-Visual center will bring together films, movies, TV documentaries and musical works depicting the historical background and the tragic circumstances of the genocidal process.

Conference Center

A conference center will provide the setting for symposia, lectures and seminars devoted to the study and commemoration of the Genocide.

Memorial Wall & Garden

A memorial wall bearing the names and birthplaces of the victims will honor their memory and stand as an unforgettable monument for future generations. The memorial wall will be situated in a small garden with khachkars and water fountains symbolizing the determination of the Armenian people to build a peaceful future upon the tragic legacy of the Genocide.




Dear Rabbi Schindler:

Dear Senator:

Americans for Peace Now, an American Zionist group which supports the government of Prime Minister Yitzhak Rabin as it seeks a secure and lasting peace in the Middle East, strongly supports the Prime Minister's formulation that Jerusalem must be an undivided city and the capital of the State of Israel. We believe it would be counterproductive to the effective realization of these goals for Congress to take any legislative action on the question of moving the U.S. Embassy to Jerusalem at this delicate stage of the peace process. The time to move the U.S. Embassy in Israel to Jerusalem is upon completion of the peace negotiations. We urge that you oppose Senator Dole's initiative regarding moving the U.S. Embassy to Jerusalem.

As you consider your position on this question, we ask that you bear in mind the consequences of such an act on Israel's interests and on the Middle East Peace Process.

The United States government should uphold this agreement by doing nothing to undermine or pre-empt these negotiations. Such an action will compromise the trust and confidence of the negotiating parties that the United States will honor and spirit of the Declaration of Principles and therefore be able to engage all parties. In fact, actions which accelerate the timetable for the parties to consider the final status of Jerusalem undermine the fragile unity that exists today in the city. Further, a negative reaction to legislation setting a precipitous timetable for moving the U.S. Embassy could well disrupt the peace process, thus harming Israel's security and strategic interests.

As the peace process moves forward, Jerusalem will be taken up in final status talks between Israel and the Palestinian Authority. When these negotiations are completed, it will be appropriate and desirable to move the U.S. Embassy in Israel to Jerusalem.

APN CALLS ON CONGRESS TO DELAY ACTION ON FUTURE EMBASSY IN JERUSALEM

Questions motives of those raising the issue now

WASHINGTON - Americans for Peace Now (APN) today called on Congress to delay any legislative action on the question of moving the U.S. embassy in Israel from Tel Aviv to Jerusalem.

In a letter to all 100 U.S. senators, APN co-presidents Richard Gunther and Linda Heller Kamm asked that legislators "bear in mind the consequences of such an act on Israel's interests and on the Middle East peace process...at this delicate stage in the process."

The U.S., as nearly every other nation in the world, has always maintained its embassy in Tel Aviv. Recently, 93 senators signed a letter calling for the embassy to be moved to Jerusalem as a part of final negotiations between Israel and the Palestinians on the status of the once-divided city -- negotiations not scheduled to begin until 1996.

Since then, several senators, including Majority Leader Bob Dole, have attempted to accelerate the move. Dole plans to introduce legislation this week calling for almost immediate construction of a Jerusalem embassy, to then be occupied, without delay, in May, 1999, the target date for conclusion of the final status talks.

APN specifically urged opposition to Dole's initiative and attacked those who support it and others like it most.

"There should be no doubt about the motives of groups that seek to raise the issue of Jerusalem during the complex negotiations between the Israeli government and the Palestinians," said Gary E. Rubin, Executive Director of APN. "They are seeking to undermine the negotiations. Their ploy is to exploit the popular issue of Jerusalem to achieve the unpopular goal of destroying the peace talks," he said.

"We believe it would be counterproductive to the effective realization of these goals," Gunther and Kamm write in their letter to senators, "for Congress to take any legislative action on the question of moving the U.S. embassy to Jerusalem at this delicate stage of the peace process."

To do otherwise, "will compromise the trust and confidence of the negotiating parties that the United States will honor the spirit of the Declaration of Principles and therefore be able to engage all parties," the letter continues. "In fact, actions which accelerate the timetable for the parties to consider the final status of Jerusalem undermine the fragile unity that exists today in the city. Further, a negative reaction to legislation setting a precipitous timetable for moving the U.S. embassy could well disrupt the peace process, thus harming Israel's security and strategic interests, says the letter.

"The framers of the DOP wisely left the critical issue of Jerusalem for the last stage of negotiations," Rubin said. "Maintaining this schedule is the surest way to achieve peace with security for Israel."

APN does support a move of the embassy at the appropriate time. "As the peace process moves forward, Jerusalem will be taken up in final status talks...", the letter reads. "When these negotiations are completed, it will be appropriate and desirable to move the U.S. embassy in Israel to Jerusalem."

Rubin agrees. "There is no debate that the American embassy should be in Jerusalem, the capital of Israel," Rubin said. "The critical issue is when to move it and with what consequences for the peace process. Moving the embassy now could undermine the negotiations and prevent the realization of a truly united and peaceful Jerusalem; moving the embassy as part of the implementation of a final agreement between Israel and the Palestinians, by contrast, would express a vital United States interest in a lasting peace," he said.

Rubin also took a swipe at some politicians bringing up the issue now. "As the political season begins to heat up, candidates will not be well served by pandering to the Jewish community in ways that disrupt the peace process," he said. "Polls clearly show that the overwhelming majority of American Jews support peace with security for Israel. The most advantageous strategy for approaching American Jews is through policies that advance Israeli interests," Rubin advises. "This means foremost backing the Rabin government in its courageous quest for peace."

The faith community in America has been an active partner in the care of people with AIDS since the very beginning of this epidemic. AIDS ministries and faith-community social service agencies have provided housing, meals, pastoral care, home care and transportation, among other services. However, like all other groups among the nonprofit, volunteer sector of American life, our communities cannot provide for all the myriad needs of people with AIDS and their loved ones without assistance. Particularly in this epidemic, such assistance from the federal government is both proper and essential.

We further commit to speak publicly about AIDS prevention and compassion for all people.

The majority of services for Americans with AIDS are provided with support from the Ryan White CARE Act, an excellent example of federal/local partnership that works. We urge its reauthorization, for the benefit of our brothers and sisters infected with and affected by HIV and AIDS, for the benefit of the human family that is America.

Attended by 500 patrons and artists, these ceremonies celebrated both Jewish contributions to the arts in America and artistic contributions to American Jewish life. This was a rare opportunity for us to recognize our vitality and creativity as Jews and Americans—and the emotion which filled the hall was palpable.

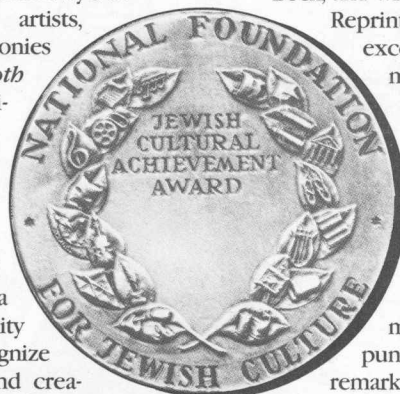
It is difficult to convey the full excitement of these ceremonies in a few words and photographs; however, through this special issue of The Jewish Cultural News we would like to share some of the highlights. The focus

of the evening, naturally, was on the awardees: composer Hugo Weisgall, sculptor George Segal, the National Center for Jewish Film, and the creative team for "Fiddler on the Roof" lyricist Sheldon Harnick, composer Jerry Bock, and writer Joseph Stein.

Reprinted below are excerpts from the moving tributes to the awardees as artists and as Jews presented by their colleagues in the arts.

The ceremonies were punctuated with remarkable performances—to celebrate the awardees, to celebrate the heritage of Russian Jewish culture, and to celebrate new Jewish artistic creativity in America. Among the special guest performers were the brilliant, young, Russian emigre pianist Alexander Paley, the

Helping a New Generation of Artists

We are witnessing extraordinary changes in our time. In Europe and the Soviet Union, artists are finally being freed from the shackles of censorship and uniformity that stifles the creative impulse. Jews who landed on Ellis Island in previous decades and those now arriving at Kennedy Airport know firsthand of the measures forced upon artists and extraordinary minds by oppressive cultures.

Here in the United States, a very different transformation has been occurring. For the first time since Jews came to these shores, a new creativity has been borne. It is an incredible creativity, and one that has only been able to come about through the interaction of American and Jewish identities. Jewish artists are finally at home in America.

Too often in the past, we have overlooked this unique blend of

The National Foundation for Jewish Culture launched the Jewish Cultural Achievement Awards to recognize our artists and celebrate their artistic creativity. The seven awardees we honored—and dozens like them who we hope to honor in subsequent years—represent the spectrum of American Jewish creativity, from modern art to classical music, film and theater.

A new generation of artists is now struggling to make their impact on America. With our help, they will succeed. ■

Presentation to Hugo Weisgall

by Samuel Lippman

Hugo Weisgall is a many-splendored man. It has been my honor and privilege, over thirty years, to know these splendors personally. Perhaps Hugo's most interesting splendor is persistence. To explain that to you, I only need tell you of the circumstances of our friendship.

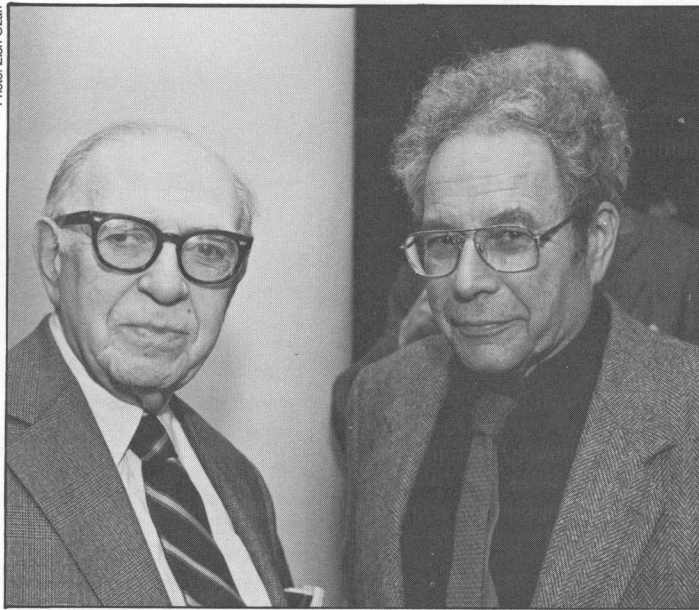
I met Hugo back in 1959, when I came as a student to Juilliard. My first class—Literature and Materials of Music—was with Hugo. I found myself faced by a musical tornado. A musician, interested in everything, knowing everything, and caring about everything musical. He played the piano, he sang, he exhorted, and above all he taught every minute of the class. I thought to myself, if this is what Juilliard is like, it must be a great school. I won't hide from you the answer—that it wasn't on either count.

I have to admit, as a further tribute to Hugo, that the grade he gave me was my lowest grade at Juilliard. Since then, Hugo and I have spoken at least once on the phone almost every day, and I consider him one of my dearest friends and greatest influences. He is in every sense my honored teacher. At once a proud and pious Jew, and a remarkable citizen of the world, Hugo is truly a light unto the nations. A believing Jew who has never eaten *traif*, a Jew who every year conducts as a *chazen* his own High-Holiday services in Maine. A worldwide authority on Jewish liturgical music, Hugo continues to be our best exemplar of what it means to be a Jew in the world. Now, he has just been elected President of the American Academy Institute of Arts and Letters.

He is America's most distinguished opera composer. *Six Characters in Search of an Author*, written on commission from the Ford Foundation, and performed for two seasons at the New York City Opera, has remained from the day of its composition a landmark in American opera for its profound theatricality and a landmark in world contemporary opera for

its distinctive position in international modernism. Beyond Hugo's sense of theatricality in song, one must remark on the distinctiveness of his style. Written entirely within the mainstream of 20th Century musical expressionism, Hugo has taken from Schoenberg, and particularly from Berg, the beginnings of a vocabulary which he has over a long lifetime made conspicuously and undeviatingly his own. We will shortly have a

chance to see and hear just what Hugo has wrought, for this month the Chicago Lyric Opera is doing a long overdue revival of *Six Characters in Search of an Author*. Moreover, Hugo is now hard at work completing an opera on Racine's *Esther*—a Jewish subject if ever one could be found—on commission for the San Francisco Opera for performance in the 1991/1992 season.

Miraculously, in this age of compositional cafeteria-hopping, Hugo has written in one style, always subject to development, but always unmistakably his own and no one else's. It can and must be said, that whether as Jew, as composer or as man, Hugo has always been a figure of honor. May he and his work flourish for a thousand years! ■

Presentation to George Segal

It is really both a great pleasure and a true honor for me to be in the position of presenting George Segal with this award for cultural achievement. I am happily touched by association with the ceremony just as I have been incredibly educated and moved by my fortunate role as Director of the Jewish Museum and the particular association I have had with George Segal and his work. In 1981 San Francisco's Mayor Diane Feinstein commissioned a

sculpture, my own conversations with George Segal over the years and the reading and thinking I have recently done about his career makes me not at all surprised by the many honors, books, films and awards he has accrued and the many exhibitions which have taken place all over the world, including Europe, Israel and Japan.

While Segal's work did, indeed, burst upon the art scene in the early 60's with incredible force, his startling plaster, human forms and his radical formal approach to sculpture are not, I feel, what has totally brought him his fame. I think it is more the extraordinary balance in the work—between the formal and narrative and between the enormously accessible and the abstract. It is this delicate balance which has touched people and brought George his deserved fame. I think it is also what has brought him into this troublesome, yet provocative, interesting and inspiring arena which we call "art and Jewish identity".

I will ask George for forgiveness in taking the liberty of broadly capsulizing his work in two different directions: one where he takes for the subject of his sculpture everyday people in everyday situations: crossing a street, waiting in line at a bus station, sitting on a park bench. In these we can easily recognize ourselves, and what's more, we feel we can even enter the scene and be part of the work. Yet this presentation of the ordinary is strangely and powerfully moving. It makes us reflective, thoughtful, even reverent and then transported to thinking about the essential relationships of our daily lives and even our place in the world.

The other direction of Segal's work is one where he uses Biblical figures, such as Abraham and Isaac, Lot and his family, Hagar and Ishmael: heroic and mythical figures, used as yet another route to essentially the same goal: the consideration of philosophical, psychological and

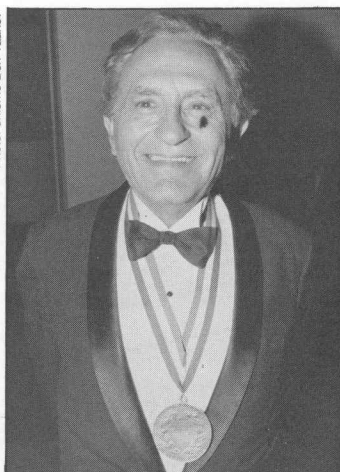

I want it known that I am responsible for *Fiddler on the Roof*: without me there would have been no *Fiddler*. Why? Because when I was two years old, Sholom Aleichem boasted I helped him write by holding on tightly to his hand when we walked together. So I assume full credit for all his works, including *Tevye the Milkman*.

Years later, just before the contract with Sholom Aleichem's family was to be signed, I was invited to the office of Tommy Valando, music publisher, to hear the run-through of the musical. There I found Sheldon Harnick, Jerry Bock, Joe Stein, Tommy Valando and a representative of William Morris Agency looking very glum, discouraged and frustrated—about ready to give up the whole project, because the attorney for the Sholom Aleichem estate made himself unavailable and was not answering his telephone. He will be nameless; besides he is long since dead, but he was singularly inadequate. I once asked my aunt why we kept him. She gave me a Jewish answer: "We *have* to keep him; he's a sick man!" Sheldon Harnick played the score and sang the lyrics of *Tevye*, which was magic. I hugged him (I've been hugging him ever since), told him it was done with talent, taste and love, and I marched to the telephone and somehow got through to the nameless attorney. Whatever I said must have been effective, for

the contract was signed a few days later, *Tevye* became *Fiddler on the Roof*, and the rest is history.

But to say that Broadway discovered Sholom Aleichem through this musical is like saying that Freud discovered sex, and Masters and Johnson perfected it. Jewish people knew and loved Sholom Aleichem long before *Fiddler*; after it, non Jews as well as young people all over the world knew and loved him. As a matter of fact, when *Fiddler* played in Japan, the Japanese actor who played Tevye, on a visit to this country, said: "Do you Americans understand this play? It's a Japanese play: tradition, family feeling. . ."

There was a real milkman named Tevye who used to deliver dairy products to Sholom Aleichem and his family. He was a small, wizened man, not at all like the powerful actors who played the role. He had a funny black beard

Presentation to National Center for Jewish Film: Sharon Pucker Rivo, Miriam Saul Krant-Founders by David Altshuler

In August of 1976, the largest extant group of Yiddish language films in the world was acquired by the American Jewish Historical Society. With the foresight and generosity of Henry and Edith Everett, the Rutenberg and Everett Yiddish Film Library was established to preserve and distribute these films.

Sharon Pucker Rivo and Miriam Krant were engaged to develop this project, and as their work proceeded, it became clear that the Jewish community needed a centralized source for Jewish films. Over the next few years, the project evolved naturally into the National Center for Jewish Film.

Our two honorees had an extraordinary partner in much of their labors, their Board Chairman Arnold Picker, *zichrono livracha*. Together, with energy and commitment, they built a monumental repository for our Jewish heritage. To do so, they had to overcome considerable obstacles, including the problems of rights clearances for media materials, international relations in bringing footage from behind the Iron Curtain, permissions from commercial companies to distribute for non-profit use, and technical and, of course, financial challenges in preserving and cataloging the films they did acquire.

Today, the Center has an international collection of more than 3,000 films that address every aspect of modern Jewish life. The Center also accepts archival footage from Jewish organizations such as ORT, JNF, JDC, UJA and others. There is an active program to enhance the original Yiddish film collection, and the service of circulating films now makes available hundreds of titles.

We look forward to the time when our two honorees will publish a comprehensive filmography, because they are the definitive source in this field. Meanwhile, they do assist other scholars, such as Patricia Erens, author of *The Jews in American Cinema*, and Lester Friedman, who wrote *Hollywood's Image of the Jew*, as well as major motion picture companies like MCA/Universal, and the American Film Institute. Finally, we at the Museum of Jewish Heritage are very grateful that the Center has been so helpful in our research and acquisition of film materials for our exhibitions and other educational ventures. ■

moral issues which effect us daily in our families and in society as a whole. The scale of these figures is taken from life casts and is always human yet somehow grand, familiar yet heroic, fragile yet powerful.

A person cannot totally escape from his or her past, and George Segal's Jewish background—which is in fact a traditional one—has had to have informed his art, which when we see it, allows us to create our own view of the world, thus stimulating a continual process of creation and recreation, which is indeed very much a part of Jewish identity.

Segal, in fact, takes casts of his family and friends, using the image of men and women, as the point of departure for his work. This might seem to be the most un-Jewish kind of art given the ancient Jewish mandate against the creation of graven images. Yet Segal may indeed be the most profoundly Jewish artist in our midst, as he seems to replicate the Hebrew Bible's deep lesson that human personality only realizes itself in the

moral interrelationship between one person and another as well as between man and God.

Yet another philosophical thinker has written, "we have art so that we may not perish from the truth". I think of this when I revisit the Holocaust piece in the Jewish Museum. I also think of a quote from George Segal himself, which I end with and which truly captures the reasons we present this award tonight: "The hunt", said Segal, "is not for versimilitude, not for the naturalistic reproduction, but a hunt for the spirit. ■"

that grew out of his neck instead of his chin, and he had no daughters at all. Sholom Aleichem liked to talk with this Teyve, and wrote a series of stories in the Jewish press about Teyve the milkman and his seven daughters. (*Fiddler* subtracted two!). The success of *Fiddler on the Roof* is ironic: Sholom Aleichem wanted so much to have his works translated into English, his plays produced in this country—

but he didn't live to see this. He wrote to my parents in Odessa: "My eyes won't see it; perhaps yours or your children's will." Ours have. That's why it gives me pleasure (and the opportunity to hug Sheldon once more) to present this award—I think, with my grandfather's happy approval—to these special people who made of Sholom's Aleichem's Teyve a classic of American musical theater. ■

- Monday, April 24 Depart New York via El Al Airlines at approximately 8PM.
- Tuesday, April 25 Arrive in Warsaw and check in at the Marriot Hotel early in the morning. Tour Warsaw and visit the site of the Warsaw Ghetto, the Jewish Cemetery and the only remaining Synagogue (standing only because the Germans used it for a stable) as well as other historic places.

Enjoy Shabbat Dinner with the Chief Cantor, the Israel Defense Force and Army Rabbinical Choir.
- Saturday, April 29 Relax, walk the beach and enjoy Shabbat at leisure in Tel Aviv. Our Women's Division will sponsor a reception at the Hotel in the afternoon.

Dear Rabbi Schindler:

I read with great interest your "Dear Reader" column in the Fall 1994 issue of *Reform Judaism*.

Your declaration that, "For many Jews, the Land of Israel remains the sole touchstone of their Jewish existence. They have for too long been plugged into Israel as if it were a dialysis machine....Equating Judaism with Israel does irreparable harm. We will never know who we are if we continue to use Israel as a fig leaf to cover our own nakedness," was indeed welcome. It provides us with an analysis of the current American Jewish condition which should be carefully considered and discussed by those individuals and groups who have, for many years, followed precisely the path you describe.

Unfortunately, many in the American Jewish community have indeed made the State of Israel a false God. Our religious life all too often has been dominated by the politics of the Middle East rather than the spiritual needs of American Jews. In many of our religious institutions, American Jews have been told that Israel is their "homeland" and that they are in "exile" in the United States. Rather than bringing them closer to God and to Judaism's moral and ethical precepts, these institutions have told them that their goal should be emigration to Israel.

Ever since its creation more than fifty years ago, the American Council for Judaism has argued that Judaism is a religion of universal values, not a nationality, and that Americans of the Jewish faith are Americans in precisely the same way as are Americans of other faiths.

The Council has been true to the 1885 Pittsburgh Platform of Reform Judaism which, in its fifth paragraph, declared: "We consider ourselves no longer a nation but a religious community." Sadly, many in Reform Judaism have abandoned that conviction and have embraced the Zionist notion of a narrow and exclusive nationalism. It is because of that embrace that so many now fear for the future of American Judaism. Young

Americans are unlikely to participate in institutions which tell them that they are in "exile" in their own country and which seek to involve them in the politics of another country as a substitute for religion.

In the book, *Jews Against Zionism: The American Council for Judaism, 1942-1948*, Professor Thomas A. Kolsky concludes that the Council's warnings about Zionism were prophetic. He writes: "...many of its predictions about the consequences of the establishment of a Jewish state did come true. As the ACJ had foreseen, the birth of the state created numerous problems--problems the Zionists had minimized....The ominous predictions of the ACJ are still haunting the Zionists."

In your "Dear Reader" article you conclude that, "Only the synagogue" can meet the current challenge to American Judaism. "The synagogue," you write, "is where Jews are made, and where the individual soul and the community are joined." Yet, if the synagogue becomes a center of ethnic display and chauvinistic posturing rather than of religious life, it is unlikely to remain a vibrant force in our free and open society. The spiritual vacuum which is now apparent in our society, and which has motivated men and women of many religious traditions to search for faith in an increasingly secular age, cannot be addressed by a separatist, ethnic-nationalist enterprise.

Your "Dear Reader" message appears to understand that much has gone wrong with an American Judaism focused upon the State of Israel rather than upon our universal ethical religious tradition. We in the American Council for Judaism applaud this understanding and hope that it indicates that, at long last, the philosophy of classical Reform Judaism may once again receive the attention which has been lacking within the UAHC in recent years.







The Arabs are insisting that Jerusalem be part of the peace talks agenda. Israel has stated categorically that this issue is non-negotiable and never will be. The American are proposing that the question be deferred until the final stage of the negotiations.

By describing Jerusalem as equally holy to Jews, Christians and Muslims, we are unintentionally supporting the Arab position. This erroneous equation could lead the neutral observer to wonder why the contesting parties cannot discuss the matter between themselves.

The real question is, how long are we going to be able to withstand pressure in the global political arena, pressure that is often supported by hostile media? Battle for the holy city

ON its 26th anniversary, Jerusalem Day has firmly established itself in the Jewish calendar. This year, it is being commemorated by a mass rally to Jerusalem of representatives of Jewish communities throughout the Diaspora, reminiscent of the pilgrimage to Jerusalem during Temple times.

Heartwarming as this manifestation of Jewish solidarity may be, one might well ask: "What is being done for Jerusalem the rest of the year?" The question is particularly pressing in the field of *hasbara*.

Selling Jerusalem to Jews is hardly necessary. After all, it is the only issue which enjoys complete consensus in an otherwise divided Jewish world. Unfortunately, this view is not shared by most of the rest of the world, including our closest friend, the US.

One cannot escape the feeling that the arena has been ceded to Arab propaganda, which has become more consistent and sophisticated over the years.

A modern Sheherazade has appeared on the scene in the person of the astute and slick-tongued Dr. Hanan Ashrawi. Like her, other Arab spokesmen are trying to rewrite the history of the Holy City, without even blushing.

Behind the cloak of academic credence and fine rhetoric lies pure propaganda. Among the assortment of half-truths and brazen distortions: the Palestinians are the descendants of the Jebusites, and therefore have an earlier claim to Jebus, i.e., Jerusalem; the biblical Philistines are the precursors of today's Palestinians; Jesus and St. Paul were Palestinian martyrs, etc.

One could dismiss such statements with an ironic smile, had they not already been absorbed into the general media and even penetrated prestigious publications. The damage is almost irreparable.

Unfortunately, we have played into the hands of our adversaries in more ways than one.

Israel has harmed its cause by adhering to the commonly used definition of Jerusalem as "the city holy to three faiths." This equation

is as dangerous as it is inaccurate, since it places the rights of the three religions on an equal footing. There is no denying that Jerusalem is holy to all three – but the degree of sanctity varies.

The fact is that Jerusalem is the heart of Judaism, the cradle of Christianity and only the third holiest city to Islam. This should be the major theme in the badly needed campaign for Jerusalem.

This basic error has been compounded by the perpetuation of the Dome of the Rock as the pictorial symbol of Jerusalem, in albums,

books, posters and advertisements – somewhat similar to the Eiffel Tower in Paris or Big Ben in London. Additional damage is caused by official Jewish sources referring to Jerusalem as a center of Moslem pilgrimage – which it most certainly is not.

WHAT is called for on our part is a broadly based, long-term campaign, unlike the beautiful publications printed by those entrusted with our information drive.

The very term *hasbara*, which means "explanation," reflects our mentality and strategy. We must stop being on the defensive and let the Arabs do the explaining.

In this controversy, Israel holds very good cards, which it has yet to play.

While branding the Jews as "newcomers" to Jerusalem, Faisal Hussein claims to trace his family tree back to Saladin. Fair enough; but so can we. Soon after Saladin's victory in 1187, Jews also began to return to the city. The largest contingent, comprising 300 rabbis from England and France, arrived in 1212. Since then, *aliya* has continued uninterruptedly.

Another cliché coined by the Arabs and adopted by the media is "Arab Jerusalem," when referring to the Old City. How many of Israel's friends, engaged in the ongoing debate over Jerusalem, are aware of the fact that Jews have constituted the largest sector of the city's population since 1820? Other similar myths can and should be exposed.

There is general agreement that once the Arab-Israeli conflict is on the agenda, the issue of Jerusalem will be the hardest to resolve. Jerusalem was the main note of discord at Camp David; Menachem Begin stated that Jerusalem was indivisible, while Anwar Sadat declared that all Israel's attempts to alter the status of the city were null and void. The gap between these opposing views has not narrowed since then.

Traditionally – and understandably – Israel has concentrated most of its *hasbara* efforts in the US. It is estimated that some 80 to 90 percent of available resources have gone into this.

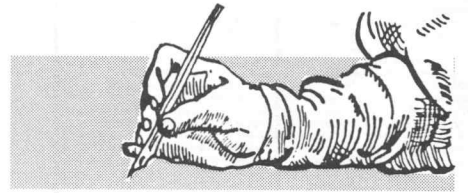
Yet the US is far from being the only arena of concern to Israel. There are additional regional centers of influence in the world – and the Arabs have lost no time in establishing a strong presence, be it in Paris, Stockholm, Buenos Aires or Melbourne.

The battle over this sensitive political and religious issue is being fought with words and imagery rather than with guns and missiles. But well-meaning declarations in Congress, the Knesset or at Bin-yenei Ha'uma will not suffice.

The issue of Jerusalem is one of international proportions, and must be dealt with on a global scale. Both the Vatican and the Moslem world will insist on having a say in the matter, and it may be safely assumed that their attitudes will be less than friendly to Israel's position.

A long, hard struggle lies ahead. Have we laid the proper groundwork to meet the challenge? Are our Jewish and non-Jewish friends equipped with the necessary information tools to reinforce Israel's historical rights and refute our opponents' claims?

Jerusalem, Jerusalem Everywhere ...

Aided by its ten-member Academic Advisory Committee, the Forum conducts studies relating to specific, little-known aspects of the city's history. The latest topic researched by us is places throughout the world named after Jerusalem or its synonymous names. Below is a summary of our findings, which we believe is the first of this kind.

The accumulated data is not only from leading atlases, but has also been provided through the good offices of the cultural attaches of the foreign embassies in Israel and the British Council, to whom we are grateful.

★ ★ ★

The endearment to the Holy City is expressed by calling many places after Jerusalem and its synonymous names. The map of the U.S.A. in particular, is dotted with such names. True, there is a Paris in Texas, a London in Ohio, a Cairo on the Mississippi and an Alexandria on the Potomac River. But no other city in the world has as many parallel names as Jerusalem.

Some 40 locations in the U.S.A. are called Salem - after Jerusalem's ancient name - the most famous one being the historic port of Salem, Massachusetts, which attained notoriety with the witchcraft trials of 1692. Salem is also the capital of the State of Oregon. Towns called Salem are also found in South Africa and in India.

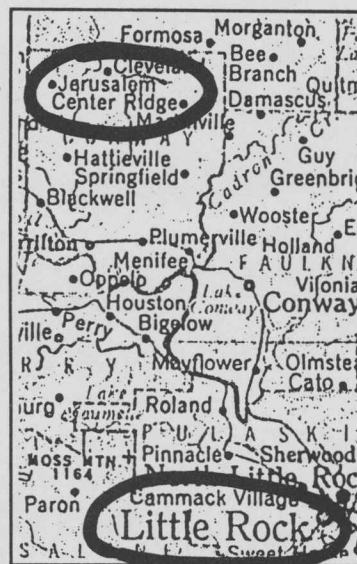
The U.S. has at least six locations called Jerusalem, among them: Jerusalem in Conway, Arkansas, north of Little Rock (Pres. Clinton's home town); in Lake Country, California; in Franklin County, Maine; and in Monroe, Ohio.

There are ten villages called Jeruzal or Jerozolima in Poland. And one townlet in New Zealand in the region of Christchurch.

Twenty towns named Zion or Zionville can be found in the U.S. There are also a Zion National Park and Zion Mountain, both located in Utah. Lake Zion is located in Illinois, Zions Hill in Wales and in South Africa.

Sion is the capital of the Swiss canton of Valais. Places called Sion can also be found in France and Northern Ireland.

Moriah appears in New York State, Delaware, Iowa and Illinois, as well as in Trinidad - Tobago.

WHAT DO YOU KNOW ABOUT THE BIBLE?

Without reading the Bible over and over again, one cannot grasp its deep meaning to both Jews and Christians.

- It takes 52 hours and 20 minutes at pulpit rate to read the Old Testament. And 18 hours and 20 minutes to read the New Testament. In other words, less than 12 minutes a day throughout the year.
- The Bible is easily accessible to 95% of the world's population. It has been translated into some 1300 languages and dialects.
- The Greek version, the Septuagint, supposedly done in 72 days by 72 translators and hence its name, dates back to the second century BCE. The Latin version, the Vulgate, was completed by St. Jerome in 404 CE.
- The Bible was the first book to be printed by Johann Gutenberg, the inventor of the printing press (1437).
- The King James authorized version dates back to 1611 CE and the Martin Luther New Testament German translation dates 1522. The French translation of Jacques Lefevre was printed in 1509.
- The Bible and portions thereof have a roughly estimated circulation of 20 million copies per annum - the world's bestseller indeed.
- The Bible societies world-wide make the Book available at minimum cost price. Thus, one can find the Bible in hotels, hospitals and prisons.
- The name Jerusalem appears 657 times in the Hebrew Bible and 154 times in the New Testament. Zion is mentioned 152 times in the Old Testament, and it appears as Sion 7 times in the New Testament. Jerusalem (al-Kuds) is not mentioned a single time in the Koran.

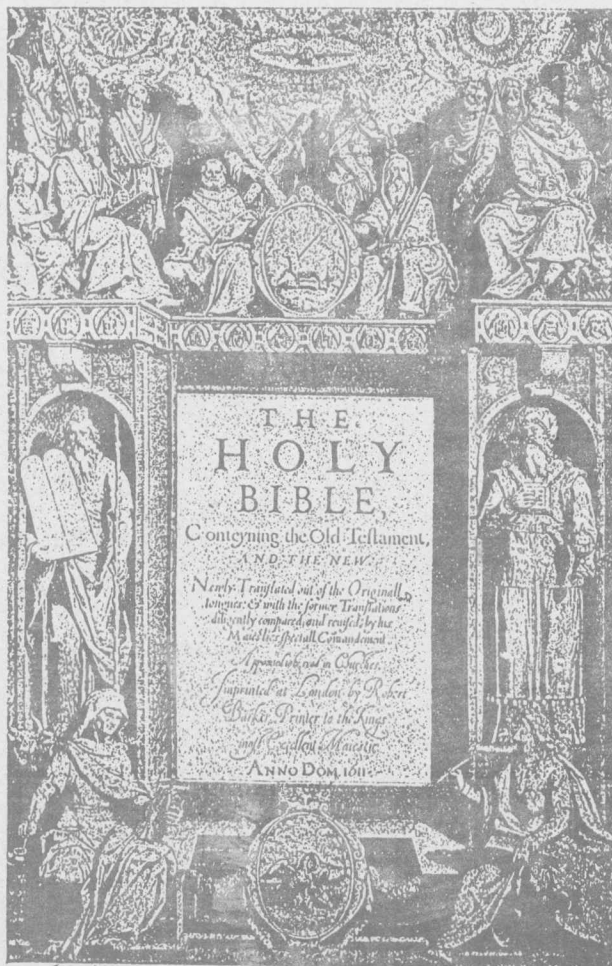

Christians Who Care For Zion

Long before Herzl and Balfour, devout Christians were advocating the restoration of the Jewish State, with Jerusalem as its capital. What motivated these people to ally themselves with Zionist aspirations:

Was it their traditional love of the Bible?

Was it their belief that, without the Jews' return to the land promised them by the Lord, there would be no final redemption?

Was it a sense of guilt and remorse for the shameful persecution of the Jews from medieval times to the Holocaust, coupled with the desire to make amends for this historic injustice?

Whatever the reason, Christian Zionism is a special phenomenon to be admired.

The term "Christian Zionists" is applied today to some 90 million Evangelical Christians partly centered in the U.S. Bible Belt. Their devotion to Israel is not manifested by moral support alone. During the period of mass immigration from the Soviet Union and Ethiopia (1989-1993), they chartered planes and ships to bring the immigrants over and provided them with basic staples via their Jerusalem offices.

However, in a much broader sense, Christian Zionism encompasses a much larger number of followers from most of the Christian denominations. Overleaf, there are letters of support received from Catholics, Baptists, Methodists and others. Since its inception, one of the Forum's primary goals has been the fostering of relations with Christian organizations and individuals.

When the Jerusalem issue will come up on the international agenda, their staunch support will be inestimable.

What Is Amishav?

Amishav is an organization dedicated to finding lost and dispersed remnants of the Jewish people and to assisting those who wish to rejoin the Jewish community.

During the course of our history, large segments of the Jewish community were "lost" as a result of war, exile and forced conversions. The greater part of the Jewish people were "lost" in the eighth century B.C.E., when the ten northern Israelite tribes were conquered by Assyria and the captives were forcibly resettled. Today, these groups can be found in India, Burma, Afghanistan, Pakistan, and China.

Another large group of Jews was "lost" during the period of forced conversions to Christianity in Spain and Portugal in the 15th century. Many of these so-called "Marranos" continued to practice Judaism in secret. Their descendants can be found in Brazil, Mexico, the southwestern United States, and Majorca, as well as Spain and Portugal.

Under the directorship of its founder, Rabbi Eliyahu Avichail, Amishav has, for the last 29 years, undertaken a variety of activities worldwide on behalf of these dispersed groups, including research, contacts, education, financial assistance, conversion when requested and relocation to Israel if desired.

Amishav USA was formed as a tax-exempt charitable organization to assist Rabbi Avichail's work.

Discovering Brazilian Marranos

Even though Natal, the capital of the Northeastern Brazilian state of Rio Grande do Norte, is not one of the main Jewish centers in Brazil, it has become the site of one of the most fascinating phenomena of Judaism in our times. After practicing Judaism in a hidden way for almost four centuries, some families of Marrano descent are shedding their Christian identity and returning to the faith of their Jewish ancestors.

Currently there are in Natal 12 Marrano families that, together with five newly arrived Jewish families, comprise the whole local Jewish population. They have joined in an effort to reorganize the extinct "Centro Israelita do Rio Grande do Norte" that closed its doors in 1967 due to lack of members.

The return of Marrano descendants to Judaism is not a new phenomenon, nor is it exclusive to Natal. Something similar happened in Portugal in the 1920's. The uniqueness of the Natal phenomenon lies in the fact that these people are willing to return to Judaism as a group, and that they have created a havurah or synagogue for this purpose.

I had the opportunity to visit with the Jewish/Marrano community of Natal in August of 1992 and in July of 1993. On both occasions, I went to Natal to do research for my Masters thesis, required for rabbinical ordination at the Hebrew Union College - Jewish Institute of Religion in Cincinnati, Ohio. I myself am Brazilian, a native of Sao Paulo.

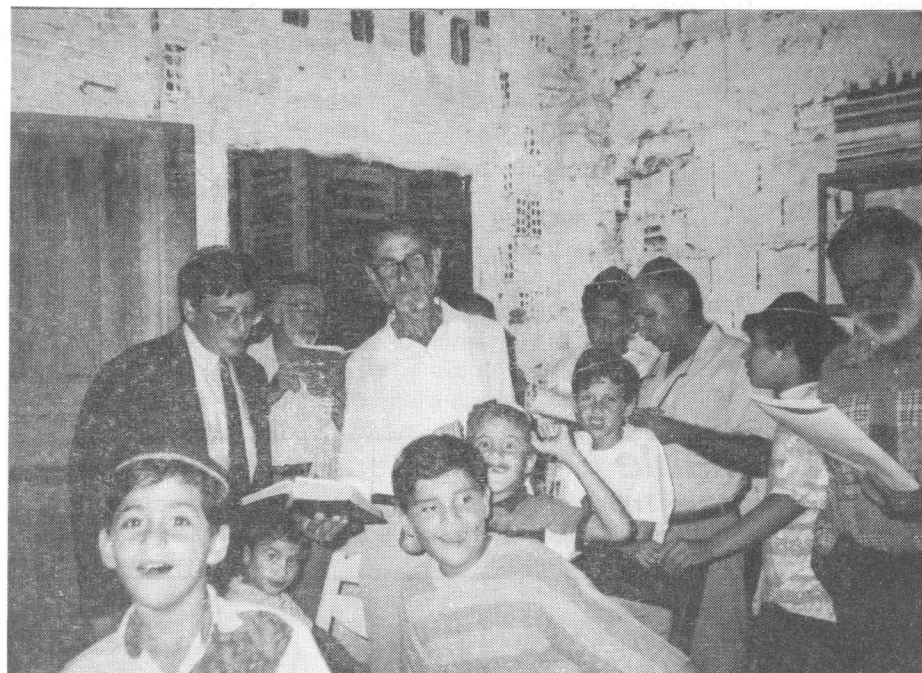

Marranos of Brazil

During my 1992 visit to Rio Grande do Norte, I also visited some of the interior parts of the state since I had heard that I might find many people of Marrano descent in those areas. In Chapada do Apodi and Serao do Seriode, around 70 percent of the white population is of Marrano origin. ***I encountered several groups that still follow Marrano practices that resemble Jewish ones, such as abstaining from pork and shellfish; not kneeling in church; burying their dead in shrouds and mourning for them for seven days; cleaning the house and lighting candles on Friday night; leaving a stone on tombstones when visiting the cemetery; and fasting on the tenth day after the new moon of September.***

After visiting the interior, I stayed in Natal, the capital, and had contact with the local Marrano community that expressed a great desire to study and learn more about their ancestors' faith. Even though they had been receiving books and educational material from the Jewish community of Sao Paulo, the country's largest Jewish center, they wanted to learn more; their thirst for Jewish knowledge was not being quenched. Motivated by the desire to help in this endeavor, I returned to Natal in July of 1993.

I was able to get the Marc Rich Foundation's financial sponsorship for my educational mission to the Natal Marranos, which made it possible for me to serve as the "rabbi" of Natal for three weeks. During that period we celebrated Kabbalat Shabbat in the primitive shack that

houses the Centro Israelita do Rio Grande do Norte and I gave several classes and lectures.

I interviewed every member of the Marrano community of Natal, trying to better understand their motivations for wanting to return to Judaism. Most of them were very serious about returning to Judaism, and some even expressed the desire to move to Israel. On my last Shabbat in Natal I conducted a day-long seminar that was open to the whole community -- Jewish, Marrano and Gentile. That seminar, which received coverage by the local press, dealt with the basic concepts of the Jewish life cycle and the Jewish holidays. It included prayers, a kosher meal at lunch time, and prayers and havdala at the end of the day.

To my great surprise, I was told that there are other Marrano groups in the Brazilian Northeast. I had contact with Marrano groups from the states which are right above and below Rio Grande do Norte, Ceara and Paraiba -- with dozens of individuals who were interested in learning more about Judaism. The group in Paraiba was so excited about my presence in Natal that they sent their leader to have an interview with me.

Of the total Brazilian population of nearly 150 million, around 10 percent are of Marrano origin. Given this reality, there is a real possibility that new individuals and groups will appear who are willing to recover their Jewish ancestral heritage and identity. ***It is crucial that the Jewish community support the Marranos in the recouping of this heritage and identity.*** I hope that my research in the Brazilian Northeast will be but the first of many such efforts.

Message from Rabbi Avichail


My Dear Friends in the USA:

Greetings from my little office in Israel! Since our last newsletter, I have been in Brazil, lecturing and attending meetings. In Sao Paulo we met with rabbis and with the "Shma Ami" association in order to find ways to help the descendants of Marranos. In Natal, I lectured before a mixed group of Marranos and Jews; I promised the assistance of Amishav to those who intend to lead full Jewish lives.

The importance of our visit in Brazil was the contacts we made in Sao Paulo and the cooperation and agreements which we came to with Shma Ami in regard to helping the descendants of the Marranos there (estimated to be some 3 million people). Shma Ami is run by a young man, a Marrano descendant himself, and a totally committed Jew today. The arrangement we came to with this organization was according to Amishav's policy and conditions. Preparation for conversions to Judaism will be made in Brazil, and we will arrange the actual conversions and aliyah through our contacts in the USA. We intend to send a suitable person to Brazil to assist in this project if we can raise \$10,000 a year as a budget.

And now an update on the Shinlung in Israel: The 41 Tribe of Menashe immigrants from India who arrived in Israel last August have been moved to Midreshet Hadarom. This has turned out to be a very positive location, and I am pleased with this arrangement. The Bnei Menashe work in agriculture in the mornings and spend their afternoons in intensive study, rediscovering their Jewish roots. **Obviously, their work does not begin to cover the cost of teaching and sustaining them. The rent on their rooms comes to \$20,000 a year; clothing and footwear will cost \$200 per person; equipment for classrooms costs \$4000; and so on!**

These people, who for hundreds of years were denied their roots, have come home to their homeland. We would love to bring you here to meet our newly discovered brethren and to see what is being done for



Report from Mexico

On a trip to Mexico last August, I found a fascinating and vibrant Jewish presence both extant and in the process of formation. I went as a representative of both Amishav and the DC Latin America Network of B'nai B'rith.

Mexico's total Jewish population is currently about 50,000, of whom some 70 percent are Ashkenazi, 25 percent Sephardi, and 4 to 5 percent converts. Of the converts, about 10 percent are of Marrano ancestry and 90 percent are indigenous Mexicans formerly Catholic or Protestant. Although 90 percent of Mexico's Jews live in Mexico City, there are small communities scattered around the country.

Mexican Jewish history commenced with the arrival of a group of Sephardi Jews from Syria in 1912, beginning a wave of immigration which brought about 25,000 Jews to the country by 1940; the majority Ashkenazi community had begun arriving after 1920.

There is only one rabbi in Mexico who currently accepts converts. Rabbi Samuel Lehrer, an Israeli-born rabbi ordained by Rabbi Abraham Isaac Kook in Jerusalem in 1935, heads a Conservative bilingual (English/Spanish) congregation. He has converted some 2000 Mexicans to Judaism, mostly members of rural indigenous communities in Venta Prieta, Puebla, Jalapa, Veracruz and a havurah in Mexico City, and these congregations practice Judaism faithfully. About 20 percent of Rabbi Lehrer's converts have made aliyah to Israel.

Small communities of Jewish converts (indigenous Mexicans and Marranos) in Veracruz and Jalapa already

have a relationship with Amishav. Although Rabbi Lehrer originally converted these groups (about 50 families) under Conservative auspices, some of their leadership wished to undergo Orthodox conversion. Some members of the Orthodox community referred them to Rabbi Avichail, who came to Veracruz and Jalapa in 1991 and converted them again. Thereafter, about 70 percent of the 100 or so members of the Veracruz synagogue made aliyah to Israel.

The communities in Veracruz and Jalapa are continuing to hold weekly services in members' homes (in Jalapa) or maintain the synagogue building (in Veracruz). The Jalapa group is sorely in need of a sefer torah scroll, and a group of indigenous Mexican and Marrano converts in Mexico City is in need of siddurim (in Spanish and Hebrew), tzitzit, kipot, tefillin, a sefer torah and other worship objects. In addition, as Rabbi Lehrer is in his late 70's, we strongly feel that the 700 or so Jews in indigenous communities deserve additional rabbinic leadership.

I have found the effort made by myself and others to secure mainstream assistance for these groups disappointing. One organization's response was: "We don't need any more poor Jews, we have enough work to do with REAL ones!" Accordingly, Amishav is establishing a Mexico Mitzvah Fund to assist these communities. Contributions to Amishav should specify the "Mexico Mitzvah Fund."

Why I Joined Amishav USA

One of the characteristics of a really successful and important Jewish organization is that it be able to draw a variety of people to do important work. It is hard to imagine more important work than reviving Judaism among those who have been lost to the Jewish people.

This important task brings people together with very different motivations. I know that some people who join Amishav USA do so because of demographic reasons. They see increasing numbers of Jews, especially in Israel, as valuable because the more Jews there are, the more secure is the Jewish future. Others join because of religious reasons; they see the return of people who may have been Jews at one time as the dawn of redemption. Still others participate because Amishav is engaged in a vast humanitarian rescue mission. Some members believe the stories of those rescued are inspirational and, because they are, will influence Jews to have a deeper attachment to their heritage.

I think all of these are excellent reasons, and I find some value in all of them. ***I know that the pluralism of reasons for joining strengthens an organization, and I find the various reasons why people become interested very fascinating.*** In this article, though, I would like to focus on one more reason, maybe an idiosyncratic one, but nevertheless the principal reason for my interest in Amishav USA.

I have a long-standing interest in the general subject of conversion to Judaism. I have written an academic book on the subject, a curriculum for Jewish schools, a bibliographical and encyclopedia article, and many other articles on the subject. Next year I will publish a guidebook for converts to Judaism, and I just signed a contract to edit a book on the subject.

At first, my interest in conversion was practical. I saw it as a way to increase the number of Jews and decrease the number of intermarriages.

I also had a personal reason. I had been raised in a very secular home with only a little Jewish upbringing. My knowledge of and attachment to Judaism were very weak. ***When, in my early 20's, I rediscovered my Jewish heritage, I felt very much like what a convert must feel like. Therefore, I feel an emotional kinship with those who voluntarily choose to become Jewish.***

When I read that Rabbi Eliyahu Avichail was going around the world finding people he thought might be connected to the Ten Lost Tribes, who wanted to practice Judaism, I was intrigued by the exotic nature of the subject, although I maintained a healthy skepticism about all such claims. As I learned more about Amishav's work, I discovered that Rabbi Avichail was not just conferring renewed Jewish status on these people, but was helping many come to Israel to undergo formal conversion.

This was very important to me. When one undergoes conversion to Judaism, the actual fact that he is a descendant of the Ten Lost Tribes becomes less important than the fact that he wishes to become Jewish and live his life out building up the sacred land of Israel.

Such efforts to help people become Jewish are exactly what my reading had led me to define as part of the Jewish covenantal obligation. My interest in conversion to Judaism, in seeing the active welcoming of people who voluntarily wish to become Jewish as a divinely-inspired Jewish mission to be a light unto the nations, is being played out in real life by Amishav. I knew that I had to get involved.

My guess is that not very many people have joined Amishav for a reason similar to mine. Perhaps, not many people even agree with the conclusions I have drawn. But I think such differences are enriching. ***I hope other members of Amishav USA will write in to explain their own reasons for joining.*** Readers who have questions or are interested in discussing my views can contact me c/o English Department, Suffolk Community College, 533 College Road, Selden, NY 11784.

From the Editor

WHY GIVE? ONE PERSON'S REASON

I've been donating some time to Amishav USA since its inception, but two events in my life in October helped me focus on why I should support the organization financially as well.

First, I read my August 1993 issue of *Moment Magazine*, which had as its cover story and theme "Jews in Cults". While I had read much about cults before, some of the information was new to me. I learned from Arnold Markowitz's article that three-quarters of those who join cults are relatively balanced, successful people from upper-middle income, intact and educated families. The author suggested three reasons for the disproportionate number of Jews in cults or cult-like groups: They are open to alternative political and theological ideas, they attend college or university (where cults recruit most energetically), and Jewish families are sometimes too close and don't allow for appropriate separation. Committed Jews are not immune. The article by David and Livia Bardin gives a moving account of their son's involvement in a destructive cult -- even though he had graduated from Jewish day schools and young adult programs, spoke Hebrew, lived in Israel as a boy, and returned twice as a youth. The magazine noted that the average cost to deprogram a former cult member ranges from \$18,000 to \$30,000.

The very next day I encountered a long-time acquaintance at the supermarket. We had not seen

each other in several years and quickly got caught up. Our sons had gone to high school together, and I knew that their family was fundamentalist Christian and that their son had been pulled out of biology class when the topic of evolution was discussed. I now learned that their daughter teaches second graders in "a messianic school for Jews" in the Washington area.

That night my husband and I wrote out a check for \$600 to Amishav USA to cover the cost of transporting a Shinlung immigrant from India to Israel. I began to feel much better!

Yes, we all know we are losing Jews to intermarriage, to cults, to other religions, to indifference. I agree with many that education is a vital tool in turning around this situation. Unlike some, however, I do not place my focus on replacing lost numbers; quality is more important than quantity to me. What I have come to appreciate, though, is the irony that allows many Jews to wring their hands in despair over the intermarriage rate and yet to ignore the plight of our cousins, shown by impressive scholarship to be from the Ten Lost Tribes, who have maintained their identity through 27 centuries of hardship. Many are practicing Jews eager to study further in Israel, and some to relocate there. They deserve at least as much attention -- and financial support -- as those who are *leaving* Judaism.

Dear Rabbi Schindler:

I am writing to invite you to be a member of the Advisory Council of a recently formed group called the Religious Consultation on Population, Reproductive Health and Ethics.

The primary goal of the Consultation is to facilitate greater participation in the discourse about population by those who can articulate religious and ethical perspectives. This input will ultimately assist in the formulation and adoption of international policies that are rooted in social justice. The project is especially timely as the International Conference on Population and Development (ICPD) will be held in Cairo in September, 1994, under the auspices of the United Nations.

As I have begun to work on this issue, it is increasingly clear that in population and development circles there is, for the most part, a serious lack of appreciation of the positive contribution that religious thought and ethical values can make to the debate. Indeed, religions are broadly perceived to be an obstacle, not a contributor, to policy development. This is due in part to the nature of the role played by more conservative religious institutions, as well as to caricatures of religious groups by some secular participants. It is also the result of the lack of a sustained interest and public participation in the debate by religious groups and scholars. The Consultation will respond to these problems in a number of ways.

Our projected approach is to highlight the sins of the developed world's environmental profligacy rather than to focus simplistically on the inflationary demographic numbers. Stressing the privileged role of women, Third World people, and people of color in education for personal responsibility and ethically sound population policies, we want to counter the tendency to blame the poor for reproducing while ignoring global disparities in access to reproductive and basic health care, education, and economic well-being.

We will hold symposia, convene several working groups, publish bibliographies, and link religious scholars and activists with the population, environment, and family planning communities. We will also facilitate the participation of religious and ethical leaders both in the preparatory process leading up to the ICPD and in the Cairo conference itself.

While the Consultation is in the early stages of formation, we have already had the opportunity to participate in PrepComm II, the second preparatory meeting for the ICPD held in New York in May. At the request of the NGO Steering Committee for the ICPD, we organized a panel consisting of Azizah al-Hibri, a Muslim philosopher and jurist; Rev. James. B. Martin-Schramm formerly of the Union Theological Seminary; and myself. The panel was well received and a proceedings will be published within the next month.


We have benefitted from the advice of both Larry Rasmussen and Krister Stendahl, among others, in the development of our invitation list and our focus. Frances Kissling from Catholics for a Free Choice has agreed to take on responsibility for fundraising, as well as acting as liaison with the women's health community. To date, thanks to her efforts, we have received an initial planning grant from the Ford Foundation as seed funding toward organizing the Consultation as an independent tax exempt institution.

I sincerely hope you will agree to serve as an advisor to the project. Beyond lending your name to the Consultation and agreeing to put these issues on your own agenda in some way, the extent of your participation is up to you. As advisors, we will keep you informed of current thinking on the issues, including sending you various publications for your own use. We will ask you to suggest names of colleagues who are doing work in this field, and occasionally to read or review a paper or publication. If your interest is stronger, we will include you in a speakers' roster and invite you to participate in working groups, to represent the Consultation at meetings here and abroad, to participate in the Conference, even the Cairo meeting itself. There will be a first meeting of those who have agreed to be advisors March 18-19 in Washington.

Should you agree to accept this invitation, please send us a C.V. for our files. An envelope is provided for your response.
