

Dear Alex:

I have yours of November 22. I am follow-  
ing up on the idea of the energy program we discussed  
and I will get back to you on it soon.

I tried to make clear in our discussion that  
the Jerusalem issue does not lend itself to separate  
"spokesmanship." It is likely to be the prime issue  
the Conference will have to deal with in the immediate  
future. The Prime Minister suggested to me such a role  
for you, because he rightly wants us to make maximum  
use of your talents. I told him that such a role  
would be an abdication of my own responsibilities as  
spokesman, and that instead I would meet with you to  
discuss how the Jewish community would be most  
benefited by Alex Schindler. The energy ideas we  
discussed provide one very excellent avenue, since I  
agree with you that the energy problem, as the admin-  
istration sees it, will underlie administration middle-  
east policy in the years ahead.

As noted, I will get back to you soon.

Thank you for your visit.

As promised, I will give the matter of the Jerusalem spokesmanship some thought. I will get back to you just as soon as I come to a conclusion.

The chairmanship of the Energy program does interest me very much. I would be glad to be involved with it either as head of a special Task Force under the aegis of the President's Conference or if the Union should be asked to spearhead this campaign. As I indicated to you, I am determined to move ahead with this in any event via our Religious Action Center in Washington. I didn't have a chance to tell you but Rabbi David Saperstein, Director of our Religious Action Center and one of the ablest Jewish civil servants, is currently the chairman of the Interreligious Committee on Energy (ICE), which is moving ahead in this field, a position which puts him in a unique position to carry forward the larger program as well.

Bernstein is more thoughtful and articulate. We have to have one of them and I would like your judgment in this matter. My inclination is to go with the more intelligent guy and that is Bernstein, but I don't feel strongly about it one way or another. You decide and let me know.

Rose Matzkin will be leaving the presidency of Hadassah in August. Her successor, I am told, is not so strong but we will face that problem when we get to it.

Should ADL be represented? Sy Graubard is a very intelligent lawyer and more attuned to our thinking. I offer this merely as a suggestion and for your judgment. It certainly isn't necessary to have him present.

Ouch, one thing I almost forgot...must not Yehuda Hellman be at the meeting? I really think so, in all fairness to him.


