

As per your request, enclosed please find the Budget of the Presidente' Conference which was adopted by the meeting of the Presidents' Conference on April 5th, 1963. The Budget was adopted for a period of twelve months ending April 1, 1964.

I am also enclosing a statement of actual expenses as incurred by the Presidents' Conference between October 1, 1962 and October 1, 1963.

The Third enclosure is an item by item analysis on which items we have spent less than appropriated and on which items more than appropriated. As you will note, during that year, we have exceeded our budget by \$188.44.

I will present these figures to the meeting of the Budget and Finance Committee which will meet on December 5th, at 11:00 A.M. in the office of the Conference of Presidents.

The terms of reference of the Budget and Finance Committee were determined by a resolution of the Presidents' Conference which was adopted on September 25, 1963 and the wording of the resolution is as follows:

> "A Budget Committee shall be appointed to study the budget of the Conference and puruse the ways and means of financing it."

SUBJECT: MINUTES OF MEETING OF PRESIDENTS' CONFERENCE OF THURSDAY, APRIL 23, 1964:

Mr. Lewis H. Weinstein, Chairman of the Presidents' Conference introduced our guest of honor, Governor W. Averell Harriman, who discussed problems of mutual interest with the members of the Conference.

Mr. Weinstein thanked Governor Harriman and introduced the next item of the agenda, Budget:

Mr. Weinstein asked Rabbi Jay Kaufman to give a report of the work of the Budget and Finance Committee.

Rabbi Kaufman: The Budget of the Presidents' Conference was adopted at its meeting in Washington and the body had asked us to draw up a schedule of payments for the organizations involved, in order to meet this budget. This is the schedule of payments which we propose for the fiscal year April 1, 1964 to March 31, 1965. We have considered various possibilities and I am happy to report to you that we feel that we can bring you the kind of a proposal which will be acceptable to the whole Conference. "Under the porposals of the Budget and Finance Committee, each of the twelve organizations now paying \$900 a year would pay an additional \$465 a year bringing its total payment up to \$1,365 a year. Each of the six organizations now paying \$600 a year would pay an additional \$265 a year bringing its total payment up to \$865 a year.

<u>Mrs. Kramarsky</u>: seconded the motion submitted by Rabbi Kaufman on behalf of the Budget and Finance Committee.

THE SUBJECT WAS THEN OPENED FOR DISCUSSION.

<u>Mr. Tabachinsky</u>: explained that he would like to confer further on this matter with the Chairman of the Budget and Finance Committee. He felt that the Jewish Labor Committee did not belong in such a high category.

Mr. Minkoff: explained that he would vote "no" and that he is for the adoption of the budget and for trying to find means to cover the budget immediately. He regretted. however, that the original suggestion of the Finance Committee to establish three categories of financial contributions instead of two had been dropped. Mr. Minkoff feared that the two-category formula might become a precedent, and make it impossible to cover the budget if and when it has to be increased in the future. The agencies in the category that has been dropped, namely those with the largest budgets and whose relationship to the Israel issues is very close, could properly be expected to participate financially on a greater scale than the agencies whose budgets are much smaller and for whom it is a greater hardship to make the appropriations that are required now and that will be required in the future.

Mr. Weinstein called for a vote and the proposed scheme of payments was declared adopted.

The next item of the agenda, the American Jewish Conference on Soviet Jewry, was introduced. It was recommended that a meeting of the twenty-four cosponsoring organizations be convened for May 5, 1964 at the Delmonico Hotel at 1:30 P.M. and that the Professional Technical Subcommittee be invited to meet before the meeting of the twenty-four organizations to prepare proposals and to discuss problems to be brought up at the all-auspices meeting on May 5th. As you know, the Presidents' Conference has been restive under the arrangement which had the Jewish Agency paying one-half of its costs. After much deliberation, it was decided that the members of the Presidents' Conference would pay their own expenses with the Jewish Agency contributing a share akin to that of the other groups and no more.

In order to accomplish this an increase in the contribution of each agency was necessary. At first it was suggested that large organizations, for example, organizations with budgets over a million and a half dollars, should bear the major burden with the other organizations making only a token contribution.

I am pleased to report that the Budget Committee, of which I am a member, finally decided upon the following formula:

a) Presently twelve organizations pay \$900 and six pay \$500 per annum.

b) Organizations paying \$900 will henceforth pay an additional \$465 and organizations paying \$600 will henceforth pay an additional \$265 per annum.

Therefore, the UANC's dues to the Presidents' Conference will be increased by \$465, per annum.

I have your latter of May 26 and I hasten to respond to you. At least you will have a response, but I am afraid I can't give you any manifestaction on the substance.

As a matter of gunaral principle the Presidents' Conference does not reimburse organizations when they incur expanses in its behalf. We have a miniscule national budget, as you know, and we could not even begin to do anything at all without the full and free cooperation of groupings of our organizations on the American scene. As a case in point, as Chairman of the Presidents' Conference, my service will cost the Union's budget some \$20,900 to \$30,000 in additional expanses for meetings and travel and not a penny will be reimbursed by the Presidents' Conference. Even in the past, prior to my taking the chairmanship, expanses were incurred by the UAMC for the Presidents' Conference over the years and we have not been reimbursed.

Iz Miller was the Chairman when your particular project was initiated and he talls me that this policy obtained during his administration, as it obviously does still. I am certain that you were informed of this policy at that time. In any event, it is a policy I must enforce, much as I regret it.

We have communicated with the Presidents Conference several times regarding reimbursement for this project. What amazes me is that until now, none of our communications have even been acknowledged.

The Board of Jewish Education involved itself in all aspects of the rally, including organizing schools, arranging buses to transport pupils, disseminating information about the rally and motivating participation (each school was called at least twice), in addition to numerous mailings. The costs for all the above have been absorbed by BJE. Reimbursement was requested only for the special printing of the Fact Sheets for distribution prior to, and at the Rally - done at the request of the Presidents Conference.

I truly regret having to bother you with such trivia. But, my controller is pestering me galore about this "unpaid receivable". Help! Can you? I hope you can!
