

SUGGESTED RESOLUTION ON THE 30TH ANNIVERSARY OF  
ISRAEL'S ESTABLISHMENT AS A STATE

Whereas, thirty years ago the tiny nation of Israel was born out of the yearning of the Jewish people to return to their ancient homeland, out of the dire necessity to provide a refuge secure against possible reoccurrence of another Holocaust, and out of the sacrifices and hard labor and zeal of great Israeli leaders such as David Ben-Gurion, Golda Meier, Yitzchak Rabin, Menachem Begin, Chaim Weizman, Moshe Dayan and others, and

Whereas, the United States under the leadership of President Harry Truman provided the support that led the United Nations to accept the reality and legality of Israel as the homeland of the Jewish people, and

Whereas, since that historic period of the creation of the state of Israel that nation has been a foremost bastion of strength for democratic ideals, representative government, and democratic practices, and

Whereas, since that historic period Israel has been a strong front-line in the American effort to curb Soviet imperialism in the Middle East, and

Whereas, despite the enormous portions of her national budget and sustenance that has had to be committed to defense, despite the horrendous toll that wars have taken of her sons, Israel has succeeded in raising the standard of living and quality of life of her people beyond that of any other people of the Middle East, and

Whereas, despite the many years during which her enemies have surrounded her with overwhelming ground forces and air forces, Israel has maintained a courageous stance reminiscent of our own history when we were confronted with superior British forces in our colonial period, now, therefore be it

RESOLVED, That the legislature of (insert \_\_\_\_\_) does hereby salute the State of Israel, pay tribute to its courage, express support for its constancy in fighting for democratic ideals, voice its admiration for its quest for peace despite numerous obstacles and for what it has done to make the desert bloom with fruit and flowers and trees and for what it has done to make the hearts of mankind soar with hope that justice will prevail, that the right can overcome might, that all the children of God can live together in peace.

### WHAT IT IS

The National Association of Jewish Legislators, founded in 1977, is designed as a loose-knit organization of state legislators of Jewish descent, to provide an occasional forum where they may exchange experiences and information, and provide a forum for the Israeli Ambassador to the United States, our own United States Department of State officials and others on matters affecting Israel.

It will serve as a quick referral source for any Jewish legislator seeking information, pro or con, on any issue affecting Jews, and act as a channel of communication between legislators and Jewish national groups, if asked. It is expected to serve as a data bank on issues pertinent to Jewish legislators, and issue from time to time a newsletter.

It is expected to be a strong supporter of Israel. Hopefully it will give Jewish legislators from small states and large states a sense of identity with each other. It will be a voice that will be heard for protection of the human rights of Jews wherever they may be assailed or discriminated against.

### WHAT IT IS NOT

It is not a caucus. It doesn't seek power. It will have no "line". It will not take stands on particular legislation or specific bills. It is a non-profit, educational organization. It recognizes that Jewish legislators, represent a diversity of Jewish background, a diversity of constituencies, and often differ on many domestic issues. It will therefore not take stands on issues which divide the Jewish community, whether orthodox, conservative or reform.

### WHO ORGANIZED IT

A mid-west legislative leader came to Al Abrams, then Chairman of the National Legislative Conference and said, "Why don't you get the Jewish Legislators together?" The idea lingered in his mind and when he retired as Secretary of the New York Senate, he approached Senate President Matthew Feldman of New Jersey and Senate Majority Leader Joseph Lieberman of Connecticut and New York Assembly Speaker Stanley Steingut to gain their views. They were enthusiastic and agreed to become founders.

### MEMBERSHIP BENEFITS INCLUDE:

#### Publications:

A newsletter will be issued periodically.  
Information on Israeli issues will be sent periodically; informative, analytical.  
Periodic issue briefs will provide **pro and con** data.

#### Conferences:

The organization will meet once a year at the same time and place as the National Conference of State Legislatures.  
It will also meet once a year in Washington with the Israeli Ambassador, U.S. State Department officials, and Congressional leaders.

#### Missions to Israel:

It will help arrange study missions to Israel, provide introductions to Knesset officials, and help in arranging for Knesset officials to visit your state legislature.

#### Information and Referral:

It will set up a data bank of material so that any member who seeks information on any pertinent issue will have access to such information without charge or will have such information sent to him by relevant Jewish organizations which may already have such data.

Dear Mr. Epstein:

I was disturbed to hear of your public criticism of Dr. Hertzberg at the President's Conference last week, not only because of what you said but of where you said it.

Dr. Hertzberg does not need me or anyone else to defend his record as a Zionist and his commitment to the State of Israel. Only the most uninformed and ignorant would question his lifelong devotion to and his work on behalf of Israel. Nor does the American Jewish Congress need me to defend its record as an outspoken advocate of the right of Israel to live and survive in peace and security. Even before the state was founded and long before this was a popular American Jewish position, the AJCongress spoke out unequivocally on this issue.

As for our comments on the U.S.-Soviet agreement, may I suggest that you read the enclosed statement which assailed this declaration as a major reversal of U.S. policy that "brings into question the reliability of our country's solemn international obligations." In that statement Dr. Hertzberg declared further:

We deeply regret that the U.S. has now appeared to join with the USSR in a disastrous alteration of the terms of the Geneva Conference that elevates the Palestinians to the status of a party and that confers upon them 'legitimate rights'--'rights' which those who claim to speak for the Palestinians have defined to mean the liquidation of the State of Israel.

Following the issuance of that release Dr. Hertzberg was in touch with the White House criticizing the President and urging that

he clarify the U.S.-Soviet statement making clear that the U.S. believes that any Geneva Conference must be bound by UN Resolution 242 and that there would be no imposed peace on Israel. When President Carter included those two points in his UN speech we felt that sound political strategy called for us to acknowledge this acceptance of our posture. We believe in "yelling" when the President or any political figure says or does anything about which we disagree. But it is equally important to acknowledge when he accedes to our wishes and demands. In any event, the AJCongress prides itself in its knowledge and effectiveness as to the utilization of the political process.

As for your bringing this attack before the President's Conference, I believe you did a disservice to the coordinating process. The President's Conference exists in order to bring together diverse views and opinions in American Jewish life and attempt to work out a consensus and agreement so that we can all bring our total strength to bear on behalf of Israel. It is not a forum for divisive, acrimonious personal attacks that do nothing to help the unity of the Jewish community. If you were critical of anything that Dr. Hertzberg or the AJCongress said or did and if you were truly interested in arguing substance and tactic, you should have called me or Dr. Hertzberg for a meeting and then as adults we could have discussed this matter in an intelligent and serious fashion.

I would hope that in the future you would bear this in mind.

Dear Rabbi:

In July, Menahem Begin, the Prime Minister of the State of Israel, spoke before the Conference of Presidents of Major American Jewish Organizations.

At that time, he stated that there were four points behind which almost all the people of the State of Israel were united. These points are:

- 1 - The need for defensible boundaries.
- 2 - The right for Israel to negotiate its own Peace Treaty with its Arab neighbors.
- 3 - The right for Israel not to negotiate with the P.L.O., whose objective is to abolish the State of Israel.
- 4 - The right of Jews to live anywhere in the world, including Judea and Samaria.

Subsequently, I attended two additional meetings, one where we were greeted by the former Foreign Minister of the State of Israel, Abba Eban, and another meeting last week, when Moshe Dayan gave us a briefing. The one thing that was clear at all these meetings was that there was unanimity on the part of all the speakers as to the importance of the support by American Jews for these positions. It seems odd to me that the Conference of Presidents has not, as yet seen fit to publicly state its position that it supports Menahem Begin and the State of Israel specifically on these four elementary yet crucial points.



In reference to your memo on JGS representation on the Presidents' Conference, I fully agree with you, you are entitled to a place there and I suggest that the very best way of approaching it is to have Mort Kemper send a letter requesting the membership in the Conference of Presidents of Major American Jewish Organizations to the present Chairman, Jacob Stain, with a copy to Yehuda Hellman, the professional of the Conference.

You ought to know that the UAHC has had its problems with the Presidents' Conference. Several times now we were passed by for the chairmanship, a coalition of the Zionists and the Orthodox stopped us every time around. Maurice was ready to withdraw and because of the need not to break unity in these trying times we decided not to boycott but merely to reduce our membership contribution from the required \$6,000 per annum to \$500, which means, of course, that we are not exactly a voice of influence in the Conference right now.

You also ought to know that neither of your counter-parts in the Orthodox and Conservative movements belong to the Conference. You might enhance your own chances by contacting your colleagues and making a concerted effort.

Our weak voice to the contrary, notwithstanding, you can count on our strong vocal support when the matter comes before the Conference itself.

Because of the significant service it renders to the Jewish community, THE NATIONAL FEDERATION OF TEMPLE BROTHERHOODS should be a constituent body of the Conference of Presidents of Major Jewish Organizations.

It would seem that this should have been enterprised previously, particularly when it was arranged recently for THE NATIONAL FEDERATION OF TEMPLE SISTERHOODS to be represented.

It is unfortunate that we are cut off from the mainstream of Jewish communication and decision making, particularly in times of crisis, like the present situation in Israel.

Twice before, our JEWISH CHAUTAUQUA SOCIETY was called upon by the Conference to render an important service to the Jewish community and each time we came through with massive accomplishments. The first was when we helped to alert world conscience to the plight of Soviet Jewry by producing "The Price of Silence", a half-hour documentary motion picture starring the late Edward G. Robinson. The second was when we counteracted the Arab League propaganda line branding Israel as the aggressor by producing "Beyond the Mirage" with Lorne Greene, which documents the opportunities for peaceful coexistence and understanding between Arabs and Jews in Israel. These films won several major awards and had hundreds of telecasts and thousands of group showings. "Beyond the Mirage" is still in popular demand and is the No. 1 film on a list of 40 motion pictures about Israel recommended by the State of Israel for showing in English-speaking countries.

Now more than ever, it is essential to maintain better understanding of Jews and Judaism by people of all faiths. This is the task the JEWISH CHAUTAUQUA SOCIETY has been doing so well for the past 80 years. This important function merits recognition by representation on the Conference of Presidents, which it does not presently have. We would appreciate your recommendation and support to accomplish this.

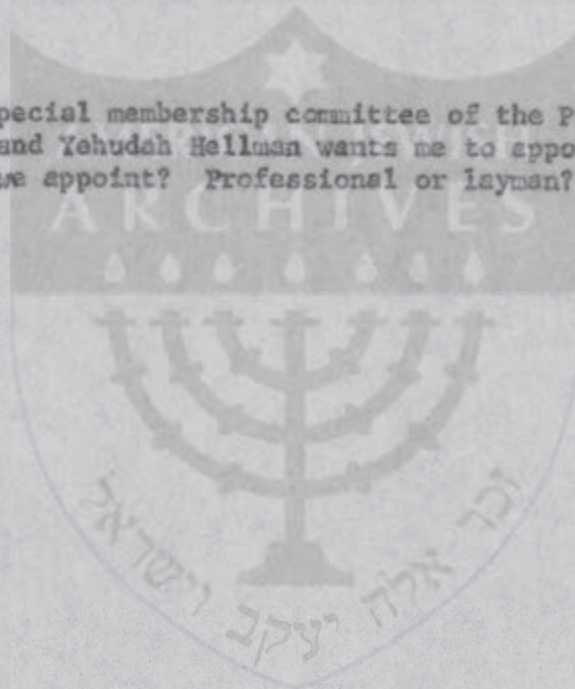

Wolf Kelman was good enough to send me a copy of his letter in which he voiced his complaint about the nominations procedures of the Presidents Conference. Needless to say, we associate ourselves completely with his views and admire him for expressing the sense of outrage which fills us as well.

Do you really blame us for this sense of outrage? It is an institutional slur, plain and simple, one which we cannot be expected to countenance. Either we are a unified community or we are not. If we are, then its plural character ought to be recognized.

I know that we have had discussions, but I do not for one moment recognize the validity of the problems which have been raised. We are perfectly willing to work with organizations whose views diverge from ours. Other organizations ought to be equally willing to work with men and institutions whose views diverge from theirs.

I just chanced to complete Nahum Goldmann's recently published autobiography. In it he repeats a statement he made to the Presidents Conference not too long ago, to wit, that Maurice Eisendrath together with Phil Klutznick helped him establish the Presidents Conference. Does this count for nothing? And what of our cooperation throughout these years? Has anything ever been denied? Have we not given both material, and in the labors of our professional and lay leaders, everything that was ever asked of us?

Throughout these years, moreover, promises were made of Chairmanships or recently of Vice Chairmanships. If our work is of no avail, are the words of the Presidents Conference's professional and lay leadership of no account either?

In a word, my friend and colleague Hersehel, we have just about had it, and because I know that you are a thoroughly decent human being, you will understand our chagrin and dismay.

"The history and Structure of the French Jewish community"

a presentation by Baron Alain de Rothschild, president of the Consistoire Central Israelite de France et d'Algerie

at the December 11, 1967 meeting of the Conference of Presidents of Major American Jewish Organizations

-----

First I wish to say how much I appreciate the possibility that is being offered me to address this most learned and dedicated body of men who is responsible for the welfare and the development of Jewry not only in this country but practically everywhere in the world.

forget

I cannot/that if in Europe and more particularly in France the Jewish communities have come back to existence and are now flourishing, it is thanks to the most generous and liberal help both financial and spiritual of the American Jewry. May I once again express to you all my most sincere gratitude.

I do not know exactly what you would like to hear from me. I know that quite a number of organizations here have a very good and broad knowledge of the organization, and of the needs of the French communities; some have offices in France and as for U.J.A. or the Joint, I would say that they are practically partners.

Nevertheless, some of you are less conversant and if the French experts here will excuse me I shall try and make a very rapid expose of our situation.

Historically the Jews in France came to full citizenship in 1790, by a decree of the "Convention" the democratic house of representatives of the French revolution.

The French community as a whole was organized by Napoleon and has retained more or less the same status since then. The local communities were organized in local "Consistoire" who were the administrative council of these communities. The members were elected and had an official status. They represented the community vis-a-vis the public authorities and they governed the community and ran the various charities. They nominated their Rabbis.

Heading all the local "Consistoires" there was a "Consistoire Central". There were seated elected representatives of each local Consistoire. The duty of the Consistoire Central was firstly to nominate the Chief Rabbi of France. It was on the top level the political and religious mouth-piece of the Community. It was the Central who discussed with the Government. It was through the Consistoire Cen-



tral that instructions were passed on by the Government to the community. It was also through the Central that relationship was established with the other religious congregations.

Last but not least, it was responsible for the rabbinical school who formed the rabbis and all religious assistants for the local communities.

It is important to know so to understand the official status of the Consistoires that the rabbis were paid by the Government as were the catholic and protestants priests.

This has gone on until now with the exception that in 1905 the state decided to split with the churches of all creed. These then became independant bodies. They had not official status and their priests were no more taken care for by the state.

With this last exception the administrative organization of the Jewish community has remained the same up to today.

Local consistoires administrate the local communities - of which the Consistoire of Paris is by far the most important - and a Consistoire Central, formed by the union of the local ones, nominates the Chief Rabbi, runs the Seminaire and settles the conflicts within or between the communities. Together with the Chief Rabbi, it keeps in touch with the Government on all religious and moral and also political problems. To be absolutely complete I must add that this law of separation between state and church has one exception. In the three "departments" of Alsace and Lorraine that were taken away from France after the 1870 defeat by the Germans, and have been returned after 1918, this law does not apply and in those three "departments" the priests are still paid by the state.

Up to a few years ago, the organized judaism centered around the local Consistoires and the Consistoire Central of France and Algerie. The local charities were independant and went about in an incoherent way, collecting money for their budgets.

About 15 years ago, following the very successful example of U.J.A., the Fonds Social Juif Unifie was founded. After a short period of trial and error, it turned out as the main collecting and distributing organization for social cultural and charitable organizations. It did not collect for the religious need nor for Israel.



Most of the charities joined the Fonds Social - accepting the term of a charter - voluntarily stopping to raise funds, and depending practically entirely on the F.S.J.U. to fulfill their budget. This F.S.J.U. was heavily supported by the claims conference who contributed up to over a half of the money distributed by this organization.

Backed by the technical know-how of fund raising of the U.S., the F.S.J.U. little by little educated the Jewish community to be more generous and when the claims conference ~~went out~~ of being, the French community was more or less able to take care of its social, charitable and cultural needs.

As I mentioned before, the appeal for Israel and other pro Israel organizations conducted separate drives; neither were the Consistoires included in the F.S.J.U. and had to go about it alone to meet their needs.

This they did through the dues paid by their members and by the services rendered to the community - Cashrout, wedding, funeral, leasing of seats in synagogues and voluntary contribution.

The Consistoire Central depended mainly on the contributions of the local communities and voluntary contributions. That is to say that it lead a hand to mouth life mostly because since my cousin Guy resigned his presidency no leadership showed up and no consistent policy was followed.

Such is, the administrative background of the French community.

It might interest you to know a bit of the general aspect of this community.

In number from 250,000 known Jews prior to the war, 150,000 about remained or returned when the war ended. Through five waves of immigration - namely : the dispersed persons and remnants of interned Jews : the Hungarians after Budapest, the Tunisians after the Bizerte, the Egyptians after the Suez campaign of '56, the Algerians after the Evian treaty that put an end to the Algerian rebellion and now the Tunisians and Moroccans who though they are not in immediate danger don't feel secure in these Arab countries and are leaving.

Through these five waves the Jewish population has risen to about 500,000 of which more than half are North African and belong to the medium to low proletariat.

These newly comers settled in the Paris suburbs where new townships were being built. In the provinces they settled in preexisting communities and, in many cases, in places where no communities ever existed. Thus, the pattern of Jewish demography was deeply modified.



How did the existing community cope with these immigrations?

As far as Paris was concerned it was mainly the task of the Paris Consistoire, who being a recognized official body was able to borrow from the state and local authorities; the Paris Consistoire, fearing a split between the two communities that would endanger the very existence of the community as a whole, started a rush program of organizing the new comers in local communities, giving them every facility to find again their identity : synagogues, community centers, classrooms were built, bought or rented - religious leaders were provided - local councils were organized under the Consistoire's auspices. In ten years, 32 new communities came into existence, each with its typical traditional identity but all adhering to the central organization. Ten seats in the Consistoire were created specially for representatives of the North African. Thus, the unity of the community was saved. This program was carried out without the help of the Fonds Social.

As far as the provinces are concerned, it was the responsibility of the Consistoire Central to take care of the problem. Unfortunately its means were more than limited, both in money and man power. Thus, the F.S.J.U. and the Joint came in as partners and helped organize the life of those communities, providing community centers, synagogues; helping the Consistoire to form and send out educators and religious assistants and organize religious life. A few days ago, I accompanied the Chief Rabbi Kaplan in a tour of the South West of France where we inaugurated 3 synagogues centers in two days in places where Jewish life before the arrival of the North Africans has practically disappeared.

What is today the image of the community? I am speaking of the active community of those who manifest themselves in a way or another, who regularly contribute their money, or their time, or worship in synagogues.

In general, apart from the North African elements who are still very attached to their traditional practices and melodies and habits epitomized by the synagogue, the community is rather detached from religion. The prevailing atheist attitude stemming from the pre-revolution philosophers and has been for many synonymous of democracy, has contaminated the French Jewry.

And in opposition to the U.S. where it is a social must to belong to a religious entity, in France such an association is considered somewhat of an oddity.

The belonging to the Jewish community stems more from the opposition and reaction to antisemitism, and respect from the millions of Jews slaughtered during the war, than from the positive attitude of adherence to the Jewish heritage and spirituality.



Nevertheless an increasing number of younger people are clamouring for knowledge of the Jewish spiritual, religious and philosophical values.

For them, university student centers are being organized. The last one in date being the center Edmond Fleg created by the Consistoire de Paris in the Latin quarter and which has a fantastic attendance of intensely interested and dedicated students.

Generally speaking the urgent problems of resettling physically and morally the new comers have overshadowed and monopolized the resources of the community and, thus, the religious needs have found little support from the public or the F.S.J.U.

Paris Consistoire has managed to pull through, but for instance the rabbinical school is leading a hand to mouth life very detrimental to the essential role it should assume in the building up of a learned and consistent body of Rabbis and educators without whom all traditional and religious life is in danger of disappearing.

Nevertheless we have maintained in Paris four day schools and 50 talmude Thoras.

Now what happened since June when it became clear that war was inevitable and that the risk of annihilation of Israel was the aim of Egypt? A unanimous upsurge took place, both amongst the Jewish population as, I must say, amongst the non Jewish population.

As far as the Jewish organizations were concerned, a Coordinating Committee was created, headed by my cousin, Guy. (To this Committee all the organizations, Zionist, political, religious or charitable surrendered all initiative as far as the fund raising, and more important, the propaganda and public relations were concerned.) This Committee headed by the most prominent Jewish citizens and by technicians in the newspaper, radio and television field did marvels, and though as you know, the Government took a neutral position, as did all other nations, the press and radio backed the Israel cause, with the exception of communist papers, and even these, under public pressure had to shift their position.

As far as fund raising, millions were collected in a week or so multiplying more than ten fold the usual contributions.



Following this extraordinary enthusiasm and reawakening to Jewish identity of a great segment of otherwise detached Jews in France, it was decided this fall to perpetuate the coordination committee and, more important, to merge the Fonds Social and what corresponds to United Palestine Appeal into one single fund raising campaign that took the name of Appel Juif Unifie.

It is certain that the June six day war and, maybe more so, the anxiety packed week, prior to the out break of fighting proper has brought to the fore, whole new segments of Jewish life. It is up to us to see that they do not sink back to their apathy.

As far as the General's press conference is concerned, I think the public protest of Rabbi Kaplan expressed in a nutshell the emotion and the reaction of the French Jewish population.

As usual it is impossible to understand the motive of such a move and even more impossible to guess what the future policy of the present Government of France towards Israel would be.

One thing I am certain of, it is that however unfortunate the remarks of the head of the State could have been and the use that could be made of them by the always present though small antisemitic portion of the population, the General himself is certainly not antisemitic and no antisemitic action or discrimination is to be feared concerning the French community.

Whatever our feelings may be, however upset we may feel, we must keep a cold head and stay away from hasty action. To even mention nazism in the present context is ludicrous.

As I said, I have not the slightest idea of what are the plans of the Government but there is one thing I am certain of, it is that a boycott by U.S. industry stemming from the General's stand towards Israel or his remarks about the Jews in general could only have an adverse effect.

However slim the possibility of the lifting of the embargo could be, it is certain that a boycott could bring about a change of mind and as far as the Jewish communities are concerned it may be a catastrophe.

If on account of Israel or of the Jews, business falls off in France, there is no doubt that it will be blamed on us and not on the Government and, as far as the community is concerned, it risks to put it in a very difficult and ambiguous position. I am afraid the proposed remedy could be far worse than the ill.



May I end up by giving the reasons of my visit here:  
As head of the religious community in France, I came at the invitation of the Union of Orthodox Jewish Congregations to see if in the religious sphere an intimate collaboration between our communities could not be brought about.

As a beginning, we are considering sending over young men at the end of their formation stage so as to study here and get acquainted with the methods that have so well succeeded in the United States.

Let me say again how grateful I am for the marvellous and generous reception I was given here. The will to perpetuate in the world the love of the Thora and the development of its knowledge is everywhere evident and I come back confident that we can depend on your religious communities to help solve our local problems. Again "merci" to all.

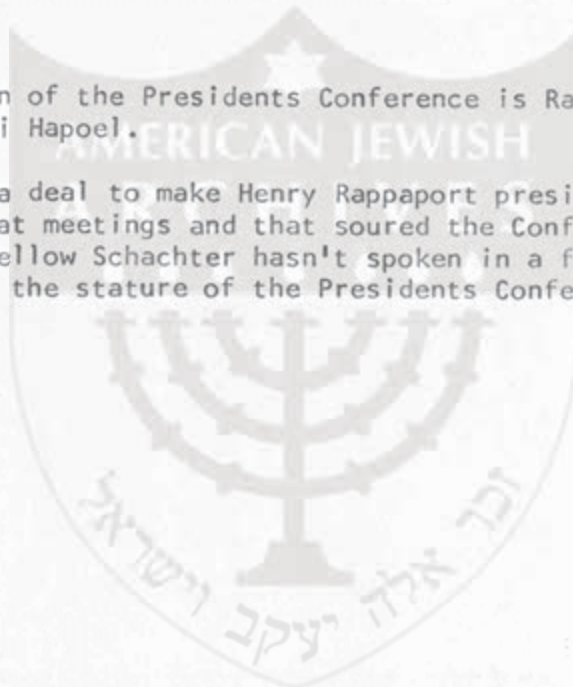

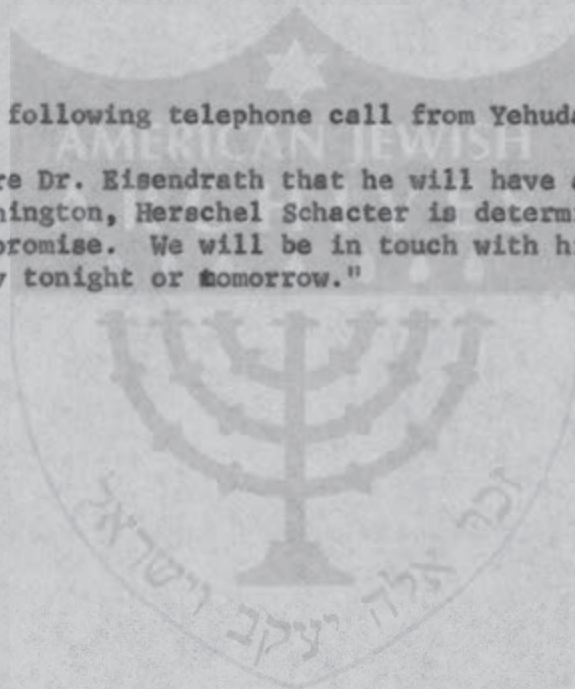

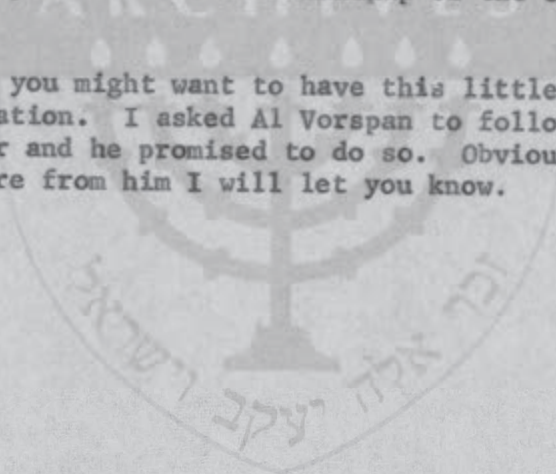

Dear Rabbi Miller:

On several occasions, since my election to the Presidency of the United Synagogue in November, 1961, you and I have discussed the possibility of my becoming associated with the Conference of Presidents of Major Jewish Organizations, of which you are presently the Chairman.

On these occasions, I pointed out to you my specific objections to the present constituency of this organization. I also indicated to you that I have strong feelings regarding the need for a representative Jewish body of the heads of truly representative Major Jewish Organizations on the American scene, which would be concerned with political, cultural, and religious problems of our people, not only in relation to the State of Israel, and our interest in its meaningful survival, but also in relation to Jewish Communities in every other part of the world.

When I met with Mr. Label Katz, yourself and Rabbi Friedman recently, we discussed this matter rather fully, and I was left with the impression that all of you shared my view, but it was felt that rather than to begin a new communal structure for this purpose, the present conference of Presidents could and should be reorganized along the lines we discussed from within, and you urged me to come to the November 26th meeting of the Conference.

I attended the November 26th meeting, and came to the conclusion that it would be an almost hopeless task to undertake to reorganize the Presidents Conference along the lines that we discussed. From my observation of that meeting, it became very clear to me that the present Presidents Conference is merely a subsidiary of the Zionist Organization of America and the Jewish Agency. In this connection, I still adhere unalterably to the statement that I made on this subject in the summer issue of the United Synagogue Review, with which, I am sure you are familiar.

I am strongly of the opinion that if we are to achieve

our purpose of creating a representative American Jewish Body which could really be the authoratative spokesman for the American Jewish Community, we will simply have to start de novo, and not by reorganizing any existing organisation.

To this end, I am still ready and eager to lend my wholehearted support and the support of the United Synagogue of America.

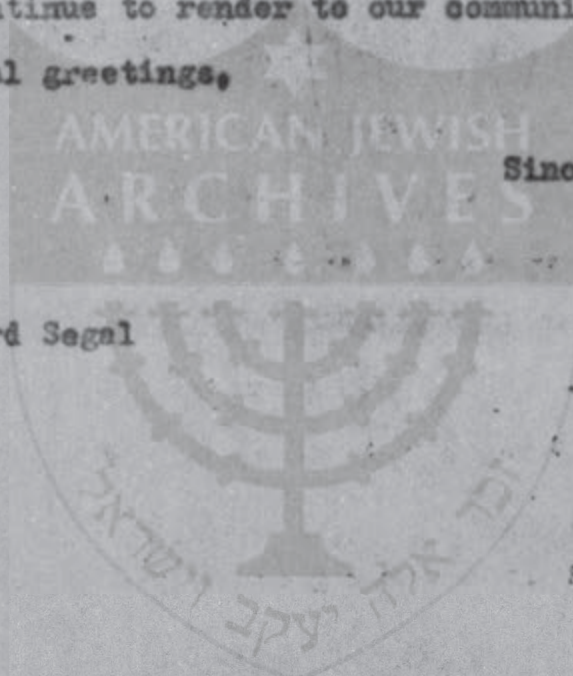

The Presidents Conference has become a most successful vehicle for coordinating the activities of all major national Jewish organizations, excepting the American Jewish Committee which insists on "going it alone." There is constant - weekly and often daily - communication between the United States State Department and the office of the Presidents Conference, i.e., with the president (presently Irving Miller) and the executive director (Yehuda Hellman).

Last week I received a call from Mr. Herbert Berman of the Orthodox Union that they were going to leave the Presidents Conference, were going to issue a press release which would indicate not only their departure but that the Presidents Conference no longer represents American Jewry. Their complaint was that the Presidents Conference was too much dominated by Zionist organizations and Nachum Goldmann, that the Conference was but "the tail of the Zionist dog," and that the organizations in it were being investigated by Senator Fullbright for this reason.

I asked that they withhold such an announcement until I return from California but they were unable to. Berman then agreed to further discussion and a meeting between Berman, Rabbi Bernard Segal, executive director of the United Synagogue, and myself. We met on Sunday and Rabbi Segal expressed views similar though not identical with those of Mr. Berman.

After a lengthy and fruitful discussion it was agreed that if a first step could be taken in overhauling the Presidents Conference, they would withhold action. The first step was to be a reconstitution of the Presidents Conference so that the "paper Zionist organizations" which have no constituency evident but which build up the Zionist position would be eliminated. This seemed to be the major consideration, though there were other objections which would be dealt with later.

Conversations with Irving Miller and Yehuda Hellman, and through them with Label Katz, brought agreement that a meeting of the Presidents Conference be called, that the president recommend appointment of a committee to study Structure, Constituency and Scope. Rabbi Segal was pleased with this development. Mr. Berman is out-of-the-city at the Inter-religious Race and Religion Conference in Chicago.

Label Katz who does agree to such a restructure and reconstituting of the Presidents Conference was, however, outraged at the Orthodox Union's insistence that the Presidents Conference be broken up if they do not get their way and be reconstituted through the NCRAC and the Synagogue Council in the same fashion as the present Joint Advisory Committee. He indicated that such action must definitely postpone the re-affiliation of ADL with the NCRAC.

Again and again voices are being raised requesting that Rabbi Eisendrath accept the Presidency of the Presidents Conference. I expect there will be a strong de marche to achieve this end.

Dear Herbert:

I believe a good first step has been made toward achieving the primary objective which we agreed was essential at our meeting in your home last Sunday. A meeting of the Presidents Conference will be called so that, officially, a committee can be appointed to deal with the Structure, Constituency and Scope of the Presidents Conference.

You were in Chicago at the time and so could not be contacted. I am therefore writing to inform you of developments. Bernie Segal and I indicated our approval of the pattern. There was a question as to whether the committee should be appointed by the president without authorization of the full Presidents Conference but it was decided that it would be best if it could be done at an official meeting. I would expect that you or a designated representative of the Orthodox Union will be on the committee.

There seems to be no objection to the "streamlining" of the constituency of the Presidents Conference. I believe it is important in order to have the objective accomplished, that all of us deal only with this goal and not speak of other objectives or alternate plans. I noted that some expression of opinion had upset people and might well cause this particular process, which seems well on its way, to be impeded, and other damage as well. To that end I think it might be wise if there be no talk of breaking up the Presidents Conference and establishing an organization under the aegis of the NCRAC-SCA. The very delicate negotiations between the NCRAC and the ADL for the latter's re-affiliation are now in progress and such talk will most assuredly end such conversations. This would be most unfortunate. Further, allegations that the second term of the incumbent president was a violation of a promise will serve no purpose and only place obstacles in the road which now seems smooth and which we wish to terminate swiftly.

Dear Bernie:

I believe encouraging progress has been made toward restructuring of the Presidents Conference along the lines which you and Herbert Berman indicated at the meeting at his home last Sunday. Herbert is out-of-the-city at the Inter-religious Race and Religion Conference in Chicago so I don't know what his reaction will be.

It seems certain now that a special meeting of the Presidents Conference will be called, that the president will appoint a committee to study its Structure, Constituency and Scope and that steps will be taken to bring about the desired modifications.

Now is the time for the utmost discretion. As you have observed countless times, any untoward speed or careless reference can ruin a much desired process. For example, Label Katz who heartily approves the objective of the first step, was dismayed to learn of the Orthodox feeling that the Presidents Conference be eliminated and a substitute be created along the lines of the NCRAC-SCA Joint Advisory Committee. Further, he learned of the Orthodox contention that Irving Miller was elected for the second year illegally and contrary to agreement. Since he was chairman of the Nominating Committee, he was understandably upset by the allegation - which both of us, at least, feel is unwarranted - that he violated a trust. Secondly, he observed that if the Orthodox Union acts high handedly, forces the NCRAC out of the Presidents Conference, that there is every likelihood they will not re-enter the NCRAC. This would be most unfortunate.

I will be away, as you know, but will be back for the meeting of the Presidents Conference. I hope in the interim that you will keep the roiled waters smooth by keeping in touch with Berman and Hellman.

MEMORANDUM

To: Members Associated in the Conference of Presidents

From: Yehuda Hellman

The following is a short summary of the proceedings of the meeting of the Presidents Conference which took place on February 12, 1965.

Mr. Lewis Weinstein, the Chairman of the Presidents Conference, called the meeting to order at 11:30 a.m.

The first item on the agenda was a report by the Chairman of the Committee on new members, Dr. Joachim Prinz. Dr. Prinz informed the Conference that the Central Conference of American Rabbis and the Rabbinical Assembly have joined the Presidents Conference. He also reported for his Committee that no final recommendation would be made at this time as far as membership of women's organizations in the Presidents Conference is concerned, instead the Committee proposed that women's auxiliary organizations participate in the delegation of their parent organizations in the Presidents Conference.

The second item on the agenda included a report on the situation of South American Jewry. Mr. Marc Turkow, the representative of the World Jewish Congress in South America and one of the leaders of the DAIA (the representative Board of Argentine Jewry) from Buenos Aires reported to the Conference on latest developments in South America and particularly about recent anti-Semitic outbreaks in the Argentine.\*

Next on the agenda was a report by Mr. George Maislen, the Chairman of the Committee on the Jewish Telegraphic Agency. Mr. Maislen recommended in the name of his Committee that the participating organizations in the Presidents Conference review their own relationship with the Jewish Telegraphic Agency in order that this important instrumentality be strengthened as much as possible by means of subscriptions and grants wherever feasible. Mr. Maislen called the JTA "an essential tool for Jewish leadership in our time". The Conference took note of Mr. Maislen's report.

The fourth item on the agenda included a short review and report by the Chairman, Mr. Lewis Weinstein, on his recent trip through various parts of Africa including a visit with the Jewish community of South Africa. Mr. Weinstein returned deeply impressed with the work done by the State of Israel in various African countries. Mr. Weinstein reported that the common people in those countries seemed to appreciate Israel's contribution towards their own welfare.

The Conference then turned to the German question. Mr. Weinstein introduced Dr. Goldmann who gave a detailed report in connection with recent developments in the German question. Dr. Goldmann spoke among others about problems of Reparation and Restitution, presence of German scientists in Egypt and the issue of the extension of the Statute of Limitations. Dr. Goldmann expressed appreciation for the work done by the Presidents Conference in connection with the German problem.

Following Dr. Goldmann's report Dr. Weisman of the Jewish War Veterans reported on behalf of the Presidents Conference Technical Sub-Committee on Germany. The following proposals were made:

- 1) An extensive letter writing campaign be started addressed to the German Embassy in Washington.
- 2) That our case be explained to the leaders of the non-Jewish community - Catholic, Protestant and Negro - in order to secure their support in connection with the extension of the Statute of Limitations and other matters on our agenda.
- 3) The Committee recommended that local meetings take place so that the community be fully informed about the issues involved.
- 4) It was suggested that the Presidents Conference call a press conference to inform public opinion about our position. Dr. Weisman also suggested that the idea of an international Jewish delegation to Bonn be further considered by the Presidents Conference.
- 5) The Sub-Committee proposed that organizations consider the possibility of publishing full page ads in connection with this problem.

Mr. Tabachinsky of the Jewish Labor Committee informed the Conference that his organization would do everything possible to involve the American Labor Movement in this program of action which would also then include direct contacts with the Labor Movement and progressive forces in Germany.

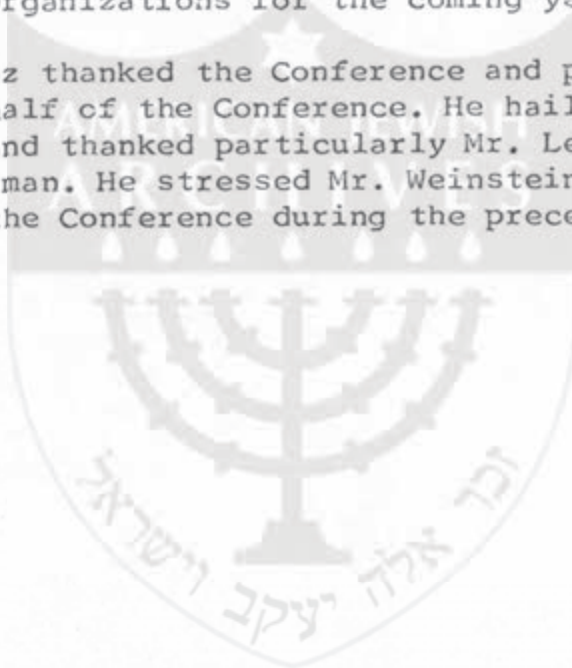


Mr. Lewis Weinstein called on Mr. Label Katz to make a report in the name of the Nominations Committee of the Presidents Conference.

Mr. Katz informed the Conference that he would like to put the name of Dr. Joachim Prinz in nomination as Chairman of the Conference for the next year. He stated that this represented the unanimous choice of his colleagues on the Nominations Committee.

Following the report, Dr. Prinz was elected by acclamation as the Chairman of the Conference of Presidents of Major American Jewish Organizations for the coming year.

Dr. Prinz thanked the Conference and pledged his best efforts on behalf of the Conference. He hailed the work of his predecessors and thanked particularly Mr. Lewis Weinstein, the outgoing Chairman. He stressed Mr. Weinstein's accomplishments on behalf of the Conference during the preceding year.

Please be informed that the North American organizations participating in C.O.J.O. held a special meeting Sunday, February 7th in order to consider recent anti-Semitic developments in the Argentine and other Latin American countries.

The meeting was benefited by the presence of Mr. Mark Turkov, the Director of the World Jewish Congress for Latin American countries, who rendered a detailed report. Mr. Turkov documented conclusively the link between the activities of anti-Jewish terrorist groups and Arab League representatives in the Argentine. The Egyptian general El Masri is now fully in charge of the activities conducted by Chusein Tricki, who was his predecessor in the same office.

Also, reports were given by Dr. Nathan Lerner of the World Jewish Congress and Mr. Philip Katz of B'nai B'rith on their meeting with the Argentine ambassador in Washington, which took place Thursday, February 5th. Dr. Lerner and Mr. Katz had expressed to the Ambassador appreciation of Jewish communities all over the world for the recent police action which led to the discovery of a Nazi anti-Semitic plot in the Argentine.

The delegation representing C.O.J.O. had also expressed anxiety over the continued activities of terrorist anti-Jewish groups in that country. The Ambassador Dr. Norberto Barrenechea issued to the delegation a determination by the government of President Illia to put an end to any terrorist activities threatening the peaceful coexistence of the Jewish community, which he described as an integral part of the Argentinian democratic society. The delegation had submitted to the Ambassador documents revealing the nature of anti-Semitic and Nazi literature and action in Argentina, as well as their international implications. The Ambassador had promised the delegation that he would transmit to his government the views expressed.

Turkov also told the assembled representatives in the C.O.J.O. meeting that similar documentation was submitted by Argentinian Jewish leaders to the government in Buenos Aires. During his stay in the United States, Turkov has maintained a day to day telephone contact with the leaders of the D.A.I.A.

At the conclusion of the meeting the groups represented (American Jewish Congress, B'nai B'rith, Canadian Jewish Congress, Jewish Labor Committee and World Jewish Congress) approved the following statement which was made public and issued to the press:

"The World Conference of Jewish Organizations (COJO) notes with grave disquiet the increasing activities of international Nazi organizations which, in cooperation with local terrorist groups, have established operational centers in several

Latin American countries. The evident purpose of these clandestine activities is to subvert democratic institutions and ordered governments; and in obedience to the evil tradition established by their predecessors in Nazi Germany, to foment and exploit anti-Semitism as a political instrument to further these ends.

"The recent discovery of a secret Nazi conspiracy by Argentine security forces, with evidences of preparation for a campaign of terror and violence against the Jewish community and the assassination of prominent Jewish citizens, has inevitably given rise to anxiety not only in Jewish communities but among friends of democracy everywhere. This discovery underscores the repeated warnings from responsible Jewish sources in Argentina of the mounting danger presented by the activities of these anti-Semitic groups.

"We note with appreciation that the Argentine government has not only adopted legislative measures in the recent past to deal with these subversive activities, but has given urgent instructions to the federal police to apprehend the conspirators and bring them to justice.

"And we draw reassurance from the firm and repeated declarations of responsible members of the Government that they are resolved both to eradicate subversion and terrorism and to protect the security and human rights of all their citizens.

"We are confident that in harmony with the highest ideals of the Argentine national tradition, which has been hospitable to men of all faiths and given them an equal place in the service of the common welfare and national interest, that the Government will press forward with the measures necessary to bring to an end the subversive conspiracies which seek to undermine the rule of law and threaten the equal rights of Argentine citizens."

LEWIS H. WEINSTEIN, BOSTON ATTORNEY AND CIVIC LEADER ELECTED  
CHAIRMAN OF CONFERENCE OF PRESIDENTS OF MAJOR AMERICAN JEWISH  
ORGANIZATIONS.

New York, Dec. 2, 1963 -- Lewis H. Weinstein, Boston Attorney and civic leader, today was elected chairman of the Conference of Presidents of Major American Jewish Organizations. He was the unanimous choice of the eighteen presidents of Jewish Organizations that comprise the Conference. His name was placed in nomination by George Maislen, president of the United Synagogue of America, on the unanimous recommendation of the nominating committee.

The eighteen organizations whose principal elected officers comprise the Conference are American Israel Public Affairs Committee, American Jewish Congress, American Zionist Council, American Trade Union Council for Histadrut, B'nai B'rith, Hadassah, Jewish Agency for Israel, Jewish Labor Committee, Jewish War Veterans of the U.S.A., Labor Zionist Movement, Misrachi Hapoel Misrachi, National Community Relations Advisory Council, National Council of Jewish Women, National Council of Young Israel, Union of Orthodox Jewish Congregations of America, Union of American Hebrew Congregations, United Synagogue of America, and Zionist Organization of America. The President of the Council of Jewish Federations and Welfare Funds participated as an observer.

Mr. Weinstein, who is chairman of the National Community Relations Advisory Council, succeeds Rabbi Irving Miller, president of the American Zionist Council, as Conference chairman. He will be the first chairman to serve in that capacity since the Conference expanded the scope of its concern last September, from American-Israel matters exclusively, to issues affecting Jews in other lands throughout the world. The Conference has been deeply preoccupied since then with the problem of the situation of Jewish life within the Soviet Union to which all the participating Jewish organizations gave a very high priority.



Other predecessors of Mr. Weinstein in the office have been, in order of incumbency, Dr. Nahum Goldmann, chairman of the Jewish Agency for Israel; Mr. Philip M. Klutznick and Mr. Label A. Katz, respectively former and present president of B'nai B'rith.

In addition to occupying many positions of distinction in American Jewish Organizations and in the Jewish Community of Boston, Mr. Weinstein has been prominent in Boston's civic life and is a Presidential appointee to an important federal agency.

An authority on housing, he was named last Spring by the late President John F. Kennedy to the President's Committee on Equal Opportunity in Housing and as a member of its three-member executive committee. A former assistant corporation counsel of the City of Boston, he has served as general counsel of the Boston Housing Authority and of a number of other municipal housing and redevelopment authorities in Massachusetts. He drafted the first Massachusetts laws outlawing segregation in housing and the state's first urban renewal legislation.

A tireless worker in communal causes, Mr. Weinstein has attained many distinctions both in Jewish life and in the general community. In addition being chairman of the NCRAC, he is a member of the executive of the Jewish Agency for Israel, Inc., he is secretary of the Council of Jewish Federations and Welfare Funds, vice president of the American Association of Jewish Education, a member of the executive committee of the United Jewish Appeal, and a member of the Board of Overseers of the Florence Heller Graduate School of Social Welfare of Brandeis University.

In Greater Boston Jewish activities, Mr. Weinstein is a former vice president of the Associated Jewish Philanthropies and former President of the Hebrew Teachers College and the Jewish Community Council. He is a Trustee of Beth Israel Hospital, a member of the Board of Directors of Temple Mishkan Tefila, and the Hebrew Home for the Aged, and other Jewish Organizations.

Mr. Weinstein is a partner in the Boston law firm of Foley, Hoag, and Eliot. He is on the faculty of the Harvard Law School of which he is a graduate, and of the Massachusetts Institute of Technology, where he lectures on land law in the Graduate Department of Regional and City Planning. An honor graduate of Harvard College, he was elected to Phi Beta Kappa and was the recipient of numerous scholarships and prizes.

A member of the Boston Mayor's Committee on Civic Improvement and Delinquency Prevention, Mr. Weinstein was co-chairman - with Father Robert Drinan, Dean of Boston Law School, and Harold Russell - of the Massachusetts Committee on the Tenth Anniversary of the Declaration of Human Rights, and, in 1957, he received the National Brotherhood Award of the National Conference of Christians and Jews, in which he has been active as a member of the Executive Committee and Board of Directors of the Northeast Region.

He is a member of the Board of Directors of the Massachusetts Federation of Taxpayers Associations, of the Governing Council of the Boston Bar Association, and educational, cultural and civic groups in Boston.

During World War II, Mr. Weinstein served in the Army, ending two and a half years of service in North Africa, England, Normandy, France, Belgium, Holland, Germany, and Italy, as Chief of the Liaison Section of the European Theater of Operations, on the staff of General Dwight D. Eisenhower. He entered Paris on the Day of Liberation as Liaison Officer to General Charles De Gaulle, and supervised American Liaison activities with all the Allied Forces and with other American headquarters. He is a graduate of the Army General Staff and Command College in Ft. Leavenworth, Kansas, and of the school of Military Government in Charlottesville, Virginia.

Mr. Weinstein received various military medals and awards, including the Legion of Merit, the Bronze Star Medal with Oak Leaf Cluster, the French Legion of Honor, the French Croix de Guerre, and citations from British Marshall Montgomery, and Generals Eisenhower and De Gaulle. In a private audience with Pope Pius XII, he was presented with a Vatican Military Medal.

Until recently, Mr. Weinstein served as a Colonel in the Judge Advocate General's Department of the Army Reserve and as Legal Officer of the 357th Civil Affairs Area Headquarters. He is a former chairman of the Armed Forces Advisory Committee of Greater Boston, a member of the Advisory Council of Naval Affairs, and of the Board of Directors of the Massachusetts chapter of the Association of the United States Army.

Mr. Weinstein is married to the former Selma Yeslawsky, a Radcliffe graduate. They have two children, David, 28; and Louise 18. He resides at 56 Varick Road, Waban. His hobbies include music, the theater, and writing. His publications include a play, poems, and numerous legal articles.



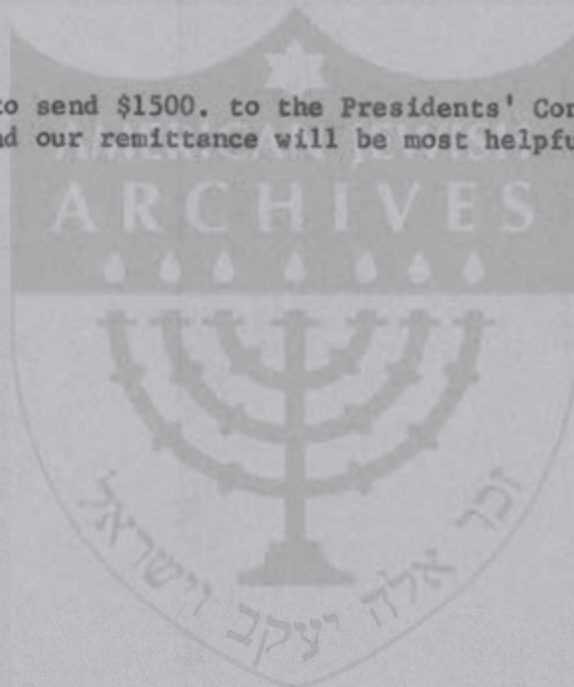


Dear Rabbi Schindler:

During 1977 we organized across America the Jewish legislators who served from coast to coast in their respective states. There are in all a little over 200 Jewish legislators in the U.S. and already over 105 have become members of our new organization. Our members include Jews who are Speakers or Senate Presidents of Missouri, Connecticut, New York, New Jersey and Maryland as well as rank and file members of 34 states including two from Hawaii, one from Alaska and one from the Virgin Islands. This network was set up to accelerate legislation of importance to the Jewish community in our country, and to unite Jewish solons behind Israel.

Our first National convention was held in Detroit on August 4 and had Ambassador Simcha Dinitz as our key speaker and two Canadian Jewish legislators as guests. We are having a regional meeting in St. Thomas this December and are planning to have an orientation session with Secretary of State Vance and Assistant Secretary Atherton in the near future.

I would like to arrange to meet with you to see how our group may coordinate its effort in support of the great work which you are doing. If you will let me know a time convenient to you, I shall be glad to come to New York City to confer with you.
