# Arabs rebuil Young likeming them to K

. - Twenty Arab U.N. delegations have expressed Humaidan saying "he was surprise to U.S. Ambassador Andrew Young for saying Arab hatred of Jews reminded him of Ku Klux Klan hatred of blacks.

The Arabs took issue with Young in a letter released Friday night while the State Department was scrambling to patch up any diplomatic damage resulting from a remark Young made Thursday when he sid he thought the South African government was illegitimate. -

"All the Arabs differentiate between Zionism and Judalsm," the Arab group said in the letter. "We consider Judaism a sacred religion as Islam and Christianity."

Zionism is the movement to create a Jewish homeland in Palestine.

Amin Helmy II, the Arab League U.N. observer, released the letter to reporters. He said the group was indignant when first learning of the remark but decided to soften the letter after a meetng Young had with Ambassador Ali Humaidan of the United Arab Emirates.

Young excused himself to new, he was ignorant, he was learning," Helmy said.

Young's remarks on Arab-Jewish feelings were made in a closed-door meeting with the Conference of Presidents of Major American Jewish Organizations on March 30. Libya complained about the remarks at a U.N. Security Council meeting on Tuesday.

Spokesmen for Young declined to release the remarks on grounds they were made off the record. But Richard Cohen, press spokesman for the Jewish organization, said he took notes which showed Young

Dear Ambassador Young:

We have learned from press reports of a letter to you from Amin Helmy, United Nations observer for the League of Arab States, that the Arab League considers Judaism a "sacred religion." For this reason, according to the same report, you could not have had the experience of encountering Arab hatred in the Middle East, which you recounted in your eloquent and moving address to the Conference of Presidents on 30 March.

It would appear, however, that this theological concept is of quite recent origin. If Judaism was a "sacred religion," why were Jews prohibited from worshipping at the Western Wall from 1948, when the Old City of Jerusalem fell into Arab hands, until the unity of Jerusalem was restored by Israel in 1967? Why were the other Jewish holy places in Jerusalem desecrated — tombstones of the sages razed to serve as toilets? And if Judaism is so dear to Moslems, why did more than 500,000 Jews living in Moslem lands flee as refugees to Israel as soon as a Jewish state was proclaimed?

All the Arab denials cannot disguise the fact that it is Arab hatred that caused six armies to invade Israel at the moment of its birth in 1948; that sent organized bands of terrorists to wreak havoc inside Israel in 1956; that expelled U.N. troops and closed the Straits of Tiran to touch off the Six Day War in 1967; and that launched a surprise attack against the Jewish State on the holiest day of the Jewish calendar, Yom Kippur, in 1973. And today it is Arab hatred that refuses to accept the legitimacy of the Jewish State — nearly 30 years after the founding of Israel — a hatred that remains the one great obstacle to a peaceful Middle East.

Judaism a "sacred religion" to Moslems? Then why the massive distribution in the Muslim world of the infamous anti-Semitic forgery known as the "Protocols of the Elders of Zion?" Once this was the favorite literature of Hitler and his henchmen. Now there are more translations into Arabic than in any other language. The late King Feisal of Saudi Arabia took delight in distributing a particularly handsome edition of the "Protocols" as a farewell gift to visitors to his kingdom. Hundreds of thousands of copies have been distributed in French, English, Spanish and Italian by the Islam Institute for Research and Publications in Beirut and other Arab institutions.

Judaism a "sacred religion" to Moslems? The amount and vehemence of anti-Jewish literature in Arabic has no parallel in the post-World War II era; most of it emanates from official publishing houses and government agencies. Anti-Jewish hatred — the kind that you experienced in Jordan — does not originate at the fringes of Arab society but rather at the center.

Rabid anti-Semitic themes are commonly found in Arab textbooks for schools and in the indoctrination literature used by Arab military forces. Indeed, religious anti-Semitism has become an Arab weapon in the war against Israel. I quote from the 1968 Conference of the Academy of Islamic Research in Cairo, where Muhammed Azzah Darwaza, in a paper entitled "The Attitude of the Jews Toward Islam, Muslims and the Prophet of Islam R.B.U.H. (Peace Be Upon Him) at the Time of His Honorable Prophethood," declared: "It is incumbent on the Muslims to strain every nerve and make all efforts in order to be well-equipped by all means to fight the Jews. The Muslims should corner the Jews without feeling exhausted or tired as Allah enjoins upon them."

The hatred that struck terror into your heart, Mr. Ambassador, was real. The evidence you heard is supported by the public statements of Arab leaders, the Arabs' enormous distribution of anti-Jewish propaganda, the experience of half a million Jews who fled Arab rule and the refusal of Arab governments to acknowledge the right of the Jewish people to live in a Jewish state on the soil of the ancient Jewish homeland.

The world awaits a sign that the Arab world is prepared to live in peace with the Jewish religion and those who believe in it. Indeed, President Sadat of Egypt, in an address to the Arab-African conference in Cairo only last month, stressed "the link between the Palestinian nationalist movement and the Black Nationalist movements of Rhodesia, South Africa and Namibia." He drew a "comparison between so-called front-line Arab states around Israel and the African front-line states around Rhodesia." He called for the "political and economic isolation of Israel, South Africa and Rhodesia." (New York Times, March 8, 1977).

The Arab League's current efforts to distinguish between Judaism and Zionism recall the hypocrisy of those who love humanity but hate people. It is deceit — and it is dangerous. But it will not delude the American people into believing that Israel's Arab neighbors are ready to live in peace with a Jewish state any more than you were

when you experienced the kind of Arab hatred that you told us about in your address on 30 March.

The assertion by 20 Arab delegations to the United Nations in a letter to Ambassador Andrew Young that Arabs "consider Judaism a sacred religion" has been assailed as "deceit" and "hypocrisy" by the chairman of the Conference of Presidents of Major American Jewish Organizations.

"If Judaism was a 'sacred religion,'" Rabbi Alexander M. Schindler asked, "why were Jews prohibited from worshipping at the Western Wall from 1948, when the Old City of Jerusalem fell into Arab hands, until the unity of Jerusalem was restored by Israel in 1967?

"Why were the other Jewish holy places in Jerusalem desecrated -- tombstones of the sages razed to serve as toilets?

"And if Judaism is so dear to Moslems, why did more than 500,000 Jews living in Moslem lands flee as refugees to Israel as soon as a Jewish state was proclaimed?"

Rabbi Alexander M. Schindler released the text of a letter he sent this week to Andrew Young, chief U.S. representative at the United Nations, commenting on a public letter to Mr. Young from Amin Helmy II, UN observer for the League of Arab States.

Mr. Helmy had taken issue with a statement by Mr. Young, in an address to the Conference of Presidents on March 30, that he had encountered Arab hatred in visiting the Middle East in 1966.

In challenging the Arab spokesman's statement, Rabbi Schindler wrote to Mr. Young:

"The batred that struck terror into your heart, Mr. Ambassador, was real.

"The evidence you heard is supported by the public statements of Arab leaders, the Arabs' enormous distribution of anti-Jewish propaganda, the experience of half a million Jews who fled Arab rule and the refusal of Arab governments to acknowledge the right of the Jewish people to live in a Jewish state on the soil of the ancient Jewish homeland.

"The Arab League's current efforts to distinguish between Judaism and Zionism recall the hypocrisy of those who love humanity but hate people. It is deceit -- and it is dangerous. But it will not delude the American people into believing that Israel's Arab neighbors are ready to live in peace with a Jewish state any more than you were when you experienced the kind of Arab hatred that you told us about in your address on 30 March."

Mr. Young's address to the Conference of Presidents was off the record but a spokesman for the Jewish organization said his notes showed Mr. Young had said:

## Young remark on West Bank

Ambassador Andrew Young, head of the American delegation to the United Nations, has had to "explain" yet another of his off-the-cuff undiplomatic statements, this time to twenty Arab delegations to the world organization.

The Arabs had protested Young's remarks before a closed meeting of the Conference of Presidents of Major Jewish Organizations on March
30. Spokesmen for Young refused to release his
remarks because they were off the record, but
the press officer of the Presidents Conference,
Richard Cohen, made his notes available. These
showed that Young said.

"I had seen hatred by people with Ku Klux Klan mentality based on ignorance in the United States. But in Jordan, I had my first experience of hatred on the part of intellectuals. It brought terror to my heart.

"I understood Israel's need for military support. I understood why Israel had to be strong and secure to cope with the hatred of its neighbors."

The Arab states sent a letter of protest to the State Department. In it, they said that "all the Arabs differentiate between Zionism and Judaism. We consider Judaism as sacred a religion as Islam and Christianity."

The letter was released to reporters at the U.N. by Amin Helmy, the observer for the Arab League. He said that the Arab states were indignant when they first heard of Young's remarks, but softened their letter to the State Department after a meeting between Young and Ambassador Ali Humaidan of the United Arab Emirates.

Helmy said that Young excused himself to Humaidan, saying he was "new, he was ignorant, he was learning." The Arab group considered the matter closed, Helmy said.

## ties with Israel; Portugal ready

(JTA) — Soviet Foreign Minister Andrei Gromyko told Cyrus Vance that the Kremlin is planning no change in its no-relations policy towards Israel. Gromyko made the comment in response to a direct question from the U.S. Secretary of State recently — and it was reported to the Israeli Cabinet this week by Prof. Shlomo-Avineri, Director-General of the Foreign Minis-

The report followed a proposal by Health Minister Victor Shemtov that Israel approach the Soviets and offer to restore ties.

Shimon Peres seemed to be making a similar proposal in a newspaper interview last Friday—but he said nothing at the Cabinet meeting.

The United States State Department has picked up "several significant indications of a gradual Soviet movement" in the direction of an early resumption of diplomatic relations with Israel, according to the Jerusalem Post. Quoting American sources in Washington, the paper says that the State Department thinks relations could be restored by this summer, before the proposed reconvening of the Middle East peace parley in Geneva.

Meanwhile, it was announced in Jerusalem that Ephraim Eldar, the country's counsel in Lisbon, would be named Israel's first ambassador to Portugal following the joint announcement in Amsterdam by Foreign Minister Yigal Allon and Portuguese Prime Minister Mario Soares that diplomatic relations had been agreed

The announcement came at a meeting of world Socialist leaders in Holland. Allon also met there with India's Minister of Communications, Georges Fernandez, India's first representative to the Socialist group, and was told that the sub-continent would "reexamine its relations with Israel in a few weeks."

India does not recognize Israel and both Jawaharlal Nehru, its first Prime Minister, and Indira Gandhi, his daughter and recent head of Government, were hostile to the Jewish state. Israel does have a consulate in Bombay which maintains a low profile.

### Taiwan believed buyer of Israel missiles

The Chinese Nationalist Government in Taiwan has secretly purchased Gabriel surface-to-surface missiles from Israel. These weapons, designed and built in Israel, are, acording to a report in the New York Times, already being installed in three Nationalist destroyers.

The Gabriel missile has a range of about two miles.

acquaintance of profour atters Without unduly presuming upon a friendship and acquaintance of now thirty year's duration, I want to express to you my profound dismay, amounting to a moral revulsion, at two public matters with which you have been identified in the past several weeks, both of them emanating from the Presidents' Conference.

First was the public attack on those who met the people from the Palestine Liberation Organization. It is possible, of course, to differ about the wisdom of American Jews privately meeting with PLO spokespeople. It is, in the circumstances and given the character and motives of the Jewish participants, impermissible to denounce them in terms that suggest that they are traitors to the k'lal. The totalitarian aspirations to control of Jewish thought, discourse, and action that emanate from the Israeli foreign office cannot oblige you and your colleagues in the President's Conference to persist in such efforts at Gleichschaltung. That attack was reprehensible politically, morally, Jewishly.

Second is the tribute paid at the Hotel Pierre luncheon to the assassin of Cambodia, our Landsmann Henry Kissinger. Again: One can be of two minds about his role in the Middle East over the past several years, but a sentient human being can only gag at the Jewish establishment celebrating this loyal apologist for the most threatening usurper of the Constitution in this country's history and the principal (indeed: dispositive) engineer of America's most disastrous and murderous foreign undertaking, the War in Southeast Asia, Christmas bombing and all.

I am appalled by both events, and I am offended by your participation in them. I know that power and prestige exact their price. We should long since have learned the bitter lesson that there are prices too high for our conscience to pay. These two matters alone may exhaust the credit balance shel ma'ala that you have no doubt earned.

Dear Henry:

You are not presuming upon a friendship when you express your dismay. You build that friendship.

First, in regard to the PLO Resolution. As it happens I was in the hoppital and not present at the meeting when this resolution was introduced by the ADL, discussed and unanimously accepted. As chairman, I suppose I will have to bear responsibility for it anyhow and so I read it after I came out. I will admit that I was not pleased in every respect with it and would probably have altered some wording here or there to moderate the resolution. Nonetheless, your charge that this resolution "denounces (the participants at the meetings) as traitors to k'lal" is an outrageous distortion of this resolution. It neither implies nor directly charges any such thing. It questions the wisdom of such meetings and expresses "the concern --- that any private meetings tend to underwine the peace process" and that ultimately peace can only be reached if the Israelis confront their neighbors and their neighbors meet with them and not is American Jewry negotiates in their behalf. It was not an attack, as you described it to be, and I can only conclude that you denounced a denunciation which you had not read and that, my friend, is "reprehensible politically, morally and Jewishly." I know that Al Vorspan and many others like him were in the room when this resolution was adopted unanimously and that alone assures me that nothing of what you described took place at the meeting, nevermind the printed text. Obviously, neither I nor the Presidents' Conference can be held responsible for how other individuals or even the media interpreted that resolution.

In regard to Kissinger, you ought to know that Reform Judaism, and I speak now as President of the UAHC, throughout the years of his tenure in office was probably the only Jewish publication which denounced him editorially for his role in Cambodia, Vietnam, Chile and his wanton disregard of civil rights on the American scene, etc. etc. And I personally and officially am identified with this position and have expressed it publicly everywhere I have gone. Insofar as his role in

the Middle East is concerned, I do not believe that the final judgment can yet be made. My own inclination, having worked with him closely on this issue, is that he earnestly strove to do good and that on balance he achieved a great deal of good. I also know from personal experience that he rendered an extraordinary amount of help to the Jewish community and quietly rescued hundreds from imprisonment, if not death, through his personal intervention, never thind the supportive role he played in Israel's hours of need. Is it not proper to say thank you for something you deem to be good even as you clobber a man for the things that are wrong? Frankly, I am appalled by this, your total judgment of a man in all his doings as evil. That simply is not fair and proper. This man has a debit ledger and a credit ledger and he deserves praise for the good even as he merits denunciation for the evil. That, at least, is my approach.

I think I am older than you, Henry, maybe that's why my moral judgments are perhaps more mellow than are yours.

The fact remains that the ultimate objective of the PLO is the destruction or dismemberment of the sovereign state of Israel — as clearly stated in its National Covenant and reiterated time and again by its leaders and spokesmen. Having failed to achieve this goal through terrorism, the PLO has turned to the United Nations, where, backed by certain Arab states and their allies, it has attempted to realize the same objective through improved diplomatic initiatives.

We endorse and support the United States Government's steadfast refusal to meet with representatives of the terrorist organization. We are confident that the new Administration will maintain this position, but we are concerned that any private meetings fuch as mentioned above with the PLO could tend to undermine official policy. The proof of the formula of the proof of the policy.

We believe such meetings could also undermine genuine efforts toward peace in the Middle East. Peace can only be achieved by free and unfettered negotiation between parties to the conflict -- Israel and the Arab states. Outside parties, be they foreign governments or individuals acting in private capacities, cannot take on the role of negotiators and could actually subvert progress on this front.

Israel's constant quest -- spanning the three decades of its independence -- has been for a just, stable, and lasting peace with its neighboring countries, a peace based on security and defensible borders. It is our conviction that this will only come about through direct discussion by the countries concerned, not by unrepresentative parties on either side.

Dear Rabbi Schlinder,

I was very disturbed and alarmed today when I found a declaration sponsored by The International Symposium on Zionism in The New York Times. This declaration listed many points against Zionism in order to prove that the Symposium supported the "Palestinian Revolution" and the "Lebanese National Movement".

The declaration also expresses the apprehension of the symposium towards Jewish immigration to Israel. They believe, of course, that the aim of the world's Jewish population is to corral every Jew into what they term "a world ghetto".

How can we, as concerned Jewish people, make the world understand the sentiments that have kept us separate from other nations, and therefore enable us to have survived for thousands of years as a people with a rich and spiritual heritage? It is also important for the world to understand the role of the diaspora Jew. He may be one who has strong feelings toward Israel, but because of certain circumstances has decided to live his life outside of Israel. This Jew is as dependant on the survival of Israel as Israel is dependant upon him for its survival. I believe that the anti-Zionists want to provoke those of us who consider Israel our homeland to immigrate as soon as possible. In this way, all the foremost and outspoken Zionists will be situated in one spot, vulnerable to some nuclear holocaust planned by the madmen of the Arab world.

Does this sound extreme? The danger is this extreme. How are we to assert ourselves and protect ourselves from world bodies such as the UN, which are clearly anti-Zionist. Of course we all realize that anti-Zionism is

another disguise for anti-Semitism, probably the most irrational racist movement in the history of Mankind.

I ask again, what are we to do? I ask perhaps with a hint of panic, because it seems that anti-Jewish movements are being born and legalized every day. It seems likely to me that someday Israel will be able to solve her political problems with her neighbours; but will the enemies of the Jews everywhere ever cease their campaign to wipe out the Jewish people?







Dear Rabbi Schindler:

It was with great distress that many of us involved in United Nations affairs read your advertisement in the Sunday New York Times of November 28, 1976. I understand how your commitment to Israel would lead to great frustration over several actions of the General Assembly in the past few years. Even though I have a rather different view of how to achieve peace in the Middle East, I do not question your choice to oppose specific actions taken in the United Nations which you feel are hostile to the State of Israel. What I find most disturbing, indeed inconsistent with past positions of your member organizations, is the broadside attack on the United Nations contained in the November 28th ad.

The United Nations has undeniably made considerable contributions to world peace through programs dealing with world health, development, refugee relief, and so forth. I also believe that some of its specifically peacekeeping actions may be considered successful (not exclusive of those in the Middle East). Other such peacekeeping activities have been abuses of the prescribed function. Most abhorrent about your ad was its total lack of discrimination in its vicious attack on the organization as a whole.

I also believe that it was deliberately deceptive in its attempt to equate the report of the Committee on the Exercise of the Inalienable Rights of the Palestinian People with the Palestine National Covenant. The creation of a Palestinian entity on the West Bank and Gaza Strip (as the Report recommends) would certainly not dismember Israel. With the exception of annexed East Jerusalem, even the Israeli government does not consider those territories part of Israel—I cannot understand why you seem to consider them as such.

What continues to haunt me about your ad is that it starkly resembles the virulent right-wing attacks which have plagued the United Nations since its inception. Not only was your attack distortive but it even alleges that the United Nations is "dominated by a Soviet-Arab axis". I believe such a charge cannot be substantiated and was most probably included to appeal to the same elements in United States society which have proven susceptible to similar attacks in the past. I have enclosed for your reflection a fact sheet published in 1967 by the Anti-Defamation League. Our office has distributed numerous copies of this item and we continue to believe in its basic assumptions. Perhaps the Conference of Presidents should take a hard look at those forces whose goals are also served by the publication of such an advertisement.

The United Methodist Church has joined with many of your member organizations in past struggles: those against anti-Semitism and other forms of discrimination, the struggle to end the Vietnam War, and the defense of the United Nations against the attacks of the radical right. It is truly unfortunate that in the last case it appears you may have changed sides.

## U.N. — A Major Radical Right Target

A cornerstone of the propaganda line of the Radical Right in the United States is an intense and persistent hatred for the United Nations and all its works. Agencies created under the U.N. Charter are looked upon as instruments designed to undermine American sovereignty and independence.

Some of the choicest invectives hurled by the Far Right are directed at the world organization and its specialized agencies. The most frequently heard anti-U.N. slogan of such extremists—popularized principally although not exclusively by The John Birch Society—is: "Get the U.S. out of the U.N. and the U.N. out of the U.S."

The opposition of rightist extremists to the United Nations is nothing new. From its inception in 1945, the U.N. and its member agencies, especially UNICEF, UNESCO and the World Health Organization, have been targets of a sustained attack by extremists. The anti-U.N. fight was initially carried on by ultra-conservatives, isolationists and ultra-nationalists, including some racists and anti-Semites of long standing notoriety.

Today, the battle is being carried forward by the Radical Right, under the aegis of organizations such as The John Birch Society, Life Line, The Dan Smoot Report, Christian Crusade, The 20th Century Reformation Hour, The Independent American and "Let Freedom Ring." Here is what spokesmen for some of these organizations have to say about the U.N.:

• "The United Nations was designed to be, and has become, the most important single instrumentality of the Communists for taking over the remainder of the free world, and especially the United States." So says John Birch Society Founder Robert Welch in his organization's *Bulletin*.

- "The United Nations Organization was conceived in conspiracy, and dedicated to the proposition that all men should be leveled to the equal status of subjects of a world order." So says Life Line founder-sponsor H. L. Hunt in his book Fabians Fight Freedom.
- "The UN is an international socialist conspiracy whose aim is to produce a socialist one-world." So says commentator-writer Dan Smoot in his publication The Dan Smoot Report.
- "Since its inception, the United Nations has been a major propaganda forum for the Kremlin conspiracy and a nesting place for its spies and saboteurs." So says Billy James Hargis of the Christian Crusade in his pamphlet The United Nations: Destroying America by Degrees.
- "... U.S. taxpayers are being forced... to pay for the financing of the Soviet-dominated United Nations, whose principal aim is the destruction of the national sovereignty of the United States." So says the Independent American's "Tax Fax" pamphlet headlined "US Foots Bill for United Nations."
- "The Almighty God will not bless atheistic Communism and the United Nations with these Communists in it, as the Communists subvert every agency of the UN for their world revolution and use the veto to prevent peace." So says Carl McIntire of the 20th Century Reformation Hour in his Christian Beacon.

#### JBS In The Forefront

The John Birch Society, whose headquarters is in Belmont, Massachusetts, and whose membership is nationwide, has been the main Radical Rightist organization in the United States attacking the U.N. Under the leadership of Robert Welch, the Society has mounted an extensive and ongoing campaign against the United Nations and its agencies. The chief JBS anti-U.N. propaganda slogan has recently been simplified to "Get US out!"

Informing the American people of the purported truth about the United Nations has long been one of the major propaganda undertakings of The John Birch Society. But the "plain unvarnished truth" about the world organization as Robert Welch sees it is a series of dogmatic charges: "The U.N. was conceived by Communists. The U.N. was created by Communists. The U.N. is controlled by Communists (and) the U.N. has constantly furthered the objectives of Communism."

Welch has gone even further, charging that the United Nations is "simply an instrumentality established by the Communists as part of their strategy for imposing Communist rule on the total population of the earth." He added that "the whole thing is a carefully stage-managed show, moving with patient gradualism along predetermined lines towards the tragic climax of worldwide tyranny."

#### **Establishing TRAIN Committees**

Because some of the Society's more effective efforts to influence public opinion have been achieved through the workings of "ad hoc" committees—front groups—Welch has urged Birchers to form local or regional anti-U.N. committees To Restore American Independence Now (TRAIN). Such TRAIN committees have been established in a number of communities.

Some local TRAIN committees have distributed an anti-U.N. pamphlet headed "Let's Quit Kidding Ourselves About the United Nations!" which asserts that the U.N. is "a Communist Tool for Conquering the United States Without Firing a Single Shot." Others have presented a propaganda film entitled U.N.—Unmasked. Launched during 1966, the TRAIN groups were beginning to become active early in 1967, but had not yet

made any significant impact on the American scene.

Nevertheless, Welch has high expectations that these committees will become an important part of the Society's campaign to bring about an American withdrawal from the U.N. If the TRAIN committees prove to be anything like the Society's anti-Civil Rights TACT committees (Truth About Civil Turmoil), they will undoubtedly be an active and divisive force in many communities.

#### The Fearful Master

Welch has stated that "There are more Communists in the United Nations building in New York than there are in the Kremlin." He has also charged that "Most of the Communist control of the United Nations is through Moscow's new African and Asian puppets." Welch sarcastically added that these countries might average perhaps twenty bath tubs per nation but nevertheless have a vote in the U.N. equal to that of the United States.

In line with the views of the Society's founder, John H. Rousselot, JBS Public Relations Director until Spring, 1967, said that "The UN was originally designed and planned by key Communist sympathizers, and today the organization is controlled and administered by the Communists." When Rousselot said this in a speech at a Birch-dominated rally for God and Country, G. Edward Griffin, a JBS official from California who is director of the Society's audio-visual department, was heard to comment: "He's read my book."

Griffin's book The Fearful Master, has been and continues to be one of the Birch Society's chief weapons in the propaganda assault on the U.N. In it, Griffin com-

pares Americans to suicidal lemmings.

Griffin charges that in supporting the U.N., the United States has "abandoned the secure ground of national strength and independence to leap into the boiling waters of internationalism." He views the U.N. itself as a nest of spies and Communist murderers. He adds that loyalty to the U.N. is designed to supplant loyalty to the U.S. and that the loyalty eventually demanded will be to world Communism.

All these facts, Griffin concludes, are kept hidden from the American people.

#### Anti-U.N. Materials

The most recent anti-U.N. propaganda produced by the Birch Society is a 29-minute film strip on the world organization that was directed by Rousselot and narrated by Griffin. This film strip, said by Welch to expose the background, history, purposes and "real truth" about the U.N., has been recommended for use by the Society's TRAIN committees and for showing to service clubs and similar audiences. The film strip is obtainable from the Birch Society. The Griffin narration is also available on either tape recording or a long-play record.

Other anti-U.N. materials of the Society include postcards, which picture the U.N. headquarters labeled "The House That Hiss Built" and contains a "message" about alleged atrocities in Katanga; stickers of various sizes bearing the slogan "The U.N.—Get US Out," which are available for envelopes or auto bumpers; and a special \$2 packet of propaganda which includes, among other things, the Griffin book and a purported expose of the World Health Organization (WHO) by the late J. B. Matthews.

A recently-compiled JBS packet for "Politicians and other Patriotic and Public Spirited Citizens" offers two books on the subject of the United Nations. The first is Griffin's The Fearful Master and the other, 46 Angry Men, is a report prepared by civilian doctors of Elizabeth-ville. According to the Birch Society it contains "a documented, illustrated survey of the atrocities allegedly committed by United Nations troops during the 1961 attack on Katanga." These were committed, according to Welch, in order to subjugate the peaceful and prosperous province of Katanga to the central Communist government of the Congo.

Welch stated in his introduction to the American

Opinion reprint of 46 Angry Men:

"There are still millions of honorable people, even otherwise well informed people, throughout the world who believe—as these forty-six doctors believed a year ago—that there is some good in the United Nations. We ourselves believe that it is simply an instrumentality in the International Communist Conspiracy's plan of global conquest.

"We believe that today the United Nations organization is almost completely controlled by the Communists; and that those who infest the upended ant box on the East River are just as cruel, murderous, ruthless, and rotten as are their counterparts in other instrumentalities of Soviet power and propaganda, wherever found."

#### Opposition To UNICEF

In addition to the distribution of anti-U.N. materials, Birch Society members are called on to protest the annual observance in various American cities of October 24 as "United Nations Day," and to oppose and refute U.N. propaganda at all opportunities. One special target has been the United Nations International Childrens Emergency Fund (UNICEF) and activities by Americans in support of it.

UNICEF was created by the United Nations in 1946 as an emergency organization to feed and clothe warravaged children, mostly in Europe. The agency is now engaged in more than 500 projects in 119 countries and territories that have sought its help. In many of these nations, private groups help raise funds for UNICEF's work, which is also supported by voluntary contributions from governments. The United States Committee for UNICEF, a private group, has contributed more than \$2,500,000 annually from its Trick-or-Treat program which began when a church in Philadelphia sent the group \$17 its Sunday school children had collected on

Halloween "for needier children."
Naturally, Birchers have condemned the yearly Trick-

or-Treat collection which many American children make for UNICEF. In Needham, Mass., on Halloween, 1965, a local Bircher gave some children who rang the doorbell boxes of candy with a telephone number on a sticker affixed to the boxes. The number was for the local "Let Freedom Ring" Radical Right telephone message propaganda operation. Those who dialed the number heard an attack on UNICEF and a plug for the JBS book on the U.N. by G. Edward Griffin.

In condemning the Radical Rightists, the local newspaper, the Needham Chronicle, said editorially that "Far from what the talker would have the listener believe, UNICEF is not a communist-dominated organization, but an international humanitarian group . . .

recipient of the Nobel Peace Prize."

(In 1965, UNICEF received the Nobel Peace Prize for having helped hundreds of millions of children in more than 100 countries throughout the world—the fourth time that the coveted prize had been given to the U.N. or its officials. Others were Dr. Ralph Bunche, in 1950; the U.N. High Commission for Refugees, in 1954; and Secretary General Dag Hammarskjold, posthumously in 1961.)

#### 'Murdered by UNICEF'

The same evening in Long Beach, Calif., extremists hung effigies—one with a "Murdered by UNICEF" sign pinned to its chest—in front of the local U.N. association office, a local radio station, and in the lobby of the building housing the community newspaper. In the lobby, the extremists left a black coffin containing anti-U.N. propaganda and festooned with bumper strips which read "Give Red China our U.N. Seat," "Get U.S. out of U.N." and "Help Get U.S. out of U.N."

The Long Beach *Press-Telegram*, reported that letterheads and return addresses on some of the material indicated that they had come from the local American Opinion Library and from the Long Beach Freedom

Forum, a right wing group.

The following year, some American Opinion bookstores distributed a flyer entitled "Watch Out For The UNICEF Trick" which charged that the U.N. agency was, in fact, "A powerful propaganda agency for the worldwide Communist conspiracy and the UN effort to create one-world government." The pamphlet also claimed that through UNICEF Halloween Trick-or-Treat programs and also sale of UNICEF Christmas cards, Americans were being tricked into sending "our enemies" millions of dollars.

Birchers have protested the display and sale of UNI-CEF Christmas cards. They have also engaged in other hijinks. In December, 1964, for example, officials of two banks and a department store in Pacific Grove, Calif., reported that threats of picketing by JBS members forced them to discontinue sale of UNICEF Christmas cards. A local Birch Society leader denied the threats but acknowledged that he had complained about the sale of the cards whose receipts, he asserted, go in part to Commu-

nist countries.

In Michigan a group of Birchers flew over the stadium at the 1964 Michigan-Minnesota football game in a helicopter dragging a 50-foot "Get US Out" trailer. And in California, members of a Birch chapter painted a huge "Help Get U.S. Out Of The U.N." sign on the roof of a factory in line with the approach pattern used by airplanes enroute to the Los Angeles Airport.

Summing up their hatred for the United Nations, one

New England Bircher said in a letter-to-the-editor of a

local newspaper:

"Although Christians are persecuted all over the world, the United Nations never has taken any action to prevent it. The godless United Nations was originally designed, and is today intended to be, government by the Communists, of the Communists, for the Communists. It is certainly a part of the hope of all true Christians that it shall perish from the earth."

#### Letter Writing Campaigns

The Birch Society's national anti-U.N. campaign has included several massive letter-writing efforts. In the November, 1964, Birch Bulletin, Welch asked members to bombard Mrs. Norman Chandler, the late Walt Disney, and other directors of the newly established Los Angeles Music Center with mail protesting a decision to fly the U.N. flag over the project. The flag did not fly, and Welch claimed a victory.

In 1964, the Birch Society declared war on the Xerox Corporation because the company announced sponsorship of a projected series of television specials dramatizing the work of various U.N. agencies. Welch urged JBS members to send "a veritable flood" of letters to the

company protesting its decision.

Even before the first program reached the television screen, Xerox had received 29,500 pieces of adverse mail. A tabulation made by the company revealed, however, that the 29,500 letters had been sent by only 6,000 individuals! In the six month period that followed, during which time Welch wrote several reminders to his membership, the company received another 15,700 adverse letters, which were analyzed as having come from only 5,500 individuals. During the same period, Xerox received a total of 11,600 favorable letters from about 11,600 individuals.

Xerox Corporation went ahead with its sponsorship of the programs and refused to be intimidated. This, as the Gloucester (Mass.) *Times* editorially noted, despite the fact that "such an avalanche of letters would have scared many small businesses right out of their profit

minded wits."

#### Vietnam Betrayal

Welch has also called on members to support a bill, introduced by Congressman James B. Utt (R., Calif.), which provides for United States withdrawal from the U.N. He has sought to flood members of the House Foreign Affairs Committee with "a million letters."

The Birch Society's present anti-U.N. ploy indirectly relates to the war in Vietnam. Welch has charged that the Vietnam war is "a betrayal" because it is being conducted by the U.S. under treaty committments to the SEATO (Southeast Asia Treaty Organization), with everything ultimately under the control of the United Nations. He has asserted that SEATO is required to "report" its activities to the U.N.'s Undersecretary for Political and Security Council Affairs. And, Welch told his members, that post "has always been held by a Communist"—a standard Radical Right propaganda theme.

Thus, as Welch sees it, "We are sending our men to fight in a war against the Communists, which . . . is actually being run by the Communists." The Vietnam war, he therefore concludes, "is an exact repetition of

the Korean war."

#### Hunt's Life Line Foundation

The Life Line Foundation is not a membership organization and does not engage in projects as does the Birch Society, but it is possibly just as effective in spreading the Far Rightist anti-U.N. propaganda line via its Life Line broadcasts heard on some 400 radio stations

throughout the country.

The founder and chief supporter of the Life Line Foundation is Texas oil multi-millionaire H. L. Hunt. Life Line is devoted essentially to spreading Hunt's own personal propaganda line. And the thrust of Hunt's propaganda operations is essentially the same as other Radical Rightist propaganda. Life Line not only conducts its radio broadcasts but publishes transcripts of its programs, a thrice-weekly publication Life Lines, and various books.

In one such book, Fabians Fight Freedom, Hunt asserts that from its inception the U.N. was meant to promote the cause of world socialism, an objective of the Soviet Union. Hunt also states that the U.N., while not preventing the Communist enslavement of a single person, has through its Charter completely hobbled the forces of freedom in favor of Communism. "Liberty," concludes Hunt, "is not the aim or objective of the UN!" and thus he deplores continued U.S. participation in the world organization.

#### Some Propaganda Themes

Life Line views the United Nations as having been planned by the Soviets "to suit their future plans" and says it is being used by them "as an instrument by which they intend to rule the world." Month after month Life Line radio commentator Melvin Munn broadcasts canards about the U.N. which have long abounded in Far Rightist circles. Headlines on the Life Line broadcast transcripts—Munnscripts, as they are called—give the anti-U.N. flavor of many of the messages: "The U.N.—A Trap"; "U.N.—World Spy Headquarters"; "The U.N. Almost Bankrupt"; "No Peace In The U.N." and "UNESCO And Classroom Propaganda."

Life Line broadcasts and printed material have also condemned the United Nations as a collection of "blocs" playing power politics, and unable to end threats of war or keep the peace. The vast majority of new, emerging, nations that have attained U.N. membership are viewed as "puppets" of the Soviet Union and/or Communist China. Or they are seen as members of a "blackmailing" neutralist bloc which accepts U.S. aid but nevertheless

votes with the Communists on crucial issues.

The whole ideology and operating technique of the U.N. is branded by Life Line as "Marxist." Atheism, it is said, flourishes in U.N. councils and conferences. The U.N. is viewed by Life Line as a Soviet base of operation for spying on the United States, as a center for worldwide spy activities, and as a haven for anti-American propaganda.

Specialized agencies of the U.N. have also been condemned by Life Line. One target is UNESCO which, Life Line charges, maintains a staff of "Marxist ideologues" who launch attack after attack on the United States. U.N. technical assistance programs are denounced as instruments using American money to finance and develop "a collectivist, one-world state." Life Line, in addition, raises to the status of "fact" the false but frequently reiterated charge that Alger Hiss and former Soviet Foreign Minister Molotov worked out a secret agreement whereby the U.N. military staff would always be headed by a Communist. To support this contention, Life Line erroneously tells its listeners and readers eight men have held that post, and that seven of them have been Russians and one was a Yugoslav.

In short, Life Line believes that "The votes are stacked, and the free world will not win in the U.N."

#### Peace League Proposal

Unlike most Far Rightist opponents of the United Nations, whose thoughts seldom range beyond repetition of "Get the U.S. out of the U.N." slogans, Life Line, and H. L. Hunt in particular, have proposed an alternative to the U.N. The plan, outlined in Hunt's book Fabians Fight Freedom, and in various Life Line transcripts and publications, calls for the establishment of a so-called "Peace League."

Hunt's Peace League proposal is said to have been initially blueprinted and shared with a number of world leaders toward the end of World War II. The plan was formulated by Hunt despite his belief that it was "not desirable or feasible" for the United States to participate in a world organization. Hunt has conceded that his proposal was put forward only because he realized that such a world organization "would probably be formed."

The Peace League, as envisioned by Hunt, would enforce treaties ending existing wars and prevent future wars. It would function through establishment of an Assembly and an Arbitration Council. Each nation's control and responsibility in the proposed League was to be determined on a percentage basis by such factors as its contribution to repelling "the forces of oppression" in World Wars I and II, population, standard of education and "state of enlightenment," record of non-aggression, "wholesome commerce," assets and the extent and nature of its area.

As the initial percentage of participation in the League among world powers, Hunt suggested 25 per cent each for the United States, the British Commonwealth of Nations, and the Soviet Union. He also suggested that France receive a four per cent share of participation, and that Brazil and Nationalist China each receive three per cent. The remaining 15 per cent was to be divided among other "free nations."

Hunt's plan sought to "protect the interests of Western nations," as he saw it, by insuring that a country like the United States would not have to pay an inordinate share of the world organization's costs while possibly having little more to say about its uses than the smallest financial contributor. Thus, Hunt's and Life Line's reason for promoting the Peace League becomes evident.

In their own words: "Those who think that there is no alternative to our present disadvantageous participation in the United Nations are mistaken. There is always an alternative, and usually a more desirable one, when conscientious men, keeping their nation's interests foremost in their minds, apply the rules of logic to the problems at hand."

#### Dan Smoot On The U.N.

Texas-based Radical Rightist commentator and publisher Dan Smoot, like H. L. Hunt and Life Line, puts great faith in radio broadcasting, printed transcripts of his programs and in books to get his message to the public. This is no accident. Smoot served for almost four years as radio commentator of Facts Forum, Hunt's defunct political propaganda operation to which Life Line is a successor.

Smoot's broadcasts are heard weekly over some one hundred radio and television stations, primarily in the Western part of the United States, by an audience that has been estimated in the millions. Some 30,000 Americans subscribe to his newsletter. Smoot, whose propaganda hews to the standard Radical Rightist line, also is in great demand as a public speaker.

In a 1962 book, *The Invisible Government*, Smoot identified the forces supposedly communizing America. In a chapter headed "United Nations And World Gov-

ernment Propaganda," he wrote:

"The fact is that every step the United States takes toward political and economic entanglements with the rest of the world is a step toward realization of the end objective of communism: creating a one-world socialist political and economic system in which we will be one

of the subjugated provinces."

The "Invisible Government" to which Smoot refers in his book is the eminently respectable Council on Foreign Relations, a private organization devoted to studying the international aspects of American political, economic and strategic policy problems. The CFR also engages in research projects with the help and advice of study groups comprised of statesmen, business leaders and academic experts. Although the CFR includes some of the nation's most respected leaders, Smoot and other Far Rightists have repeatedly charged that it is seeking to convert the United States into a Socialist state, and then to make it a part of a one-world Communist system.

#### Support Of Race Hatred Alleged

Smoot has condemned most aspects of United Nations activity. He has scored the organization's "peace record"; charged that the U.N. lied about its operations in the Congo; attacked UNESCO for allegedly publishing "Soviet propaganda"; and opposed the Genocide Convention, calling for its defeat and the defeat of all other

proposed U.N. human rights conventions.

He has also concentrated his attack on the world organization's activities in Africa, accusing the United Nations, and the United States, of supporting a "communist campaign of race hatred in Africa." He has charged the U.N. with propagating race wars and race hatreds by fostering a racist concept of colored supremacy, by inflaming primitive colored peoples to savage hatred of white men, and by encouraging and supporting them

in atrocities "loathsome to contemplate." Smoot has stated:

"The United Nations praises and aids the butchery under the pretense that it is a wholesome expression of yearning for national independence, (and) United States officialdom finances the UN-communist operation with our money and gives it the moral support of our nation."

Smoot has also decried U.S. criticism and censure in the U.N. of the Republic of South Africa. He has said that "the only nation in Africa which we consistently vote against in the United Nations is the only white Christian nation on that unhappy continent—the Republic of South Africa, an outpost of white civilization hemmed in by about 15 million blacks, most of them living in a state of semi-savagery." In studied disbelief, he adds, "we insult and condemn the white South Africans, and support the blacks."

#### Calls For Withdrawal From The U.N.

Smoot's solution to the problems in Africa appears self-evident in view of his antipathy to the U.N. "By getting out of the UN and refusing to pay its bills," he has said, "we would render a great service to Africa: neither the communists nor the Afro-Asian nations would, or could, pay for the UN operations now dragging Africa backward to cannibalism, under communist control."

The subject of money—U.S. taxpayers' money—has been used by Smoot as a focal point for much of his criticism. In issues of his publication containing such headlines as "The Tragedy Of U.S. Membership In The United Nations," "The UN Frankenstein" and the "United Nations: A Soviet Apparatus," Smoot has charged that the United States pays most of the bills of the U.N., has only one vote in 115 in deciding how its money is used, and that in addition, a majority of U.N. members are "openly hostile" to the U.S.

Smoot has also attacked the United Nations Special Fund as another device that forces American taxpayers to "subsidize socialist and communist dictators all over the world." (Actually, the Special Fund makes grants to low-income countries for projects aimed at making outside investment feasible or more effective. The Fund is financed by voluntary contributions from member

nations of the U.N.)

As Smoot sees it, therefore, the United Nations is controlled by enemies of the United States and American withdrawal from the U.N. would, therefore, constitute "a severe blow to the world-wide communist movement, and a tremendous boost to the cause of freedom." As a result, he has called upon his followers to "work relentlessly" to get the United States out of the United Nations, and has urged them to support legislation such as the Utt Bill which aims at that goal.

#### Hargis' Christian Crusade

Billy James Hargis, leader of the Tulsa-based Christian Crusade and one of the most zealous and energetic propagandists on the Radical Right, has long been an outspoken opponent of the United Nations and its agencies. Hargis' attacks on the world organization have been widely disseminated via his radio programs, news-

paper columns, magazine articles, tracts, pamphlets and books.

In a November, 1963, speech in Texas, Hargis attacked the U.N. as "that traitorous outfit in New York City." More recently, in an article entitled No Room In The Inn—or in the U.N. he wrote: "We slapped Christ in the face at the setting up of the United Nations in San Francisco in April, 1945, just as surely as the Jews slapped Him on the night of His betrayal 2,000 years ago. We gave in to Communist pressures and agreed to make no mention of Jesus Christ, or God, the Father, in United Nations Chambers. From the beginning, there has been no room for Him in the U.N."

Hargis has also been a leading opponent of UNICEF and its Halloween-time activity. He has called this undertaking a "Trojan horse" and said that by such "trick-andtreat" activities American children "will become tools of the world internationalists now and ultimately become the slaves of the Communist dictators of the future."

In a Christian Crusade publication entitled "The United Nations: Destroying America by Degrees," which contains captions such as "The U.N. Masterminded by Traitors," "U.N. Is Boosted By Communists," and "Subversives In U.N. Posts," Hargis has painted a picture of the U.N. as a threat to the sovereignty of the United States. He has said that the U.N. is an organization conceived by Kremlin planning and used by them as a propaganda forum and as a site for anti-American spies and saboteurs.

#### Anti-UNESCO

The headline on another Crusade publication screamed: "The Snake in Our Schoolroom: UNESCO: We Put It There!" In it, Hargis accused UNESCO of financing and recommending "lying communist propaganda" and decried the use of American taxpayers' money to spread such "Red propaganda" and to promote UNESCO's purportedly "questionable activities."

Hargis has stated that "the communists are working

Hargis has stated that "the communists are working diligently through UNESCO to further their world-wide revolution to enslave mankind." Therefore, he concluded, "continued blind adherence to UNESCO and other communist-polluted international organizations can only move the American people closer and closer to the brink of communist enslavement."

#### 'Tower of Babel'

Christian Crusade, the organization's monthly publication, has published attacks on the U.N. by other Far Rightists. One issue, for example, contained an anti-U.N. article by former Major-General Edwin A. Walker entitled "A Lesson In Sell-out . . . The Art of Artifice." Walker, a hero to many Radical Rightists, charged that "The UN is a communist organized—communist controlled—U.S. supported 'Tower of Babel,' operating on U.S. soil."

Hargis' publications are usually replete with ads for tracts, books, records and tapes available to readers—at a price. Christian Crusade has offered Griffin's book, The Fearful Master which, the publication trumpeted, reveals "the double standard which guides the U.N. and its quest for world domination."

During 1966, Christian Crusade also promoted a phonograph recording by Hargis entitled "The United Nations Hoax" which was offered at "only \$4.95." The recording purported to "prove" that the U.N. "is a Soviet-controlled predatory monster—housed, clothed and fed by those it plans to consume . . . the American people."

In an accompanying promotional spiel by the late Matt Cvetic, the U.N. was described as "an instrument of international deception, founded on fraud and functioning on a charter written by Soviet agents."

Christian Crusade has also offered for sale an anti-U.N. book by Bryton Barron and W. Jefferson Davis entitled Dream Becomes A Nightmare: The U.N. Today—.

#### McIntire and the 20th Century Reformation Hour

Rev. Carl McIntire, Radical Rightist leader of the 20th Century Reformation Hour, whose radio programs are aired over some 600 stations throughout the country and internationally, has long been critical of the United Nations and especially of UNICEF. He has warned his adherents to guard against the "terrific emotional appeal" of solicitations "in the name of suffering children," which are, he alleges, only a cover-up for some insidious Red Plot.

In a March, 1967, Christian Beacon article captioned "The UN Is Dead," McIntire said: "The UN has been the instrument for the steady advancement of the enemies of freedom. The world can now see that the Communists have been active in every department and in every agency and in every decision for the cause of world socialism. Moreover, men of reason and truth can no longer have confidence in the organization. It has ceased to be even a debating society. An African-Asian bloc has taken control. Its buildings of glass and gold and its spacious chambers of elegance for the elite have become hollow showrooms of failure."

He added: "The United Nations has been tried and found wanting. And the finest authority for the repudiation of the United Nations itself is none other than the testimony of its own Secretary General in his official speech on the State of the World." McIntire concluded that peace today is being maintained only by "the military might of the United States of America."

Every year since 1962 McIntire has published tracts opposing UNICEF. They have borne titles such as The Communists in UNICEF; Co-operation With Communists in UNICEF; The Place of Communists in UNICEF; How UNICEF Helps the Communist Cause and Covering Up the Communists in UNICEF.

#### 'UNICEF Trick . . . '

An article in McIntire's Christian Beacon, publication of the 20th Century Reformation Hour, bearing the headline "UNICEF Trick: The Spy Treatment," had this to say:

"Although the sponsors of UNICEF make a great hue and cry about feeding starving children—which no doubt UNICEF does—we are supposed to forget about the fact that in supporting UNICEF in Communist countries, we are constructively supporting a police apparatus bent on world domination. For whenever a Communist doles out milk paid for by the pennies of American children, he sees to it that Communist aims of propaganda are served thereby."

The article also charged that "We are also supporting an international network of double agents who use the phony humanitarian facade to gull the bleeding hearts of the world. The treat may make good propaganda, but the trick is that our children are made to support the spy from UNICEF."

McIntire has said that "Trick-or-Treat collections on Halloween by our children for UNICEF and the selling of UNICEF Christmas cards is part of a worldwide activity in co-operation with the Communists in which the Communists get unmerited recognition as worthy 'humanitarians'.

He concluded: "Do not support nor allow our children to be used by UNICEF."

#### ACCC's Resolution

A resolution denouncing UNICEF was adopted at the 1966 convention of the American Council of Christian Churches-an organization founded by McIntire. The ACCC charged that most of the UNICEF money received

by Communist governments "does not go to the children as they claim it does, but rather is used by these governments to further the worldwide Communist conspiracy." The Council urged instead support of the International Christian Relief as "the proper outlet for the benevolent giving to the poor and needy of the free world.'

International Christian Relief, whose pamphlet entitled "You Do Have A Choice" asserts that "the present program of UNICEF as it is now being operated should be rejected by all Bible-believing Christians and freedomloving Americans," is yet another affiliate of McIntire's complex of organizations and operations.

#### Kent and Phoebe Courtney

Kent and Phoehe Courtney, now separated, were for a decade a New Orleans-based husband and wife team who were among the most prolific propagandists on the Far Right and expressed great pride in being classified as Far Rightists. Now carrying on the battle separately, the Courtneys have proclaimed many of the standard anti-U.N. propaganda themes of the Radical Right through the Conservative Society of America, through radio broadcasts, and through their "Independent American" periodicals and publications.

The Independent American, a garish newspaper published every two months and loaded with reprinted material from Far Right sources, has long been edited by Phoebe Courtney and has frequently published attacks on the U.N. But the Courtneys have not merely confined themselves to quoting others. One of their early "Tax Fax" pamphlets, which continues to circulate, charged that the aim of the United Nations is the destruction of the national sovereignty of the United States. And, it added, in seeming disbelief, "the United States actually finances the operations of the United Nations."

The Courtneys have urged their readers not to support UNICEF. They claim that "when UNICEF money is sent to a Communist country . . . the money is distributed by Communist officials for Communist objectives." In addition, The Independent American reproduced an article describing UNICEF as "nothing more or less than a purchasing agency of the United Nations in spite of the hard-sell propaganda which paid propagandists root into the emotional connotations of the word 'children'."

The Courtneys have also expressed support for Representative James B. Utt's bill to have the United States withdraw from the United Nations.

A current tactic of Far Rightists to intensify local harrassment of the U.N. and its activities has been proposed and widely promoted by retired Army Major Arch E. Roberts, ex-aide to former Maj.-Gen. Edwin Walker. Roberts' mission, which in the past has been promoted under the aegis of an organization called the Council of 1776, has been to mobilize opposition to the alleged "United Nations Tyranny."

Summarized in his anti-U.N. book, Victory Denied, Roberts' scheme calls for local pressure on each state legislature to establish a committee to inquire into whether governmental powers have been delegated to the U.N. The next step would be to determine what authority exists for such a delegation of powers, if indeed any powers have been so delegated. If no authority is found to exist, Roberts' plan calls for the enactment of a state statute which would declare the pre-supposed "powertransfer" invalid and the U.N. "treaty" void and unenforceable. Finally, such a proposed state statute would make any pro-U.N. activities within the state a felony punishable by fine, or imprisonment, or both.

#### Public Appearances

Roberts has traveled from state to state promoting his scheme. He has appeared before legislative groups, local organizations and clubs. In December, 1966, he addressed a joint session of the Mississippi State Legislature. Earlier in 1966, he appeared before the Massachusetts Legislature's Committee on Constitutional Law.

Roberts' plan did not pass unnoticed and unreported by The Independent American. In its July-August, 1966, issue, the publication reprinted a review favorable to Roberts' book. In describing the U.N. as "the source of oppressive laws, that camouflaged as American laws are infiltrating levels of government in the U.S.A. at an alarming pace," the book review detailed the steps—in the form of draft legislation ready for introduction into state legislatures - proposed by Roberts (Americans) from global U.N. domination."

The Roberts plan is obviously a difficult and tortuous maneuver to implement successfully in each of the 50 states to discredit and hamper local activities in support of the U.N. But there seems no limit to the lengths to which Radical Rightists will go to destroy the world

organization.

#### Conclusion

In an April, 1966, speech in Atlanta, Ga., Joseph J. Sisco, Assistant Secretary for International Organization Affairs of the U.S. State Department declared that "polls show that the American people strongly support the U.N.: 80 percent believe the U.N. important and want the U.S. Government to 'use it more'." Some four years earlier, Gallup polls published in February, 1962, indicated that 83% of the American public felt that it was "very important" that the United States "try to make the United Nations a success."

In the same Gallup poll, the public was asked whether it felt "the United States should give up its membership in the United Nations, or not." An overwhelming majority—90%—said that the U.S. should not quit the U.N., while 5% expressed no opinion. The remaining 5% said that the United States should give up its U.N. membership.

The 5% opposing U.S. membership in the U.N. means roughly 5,000,000 adult Americans or roughly 3,000,000 voters. What portion of them had been persuaded to their position by Radical Rightist propaganda is an in-

teresting-but unanswerable-question.

The Far Right's recent efforts to bring about a reduction in United States support for the work of the U.N. has apparently been exposed to the vast majority of Americans for what it is—a misguided if not insidious attempt to destroy an organization whose aim includes the removal of the seeds of world tension and future conflicts. Nevertheless, Radical Right spokesmen continue to publish and broadcast torrents of anti-U.N. propaganda. In the face of such invective and denunciation, there is no way of measuring the inroads the Radical Right is making in discrediting the United Nations in the eyes of the American public.

#### 'A Planetary Spirit'

Constructive criticism of the U.N. must be expected. Supporters of the U.N. recognize that the world organization has its imperfections. Coupled with the fact that cold war skirmishes may occasionally evolve to the disadvantage of the United States, these imperfections could cause larger numbers of Americans to share some of the fears and frustrations about the U.N. held by the extremists. Writing of the need for the United Nations, Israel's Abba Eban said in an article which appeared in LOOK magazine:

"With all its imperfections, the UN is the only incarnation of a planetary spirit. It alone presents a vision of man in his organic unity. It does not escape into a vague universalism by ignoring the claims of nationality . . . If the United Nations has not fulfilled man's hopes, it is largely because the immediate parochial concerns of nations have won priority over universal concerns that, though they appear to be 'long-term' and lacking in urgency, will ultimately determine humanity's future." The late Adlai Stevenson, for almost five years United States Representative to the U.N., also candidly conceded that the world organization had not been "an unqualified success."

"But where failures exist," he said, "they have been ones not of the organization itself, but of the members, who have disregarded both the spirit and the intent of the U.N. charter.

The flaws," he continued, "are but the growing pains of a young organization composed of men of sharply differing views, cultures, histories and national interests. The U.N. is a realistic reflection of the division of the world. And in a divided world," he concluded, "the miracle is that it has survived and been so effective."

#### Praised by Pope and President

Arthur Goldberg, Mr. Stevenson's successor as U.S. Representative to the U.N., summed up the situation in an April, 1966, speech before the National Press Club. He said: "We attach great importance to the work of this body (the U.N.). The capacity of the United Nations to help in keeping the peace must not be weakened, it must be made stronger, and the United States will join wholeheartedly with those . . . who work to make it stronger."

In an October, 1965, address to the United Nations General Assembly, the first ever delivered by a Pontiff before the international organization, Pope Paul VI eloquently praised the United Nations as "the world's great-

est hope" for an ultimate end to war.

The Pope said: "The peoples of the earth turn to the United Nations as the last hope of concord and peace; we presume to present here, with their tribute of honor and of hope, our own tribute also." He added:

"You exist and operate to unite the nations, to bind states together . . . to bring the ones together with the others. You are an association. You are a bridge between peoples. You are a network of relations between states. We would almost say that your chief characteristic is a reflection, as it were, in the temporal field, of what our Catholic Church aspires to be in the spiritual field: unique and universal . . . Your vocation is to make brothers not only of some, but of all peoples . . . Is there any one who does not see the necessity of coming thus progressively to the establishment of a world authority, able to act efficaciously on the juridical and political levels?"

In proclaiming October 24, 1966, as United Nations Day, President Lyndon Johnson declared: "The U.N. has been effective in containing local disputes which, if unchecked, could have led to general war. It has assisted scores of nations in meeting the challenges of the technological revolution. Above all, the U.N. has proved to be a place where constructive dialogues between rich and poor nations can lead to better understanding in today's world, and the promise of a fuller life for future generations."

## The U.N.—Fact and Fiction

A compilation of typical charges employed by the Radical Right in its campaign against the United Nations and member agencies—and comments on those charges—follow.

The Charge: The U.N. was organized as part of a Communist plot for world conquest.

Comment: The stated basis for this charge is that Alger Hiss, acting as a Communist agent, secretly drafted the U.N. Charter as part of the "Red scheme." In fact, however, the first U.S. working draft of the U.N. Charter was written by a distinguished committee of Americans chaired by the late Undersecretary of State Sumner Welles. Alger Hiss, as secretary of the conference, dealt only with organizational and housekeeping problems. He was not a member of the U.S. delegation and did not have a vote on any question before the July, 1945, San Francisco conference where the Charter was finally drafted.

The Charge: The U.N. is an instrument for the establishment of a World Government.

Comment: The United Nations was never intended to be a super state. Nor was it given any attributes of state-hood—it has no power to conscript soldiers, levy a tax, or enforce a decision over the veto of a permanent member of the Security Council such as the United States. It was—and is—an organization whose members are sovereign states which subscribe to the principles of the U.N. Charter.

The Charge: The U.N. Secretariat is controlled by the Soviet Union.

Comment: The key position of the Secretary General of the U.N. has since the founding of the organization been filled by a Norwegian, Trygve Lie; a Swede, Dag Hammarskjold; and currently by a Burmese, U Thant—none of them from Communist-controlled countries. In addition, as of May, 1964, there were a total of 1,389 professional and executive positions at the U.N. Of that total, Americans held 255 or about 18 percent of such positions and U.S.S.R. citizens held less than 6 percent. If clerical staff is counted, the proportion of Americans would be even higher.

The Charge: The United Nations is ineffective.

Comment: The U.N.'s ad hoc system of meeting crises may seem unsystematic and weak. Nevertheless, through specific actions to meet specific situations, the U.N. has helped uphold the independence of smaller nations under pressure, including Korea, Lebanon, the Congo, and Cyprus.

The Charge: The U.N. is a threat to United States sovereignty and independence.

Comment: False. The U.N. Charter specifically states that "nothing contained in the present Charter shall authorize the United Nations to intervene in matters which are essentially within the domestic jurisdiction of any state." In addition, although the member states of the U.N. can recommend police action and call upon the Secretary General to invite member nations to contribute troops for such an undertaking, the ultimate decision to send troops rests with each national government.

The Charge: The U.N. appears powerless to act against Communist interests and has been stymied by the U.S.S.R.

Comment: In some cases, such as Hungary, U.N. action has had little effect because of the non-compliance of the U.S.S.R. Nevertheless, the U.N. has taken many effective steps without the participation of the Soviet Union. This has been done in Korea, Iran, Greece, Lebanon, and in the Congo. In addition, many refugee, technical assistance and specialized agency projects have been very successful in spite of Soviet opposition.

The Charge: The U.N. is a nest for Communist spies.

Comment: An employee of the U.N. who is found to be carrying on espionage activities against the United States is subject to dismissal. This latter point is provided for in the United States' agreement with the U.N. which enumerates the conditions under which the world body functions in U.S. territory.

The Charge: The U.N. is atheistic and opposed to all religion.

Comment: In actual fact, U.N. members include representatives of all of the world's major religions, and over 30 religious organizations—representing all faiths—maintain permanent observers accredited to the U.N. But no member is required to observe any specific religious practice, or to give preference to one religion over another.

The Charge: The U.S.S.R. controls the United Nations Army.

Comment: The basis for this is the allegation that the U.N. Military Staff Committee is controlled by a Communist and therefore the Communists control the U.N. army. In fact, there is no U.N. army. Although there are special and local U.N. police forces for specific limited purposes, there is no regular U.N. police force or army. Nor is the Military Staff Committee controlled by a Communist. The Committee, which to date has remained completely inoperative, is composed of the Chiefs of Staff, or representatives, of the five permanent members of the Security Council. And the chairmanship of the group is rotated monthly among representatives of the five nations—which includes the United States.

The Charge: The post of U.N. Undersecretary for Political and Security Council Affairs has always been held by a Communist.

Comment: By custom, a representative of each of the five major world powers has been appointed to one of the major Undersecretary positions, and the Russians have usually held the position of Undersecretary for Political and Security Council Affairs. However, that office prepares materials for the Security Council and follows through on Council administrative decisions, and

all of the information passing through it is a matter of public record. The office is, in short, purely administrative in its functions.

The Charge: Many member countries fail to support the U.N. financially and thus put undue pressure and burden on the United States.

Comment: The amount of dues on the regular assessed budget of the U.N. paid by each member country is determined by the organization's General Assembly. It is based roughly on each nation's ability to pay and is re-assessed every three years. During the last such review it was determined that the maximum assessment on any member nation to the ordinary expenses of the U.N. should not exceed 30 percent of the total. In addition, the U.N. Charter provides that a member nation two years behind in its assessed dues shall lose its vote in the General Assembly, unless that body decides that the debt is "due to conditions beyond the control of the member."

The Charge: The United Nations Charter is patterned after the Soviet Constitution.

Comment: Quite the contrary is true. The U.N. Charter actually embraces most of the great principles of the United States Constitution.

The Charge: The Afro-Asian nations in the U.N. vote as a bloc and always support the Communists on cold war issues.

Comment: The African nations are largely united on issues such as colonialism, racism, and related questions. Like other members of the United Nations, they have voted in accordance with their national interests. Their voting record shows that they have not consistently voted together as a bloc. They have tended to vote independently, and have often voted with the United States on crucial issues.

The Charge: The one-nation, one-vote system works to the detriment of the United States and plays into the hands of the Soviet Union.

Comment: This assertion is not borne out by the record. In the overwhelming majority of cases over the years, it has been the Soviet Union rather than the United States that has been outvoted in the General Assembly on questions at issue between the two nations. In the Security Council, where the one-nation, one-vote principle is modified by the veto power of the five permanent members, the United States has never had to use its veto power to protect its interests, whereas the U.S.S.R. has been forced to use its veto power more than 100 times.

The Charge: UNESCO is part of the world Communist conspiracy and is promoting one-worldism.

Comment: UNESCO was created to advance education throughout the world, as well as to further a better and more tolerant understanding among nations and people. Its Charter specifically prohibits the organization from intervening in matters which are essentially within the domestic jurisdiction of its member states. As a result, UNESCO restricts itself to providing assistance only upon a direct request for such assistance from the government of the member state concerned. Nor can UNESCO dictate policy—its decisions are in the form of recommendations.

#### The Charge: UNESCO is Soviet-dominated.

Comment: UNESCO employs citizens from some 82 countries and territories, including the Soviet Union. Recent figures showed that of the top 100 posts in the organization, American citizens outnumbered Soviet citizens 3 to 1. In the past, moreover, the Soviets and their supporters have sharply criticized UNESCO, charging that it was not responsive to their interests.

The Charge: UNICEF is controlled by the Communists and Communist countries are among the principal beneficiaries of its aid.

Comment: UNICEF believes that children who are starving or ill because of lack of medicine or medical care are entitled to help regardless of the political regime under which they happen to live. The United States is in accord with and endorses this very principle. UNICEF is currently assisting over 500 long-range programs in more than 100 countries, and of these, only four countries have Communist governments. With respect to the administrative staff of UNICEF, recent figures indicated it included 679 persons who were citizens of some 65 countries. Of this number, 98 were American citizens and only 10 were from countries with Communist governments.

The Charge: UNICEF's Trick-or-Treat program is a Communist "Trojan Horse."

Comment: Through the Trick-or-Treat program for UNICEF, boys and girls in the United States express with contributions their concern for needy children in other countries. Of this endeavor, the late President John F. Kennedy said: "UNICEF has caught the imagination of our people — especially our nation's children whose Halloween collections have become a symbol of concern and an expression of tangible aid."

The Charge: UNICEF greeting cards are devoid of religious spirit.

Comment: UNICEF greeting cards are designed to reflect the ethical and spiritual values of the many peoples who make up the U.N. Their content is selected solely for its artistic merit and the art work is contributed, free, by some of the world's leading artists.

An updated and expanded revision of Report on the John Birch Society 1966 by the authors of Danger on the Right

THE RADICAL RIGHT has gained momentum and is insinuating itself into the mainstream of American life today.

Dear Mr Scranton;

Referring to yesterday's Security Council resolution, in which the United States joined, unanimously and routinly deploring Israel and reviving the obsolete stupidity declaring "invalid" the absorption of Eastern Jerusalem into Israel, I would like to make some observations.

First, I wish to congratulate you on your "great success" in softening more extreme drafts sufficiently to make possible the "honor" to join in the consensus, in violation of decency, morality and simple human dignity. It was indeed a "great" achievement.

It is characteristic of the shortsightedness of those who still advocate the bankrupt "even-handedness". They are not able to see that the timing of this conspiratory step will strengthen the extremists and undermine the road to peace.

I was also deeply touched to learn how you were unsuccessful in your attempt to attach references to well-known Security Council resolutions calling on Arabs and Israelis to negotiate peace with secure and recognized borders for all states in the area.

It is imaginable how hard you tried to get through these "innocent" references, but obviously, this failure of yours did not offend your sensibilities to the degree that you would not become a partner to this discriminatory act.

It is futile to speculate on the reasons for this ill-timed and dangerous behavior. It offers the world an outrageously misleading description of the real situation.

The insertion of Jerusalem, out of nowhere, in this artificially provoked discussion, to say the least, was irresponsible. It is hoped that no one, including the Arabs of East Jerusalem, wants the Holy City divided and strifetorn again as it was before the Six-Day War. It can also be assumed that it is difficult to imagine a permanently peaceful settlement of the Arab-Israeli conflict which would leave Israelis in exclusive control of the entire city. But it is high time to recognize reality. We all agree as to the unique character of Jerusalem, sacred to the followers of three great religions,

thus, in order to keep Jerusalem worthy of its past and see it peaceful and prosperous for the future, we should admit once and for all the fact that historically Jerusalem was, as it is today, the capital city of Israel. It was so 1879 years ago and it is so again since 1967. Men with honor and self-respect should have the guts and say this truth loud, so those who have doubts and false illusions could hear it well. This is the American way, this is the way of decency and morality and not the way of shameful submission to make the United States join in the humiliation of Israel.

Every religious place, Christian or Moslem, is intact and the Israelis have no desire, nor ambition, to administrate the holy places, either Christian or Moslem, and they are prepared to have any of these religions take care of their own places.

People say this is a city of three big religions. What happened between 1949 and 1967? the Old City was occupied by Jordan and no Jew was allowed to come into the Old City; synagogues were destroyed. Jews were not allowed to visit their holiest spot: The Western Wall; and nobody said anything. Everybody slept well. The city of three religions became a city of only two religions and the third one (Jewish) was excluded and there were no emergency sessions of the Security Council. This is called cynical hypocrisy.

Israel is ready to cooperate with any arrangement to protect the holy places. The enlightened international community applauded the behavior of Israel with respect to the holy places, characterizing it as "exemplary". What Israel is not ready to do is to share her sovereignty over her capital. From this she will not budge despite the enormous change with the emergence of oil and the petro-dollar. Jerusalem was never the capital of any Arab nation, but it was the capital of the Jewish nation with its kings and prophets. This is a reality the world ignored too long now. This ignorance will not be tolerated any longer by a united Jewish people. It would have been the duty of responsible governments to emphasize this simple fact, at long last, at this Security Council debate. Instead our Department of State, true to its policy of retreat, selected to join in a one-sided racist resolution. This happened in a time when decent people the world over will testify that the Jews cannot be accused of being insufficiently sensitive to the sanctity and beauty of Jerusalem.

This resolution, as many others before it, is a further indication that the United Nations has reached a point of utter incapacity to deal seriously and constructively with problems which confront the international world today.

America's participation in this ugly spectacle is another proof of Mr Kissinger's mistaken appearement policy to which he stubbornly and cynically is sticking to, despite, or because, he knows that the end of his influence is near.

Whatever the motivation behind the Kissinger support of the Egyptian resolution in the Security Council last week, it will heighten the suspicions and fears of Israelis who are adamant against being made a helpless pawn in the American effort for Arab favor.

Recently Secretary Kissinger testified in a closed session of a Congressional committee. He said: "Vietnam needs the United States. Friendship with the United States is crucial to their independence and sovereignty".

The Arab states do not need the United States?

To preserve their independence, to avoid being preyed by the Soviets, they clearly need friendship with these United States. The inescapable question is asked: Why does Israel have to pay for it?

We all will agree that for the United States to be on friendly terms with the Arab nations is beneficial for world peace and in the long run it is good for Israel too. Secretary Kissinger worked hard trying to achieve this. It will always be well remembered and appreciated. Where many people depart sharply is the methods used by Mr Kissinger.

The principle to appease the Arabs and make Israel pay for it was, if not invented, greatly intensified by Secretary Kissinger. The thesis that the only way to lure the Arabs for their friendship is the un-American and un-ethical way of humiliating Israel and oppressing her to a degree as to endanger her security, this thesis became a standard Kissinger approach and the Jewish people could not possibly stand for it too long.

## **OPEC Wages**War on West

By Benjamin Adelman

Economic warfare has many advantages over old-fashioned military warfare. In an economic war, you can achieve all your political aims without risking the life of a single one of your citizens or losing a dollar of your national wealth. Indeed, you can make hundreds of billions if you play your cards right. Even more delicious, you can persuade your enemy to cooperate eagerly in his own destruction while he trains your armed forces, builds up your industries, and donates enormous numbers of the latest planes, tanks, warships, and missiles. All the while, he will spread your propaganda and thank you fervently for the privileges you are bestowing on him.

Too good to be true? Read today's newspaper. The Oil Producing and Exporting Countries (OPEC) are waging a world war on the West that they don't even bother to disguise from their enemies. OPEC calls it "waging the Araboil weapon." Oil, to the Arabs, is not a commodity to be used for peaceful purposes; it is a weapon for gaining their political aims. As Clausewitz said.

every war has a political pur-

There is a catch to this game. To win an economic war, you must have something that others want—condition one; and, condition two, they must believe they can't get it elsewhere.

Consider the sad case of the Vermont maple growers as an example of condition one. Early each spring, they tap their maples for sugar and sell it to the large food firms. The companies sell it to the consumers, usually highly diluted and therefore labeled as imitation maple syrup. Some brands contain no maple syrup at all and state as much.

This spring, the ambitious maple syrup growers raised the price of pure maple syrup to \$12 a gallon—and were stuck with it. It seems that the American consumer prefers the imitation to the pure maple syrup.

Sugar illustrates condition two. The cane sugar growers of Central and South America decided that if OPEC could do it with oil they could do the same with cane sugar. In 1974, raw cane sugar soared from 15 cents to a record 65 cents a pound. Last November, representatives of all the Latin Amer-

## Public Rip-Off Or Welfare Reform? .

You couldn't miss it. The ad was right in the middle of June 8th's Parade magazine disguised as a feature. "How To Save \$120 to \$2,400 A Year By Participating in The U.S. Food Stamp Program" it was titled. The pitch was that by investing \$3.50, you could obtain a booklet that would enable you to determine whether you were one of the 15 million eligibles missing out on benefits. The lure was the picture of a not-very-needy looking woman seated at her foodladen dining room table, cheerily waving a fistful of cash at the camera.

The response was quick-the usual crescendo of letters to the Hill denouncing the food stamp program and, on June 25, the introduction of the National Food Stamp Reform Act of 1975 (H.R. 8145), supported by 59 Congressmen who wanted to end the "public rip-off" and "administrative nightmare" they saw in food stamps. The thrust of the reform is to amputate eligibility at the poserty level by redefining income to exclude any deductions (such as the ones now available for high medical bills, the expenses of child care, excessive rent and utility costs, and payroll taxes) and include in-kind payments (such as Medicaid-valued at \$297 per person per year—and school lunch—\$81 per school child per year.) The impact of this reform would be to eliminate from program rolls up to one-half of the current recipients, which is a pretty spectacular form of housecleaning.

Senator George McGovern of South Dacota, on the other hand, had spent the spring jousting with Secretary of Agriculture Earl Butz and demanding that Butz resign from office because he was operating the program illegally to the detriment of the 20 to 30 million people whose adjusted income might qualify them for food stamps at least one month of the year, but who either never heard of he program (insufficient outreach-a breach of the law as determined by a federal court in Minnesota), or couldn't alford it (a family of four with a monthly net income of \$500 has to pay \$138 for its \$162 in stamps), or were deterred by the long lines awaiting certification, or by pride

Senator McGovern's complaint about the program is that it doesn't give enough help to enough people swiftly. The Court of Appeals in the District of Columbia agreed with him, on June 13, that the benefits were not as high as they ought to be to encompass the needs

of older children and pregnant women, and the higher cost of the food for large families and families living in the Northeast. The court ordered the Department of Agriculture to remedy these deficiencies by mid-September (if the Supreme Court or Congress doesn't say no.) At the same time, many welfare advocates and labor supporters were hailing food stamps as the only universal income support providing help for the unemployed and underemployed in the depres-

Where does the truth reside? Is the program an extravagant rip-off or an insufficient pittance? Does it supply too much to too many or too little to too few? The answer that nobody really knows-especially not the Department of Agriculture. As Assistant Secretary Richard Feltner admitted to House Agriculture Committee Chairman Thomas Foley of Washington. "Participation data (i.e., how many participants are students welfare recipients, strikers, elderly, etc.) ... may be available eventually." But not now.

Food stamps, running at a projected cost of \$6 to \$6.5 billion (19.6 million recipients in May receiving \$21.48 per person) in fiscal year 1976, are the

ican sugar growing countries met in Cozumel, Mexico, to set up an international sugar cartel. They failed.

They failed because they could not overcome condition two. All the major sugar importing nations can grow their own sugar, either from sugar beets (if they are in a temperate climate) or from sugar cane, if they are in a tropical or subtropical climate, or even both, as in the United States.

Also, the Soviet Union didn't go along. This is not according to Karl Marx, but according to Adam Smith. Each year, the Soviet Union buys up Cuba's sugar crop. Acting just like the vile capitalists, the Russians decided that they didn't care to pay their beloved Cuban comrades 50 cents a pound for sugar, or even more, when they could buy it elsewhere for fifteen cents a pound-or even

The difference between a business cartel and OPEC is clear. The embattled Vermont maple growers didn't intend to descend upon the hapless Boston pancake eaters with fire and sword if the Bostonians didn't switch to genuine maple

syrup. Whatever their political beliefs, the Latin Americans merely wanted more money for their product. The OPEC coalition aims both at amassing wealth and at world power. Sheik Ahmed Zaki Yamani, Petroleum Minister of Saudi Arabia, and the real head of OPEC, said as much in a speech to the American Society of Newspaper Editors:

"But oil's vital importance became really felt when, at the beginning of this decade, the so-called energy crisis visited the world and the scales of power were tipped in favor of the producers, giving them much greater influence and making oil a source of political power and a highly political weapon in their hands."

Venezuela and the Persian Gulf oil exporting countries started OPEC in 1960 in response to the price cuts made by the international oil companies to meet low Soviet oil prices. OPEC has long since been taken over by its Arab members. The non-Arab member countries docilely follow their lead for the sake of the glorious profits. Pierre Rinfret, the well-known

economist, believes that the "Arab oil weapon" will be used against the West, while actions and threats by Arab oil countries are blocking foreign investments in Israel, crippling its foreign trade, supporting anti-Semitism in the West, isolating Israel politically (more than 40 countries have broken off diplomatic relations with Israel), and building up the Arab armed forces with the help of the Soviet Union, Germany, France, Great Britain, and the United States. All this is in preparation for the fifth Arab assault on Israel.

The 1973-1974 oil embargo was OPEC's first major political move, and a successful one, for it showed that the West is a paper tiger.

The nascent Arab empire doesn't pay any attention to economics. It doesn't have to. Oil costs the Arabs nothing. The oil companies pay the production costs. Arab oil revenues are entirely profit. In spite of a worldwide glut of petroleum, OPEC is defying economics by keeping the price up by reducing production, and it is even announcing that it will raise the price. When OPEC puts into effect its proposed \$4 a barrel increase this fall, the weakened West will be struck another severe blow and unemployment and inflation will rise.

OPEC is strengthening its grip on oil while the West babbles. It is moving "downstream." With its victims' billions, it is buying up its victims' oil tankers. Tankers are cheap these days since there is a surplus of them due to the slackening demand for oil due to the sky high price of oil dictated by OPEC.

Giant tankers in the 100,000 to 250,000 ton range (that cost about \$80 million apiece to build) can be snapped up for \$30 million each. The world tanker fleet amounts to about 250 million tons. Idle tanker capacity may increase to 80 million tons by the end of this

year, thanks to OPEC, and the Arabs will be in a position to buy up most of the world's tankers at bargain rates.

For comparison, the United States owns only 8 million tons of tankers. Working at full capacity. American-owned tankers could carry only 15 percent of US oil imports.

The new Arab Maritime Petroleum Transport Company will spend about two billion dollars by 1980 on the construction of tankers having a total capacity of 5 million tons. It is estimated that at present, OPEC owns 3 percent of the world tanker tonnage. It will own more than 30 percent by the 1980s at the rate it is going. Obviously, OPEC contracts will require the use of Arab tankers. which will make future Arab oil boycotts frighteningly effective.

The Secretary General of OPEC put it this way, as reported in the Beirut Daily Star of December 15, 1974; "This is the big challenge, the challenge of the 1980s, that faces Arab oil producing countries now that they have almost completed total control of their oil resources and pricing methods. They have to look forwards to control of world shipping and marketing sectors."

OPEC is winning its war. Since the Arab Oil War began, the Western countries have done almost nothing to defend their interests. Instead, by continual fawning on OPEC, they have built up a reputation for feebleness and self-delusion that has not escaped the attention of the Soviet Union and the People's Republic of China. Recently, for example, both communist-dominated Portugal and fascist-dominated Spain have refused to let the United States use its air bases in their territory to supply Israel when the next Arab attack comes. Their refusal hasn't cost them anything.

During the Yom Kippur War. OPEC had the audacity to order American oil companies to stop supplying fuel to the US Sixth Fleet in the Mediter-Tanean. The American oil companies abjectly obeyed, and the United States government did nothing about it. Even now, the American oil companies can defy American vital interests without being liable to criminal or even economic penalties.

OPEC has even made the President's fear of a second Arab oil boycott an instrument of American policy in the Mideast by weakening our ties to our only ally in that vast area. Who will be next abandoned by the West?

Hurrah! At long last " a public relations " program is being inaugurated. I am writing to warmly commend you for your " UN The Farce Turns Ugly ", in " The New York Times" , Sunday issue of November 28th.
