I am just back from Sde Boker where I learned that B.G. has decided to accept Robert Hutchins' invitation to lecture at the 10th Anniversary Symposium of the Fund for the Republic on "The Prospects of Democracy throughout the World" in Santa Barbara on December 7th.

I tried to convince him that to visit the United States and not to meet with the Jewish leadership would not be fair to the community which has followed him loyally for the last few decades.

My idea at the minimum was to persuade him to attend at least one function for Bonds, one for the UJA and I was rather intrigued with the idea of his accepting the invitation from Philip Lown to speak at the 25th Anniversary meeting of the American Association for Jewish Education on the 14th of December. If he accepts, these meetings could of course be geographically spread as he is out on the West Coast already.

However, so far he only agreed to one sole meeting - and this only after some hesitation - (for everybody we could think of) on the problems of education in Israel.

Abe Harman and Katriel Katz will be kept in the picture and I have suggested that they contact you.
