MEMORANDUM

To Chairmen of Local Emergency Committees Date April 13, 1948

From Harry L. Shapiro

Yesterday the General Council of the World Zionist Organization (the Zionist Actions Committee) issued a proclamation which will go down in history as the Jewish Declaration of Independence. The text of the Declaration, adopted unanimously, follows:

On this, the third day of Nissan, the General Council of the World Zionist Organization, its highest unit, announces to the civilized peoples of the world, to the representatives of the United Nations and to the Jews scattered throughout the world that it has been decided to set up an organ of supreme authority of our national independence in Palestine.

In pursuance of this purpose, we declare that we refuse to remain a minority dependent on the sufferance of others. The mandate is about to end. On May 15, His Majesty's Government will surrender to the United Nations the trust it received from the League of Nations twenty-seven years ago and which it has failed to fulfill. It departed from the spirit of the mandate and replaced it with the selfish purpose of furthering its Middle East interests.

As a result of this policy, our refugees were refused entry in the hour of their direct need. They were interned instead and condemned to lead a life of danger, humiliation and helplessness while the mandatory treated with our sworm enemies, the friends and allies of the Nazis. And while refusing entry to Jews striving desperately after a last refuge, they opened our frontiers to hordes of invaders come to make a mockery of the decision of the United Nations. And now the mardatory is proposing to destroy the very foundation of our existence and leave the country in utter chaos.

To prevent this we have resolved this day that the termination of the mandatory government of Palestine shall in fact mark the end of all foreign domination in this country. With the termination of this mandatory rule, a government of the Jewish state shall come into being.

In this hour we turn to the Arab citizens of the Jewish state and our Arab neighbors, We offer peace and friendship. We desire to build our state in common with the Arabs as equal citizens. Our freedom is their freedom. Their future and ours rest on common endeavor.

Sure in the justice of our cause, we are ready to give our all to its achievement and we call on the Jews of all lands, and especially in Palestine, to close their ranks for the carrying out of this, our sublime, task. Assured in our faith, we appeal to all nations to grant us this right to our own salvation, and rest our trust in God, the Lord of Israel.

At the conclusion of the Actions Committee meeting, the following declaration was read:

Whereas, after twenty-seven years of an oppressive foreign regime that had received Palestine as a trust on behalf of the world to establish a national homeland for the Jews, that trust was not fulfilled:

Now, therefore, the Jewish nation will establish its own state and independence in its homeland.

The Jewish state to be established will be ruled by justice, freedom and equality for all inhabitants, regardless of race or creed.

We call upon the Arabs of Palestine and the neighboring states for an alliance of peace and cooperation. Together we shall build a state as citizens with equal rights and in mutual respect, for our freedom is your freedom.

Our lives are dedicated to defense, and the Lord of Israel will be our mainstay.

A five point political resolution which categorically rejects the recent proposal of the U.S. Government and which makes it clear that the Jewish people will have no part of the so-called trusteeship formula was also adopted, which reads as follows:

The General Council has learned with regret and astonishment of the attitude now adopted by the American representative in the Security Council concerning the U.N. decision on Palestine:

- 1. The Jewish people and the Yishuv of Palestine will oppose any proposal designed to prevent or postpone the establishment of a Jewish State.
- 2. We categorically reject any plan to set up a trusteeship regime for Palestine even for a short period of time. Trusteeship would necessarily entail the denial of the Jewish right to national independence and would leave Palestine under a foreign military regime.
- 3. The failure and disintegration of the Mandatory administration, the continuation of which was unanimously rejected by the United Nations, necessitates recognition without delay of the Jewish Provisional Council of Government by the U.N. Commission so that authority may be transferred to it as envisaged in the U.N. decision.
- 4. Upon termination of the Mandatory administration, and not later than May 16th, the Provisional Council of the Jewish Government will commence to function in cooperation with U.N. representatives then in Palestine. In the meantime we shall do the utmost to minimize the chaos created by the present government and shall maintain, so far as lies in

our power, the public services neglected by it.

5. The Jewish people extend the hand of peace to the Arab people. The Jewish State will be glad to cooperate with the neighboring Arab states and to enter into permanent treaty relations with them to strengthen world peace and to advance the development of all countries in the Near East.

The Actions Committee also ratified the military accord between the Haganah and the Irgun Zvai Leumi.

Another resolution, on Jerusalem, was adopted. It reads:

The General Council, representing the world Zionist Movement, calls the attention of the world and all religions to Jerusalem which is now under artillery fire. With the setting ablaze of the commercial center of Jerusalem, and looting it under the eyes of the Government which declared that it takes sole responsibility for law and order in Palestine, the Arabs began their siege of Jerusalem which has already lasted months without intervention by the Government or the military. The Arabs laid siege upon the Jewish quarters of the Old City and now have started to bombard with artillery various other quarters. In the spiritual capital of the world and the capital of the Mandatory in Palestine. Jews have for weeks been denied access to their holy places; have been prevented from bringing their sick to the hospital and to bury their dead in their ancient cemetery. The streets of Jerusalem are under constant fire from snipers and roads of supply are blocked in order to starve out the population. This happened not because the Mandatory hasn't enough power to deal with the situation, but because aggressors have been given free rein and the Government which is responsible for law and order in the city does not want to differentiate between the attacker and the attacked. In these circumstances the General Council feels obliged to convey to the entire civilized world its protest against abandoning Jerusalem. which, according to the resolution of the U.N. Assembly, is an international city, to murder, looting and destruction, in order to make the U.N. resolution null and void.

To all peoples and states in whom the name of Jerusalem inspires a feeling of holiness, we address our appeal and "ask for the peace of Jerusalem". We the representatives of the Jewish people, repeat the oath of our forefathers: "If I forget thee O Jerusalem, let my right hand forget her cunning".

The text of the economic resolution follows:

With a view to ensuring victory on the economic front and continuation of the peaceful task of rebuilding the Jewish Homeland, the Zionist General Council charges every Zionist individual everywhere, every Zionist body in the world, and calls on every Jewish organization wherever it may be, to mobilize without delay, and in the most effective manner, all its resources with a view to consolidating the economic front of Palestine; Assume maximum funds to ensure the speeding up of

supplies and equipment and everything required for defense and upbuilding of Palestine; Support immigration in every form and on a scale commensurate with the urgent needs of the Jewish masses requiring a home and the imperative requirements of Jewish man-power in Palestine for productive work and defense; Toil unceasingly to increase the national land possessions and implement the resettlement program; Further industrial enterprise and harmess it for defense needs.

Victory depends upon the speed with which supplies and equipment are mobilizable. The General Council demands that every Zionist Jew in diaspora make the fullest possible contribution for the defense and establishment of the Jewish State and considers the adaptation of Palestine economy to war needs as the condition of ultimate victory.

I know how rushed and how pressed the people in Israel are with regard to foreign dignitaries. I also know they do their very best to be courteous to everyone.

But if anyone deserves special treatment this man certainly does. He has helped us, particularly back in the time of 1948, in many unusual ways, beyond the line of duty. I think that B.G. himself, as well as Golda, Sharett and Eshkol ought to be sure to be available to him.

I understand the he is bringing with him several senators from the Senate Committee on Agriculture, and Mr. James Patton, head of the National Farmer's Union. Patton is one of the great liberal voices of America, and, in my judgment, confidentially, represents the organized farm strength behind Brannan which keeps him in office. Patton also, coincidently, comes from Denver, so that he and Brannan are personal as well as professional friends.

Dear Charlies

I write to you now, as I have done upon several occasions in the past, to put before you my views on a matter which is probably of more importance than snything I have ever asked for before. I know that you have been wrestling with this problem, and I know also that in the goodness of your heart you want to do everything possible to help us solve it.

I refer to the question of the 20 million bushels of wheat which the Government of Israel desires to stock-pile against possible future emergencies. I try very hard to get myself in your position, and to realise the emergency number of desards which are made upon you from all questers of the globe for this precious commodity. In the Dible we learn that man does not live by bread alone, and yet we also know that if he does not have bread he cannot concentrate on creating the higher and finer things of life.

I am no diplomat, and do not speak with the carefully chosen language of those practiced in the art of diplomacy. To me, the situation in Israel appears to be one in which the people and the government are alraid of what will happen, should a general world var break out. They are fearful that their supply lines to the West would be ismediately out off, and they would be left without the means of nourishing their population. There will come a time, in a few years, when the land will be capable of supporting the population. At the moment, this is not true, because of the incredible rate of absorption of refugees. As these people are absorbed, and as the productive tools of agriculture are placed in their hands, they will cause the land to give forth with most of the needs to make it self-supporting. As I gather the picture, they are afraid that time will run out on them before they can accomplish this goal. For this reason, it becomes imperative to them to have the assurance and the knowledge that they have succeeded in stock-piling a sufficient quantity of grain to assure then against possible famine conditions.

At one point, several weeks back, you thought it might be possible to make available to them as much as 50 million bushels. In my judgment, they do not need, nor are they equipped to handle such a quantity. The figure of 20 million bushels is much more realistic, for that amount they could handle, and that amount could provide them with a stock-pile which would last into the reasonably near future. I do not speak in any official capacity what soever for the Government of Israel. Their Ambassador has the power to conduct their negotiations. I simply an offering you my own judgment, that the smaller figure would allay their fears about

Mr. Charles Brannan February 20, 1951 being cut off in the future, and would help provide the stability which is so necessary for the morals of a nation. The morale of Israel is related in direct proportion, it seems to me, to the interests of the U.S. That little country is a true democracy and will stand in the Middle East in the troublesome days shead as a strong support for American ideals and way of life. Anything we can do to guarantee her safe existence will be of great value to the U.S. May I say, quite privately and confidentially, that I have discussed this matter with Mr. Eddie Jacobson of Kansas City, who is HST's close friend and ex-partner. Mr. Jacobson says that he is quite prepared to discuss this with the Boss, and is reasonably certain that he will receive a friendly and sympathetic response. If, in your judgment, Jacobson's approaching his friend would in any way help you to make this decision, he would be happy to do so. Again, I repeat, I have no wish to meddle in high places, but I am simply groping for any and all possible means of finding the way to enable this to come to pass.

Jacobson tells me that he has some friends in Kansas City, familiar with grain, who would fly to Israel immediately and make the arrangements for the construction of such elevators and storage places as would be necessary to to hold these 20 million bushels, should you be able to make them available.

I know, Charlie, how many things are weighing on your mind. I think I know, from the discussions here with Art Samelson, some of the pressures which are bothering you and giving you heartache. Because of the affection and respect I have for you, I certainly would not want to add to your problems. But I speak with my own small voice to tell you how terribly important I think this matter is, and to indicate that if there is any way within your power that you can make this wheat available, it will be the most magnificent of a long series of wonderful deeds you have done. There is an old saying among our people that the remard for doing one good deed is the apportunity to do another.

My dear Rabbi Friedman:

I should like once again to emphasize what I have already told you verbally that there is no organization in the United States, public or private, which speaks in any way or fashion for the State of Israel other than accredited representatives of the State in the United States.

I am conscious of the desire on the part of a number of organizations to make use of the State of Israel in whatever fashion possible. We, however, feel and have made it a matter of policy, not in any way to involve ourselves in any interorganizational problems on the American scene. Our task is to explain to the American public something of the development and future of the State of Igrael. On a number of occasions, some of the organizations in the United States have felt that they could be useful to us on certain specific projects and we have at their request, made use of their facilities. However, none of this cooperation can in any way mean either by implication or directly that that particular organization has assumed the responsibility for any phase of work for the State of Israel. Such responsibilities rest solely and completely with either the members of the Embassy of Israel in Washington, the two Consulates in New York and Los Angeles, and one or two government agencies operating directly with the mandate of the Government of Israel.

I can well understand your concern over the appearance in the press of statements to the effect that we have allocated our rights to individual organizations. That is a very damaging statement and one which I took up personally with the responsible parties.

There is much that all of these organizations have done for us in the past and there is much that they can do in the future and we welcome on every side, any cooperation with us in our work. In fact,

we encourage it to a degree that is unusual under the circumstances in which we work here in Washington. But it can never be assumed that by such cooperation we relinquish our control or our direction of any of our activities in the United States.

ESTABLISHMENT OF ISRAEL HAS PRODUCED NEW TYPE OF ANTI-SEMITISM, A.D.L. DIRECTOR SAYS

WASHINGTON, March 24. (JTA) -- Although the establishment of Israel has given American Jews an "ego boost," it has also resulted in a new type of intellectual anti-Semitism based on charges of divided loyalties of American Zionists, Benjamin Epstein, executive director of the Anti-Defamation League, revealed here.

Epstein said last night that an alarming lack of understanding of Israel and Zionism has been demonstrated by expressions of Protestant Ministers and other intellectuals. He cited articles in the "Christian Century." to support his remarks.

The chief source of criticism levelled at Jews is alleged divided loyalty and support by American Jewry of a foreign state which has now attained full sovereignty, Epstein said. "Professional anti-Semites seem elated at the success of Israel," Their new cry is that now that Jews have a place to so. "send them all back there." he added.

Epstein's statements were made at a forum on the significance of Israel to world democracy held at the Jewish Community Center here. Other participants were Arthur C.A. Liverhant, of the Israeli Embassy staff, and Prof. Richard J. Purcell, of Cetholic University

WHEN B'NAI B'BRITH WOULDN'T TAKE "A PARTISAN STAND" ON ZIONISM

By CARL ALPERT

N recent months I have had occasion to comment on the almost unanimous support which the Zionist cause today enjoys from almost every stratum of American Jewry. The American Jewish Committee appears to have appointed itself a special protector of our relationship with Israel; but the B'nai B'rith almost throws itself out of joint in its agitated effort to prove that it was pro-Zionist even before Herzl. Only the American Council for Judaism remains unregenerate and unreconstructed,

The friendly support and endorsement which Israel is today receiving from groups which have previously remained on the sidelines is most commendable. Such outspoken friendship is all the more a credit to the integrity and honesty of organizations which have the courage to admit they were wrong.

There is no mortal sin in admitting an error in policy. All of us are at times guilty of mistakes in judgment and opinion, and only time can reveal to us where we erred. Openly to confess such error is a sign of courage.

IT IS FOR THESE REASONS that I am surprised by the effort of the Anti-Defamation League to distort its own past record. With or without documents, almost everyone knows that the A.D.L. was for years consistently hostile to Zionism, and remained so under an unenlightened leadership. In more recent years, under the direction of Benjamin R. Epstein, the A.D.L., has undergone a

thorough house-cleaning, and has emerged as a respectable organization of which the B'nai B'rith need not be ashamed, even though its program may not command unanimous support,

A few weeks ago in one of these columns, my Staten Island ferry friend, a chap named Zalman, cited an old A.D.L. pamphlet named "How Far Zionism?" Even the title should have been enough to indicate the direction taken in the contents. Yet in an open letter in the February "A D.L. Bulletin," Mr. Epstein, in a rather aggrieved tone, complains that Zalman, and I, have not been

I don't like to argue with Mr. Epstein. People tell me he is a swell fellow-and the very point I had wanted to make-then and now-is that there is a big difference between the A.D.L. of today and the A.D.L. of another day. But he has been led astray, I fear, by his loyalty to his organization. It's a difficult matter under any circumstances to defend that old A.D.L. And to defend the particular pamphlet from the Fireside Discussion Series is even more difficult

After a fairly objective factual survey of the history of Zionism, the pamphlet closes with a discussion of the philosophy and theory of the movement. It offers only one authoritative quotation, that of anti-Zionist Morris Jastrow, who seeks to show "how fallacious it is to seek for a solution of the Jewish Question by the creation of such a state."

In hs defense Mr. Epstein is careless enough to say that "the pamphlet, of course, also quoted lots of pro-Zionist authoritiets." Well! I've gone through it four times, and I fail to find a single argument, a single quotation, a single pro-Zionist reference. There are no other quotations, and the argument is left to stand on Prof. Jastrow's fulminations.

Then the pamphlet concludes with such "questions for discussion" as "Do you think it is fair to try and eliminate the Arab from Palestine? How far should the Zionist Party go in trying to make Palestine a national homeland?"

THE POINT I WANT TO MAKE is that nothing is gained by defending an old and a dead policy. By contrast to the above, A.D.L.'s present policy is a comfort and an encouragement, and I began this discussion to emphasize the contrast.

The same is true of the B'nai B'rith. It is good to find the organization so outspokenly on the side of Israel at last. It makes excellent contrast to the days when so eminent a spokesman from the Order as Joseph L. Kun could write (1939) unchallenged: "The B'nai B'rith could not without threat to its existence, permit itself to take a partisan stand on such a controversial question as

Zionism."

New York, April 7 -- American Jewry will hold unprecedented services of prayer and intercession for Palestine tomorrow (Thursday, April 8, 1948), when synagogues throughout the nation will be filled with worshipers joining to give expression to their indignation over the American Government's reversal of policy with respect to Palestine, and to offer prayer for the embattled Jews of the Holy Land. This was announced today by the Synagogue Council of America, represending orthodox, conservative and reform Jewish rabbinical and congregational bodies throughout the United States, which has issued the call for this national mobilization.

The Synagogue Council disclosed that more than 8,000 Jewish houses of worship in the United States will hold speical services tomorrow. Every rabbinical and congregational body of the country is participating, including the Central Conference of American Rabbis, the Rabbinical Assembly of America, the Rabbinical Council of America, the Union of American Hebrew Congregations, the Union of Orthodox Congregations of America, the United Synagogues of America, the Union of Orthodox Rabbis of America and Canada, Agudath Israel of America, the Mizrachi Organization of America, the National Council of Young Israel, Vand Harabanim of New York, Poale Agudath Israel, Zeire-Agudath Israel, Hapoel Hamizrachi, Hashcmer Hadati, the Women's Mizrachi Organization and the Women's Section of Agudath Israel.

Large numbers of manufacturers and businessmen throughout the New York metropolitan area are closing their places of business at 4:00 PeN. tomorrow in order to enable their workers to arrive at their synagogues at an early hour. In most instances, the service will be held in the late afternoon or in the early evening.

It was also announced that Jewish religious organizations in Palestine, England, South Africa, Australia and Canada are planning similar special services for tomorrow and that the day of prayer and protest will have a world-wide character.

"I wish to express to you once again my thanks for your participation in the Jerusalem Conference 1953.

"The alacrity with which you - and the other leaders - accepted my invitation and came to hear the reports on the progress made in Israel in the past five years and the plans for the future, also the spirit of sympathetic understanding that you and your friends evinced for the problems of Israel, are encouraging evidence, if such evidence were necessary, of the solidarity of purpose between Jews abroad and the people of Israel.

"I hope you will agree that the Government of Israel and the Executive of the Jewish Agency did their best to place before the Conference all the relevant facts and considerations so as to enable all participants to arrive at a sober evaluation of the position. For our part we certainly took care not to gloss over our difficulties but tried to take the Conference fully into our confidence and present it with a true picture of the situation and prospects, in all their lights and shades.

"My colleagues and I, and indeed the people of Israel as a whole, were heartened in particular by the unity of purpose and the strength of determination revealed in the Declaration made by the Conference.

"I feel convinced that you came away from the Conference enriched by first-hand knowledge of the manifold problems with which the Government of Israel is trying to grapple, determined to do your utmost to assist Israel in her trials and endeavours, and reinvigorated in your faith in the ultimate triumph of our joint efforts."

Dear Herb,

Thank you very much for your note of December 16th. The person who worried you about Christian missionary schools in Israel, must have got his knowledge from a piece which appeared in "TIME" of December 15th. in the Education section with the heading "Rumblings in Israel". I am sending you attached copy of this item.

The facts as stated in "TIME" are essentially correct. Of the six to seven thousand children attending missionary schools in Israel, approximately 1,500 are Jews. This does not mean that the children have been converted to Christianity; it simply means that many Hebrew schools operating under the compulsory and free education law, are so overcrowded that some parents prefer to send their children to missionary schools, where incidentally, Jewish teachers also teach Hebrew. In view of the bad physical conditions, the number of 1,500 out of more than 300,000 school children is not really alarming. Of course the situation is not satisfactory, and a private committee recently set up is doing everything to persuade parents not to take such a course.

As you know, missionaries are free to operate in Israel and they maintain their own schools supported out of their own funds. Since we believe in, and practice freedom of religion, the Government does not interfere at all in their activities. I am sending you attached the booklet "Christians in Israel" as well as Marie Syrkin's "Education in Israel", which you may find interesting.

I have not heard from you as regards the matter of an overall Jewish Committee for Israel, or whatever you were going to name it, which I thought was going to be established under your Chairmanship in Milwaukee. I would also be interested to hear what happened to the efforts of the American Friends of the Middle East in Milwaukee and how your "pilgrimage" plans are working out. When you have a moment, please do drop me a line.

My Dear Herb:

I would like to thank you most heartily for your letter of January 14, 1953 containing the information concerning the medical and dental arrangements you have made on our behalf for the Israeli students in Milwaukee. We have already written to Ovadya, Eliezer of Milwaukee, who is the representative of the Israeli students there and informed him of the contents of your letter.

I regret that while passing through Milwaukee a few weeks ago I was unable to get in touch with you, but I am looking forward to getting together with you in the not too distant future and discussing problems of mutual interest.

Unfortunately, during the last few days storm clouds have again covered the Jewish people and we are anxiously following the developments which now take place behind the Iron Curtain, which I believe may endanger the lives of a very large number of Jews who are still in that area. I personally have great doubts whether the governments behind this Curtain will permit the Jews to come to Israel. Inspite of this we must try and do our utmost to awaken ourselves and others in order to save what we can save. All this comes at a time when we are already fighting on two fronts - to strengthen Israel's economy - to straighten out our relationships with the Arabs - and now a third front has been open whose strength should not be under estimated. I sincerely believe that we should discover ways to awaken a lot of our Jewish brethern who have sunk into an apathy which I have witnessed during my many meetings with different Jewish groups.

Dear Rabbi Friedmann

The hostility of the Soviet Union to the State of Israel and its savage campaign of anti-Jewish incitement must be regarded as events of historic significance to Jews everywhere. Both the Government of Israel and the Jewish community in the United States share a common responsibility in regard to the fate of two and a half million Jews in East Europe and the protection of the Jewish interests involved. Thus they have a common interest in ensuring that the response shall serve Jewish welfare, security and dignity in the fullest possible measure.

In our several ways we shall all be affected by what we do and how we bear ourselves in this grave hour. There can be no doubt that it is in the capacity of the Jewish people to withstand the assault.

I have, therefore, been directed by Mr. Abba Eban, Ambassador of Israel to Washington, to invite the presidents of some of the leading organizations in their personal capacity and a few other distinguished friends to consult with him informally and confidentially on the international and American aspects of this situation, and especially on the means of enabling Israel to meet those serious developments. Mr. Eban will come to Chicago on Thursday, April 16, and we will deeply appreciate it if you could be here for the purpose of meeting him on that day at the offices of the Consulate of Israel, 936 N. Michigan Avenue, from 3:30 till about 6:00 p.m. and take counsel together.

Please inform me at your earliest convenience whether we may count on your attendance.
