I am writing this letter just before tomorrow's elections in Israel, and although you will not receive the letter until after the election, I just want to wish you good luck. I know how hard you and others have worked and whatever happens you have the satisfaction of knowing that you did an excellent job and made a real contribution towards the future development of the country and its political structure.

I would appreciate it if you would advise me whether the financial condition of the party will permit my firm to render a small bill for its services in connection with the registration in the United States and related matters. Quite apart from out-of-pocket costs, the time spent in looking into and arranging the necessary filings was substantial and some payment might be appropriate, depending upon the situation. I would not, in any event, expect to charge our usual fees, but would, if appropriate, suggest some small fraction of our usual fees. I want to stress that this is not anything other than an inquiry,

However, it is respectfully requested that Exhibit D be granted confidential treatment and not be placed in the public file without prior notice to the registrant and an opportunity to dispute any proposed publication. The reason for this request for confidentiality is to preserve the rights of privacy which registrant would like to accord to those persons who made contributions to it. Registrant does not believe there is any legitimate public interest in the United States in the identity of persons supporting registrant's interests in Israel.

Also included in the filing are short form registration statements on behalf of Messrs. Daniel Doron, Merrill Hassenfeld, Herbert Friedman and Mrs. Rena Button. In the case of Mr. Friedman, his registration statement has not as yet been signed but it has been read to him and he has authorized its filing. Mr. Friedman is United States Department of Justice - 2 -

presently in Israel and a copy of his statement has been sent to him for execution. As soon as it is received by us we will forward it to you in substitution of the unsigned copy being submitted herewith. In the meantime, we are authorized by him to advise you that the information therein is correct. This filing relates to conversations previously had with Mr. Frederick Close of your staff by the undersigned and by Adrian Morchower, Esq. of the Washington, D.C. Bar. As you have been advised, the failure to make an earlier filing was wholly inadvertent and in good faith, as explained to Mr. Close. Registrant is acting on an entirely voluntary and uncompensated basis.
