



THIS SPEECH CAN BE VALUABLE SHOT IN ARM TO CAMPAIGN: TEXT FOLLOWS:

BRETHREN, MEETING TODAY TO CELEBRATE THE ANNIVERSARY OF THE BIRTH OF THE PROPHET MOHAMMED, WE MUST STOP AND LOOK AT THE TIME IN WHICH WE LIVE. IT IS A PERIOD OF MIGHTY TRIAL, . A TRIAL, FIRST AND FOREMOST, FOR OUR FAITH, THE FAITH OF THE MISSION OF THE PROPHET. WE FIND OURSELVES IN THE MOST DIFFICULT ORDEAL THAT WE COULD FACE IN OUR LIVES. THEY (THE UNITED STATES AND ISRAEL) WANT TO SHATTER OUR FAITH. A PSYCOLOGICAL WAR IS BEING WAGED AGAINST US,. THAT CLAIMS THAT WE CANNOT STAND UP AGAINST THE ISRAELIS AND MUST SUBMIT TO THEM AND SURRENDER TO TERMS OF THE UNITED STATES. THIS IS DESPERATE OFFENSIVE THAT DEMANDS THAT WE GIVE WAY TO DESPAIR, AS, TO GO BY IT, WE HAVE NO CHOICE BUT TO REACH AN AGREEMENT WITH ISRAEL AND THE U.S. AND ACCEPT THEIR TERMS. THEY ALL FORGOT, THE UNITED STATES FORGOT AND ISPAEL FORGOT THAT WE ARE THE STANDARD- BEARERS OF THE MISSION OF MOHAMMED; THEY FORGOT THA MOHAMMED AND HIS FAMILY WERE IMPRISONED FOR YEARS BUT DID NOT SUBMIT.

THYE MADE EVERY EFFORT TO DEFLECT XMEXXXMSXXX HIM FROM THE AIMS OF HIS MISSION, BUT HE REMAINED STEADFAST UNTIL ALLAH PERMITTED HIM TO MAKE HIS 'HEJIRA' AND HE THEN WENT AND COMPLETED HIS MISSION. HE FOUGHT, RISKED HIS LIFE, KEPT STRONG, AND RESISTED UNTIL THE CALL OF JUSTICE, THE CALL OF FAITH, THE CALL OF ISLAM CAME TRUE AND THE FLAG OF ISLAM WAS RAISED AFTER TWENTYTHREEYEARS. WE ARE THE STANDARD- BEARERS OF THE MISSION OF MOHAMMED; THEY FORGOT THA MOHAMMED AND HIS FAMILY WERE IMPRISONED FOR YEARS BUT DID NOT SUBMIT.

THYE MADE EVERY EFFORT TO DEFLECT XNEXXXMSXXX HIM FROM THE AIMS OF HIS MISSION, BUT HE REMAINED STEADFAST UNTIL ALLAH PERMITTED HIM TO MAKE HIS 'HEJIRA' AND HE THEN WENT AND COMPLETED HIS MISSION. HE FOUGHT, RISKED HIS LIFE, KEPT STRONG, AND RESISTED UNTIL THE CALL OF JUSTICE, THE CALL OF FAITH, THE CALL OF ISLAM CAME TRUE AND THE FLAG OF ISLAM WAS RAISED AFTER TWENTYTHREEYEARS.

ISRAEL, THE UNITED STATES AND THE LIKE FORGET THA WE CLING TO THAT VERY SAME FAITH. WE CARRY ON THE MISSION AND PURSUE ITS PURPOSE TODAY AND, FOR THE SAKE OF OUR FREEDOM, AND ANSWERING THE CALL OF JUSTICE, FREEDOM AND FAITH, WE SHALL NOT CAPITULATE OR QUIT OUR PATH. NEITHER THE U.S. OR ISRAEL CAN HURT US. THEY MAY WELL HAVE NEW WEAPONS, WE ALSO IMPORT NEW ARMS, BUT THE MATTER SI ESSENTIALLY ONE NOT OF ARMS BUT OF THE BELIEVER. WE BELIEVE THAT ALLAH IS ON OUR SIDE. WE BELIVE THAT JUSTICE IS ON OUR SIDE. WE BELIVE, AS COMMAND-ED BY ALLAH, THAT WE ARE A NATIONE ELECTED ABOVE ALL NATIONS. WE BELIEVE IN WHAT ALLAH BADE US IN HIS BOOK THAT ONLY THOSE WITH PATIENCE AND GREAT GOOD FORTUNE WILL PREVAIL. 23 '- WE SHALL BE IMBUED WITH PATIENCE OUT OF A STRONG BELIEF AND NOT BECAUSE OF A FRAIL CREED.

WE SHALL BE OF POTENT FAITH. WE ARE PREPARING AT PRESENT WITH ALL WE HAVE AND WITH ALL OUR MIGHT TO ENTER UPON OUR GLORIOUS CAMPAIGN. THIS IS THE FATE AWAITING US. THIS IS OUR DESITINY AND WE HAVE TO FIGHT FOR IT IN THIS CAMPAIGN, SO THAT WE LIBERATE OUR COUNTRY AND FREETHE FIRST OF THE TWO DIRECTIONS OF PRAYER (JERUSALEM) AND THE THIRD OF OUR HOLY PLACES OF WORSHIP. THERE ARE SOME WHO THINK THAT THEY CAN BARGAIN, THAT THEY CAN CONDUCY NEGOTIATIONS, BUT JERUSALEM IS NOT IN ANYONE'S OWNER SHIP, IT IS THE PROPERTY OF ALL, THE PROPERTY OF THE MOSLEM NATION, AND NOBODY CAN DECIDE THE FATE OF THE FIRST OF THE TWO DIRECTIONS OF THE PRAYER (JERUSALEM), JUST BECAUSE HE IS LACKING IN COURAGE, OR HIS POWER IS EXHAUSTED. NO. THIS IS THE RESPONSIBILITY OF ALL OF US. ALLAH, MAY HIS NAME BE BLESSED, TOLD US : THIS IS YOUR NATION, 9,3 NXXXXXXX CORRECTION ONE NATION, AND I AM YOUR GOD, WORSHIP ME AND HE SAID AGAIN AND TOLD US : THIS IS YOUR NATION, ONE NATION, AND I AM YOUR GOD. MANY TIMES HE THUS SPOKE.

NOBODY CAN EVER DECIDE THE FATE OF JERUSALEM. WE SHALL RETAKE IT WITH THE HELP OF GOD OUT OF THE HANDS OF THOSE OF WHOM THE KORAN SAID: 'IT WAS WRITTEN OF THEM THAT THEY SHALL BE DEMEANED AND MADE RETCHED XXXXXX WRETCHED.'SINCE WHEN HAVE THESE PEOPLE IN ONLY AFTER THE FORCES OF IMPERIALISM PUT TH CORRECTION SINCE WHEN HAVE THESE PEOPLE HAD VIRTUE? DXXXXX ONLY AFTER THE

FORCES OF IMPERISLISM PUT THEMSELVES BEHIND THEM. BUT THE FORCES OF IMPERIALISM WILL NOT BE ABLE TO CHALLENGE GOD'S WILL. THAT CANNOT BE AT ALL. WE ARE GETTING READY FOR THEM, OH BRETHREN. AS I HAVE TOLD YOU IN THE PAST, WE MUST STAND UP IN PATIENCE AND QUIET, THE PATIENCE OF THEFAITHFUL AND THE QUIET OF ONE SURE OF HIMSELF. WE MUST BE PATIENT AND QUIET TO PREPARE OURSELVES.

THERE IS NO ESCAPING THE CAMPAIGN, SO THAT WE SHALL LIBERATE OUR COUNTRY AND PROVE TO THE WHOLE WORLD, IN EAST AND WEST, THAT WE ARE NATION CAPABLE OF DEFENDING ITS RIGHT AND CAN RE-, REGAIN OUR COUNTRY. WE ARE NATION THAT WILL PERHAPS BE DEFEATED ONCE, WE SHALL PERHAPS LOSE A CAMPAIGN, BUT WE CAN NEVER LOSE OUR DESTINY, OR LOSE OUR SOULS, OR OUR FAITH.

THE FORCES OF THE WHOLE WORLD COMBINED WILL NEVER BE ABLE TO MAKE US LOSE OUR SOULS OR OUR FAITH.

WE WANT TO SAY TO ALL THESE PEOPLE : WE ARE NOW WAITING PATIENTLY: IN THE PATIENCE AND QUIET OF ONE SELF CONFIDENT, UNTIL THE HOUR COMES, AND THAT HOUR, BY THE WILL OF ALLAH, IS NOT DISTANT. BRETHREN, IN ADVANCE OF THIS EVENT, WE MUST DRAW A LESSON FROM THE LIFE OF THE PROPHET MOHAMMAD. HRE FOUGHT AND STRUGGLED AND STOOD UP PATIENTLY. HE WAS NEVER BROKEN, HE NEVE SWERVED FROM THE PATH OF JUSTICE AND THE FAITH. DURING TENSE STAGE IN WHICH WE FIND OURSELVES FACING THE GRAVEST TRIAL, WE MUST LEARN FROM THE PHROPHET TO STAD PTIENTLY AND CALMLY, IN DETERMINED DECISION, UNTIL WITH THE HELP OF GOD, WE SHALL REALIZE ALL WE WANT FOR PEOPLE AND NATION. AND THEN ALL WHO THOUGHT THAT IT WAS IN THEIR POWER TO BE OVERLORDS IN THE ARAB REGION, TO RUN AMOK IN THIS PART OF THE WORLD, BECAUSE IM-A GREAT IMPERIALIST POWER LIKE THE UNITED STATES WAS PROTECTING THEM, WILL GO BACK.

WE SHALL STAND PATIENTLY AND CALMLY AND PREPARE UNTIL WE PROVE TO THEM THAT WE SHALL NOT AGREE TO INJUSTICE AND, THAT WITH THE HELP OF GOD, WE SHALL FREE OUR COUNTRY, WHATEVER THE CONSEQUENCES AND THE DIFFICULTIES, AND WHATEVER THE SUFFERING. BUT ISRAEL MUST KNOW FULL WELL THAT THIS TIME IT WILL PAY THE FULL PRICE AND DOUBLE.

THEY WERE THE NEIGHBORS OF THE PROPHET IN MEDINA, THEY WERE HIS NEIGHBORS AND HE NEGOTIATED WITH THEM AND REACHED AN AGREEMENT WITH THEM. BUT IN THE END THEY PROVED THAT THEY WERE MEN OF DECEIT AND TREACHERY, SINCE THEY CONCLUDED A TREATY WITH HIS ENEMIES, SO AS TO STRIKE HIM IN MEDINA AND ATTACK HIM FROM WITHIN. THE MOST SPLENDID THING THAT THE PROPHET MOHAMMAD DID WAS TO DRIVE THEM OUT OF THE WHOLE OF THE ARABIAN PENINSULA THAT IS WHAT MOHAMMAD DID, MESSANGER OF GOD. WE SHALL CONDUCT DIRECT NEGOTIATIONS WITH THEM. WE KNOW OUR HISTORY AND THEIR HISTORY WITH THE PROPHET IN THE PAST. THEY ARE A NATION OF LIARS AND TRAITORS, CONTRIVERS OF PLOTS, A PEOPLE BORN FOR DEEDS OF TREACHERY. I DECLARE, HERE AND NOW, THAT THEIR DREAMS, THOSE THAT THEY SPEAK OF TODAY OUT OF THE LUST OF A VICTORY THAT THEY THINK THEY ACHIEVED IN 1967 AND WILL PRESERVE FOREVER, I TELL THEM TODAY FROM THIS PLACE THAT WE SHALL NOT GIVE UP A SINGLE INCH OF OUR SOIL, THAT WE SHALL NOT NEGOTIATE WITH ISRAEL, WHATEVER THE CIRCUMSTANCES, AND THAT WE SHALL NOT BARGAIN WITH THEM OVER A SINGLE ONE OF THE RIGHTS OF THE PALESTINIAN PEOPLE. LAST YEAR, AND IN THIS SAME PLACE, I PROMISED YOU AND I TOLD YOU THAT, UNTIL THE NEXT ANIVERSARY EVEYONE OF YOU WILL HAVE THE PROTECTION OF INSURANCES, IN OTHER WORDS, EVERY CITIZEN IN OUR COUNTRY WILL NOT REACH OLD AGE WITHOUT THE STATE SEEING MXS TO HIS LIVELIHOOD. TODAY, AS YOU HAVE READ, THIS PROGRAM ME HAS PROGRESSED AND WITHIN A BRIEF TWO MONTHS A PROTECTION OF SOCIAL SECURITY OVER THE SONS OF OUR PEOPLE WILL BE SETABLISHED.

I PROMISED YOU THIS LAST YEAR AND I PROMISE YOU THIS YEAR, THAT, AT THE NEXT BIRTHDAY ANNIVERSARY OF THE PROPHET, WE SHALL SCELEBRATE IN THIS PLACE NOT ONLY THE LIBERATION OF OUR COUNTRY BUT ALSO THE DEFEAT OF ISRAELI ARROGANCE AND RAMPAGING, SO THAT THEY SHALL RETURN AND BE AS THE KORAN SAID OF THEM 'CONDEMNED TO HUMILIATION AND MISERY'.

WE SHALL NOT GIVE IN ON THIS. THE MATTER IS NO LONGR ONE OF ONLY FREEING OUR COUNTRY, BUT ONE LINKED WITH OUR HONOUR AND THAT DESTINY OF OURS IN WHICH WE BELIEVE. WE SHALL SNED THEM BACK TO THEIR FORMER STATE.

YES, IF THEY EVER THOUGHT FANCIFULLY THAT THEY HAD WON A MEASURE OF POWER THEN WE SHALL SEND THEM BACK TO THEIR FORMER STATE, FOR, AS I SAID, POWER IS NOT IN STRENGTH OF ARMAMENTS. POWER SPRINGS FROM THE INNER FORCE OF BELIEF, THE FORCE OF LAW, THE FORCE OF FAITH IN A MISSION, AND OF BELIEF IN A PRINCIPLE. THANKS TO ALLAH WE ARE THE SANDARD BEARERS OF THE SUBLIMEST MISSION, THE FORCE OF THE INDIVIDUAL, THE FORCE OF SOCIETY ,. THE FRCE OF BELIEF THAT ALLAH IS THE KING OF KINGS WHO BESTOWS HIS KINGDOM AT WILL AND TAKES DOMINION FROM WHOM HE CHOSES, WHO STRENGHTHENS THE HAND OF SOME AN D HUMILIATES THOSE WHOMHE WISHES TO DEMEAN. HE IS ALMIGHTY. GOD, YOU ARE THE ONE WHO KNOWS WHAT WE CONCEAL AND WHAT WE KNOW AND NOTHING IS EVER HIDDEN FROM YOU. DIRECT US IN OUR WAY, HELP US TO BE VICTORIOUS, \$\$77/FA3/ YOU ARE THE FINEST LORD.



PLAN WAS TO SEARCH FOR SUITABLE PEOPLE WITH EXCITING STORIES GOOD ENGLISH ANDFREEDOM OF PERSONALITY TO PROJECT TO AUDIENCE. DOMINITZ AGREED THAT SEARCH FOR PEOPLE

- 4) I WAS PREPARED TO , AND AS A MATTER OF FACT, TOGETHER WITH SIMON AND SHESKIN, ALREADY HAVE UNCOVERED FOUR OR FIVE PEOPLE MUCH BETTER THAN THE TWO WHO ARE COMING.
- 5) SINCE PINCUS WANTS TO TAKE THE MATTER UP WITH YOU IN NEW YORK, I WILL DESIST AND AWAIT INSTRUCTIONS.
