Dear Zang and Irv.

If I were the Rabbi of your congregation, I am positive that I would "tell you off" properly. Since I am not, all I can do is register my complaint and my deep dissatisfaction.

I was most disappointed and very upset by the "card calling" at the dinner this past Sunday evening. I object to it for a variety of reasons. In the first place I find it to be totally out of keeping with the moral and ethical dictates of our faith. Judaism never has taught that the end justifies the mean. In fact, I believe that a good case could be made for the exact opposite. Purther, the procedure, as conducted, violates Judaism's highest teachings with regard to Tzedakah. I would suggest that you look at the writings of Maimonides dealing with this subject. If you cannot find it any place else, it is in volume 2 of the Union Prayer Book on page 117. There you will discover that the highest levels of charity require anonymous giving. Lastly, the Sunday might spectacle completely violated my sensitivities regarding what is classified as proper conduct.

My position on this matter is nothing new to either of you, in that on every opportunity, at every meeting of your board I have always spoken out for a high level of moral conduct as part of our campaign.

A further reason for writing this letter is to indicate to you and to the Community Council that neither Rabbi nor Mrs. Mahrer were happy with nor comfortable in their attendance and participation in Sunday's dinner.

I hope you realize that I was rather upset. I hope you realize, also, that a great number of other people who were present that night, many of them among your most active and generous workers and contributors feel exactly the way I do. They might not tell you, I felt is my obligation to do so.

Dear Rabbi Mahrer:

I have before me two documents: One is your letter of April 11, 1967 addressed to Zang Freed and Irwin Zeisel, c/o Jewish Community Council, and the other is a copy of a Resolution adopted by the Board of Trustees, Congregation Anshai Emeth, Thursday, April 13, 1967 — "Declaration of Rights for Soviet Jewry."

Since your letter was written on Congregation Anshai Emeth stationery and signed by you as Rabbi, with copies to Jack Szold and Robert Pritzker -- both officers of the Congregation -- I am not sure whether in your letter you were expressing your own personal opinion or if the letter was an official expression of Congregation Anshai Emeth.

As a member of Anshai Emeth I would appreciate clarification.

With regards to the meeting itself and the manner in which it was conducted, I cannot comment, since I wasn't present. Concerning your disappointment and distress by the "card calling" this is another matter. As a Rabbi one might rightfully assume that your "disappointment and distress" would have been with the poor attendance and lack of voluntary response, rather than the method used. One would think your concern would be for the success of the appeal.

Do you know what it is like to stand up there and wait for a voluntary response? How long the pauses are? How every second of silence seems like hours? Let me assure you Rabbi that very few enjoy this task; that it takes real courage and devotion to do it.

Do you know the argent need for the maximum funds? Are you aware of the plight of the Jews prior to the establishment of the State of Israel?

Do you know that Israel has taken in 1,250,000 people during this period? Do you know that the Jewish Agency is in debt for hundreds of millions of dollars (yes, hundreds of millions of dollars)? Because people were coming in and sufficient funds just were not available to meet the needs, money had to be borrowed. Thank God they had the credit to borrow these wast sums which still have to be repaid.

Rabbi, do you know how Jews are brought out of certain countries and what it costs to bring them out? Not so many years ago the difference between life and death for some was directly related to the amount of money raised — today it can be the difference between freedom or hopeless despair.

It is highly unrealistic thirty years after the rise of Mitler and nineteen years after the establishment of the State of Israel, to assume that either of these crucial chapters in the history of the Jewish people would have been met with the standards of charity prescribed by Maimonides. I am sure that if Maimonides had had a crystal ball and could have foreseen the terrible tragedy that was to overtake the Jews a thousand years later, he would have provided for a more liberal interpretation in accordance with the spirit and needs of the times, and not with the inflexible literal concept you quote.

The fact is that no major undertaking on the part of American Jewry, and that includes the present movement for the improvement of the status of Soviet Jewry to have their right to issignate, would be possible if the principle of self-sacrifice and community consciousness were not mobilized for fund raising on a major scale.

What the Rabbi characterizes as undignified use of any means to achieve a worthy end, has the acceptance and the universal recognition, not only of the leaders of Jewish fundraising, but of the men and women who are the backbone of such campaigns. They will be the first to admit that without some degree of social and communal pressure their contributions might well be less generous.

My dear Rabbi, you are either very maive or uninformed of the practicalities of Jewish life. I can assure you that the only people embarrassed at the meeting were those who gave inadequately. Exparience has told that on a voluntary basis people give very little, that most Jews are just mildly interested, let alone concerned. Why have meetings at all? Why not do this by mail and let people give what they want?

Card calling is exerting the right to ask Jews to stand up and be counted. Is it wrong to embarrass those who decline to recognize their responsibilities as Jews? It seems to me that this has been the theme of many mrmons in synagogues from time immemorial.

The present needs are too great to afford the luxury of experimentation with what you call "high level moral conduct as part of the campaign." If you want to experiment, you might start it with your own Congregation, and let us see what you achieve.

The Resolution on Soviet Jewry is an excellent one as far as it goes, but it just doesn't go far enough. A fourth point could be added, or should have been added, as to who is to provide the funds should the Resolution be implemented. It would have been a much stronger Resolution if it would have stated that we are prepared to take care of ten, twenty, thirty, forty or fifty families, or X number of families to find homes, to find jobs, find schools for the children, if and when Jews are permitted to immigrate from the Soviet Union. Otherwise the Resolution is idle words and is meaningless.

I am sending you under separate cover the documented history of Bergen Belsen. You might find it interesting, and after you read it, you can put it in the Congregation Anshei Emeth library.

Dear Mr. Rothberg:

Thank you very much for your letter of May 5 and for sending the book on Bergen-Belsen. It has just arrived, and while I have not had the opportunity to review it thoroughly, it does appear as if it will make a valuable contribution to my own personal knowledge and a significant addition to our congregational library.

I believe that you and I are in complete agreement with regard to the well documented needs which campaigns such as the one recently conducted in Peoria are designed to meet. We would not have any argument on that score. However, we do disagree regarding the approach which the community takes to this kind of fund raising. I don't believe that it will benefit either of us to attempt to discuss this through the mails. I hope that some day we will have the opportunity of discussing it face to face. While the letter to which you refer was written on congregational stationary, rest assured that the opinions stated were not the official opinions of the congregation. I spoke for myself, though I would venture to guess that a significant proportion of the Peoria Jewish Community would agree with the views expressed.

With regard to the resolution adopted by our congregation concerning Soviet Jewry, I must admit that your suggestion is one that had slipped my mind entirely. I think it is very, very important and highly significant. Therefore, should the Jewish Community Council agree to conduct the meeting requested, or should that public meeting be held under other auspices, I will work diligently to have such

a pledge included as part of the outcome of the meeting. I believe that the Peoria Jewish community would be willing to assume this kind of financial and moral obligation.

Again, thank you for writing and sharing your thoughts with me and my appreciation for the book.



Dear Larry:

1. You may recall that I once spoke to you about Jay Phillips of Minneapolis. When I went to solicit him some weeks ago for \$1 million, he spoke with great admiration of your gift in that same amount. He spoke in warm terms of how much he admired such action on your part. I asked you to help with him, and you said you would be glad to do so after the first of the year. By now Phillips has left Minneapolis and is at the Harbour House in Bal Harbour. Before going south he told the UJA committee that he would give \$250,000 for 1971, which is only \$50,000 increase over last year.

I am really surprised. I thought he would make a much larger increase, from the way he spoke. I think it would be very helpful if you could see him, or at least, talk to him on the telephone. If he will not give the \$1 million, he should and could give at least \$500,000. If he does not, there is no chance whatsoever of Minneapolis reaching its goal.

II. Martin Peppercorn tells me that there are two people of Miami Beach whom you agreed to solicit when you go south. They are Morton Hill and Morris S. Burk. Each man should be asked for \$100,000. The following is their giving history:


