Mother and child are doing fine, the bris has just been successfully accomplished, and now I will get my correspondence in order.

To begin with, I know you will be pleased to learn that not one minute of your time will have to be spent collecting any pledges to pay for the General's appearance. He has graciously accepted to appear at the UJA Annual National Conference on December 11, 1965, without any fee at all. Purthermore, the primary purpose of the Conference is to commenceate the Twentieth Anniversary of V-N Day, an event never to be forgotten by free wen everywhere and certainly of special significance to the survival of the Jovish people to our times. General Eisenhover was invited as the Supreme Commander of the Allied Expeditionary Porces, together with two fellow commanders, the English General Alexander and the French General Keenig, as the leader of that group of free and democratic armies which crushed the Wazi enemy. General Eisenhower's record vis-s-vis concentration case survivors and the Jovish displaced persons is most commendable. I had the privilege of serving under his command at the time as a U.S. Army Chaplain, and can testify from personal experience that General Eisenhover himself was fully aware of some of the most crucial aspects of the problem of Jewish displaced persons and was annious to improve their lot as rapidly as possible. In addition, it is a fact that the only official territorial guarantee Israel has, to this very day, is based on the Tripartite Agreement of 1950 between the United States, England and France, which was designed to maintain the status quo in the Middle East. This declaration may have been insufficient to counter the threat of Arab Fedayeen guerills raiders, but, in the absence of alternate agreements, the Tripartite Quarantee, reaffirmed during the Eisenhosor Administration, cannot be ignored. The purpose of this letter is not really to engage in a discussion of General Eisenbower as a Eispist or lover of Israel. I am sure you agree that as the liberator, as a former President, as a man of genuine concern for the IP's, he is certainly to be considered an bonored and worthy guest for the UJA Conference. 

Dear Charlie:

I have read and re-read your letter of 7 October concerning Norway and Sweden, and must confess a certain amount of confusion.

When we spoke in Copenhagen, and you suggested that perhaps you would look into the question of whether the Norwegians and the Swedes had not also done something outstanding for Jewish survival. I had no idea that you were talking about entering into any full scale research projects. I thought you simply meant that you would investigate, in quite personal terms, by having conversations with various people, what the background story might be.

As for full scale research involving a book, a salary, and all the subsequent problems of publishing and selling, I had nothing of the sort in mind and I think this has been carried far beyond our simple Copenhagen conversation.

Isn't fundamental research of this sort more in the interests of the World Jewish Congress or the American Jewish Committee? I certainly do not want to embarrass you, but it does seem to me that this is not a matter on which I can spend UJA money.

We can talk about this some more in person when we next see each other.

It will probably be difficult, as it was last year, because the New York State Legislature is in session at the Capitol in Albany during that month, and the Governor does not like to absent himself during that period. You will recall that was the reason for his turn down last year. Let us hope, however, and we lose nothing by trying. Regarding the material on the development towns, I plan to make extensive use of this approach in the 1966 campaign. The problems of absorption must be dramatized and that is why I thought of the approach of a specific number of towns, with the exact and specific data describing the life of the people in those towns. Ben Eliezer did the basic research and then our team of writers went to work on it. They have done what I think is a beautiful job. The title is "21 Frontier Towns." Each town will be written up in four pages - the size of a Readers Digest page. There is also an eight page introduction. The whole, therefore, published and bound as one book, will reach almost 100 pages, approximately the thickness of a Readers Digest ordinary issue. A man can easily slip it in his policet. When used individually, each four page prochure can be placed next to a dinner plate at a table, and can be read easily during the course of a dinner. By the end of this week I shall be able to send you typed scripts of the 21 stories plus the introduction. If you want us to print some extra copies for you, we will, so course be glad to. Teddy had suggested that the best possibilities were either in Central Galilee or the Boor Region. Bill has indicated a preference for the Central Galilee. I know that you have many things on your mind during this difficult period, but life must go on. I would appreciate your being the catalyst now to ask Mr. Eshkol and Mr. Pincus to carry this matter to its conclusion. Hill's support of Israel through the UJA during all these years is a matter of great pride to him and to us. After his return from his trip this summer, he spoke about Israel with such a new dimension of understanding that you would have been thrilled. My dear Mr. President:

You are a man with a great sense of history and a deep understanding of how a strong vision can motivate people to attempt far-reaching solutions 60 their problems. This sense of history and sense of vision have impelled you to fashion "The Great Society" as an answer to many of America's problems.

The United Jewish Appeal, of which I have the honor to serve as General Chairman, has also operated from the same premises. For more than a quarter of a century our organisation, embracing the loyal support of almost all American Jews and many of their Christian neighbors as well, has worked with a sense of history and vision to save 1,500,000 lives chiefly through resettlement in Israel and other free countries of the world.

I shall never forget your inspiring words to the UJA leaders, including myself, assembled by your gracious invitation at the White House in February of 1964: "The noblest work of man is what he does for his fellow man... because of you we have a better country and because of what you are doing, we will have a better world."

A very noteworthy historic anniversary is being observed in this year of 1965 -- the 20th anniversary of the end of the Second World War and the liberation of the concentration camps in Europe by the victorious Allies. The UJA is now preparing an impressive Commemorative Conference to mark this victory of freedom and to recall that moment two decades ago when man's spirit as well as his body was released from tyrannical oppression.

We decided some months back to invite the Commanding Generals of the Allied Armies, for these men symbolised the millions of soldiers who fought for freedom. I am happy to inform you that the following men have accepted our invitation and will attend: The Supreme Commander, General Dwight D. Eisenhower, for the United States; Lord Alexander of Tunis, for the United Kingdom; and General Pierre Koenig, for the Free French.

It will be the first time in twenty years that they have been on one platform together and, conceivably, the last time they may be able to do so. A new generation, born since the war, surely will understand the symbolism of the three standing together, and will be reminded of the eternal lesson that liberty must always be dearly defended.

These military commanders remind us of great past events. It is our carnest hope that you can be present to speak to us of the future.

The date is Saturday night, December 11, 1965.

The place is the New York Hilton Hotel.

The audience will consist of 3,000 communal leaders from all over the United States.

We are deeply convinced that your participation will make this occasion one of great historic significance for all mankind.

I am sorry that the reply to that letter was delayed by my absence from the country. As you know UJA is very reluctant to be involved in the management of a corporation. I do not believe there has been any instance of a gift of stock to UJA in which its position has been anything more than that of a stockholder with no responsibility for management. It was our expectation in accepting the gift of Stratford stock that the persons acting as officers and directors would continue in office until the property was sold. It would be my preference that they should continue in office so that UJA is not involved in management. However, if I am in error in that assumption, please advise me. In that event it will be necessary for me to submit the question of the election of directors and officers of Stratford to UJA's Board of Directors. I do not have the authority without a resolution of the Board to vote the share of stock of Stratford for the purpose of electing directors. There is one practical problem concerning a meeting of the Board. I do not anticipate that the Board will meet prior to January when the annual meeting customarily takes place. Cordially, Herbert A. He returned to New York a couple of days ago and I shall speak to him by telephone later this morning. I appreciate everything you have done and I will now carry the matter from here. Progress will be reported to you through ccopies of correspondence because I would certainly want you to be informed. Let's hope everything comes to a fruitful conclusion. Regarding the Museum, I hope that you have by now received the official letter signed by Mrs. Halprin. What lies behind it is simply the fact that fund raising in the United States cannot take place in a vacuum. It must be connected to some established and authorized organization. The natural relationship for the Museum is obviously the A.I.C.F. Therefore, what the Committee was saying was the fact that official approval for conducting this campaign had to be granted to an already authorized institution. I visualize no difficulty. I do not know if there is any reason, on your end, why you should not want the A.I.C.F. to act as the umbrella under which you operate. Actually, you need a channel for many reasons, not the least of which is to have an address in the United States. Please discuss this whole thing with Messrs. Stern and Recanati and I will continue to be at your disposal, to steer things through, and to help wherever I can. The formalities can be concluded very quickly as soon as they return to the United States. If they will be in touch with me, I will try to advise them as to what questions they might face before the Committee and what information they might be requested to provide. The basic thing that the Committee would want to know would be your projected plan of operation -- when you intend to work, where you intend to work,

Mr. Theodore Kollek -2-26 August 1965 with whom, etc. If you wanted, I would also be happy to assist in the preparation of such a plan. One thing I am doing now is drawing up a list of prospects. This is the first chance I have had to write since coming back. Things

This is the first chance I have had to write since coming back. Things are very busy here and so much is happening that I am not sure I can clue you in on everything. But, I will try.

1. December Conference - We now have acceptances from General Eisenhower, General Pierre Koenig and Lord Alexander of Tunis. Max Fisher has been sounding out opinion and is of the frame of mind not to invite a Russian. That item is still pending.

In addition, our plan was to invite several important lay leaders from around the world, and we now have acceptances from Israel Sieff (England), Baron Guy de Rothschild (France), Samuel Bronfman (Canada), Astorre Mayer (President of 14 European Countizes), Israel Goldstein (Israel) and Edel Horwitz (South Africa). We are whiting to hear from Goldenberg (Argentina) and Kashfi (Iran).

I tell you all this simply to indicate that the conference is beginning to assume the quite large and historic proportions that I had hoped it would when we first projected this idea.

2. October Mission - The list has now assumed the largest proportions in our entire history. There are approximately 190 persons at the moment, and while there will undoubtedly be some fall off, there may also be some additions. There are many, many large contributors, plus some large prospects for the I. E. F.

- 3. New Settlements a. I notice from the enclosed clipping that the Agency took a decision to establish new farm settlements. This is the first time in a year or two that this is being done. You will recall we discussed the whole concept and agreed that we would not make a major campaign out of it, for it was not timely. On the other hand, since it has been announced publicly, it would seem to me that we should not ignore it completely and make some judicious use of this fact. Could you, therefore, send me whatever informational material you have about these ten new settlements. I particularly want to know exactly where they are (please send a map) and some simple background information about them.
- b. The enclosed clipping from the Hadassah convention will indicate to you that Hadassah plus the JNF are developing the new town of Carmiel. Is that a fact?
- 4. Bonds I am curious as to whether you have any information as to what is meant by the phrase "expansion of the bond organization." If this is just a publicity writer's phrase, it doesn't matter. If, on the other hand, there are concrete plans for the expansion of the bond work in which we might be interested, then it would seem to me that we should be informed on what those plans are.
- 5. Study of 21 Towns You will recall our final telephone conversation in which I discussed with you the question of whether you thought Moshe Rivlin could produce the necessary studies of these towns in time, so that the raw data could be translated by my publicity department into tuntable campaign documents. Your personal opinion in that phone conversation was that, with the best will in the world, Moshe probably could not get the material done in time.

I have been giving a great deal of thought to this. The story of absorption must figure very prominently in the 1966 campaign. If that story is told through the nignette approach, then it can be made attractive. What it all boils down to is that I am thinking of sending a person or two over for 6 or 8 weeks, to do the researching and the writing on the spot. I am sure that you, Moshe, Zygel, Ben Eliezer and everyone else will lend their support and cooperation. I am looking around now for the proper personnel and as soon as that is decided, I will let you know.

6. Radio tubes - I sent them with Peppercorn and assume that you have long since received them, but if something has gone wrong, please let me know.

I do not know anything about the Ruppin Institute. Perhaps you should write to Michael Arnon, the new Consul General in New York, who was formerly Ambassador to Chana and who might have some suggestion for Mr. Cohn. (2) I received the article you wrote about Sharatt and it was very interesting, warm and sentimental. I want you to know that we are going to build a tremendous school in his name, high on a hill in Upper Nazareth. I selected that location because, somehow, he seemed to have an interest in and understanding for the Arab mentality as well as the Christian. While the school at Nazareth will obviously be primarily for Jewish children, nevertheless, as the years go on, it is equally obvious that Arab and Christian children from the lower town will find their way to the high school in the upper town. I am not taking the time to develop this theme, and as I have stated it, it may sound rather crude, but I think you have a glimmering of what I am driving at. We have already found three people who are willing to contribute \$100,000 each in Sharett's memory because of the feeling they had for him. I know how you felt about him, and if there is anyone you can think of who should be approached for this project, I would love to hear about it now. We are working on this currently and would like to complete it fast.

Rabbi Philip Bernstein -2-5 August 1965 (3) With regard to the stones, I had a long talk with Avraham Biran, the head of the Department of Antiquities in Israel, without whose permission nothing from Caesarea can be touched. He is very reluctant to grant permission for a Roman column or capital to leave the country. I pressed hard and he is thinking about it. Let's see what happens. With regard to large stones from Jerusalem or the Dead Sea or King Solomon's Mines, there is really no problem. It is simply a technical one of finding a company with heavy equipment to handle packing and shi pping. I am having some inquiries made as to what this might cost and as soon as I hear, I will let you know. I am making my inquiries on the basis of pieces 2 metres square, wide and high. Were you thinking of something larger than this? (4) The article for the Zeitschrift is almot finished. Frankly, it was rough going. I had to extract myself from current preoccupations and bring back to mind the fabulous years of 1946-47. But, once I started the article, I enjoyed writing it. The more so, because the time we spent in Europe were the best years of our lives. Seriously speaking, I would appreciate your hand, ling the following matter:

I received a call from Rabbi Sidney Regner, Executive Director of the Central Conference of American Rabbis (Reform). He had received a letter from Rabbi Chanan Brichto, now in Jerusalem at the Hebrew Union College Building. Brichto wrote in regard to the case of a 92 year old woman, Mrs. Lauterbach. She is the first wife of a famous professor at the Hebrew Union College, Jacob Lauterbach. He is dead now. They were divorced many, many years ago. The feeling of responsibility for the woman is therefore sentimental, not moral or legal.

She has a son living in Israel with her and earns IP 400 per month bruto. He has been supporting his mother up to now but is running into difficulty.

I do not know whether she is eligible for admission to one of the Malben institutions -- probably not, because she is not a new immigrant. On the other hand, I am sure that no real case work study has been made of the family situation. Therefore, what I am asking you to do, Ted, is to give Rabbi Brichto of Jerusalem and audience when he calls you for an appointment, listen to his whole story and then see if you can arrange for some social work investigation to be made so that you can suggest whether Malben kan handle her case, or if something else could be done.

There appears to be a slight hitch in the dates we discussed. I spoke to you about October 11 and 12. It turns out that the reason these dates were free on the calendar of the touring teams is because they are the first two days of Succoth. Those dates would apparently not be any better for you than for any other community.

My suggestion, Jim, is that you and Martin discuss alternate dates and give me a series of possibilities. The entire month is booked, but we will try to re-juggle with some other communities in order to accommodate you.

Aside from the question of dates, please think through the question of the usage of these men. You would get one Israeli and one American for at leasr two days. You might want to arrange a meeting of your B oard. You might want to arrange a social get-together of some of the potential younger leaders of whom we spoke. Dear Bill:

I read the long letter which Charlie Jordan sent to you on the whole matter of the Jewish Agency-UHS fight, and I must say that he covered the waterfront very thoroughly.

I understand that you wanted my opinion as to how you should proceed in the matter. I would say that you should do nothing at all. There are many issues constantly boiling in this non-tranquil Jewish world of ours, and it is not necessary for you to feel obligated to take up the gauntlet on every one.

My point of view is that Mr. Shragai's war with the UHS must be brought to an end immediately. I refer both to his public war, conducted in the press, and his private war conducted in letters to his own staff. It is unseemly, undignified, and damaging to the UJA, for two of its beneficiaries to be involved in a fight. From everything I can gather it is not even a two-way fight, but one which was imposed on the UHS. It seems to me to make absolutely no sense for this to continue.

If there are disagreements on a local operating level, they should be ironed out on that level and should never reach the proportions to which this tempest has blown.

The second thing I feel is that the struggle on the local operating level, notably Naples and Vienna, is also unwarranted. Our proposition, in the simplest terms, must be that a migrating Jew has a right to choose his destination. I know of the line of reasoning which says that the exits from Rumania are predicated upon the reunion of families in Israel. I am fully aware of the sentiment and feeling of the Jewish Agency and the Zionist movement that the best refuge for any Jew seeking to resettle himself is Israel. You know perfectly well that I agree with that fully and have stated so hundreds of times in all of the public speeches I have made.

Mr. William Rosenwald -2-3 August 1965 On the other hand, there is one thing to which I will never agree and that is the concept of forcing a man to elect a destination which he really does not want. I would do everything possible to explain to the prospective migrant why I thought Israel would be the best place for him, but once I saw that his mind was fixed elsewhere, for whatever reason, I would not feel that I had the moral right to attempt to play God in the solution of his life's problems. It seems to me incredible that there should be any argument on this point. If the migrant makes up his mind after all the discussion, that he wants to go to Canada, or the United States, or Australia or wherever, he should be turned over at once to the UHS. As far as the IRC is concerned, not a single Jewish migrant would ever fall into their hands if harassing and delaying tactics by Agency personnel were not employed. Nor should anyone be referred by the Jewish Agency to the IRC. Non-Israel-bound cases should be turned over only to UHS. Therefore, Bill, I repeat that it is not necessary for you to get involved in this. Should Louis Pincus, who has the ultimate authority, speak to you, there are two things to be stressed: (1) request Mr. Shragai to call off his attacks; (2) request that the operating procedures in the field be such that upon an individual's statement that he does not want to go to Israel, he be turned over to the UHS for processing. I think I have now outdone Charlie in the length of his letter and since he apologized for invading your vacation in Cannes, I will do the same re your visit with Alice to Israel. It will project you throughout the community with an even larger image. You must sumply make certain that in all biographical releases about you, your UJA connection and titles are spelled out very prominently.

My only feeling in the matter is that if you have a choice, let Mitchell take it first, and you take it the year after. My reason for saying that is that if you follow Mitchell, you would not lay yourself open to the accusation of being only a red hot, pro-Israel sealot (which nobody would accuse Mitchell of being) and therefore if you took it after him, you would simply be following in the line of good community leadership responsibility.

I think it would be good for the UJA if you took it and while it might be better if you took it a year from now, perhaps it is just as well for you to make any deal with Mitchell that you and he are both comfortable with.

The bottom line of the whole businesskis, in my judgment, that he is not accustomed to giving away large sums of money. He is going on the UJA Study Mission to Israel in October and said that he would then be interested in seeing various areas where schools were needed. We will certainly show him everything. He spoke at great length about the party he gave for Shalev and was obviously quite proud of that. He also said that he now holds over \$100,000 in bonds which he has not given away. I urged him to continue buying and holding so that he would have a very nice nest egg with which to make a big commitment.

If there is any way that you can think of to continue to keep this matter alive in his mind until October, I would certainly appreciate it.

Dear Teddy:

As you can see from the letterhead on which I am writing to you, the Education Fund for the buildings in Israel about which I have spoken to you in the past has become a reality. We have been in actual operation since last October and have accumulated about \$5 million worth of pledges in that period of time. During that same season we have, of course, launched and three-quarters completed the current 1966 regular campaign of the UJA. I am most encouraged by the start and feel that we will be making another important contribution to Israel's growth. I am sending, under separate cover, several of the basic reports and documents which went into the establishment of this new campaign.

The other day I was in Los Angeles and had a long personal visit with Mr. Dave K. Marks. He contributes annually to the Los Angeles campaign only \$2500. It was suggested that I see him, however, because of his interest in education and the fact that he has contributed very substantially (I would guess running into a total of somewhere between \$1 and \$2 million) for the construction of large buildings at the University of Southern California, Claremont College, the Hebrew University and Loyola (a Catholic institution).

In the course of our conversation he told me that he was the first cousin of the late Lordsimon Marks. This surprised me for I had been given no inkling of this fact by anyone. He spoke very proudly of his association with the family and showed me a telegram from Mrs. Blond acknowledging his invitation to attend the dedication of another building he had built and regretting her inability to be present.

I explained to him the needs for secondary schools in Israel and he was quite sympathetic. He also stated that he was committed to many projects which would take him several more years to pay off. He thought he would be prepared to do something for us in 3 or 4 years. He is quite a remarkable man, 75 years of age and in possession of full vigor. He has no hesitation about speaking of "3 or 4 years from now" in spite of this age. He is a bachelor, whose only brother died recently so there is the whole question of a wery large estate with no heirs.

Mr. J. Edward Sieff 8 June 1965 -2-I am writing to you, Teddy, in order to seek your support and that of Israel in this matter. I understand that the Directs of Secondary Schools of the Ministry of Education, a Mr. Eliezer Shmueli, was in London early in the spring and spoke to Israel about constructing a comprehensive school in the town of Migdal Haemek in the name of Lord Simon Marks and that Israel said he was prepared to contribute towards this school. I would like Mr. Dave Marks of Los Angeles to contribute his funds, if we can get something from him, towards the same project. When I was with him last week, I did not discuss any specific school or any specific amount, prefering to leave that completely open. Therefore, what would be helpful would be a letter from you or Israel supporting the general proposition that these secondary schools are desperately required in Israel and urging him to participate in the specific school honoring Lord Simon. DRAFT MEMORANDUM

NATIONAL COUNCIL OF CONGREGATIONS FOR UNITED JEWISH APPEAL

I. PURPOSE

During the past two decades, the membership rosters of Jewish religious institutions have greatly increased. This fact is reflected, especially, in the suburban congregations of the larger cities in the United States where the overwhelming majority of American Jewry resides.

The primary objectives of the National Council of Congregations for UJA would be to enlist the active support of the rabbinic and lay leadership of Orthodox, Conservative and Reform Congregations, in coordination with local federation leadership, to increase the number of contributors to the annual campaign and to raise the level of giving among the membership of synagogues and temples throughout the country.

II. NATIONAL STRUCTURE

The structure of the National Council of Congregations for UJA will consist of the following:

- A. A Chairman to be appointed by the General Chairman
- B. A group of Vice-Chairmen -- one from each community where a Council of Congregations or its equivalent is established or is presently in existence. The Vice-Chairmen will be selected in consultation with local federation leadership. The Chairman and the Vice-Chairmen qualify for positions of leadership by virtue of their past record of achievement in behalf of the annual campaign and their prominence in the religious life of their respective communities.
- C. The National Presidents of the three major religious groupings, viz::

Union of Orthodox Jewish Congregations (Orthodox) United Synagogues of America (Conservative) Union of American Hebrew Congregations (Reform)

D. The Chairman of the UJA Rabbinical Advisory Council

It is of interest that the Presidents of the three major rabbinic bodies:

The Rabbinical Council of America (Orthodox)

The Rabbinical Assembly (Conservative)

The Central Conference of American Rabbis (Reform)

are presently members of the UJA Rabbinical Advisory Council.

E. A member of the UJA National Executive Staff will be assigned to the Chairman and the National Council of Congregations.

III. LOCAL STRUCTURE

The National Council of Congregations for UJA is prepared to work flexibly with each community and to adjust techniques and methods to local conditions in order to assure maximum effectiveness of the program. Among the suggested approaches are the following:

- A. Where a congregational council or its equivalent does not exist, the Chairman, in conjunction with the local Federation leadership, will seek to establish a city-wide Council of Congregations for the Federation or Welfare Fund. The city-wide Council of Congregations will urge the creation of a Campaign Committee, or other mechanism for campaign cooperation and aid, in every congregation, to enlist the support of those congregational members who are not presently contributors to the annual campaign, and to reach others with greater effectiveness.
- B. The Vice-Chairmen should guide and follow through on the activities of the congregations, to evaluate and help accelerate the progress made.
- C. Organizational meetings may be held to officially launch the program of a local Council of Congregations or its equivalent. To this meeting are invited the Rabbis, Presidents, Executive Directors, Men's Club and Sisterhood Presidents, of every Orthodox, Conservative and Reform congregation. The gathering will be addressed by the Chairman of the Council and/or the Chairman of the UJA Rabbinical Advisory Council, or an appropriate communal leader.
- D. The tentative plan is to launch the program of the National Council of Congregations for UJA in New York and the major communities. If successful, the program will be extended to the communities of smaller size.

IV. SUGGESTED PROGRAM

- A. The local Congregational Council will seek to publicize the needs and achievements of the UJA and the local Federation through the synagogue bulletins and in other ways.
- B. The Board of Trustees of local synagogues and temples will be asked by the local Congregational Council to send a letter to all congregants, urging their support to the local campaign.
- C. The local Congregational Council will make a special effort to increase the participation of the religious school students in the annual drive.
- D. The local Congregational Council will seek the general support of the Rabbinate for the campaign. The Rabbi will be asked to devote at least one Sabbath to a discussion of current needs.

E. The National Council will endeavor to publicize its program in the publications of the major religious groupings.

V. GOAL

Mr. and Mrs. Joseph Meyerhoff of Baltimore will be at the Claridges in London from May 13 until May 20. Mr. Meyerhoff was the General Chairman of the United Jewish Appeal from 1961 through 1964. His current contribution is \$92,000, and he has given as much as \$120,000, but more important, Joseph Meyerhoff is one of the truly significant leaders of the United Jewish Appeal in America. He is as well informed on campaigning as he is on the needs of our overseas agencies. He and his wife have travelled extensively and have made it their practice to meet with leaders of Jewish communities wherever they have been.

Although they visited Landon before, they really have not met with the leaders of the British Jewish community. I would very much want them to be received by Sir Isaac Wolfson, Teddy Sieff, Jack Lyons and Haim Morrison. What I hope is that you will be able to arrange for Mr. Wolfson to have the Meyerhofts for dinner at his home. I trust you will be able to handle this in your own very tactful manner. It would be very nice if Mr. Wolfson would invite some important people along with the Meyerhoffs. Mr. Meyerhoff knows Barney Shine quite well and his inclusion might mean one mutually familiar face. The primary function of the United Jovish Appeal is the raising of funds for the relief, rescue and rehabilitation of Jews in mood enywhere in the world. The funds raised are transmitted to the beneficiary agencies of the United Jovish Appeal, wis., The Jovish Agency for Israel, Inc. The American Jouish Joint Distribution Committee, The United Hiss, and The New York Association for New Americans. The philasthropic progress of the constituent agencies of the UJA are conducted in thirty countries including Israel. The sale of bends, sponsored by the Israel Povelopment Corporation, is to be viewed as an investment in the economy of the State of Israel. The increasing demand to expand the economy in order to provide cuployment for the 250,000 Jess who entered Israel in the last four years, is one of the major factors responsible for the launching of the Third Development Issue of Israel Bonds, However, due to external and internal pressures on the Israel economy in recent years, it was resolved not to permit the exchange of Third Development Bonds for Israeli pounds for a minimum period of two years from the time of purchase. This was a policy decision of the Government of Israel and is reflected in the Third Development Issue Prospectus. The UJA, in conjunction with the Earsel Bond authorities, therefore, issued a directive which prohibits the acceptance of Third Development Bonds as payments toward UJA pledges for a period of two years from the time of purchase. It will interest you to know that in 1984, the total cash receipts of the UJA was \$60,724,327. This figure exceeded the UJA cash figure of 1963, which was 860,597,208. Yot, in 1964, the USA received as payments for pledges, \$1-1/2 million less in Israel Bonds than in 1983, partially because of the two year rule of the Third Development Issus Prospectus. This accomplishment reflects the evareness on the part of American Joury of the needs of the constituent agencies of the UAA.

It is quite evident that the American Jowish Community, by and large, appropriates the besic differences in the purposes of the UJA and the Israel Development Corporation. In the light of these developments, I would urge you to emplain to your colleagues why the UJA, if it is to meet its responsibilities to the Jewish Agency, the JDC, United Hiss, and NYAMA, cannot accept Third Development Bonds in payment of pledges in 1965.

Receiless to say, your personal interest in the success of this year's campaign is dooply appreciated by the loadership of the UJA.

Feldman Both Israel Temple 701 Farmington Avenue West Hartford 7, Connecticut Dear Abe: Pursuant to our telephone conversation today, I am enclosing basic material describing the very real needs in Israel Which underlie the campaign of the Israel Education Fund, These itoms are the result of intensive research conducted by the United Jewish Appeal over a period of several years, and the resulting program - which you will find on the last pages of "ISRAEL'S MAJOR NEEDS IN REDUCATION" - is a minimal one. The need has grown even in the few short months since that report was issued. Enlman Aranne, Ternel's Minister of Education and Culture, told the Knesset yesterday that 9,000 teachers must be trained in the next three years to meet the teacher shortage, which exists mainly in secondary education; our report, issued last September, had set the need at 8,500 teachers within five years. To confirm what I stated on the phone, the Israel Education Fund campaign is limited, selective and specialized. There is no publicity in the usual campaign sense, and no large meetings. Solicitation is restricted to specific appointments with individual prospects. No IEF gift is solicited until the prospective donor has made his regular campaign pledge. I would, as I said, very much appreciate your informing Mr. Louis Fox that Mr. Charles J. Bensley, president of the Israel Education Fund, would like to meet with him to discuss his participation in the IEF program. Because of Mr. Fox's service on the Board of Education in Hartford, he will be interested in knowing that Mr. Bensley was a member of the New York City Board of Education for many years. He organized and led the mission of educators to Israel whose report served as the basis of the IEF program. He has

been in Israel many times during the past decade in the course of an exploration in depth of the education system there and is one of the best informed men in this country on this subject.

My young brother-in-law, Norman Bensley, is graduating from Princeton this June. He has majored in Modern History. He has applied to the London School of Economics, to take the General Course (for foreign students). This is a program designed for graduate students from abroad who wish to enjoy the benefits and high standards of British education. I do not know how these matters are handled in England, but I do know that in the United States letters of reference which are sent in by well known persons do have a way of aiding the registrar in deciding on whether to accept an application or not. If you felt that you were in the position to do so, I would appreciate your sending a letter to the registrar at the London School, Houghton Street, Aldwych, London, W.C. 2, supporting Norman's application. He is a fine young man, of the highest character and ethical standards, quite sensitive and intelligent, who wishes ultimately to pursue the study of law. Dear Irving:

Thank you for your lovely letter of 8 March. I am delighted that the meeting had such a wonderful tone and was so successful. I think the front-page publicity canonly hwip to make the Federation more important in the eyes of all the contributors. Congratulations for such good organization as to have the editor of the paper present.

I do understand more fully the various problems you describe in relation to the Community Chest. It simply seems too bad that because of the lack of responsibility in the community as a whole, the Jewish Federation cannot enjoy the same advantages that almost all other Federations in the country have at their disposal. When all is said and done, I am sure you know the local situation better than anyone, and if it doesn't make sense to try to become a beneficiary of the Chest, then just drop it.

We will have to continue to try to raise more money in Atlantic City so that the UJA can receive at least the national average of 50% of the gross total raised, which, I am sure, you and your leadership would really like to allocate to us. If we continue to work together, then perhaps we can push the total fund raising up so that the UJA can receive a larger share.

In that connection, I meant what I said in the closing part of my remarks when I talked about the priority of the Federation and the disproportionate way most of the people distribute their money. You have been kind enough to ask if I could dictate the sum and substance of those closing sentences. It is hard for me to do that, but I can recapitulate the argument in topic sentences as follows:

Mr. Irving T. Spivack -2-12 March 1965 1. The Federation is the most important Jewish secular activity in any community. 2. The Federation deserves by far the greatest measure of a man's philanthropic giving. If I were asked to be specific I would say that a man should give two-thirds of his total charitable dollars annually to the Federation. 3. Everyone speaks of the great days of fund raising back in 1948, as though this was the peak of achievement. It is not so. 4. Jews are giving away more money today than they did then. They are simply giving it to other things, instead of to their Federations. 5. In addition to giving more money now than they did 15 years ago to Jewish' causes, they are also giving more today to non-Jewish causes. 6. Therefore, it is fair to say that the philanthropically-minded Jews of this country are at the peak of their generosity today. 7. Jews are making a terrible mistake in reducing the proportion of their total giving to their central Federations, because if the central Federations grow weak, then it will be hard to finance all the good causes which the Federations support. 8. It is not enough to applicad a man for his total generosity if the manner in which he has allocated his gifts shows a disproportionate and unbalanced distribution. The truly generous man must be made to understand that he should re-allocate his annual "portfolio of contributions" so that his Federation receives the major portion. 9. The man who is not truly generous must be made to understand that a greater share is required from him, and that simply re-allocating does not represent assumption of full responsibility on his part. Let me give you my personal reactions, as follows: 1. I think your analysis of the campaign is correct. The greatest bulk of the money must come from the smallest number of too contributors. I think it is absolutely splended that you are willing to try to stimulate these top contributors by matching their increases with a 1/3 increase of your own. I think what you did in the 1964 campaign was marvelous when you said you would increase your pledge to the extent of 10% of all pledges made and paid above \$405,000. As you pointed out, this increased your liability by \$6000 above your basic pledge of \$25,000, which you were happy and willing to do. This year you are making an even more generous offer, and I think you are greatly to be commended for it. 2. I do not think you are correct in saying that if you increase your basic pledge of \$25,000 it will not affect the giving by others. I would strongly urge and recommand that you do make some increase, as a definite commitment. You know, and you hope very much that it will come to pass, that your offer to match will result in costing you more money. Last year, it cost you an extra \$6000. We do not know what it will cost you this year, but you are obviously willing to give something more in order to stimulate others. Therefore, my recommendation is that you take a fixed amount, let us say \$5000 and increase your gift by that definite commitment from \$25,000 to \$30,000. This might serve to inspire some of the other top 25 or 50 centributors, which is exactly what you want to see happen. I think you will help it to happen by making a small definite commitment increase.

Mr. Lazure L. Goodman -2-8 March 1965 3. The 1965 campaign has started out with some increases, but I do not see this campaign spurting abhead of last year's in the same proportion that last year's went ahead of the year before. In other words, 1964 showed almost a \$60,000 increase over 1963. I do not see a \$60,000 increase in 1965 over 1964. There will be some increase but I do not see it in the same dimensions. It might be that your plan has not been fully communicated to the top 25 or 50 individuals. 4. Therefore, I would like to make another suggestion, namely, that you write a personal letter to the top 25 or 50 men, explaining your willingness to match them, and urging them to increase their gifts. I think it is entirely possible for the Welfare Fund to reach a figure of \$500,000 if you spur the men forward. I realize that you cannot be active in the campaign because you are adhering to your doctor's advice. On the other hand, writing a letter such as I am suggesting would not be too strenuous a task. I am sure that Frank Newman at the Welfare Fund office would be glad to have the typing done individually (it should not be a form letter by any means) and all you would have to do would be to sign your name 25 times. That you could do at your leisure in the evenings. It is just wonderful to think that there are people like you who care so much about raising the level of the campaign. The thought you gave to these various plans and schemes makes of you more than just a contributor -- you are really a creator of ideas. Please let me know what you think of my suggestions. When I went to his office in the Senate to pick him up to bring him over to the hotel, I reminded him that the last time he spoke for the UJA was at the Western Regional Conference two years ago at Palm Springs. The cost for the trip of \$1050 per person includes round-trip jet air fare from New York, all hotels and all meals on the scheduled days, taxes, airport taxes, tips, transfers and bus tours.

Hundreds of leaders like yourself have participated in missions conducted by the UJA or toured Israel as individuals with the assistance and guidance of the JDC and Jewish Agency. Unfortunately, most community professionals have never had an opportunity to participate in such missions. In view of the vital role of the staff in fund-raising and the importance of these needs in community campaigns, I am sure you will recognize how valuable it would be if it were possible for a member of your professional staff to take advantage of this opportunity.

Participants in the Mission will meet with Israel's leaders in the Government and Jewish Agency, as well as with Israelis from all walks of life in their homes and at social gatherings. The problems and the process of immigration and absorption will be studied in depth.

In Europe, representatives of the Joint Distribution Committee, United HIAS Service, and ORT will review their organizations' programs and needs. There will be the opportunity to observe on-the-spot activities in Paris, Vienna and Rome.

The cost of the Mission is \$1050 per person and includes round trip jet air fare from New York, all hotels and all meals on the scheduled days, taxes, airport taxes, tips, transfers and bus tours. A total of seven days in Paris, Vienna, Israel and Rome do not have scheduled programs and you will have them free for personal activities. Hotel accommodations and breakfasts for these days are included in the Mission price.

All hotel accommodations will be first class, with the price based on double occupancy. Single accommodations are slightly higher. Reservations for the Mission must be taken on a first-come first-served basis. Spouses are welcome, but there are no accommodations for children.

The Mission schedule is as follows:

Monday, July 19 - Leave New York - Arrive Paris
Thursday, July 22 - Leave Paris - Arrive Vienna
Sunday, July 25 - Leave Vienna - Arrive Tel Aviv
Tuesday, August 10 - Leave Tel Aviv - Arrive Rome
Thursday, August 12 - Leave Rome - Arrive New York

For reservations, a deposit of \$200 per person made payable to the United Jewish Appeal is required by March 1st. Payment of the total by April 1st to secure reservations is requested.

I know that it has been a long time since many community professionals have had an opportunity to participate in a survey of the overseas programs of the UJA. It is my strong hope you will be able to take advantage of this opportunity.

I would very much appreciate your advising me now if you are interested in this Mission. As noted, the agenda is being worked out in cooperation with the CJFWF and your suggestions, comments, and questions will be most welcome. I am attaching for your information a copy of a letter describing this trip which has been sent to Federation and Welfare Fund Presidents.

First of all, I should like to thank you very much for agreeing to take the Big Gifts fund raising meeting in Los Angeles on the evening of January 27th. After his cancellation, discussions were held with the various communities and with Ambassadors Harman and Comay, both of whom felt that it was necessary to find the requisite substitutes for the Minister. Each is doing his share and have both suggested that you take the Los Angeles meeting.

I know how you feel about not leaving Ganada, since you have more than enough to do in that primary area of your responsibility, and we certainly will not consider your acceptance of this meeting as a precedent, although you must be aware of the fact that there are many American communities which would like to invite you back after your previous successful visits.

This particular meeting will take place at the home of Mr. Bram Goldsmith, 924 North Beverly Drive, Beverly Hills. He is the chairman of the 1965 campaign.
